**To Sign Contract Under GPC Program** The Great Plains Conservation Program is now a reality for Mills County farmers and ranchers, Maxwell C. Kirkpatrick is the first to develop a conservation contract for costshare assistance under the new

program for the county. The GP Program is a natural for farm and ranch operators who have a need for large amounts of conservation work to be done in a short period of time, Charles Studer, District Conservationist, at Goldthwaite, points out.

The new program is set up by the county GPCP Committee with representatives of the varous agricultural agencies of the county, including the Agricultural Stabilization and Conservation Service, Farmers Home Administration, Extension Service and the Soil Conservation Service serving as members. The permanent county committee invites all organizations interested in agricultural and total conservation resource development to consult with them in selecting a list of practices for signs the first Mills County Great Plains Conservation Program the program.

Highlights of the first GP contract on the Kirkpatrick serve the contracting procedure. A copy of the contract is mainstock farm located near Mullin, will include converting 106 acres duplication in cost-share assistance between the GPCP and ACP of cropland to Kleingrass for pasture, and controlling brush with seedbed preparation for range and pasture seeding.
