custom in those days. The family and social life of a doctor were planned around when babies were due, and many times plans were canceled or

postponed. Dr. Campbell was known to "stay for dinner" while waiting for a baby to arrive or for a patient to pass the crisis of a serious illness since distance prohibited his going back and forth, and several have told the story of his sleeping in a swing or bed on a porch for part of the night

while waiting. Many interesting stories and anecdotes relating to Dr. Campbell's practice exist. It is impossible to attempt to tell them all, but a few can be recalled that portray a picture, familiar to all who knew him - of "Stump-water" as he was lovingly called by some

Many diagnosis were made and treatment administered by Dr. Campbell on the sidewalks of Goldthwaite, and many children and adults were taken into the office to have a sore throat mopped with silver nitrates He always wore a vest and a coat and the pockets were stuffed with calumel packets and other medicines which he might need quickly or if he met someone on the street who was ill.

For years he kept no books and sent no statements - and was paid often during the hard times with chickens, eggs, sausages, hams and feed for his horses. After money became more plentiful, people paid doctor bills for years back and often his vest pockets bulged with crumpled one dollar bills collected on the street. He was a contented man and had no desire to amass a fortune. His greatest pleasure was his family - above all his grandchildren, first a granddaughter and then a grandson. Dr. Campbell's love of the great outdoors afforded him the pleasure of many hours

spent hunting, fishing and camping. There were other hobbies to help relieve the grueling tensions and demands on country doctor. He was an avid race horse enthusiast, and in partnership with Sam P. Rahl raised race horses for a time He spent many hours playing

dominoes and also played the violin for years. Dr. Campbell participated in

numerous community, state and national activities. He was the local Santa Fe physician for years, and through his association with this railroad was instrumental in getting the Mills County Hunting and Fishing Club established at Lake Merritt. In 1921, he was authorized by the City Council of Goldthwaite to negotiate with the Santa Fe for a purchase of land south of town in order that a well might be dug to furnish water for the city of Goldthwaite. He helped establish the Fair Grounds and Racing Association

in Goldthwaite. He was Chairman of the Board of Directors of the Trent State Bank for several years and was active in the Masonic Lodge. He was President of the Brown, Comanche, Mills and San Saba Medical Society and County Vice-President of the Texas Medical Association. He was the Medical Examiner for the Selective Service Systems through World Wars I and II. Numerous times former classmates in Medical School and friends in Scott and White Hospital in Temple urged him to join the staff there, but he pre-ferred his life in Mills County. Campbell was a godly Dr. man. He was a close personal friend to ministers of all denominations and the strength of those friendships was evidenced at his funeral when representatives of all faiths, Catholic and Protestant, requested that they be allowed to participate in the service. He saw many travel through "the valley of the shadow of death" but was able to help postpone that journey through his skills

and knowledge. Although he was not the first, nor the only beloved doctor in Mills County or Goldthwaite, Dr. James Milton Campbell was one of the very early doctors in the area and typical of the "horse and buggy" ' country doctor of his time. His dedication, unselfish devotion to his profession, and love for humanity left a mark on this county that will live forever.
