The City Commission in conjunction with the committee of Eastland taxpayers held its second meeting Wednesday night for the purpose of planning a way to liquidate the city's bonded indebtedness.

Proposals by the representatives of the bond owners as well as by the citand studied with the hope that a methwill be alle to liquidate the debt by paying within its ability from year to year.

Repudiation is not suggested but liberal terms, entirely within the city's ability to pay, will undoubtedly result from the discussions.

Families with children will be given preference in distribution of cloth, and Dr. Tanner says that there may not be enough cloth for those who really need it and he urges that people not take advantage of the situation and take cloth when they do not need it.



> Eastland County received 22,000 yards of cloth, which is a part of the 500,000 bales of cotton turned over to factories by the government. The cloth was divided among the towns of the county on the basis of the flour distribution up to September 1. Eastland's apportionment is as follows: prints 1120 yards; shirting, 1120 yards; muslin or domestic, 1120 yards; outing, 840 yards; birdseye, 310 yards; making a total of 4510 yards of cotton materials. The cloth will be distributed according to the size and needs of the family.

Only about one-third of the amount requested in the application was allotted the county, making the serving of only the most needy families a necessity, J. E. Spencer, county Red Cross chairman, pointed out in a letter to Dr. Tanner. A large amount of the cloth will probably be given away unmade, Dr. Tanner said. Needy children will be supplied first, after which adults may receive their share of the garments.




After the proposals are received and opened an inspector will be sent to Eastland to choose from the sites proposed one or more that are suitable for the building, and the definite site

Randolph Speaks On 'Telegraphy'

"Telegraphy" was the subject of a classification speech made by H. B. Randolph, manager of the local Western Union, at the weekly luncheon. of the Lions Cluit on the Connellee Rotel roof garden Tuesday noon.

Mr. Randolph explained how telegraph has evolved from the time when it was used only for death and emergency messages to the present time when it is a necessary adjunct of everyday commercial life.

Money orders, airplane tickets, theater tickets, flowers can now be handled by telegraph, Mr. Randolph said in explaining the range of service.


"When I was working in the telegraph office in Huntsville," Mr. Randolph began, "a negro brought in a sack of potatoes and wanted me to wire them to his daughter in Houston. He said that if I were able to wire money and flowers, I should be able to wire potatoes just as well. I spent about thirty minutes trying to explain to the negro why I couldn't wire the potatoes for him."

Explains Machine

Mr. Randolph had with him a Simplex machine used for both sending and receiving telegraph messages, and he explained it in detail to the club.
