PARMER COUNTY came within a couple of penalty flags, or on the plus side, a couple of play executions, of having three schools in post-season competition in football.

As it is, only District 5-AA champion Farwell will compete in the playoffs. But both Bovina and Friona came so close, that each one could almost taste that "playoff pudding."

Bovina's 10-7 loss to Olton kept the Mustangs from clinching the runnerup spot in the playoffs in District 5-AA, and Friona's 9-3 setback to Muleshoe cost the Chieftains the runnerup spot in 2-

In Friona's game with Muleshoe, the Chieftains drove the length of the field, and apparently had the tying touchdown with the chance to kick the PAT for the win, when a holding or "pushing" penalty wiped out the TD. The official who called the penalty must have had pretty sharp eyes, since those reviewing the films haven't caught the infraction yet.

Bovina likewise had a chance to win, and Michael Shepherd's runback of a pass interception was called back for a clipping penalty. Coach Larry Helton didn't question the call in this instance, however.

The Mustangs even had a second chance at the playoffs when they came out in a three-way tie with Olton and Kress. But Olton proved to be lucky at coin-tosses on Saturday, when they won the right to advance in

the playoffs. Since the District 5-AA runnerup is slated to play powerful Morton (who bombed Bovina, 55-0 earlier in the season), there has been some talk that the Mustangs may have had mixed emotions about gaining the playoffs, and that in reality, Olton "lost" the toss when they "had to play Morton."

But getting into the playoffs would have been nice. Question of the week: When were the Bovina Mustangs last in the playoffs in football?

HOW LONG HAS IT been since you could sleep with a window open during a November night? Or better yet, during an entire week of them?

What an unusually mild week or two the area has enjoyed. After experiencing one of the earliest freezes on record (September 21), it now looks as though Mother Nature's fickle personality might let the area go two additional months before another killing freeze.

Someone remarked to this writer the day or two after the early freeze that in all liklihood, we might just go another two months without another freeze. We thought at the time the remark was mainly in jest, but it will at least come close to that prediction.

The mild fall, one of the mildest in recent years, has allowed harvest operations to move almost uninterrupted. Except for the nice rain the area received the week of October 17, outside activities have not been seriously limited.

The corn harvest is just a memory for farmers, and the harvest of other crops is well underway. We see trucks of sugar beets and carrots headed toward Hereford, or in the case of the beets, toward Bovina's Holly Sugar dump station.

Cotton was the crop most affected by the early freeze, as it could have surely used the additional time for maturity and extra yield.



# Commissioners Table Bids On New Grader

Parmer County Commissioners, in their regular meeting Monday, October 24, opened bids which had been sought for a new motorgrader for Precinct 4, but took no action on the bids pending further study.

The new CDs will mature November 22, 1983, and will allow the funds to earn income prior to the time they are to be disbursed.

A motion was passed appointing Paula Wilson as presiding judge for voting box 2-2 in Friona.


# Scrimmage **Dates Set**

## Tips Are Given On Cold-Related Injuries

The recent cold wave and the fact that November is here seems to herald the coming of winter.

Here are a few timely hints about cold-related injuries from paramedic Don Spring of Bovina.

A severe and dangerous coldrelated condition is frostbite. This condition is rare in the Panhandle and usually occurs in the elderly person who is outdoors, and for whatever reason is unable to make it back inside to warmth.

"As the tissue, usually in the extremities, freezes, the cells rupture and the blood vessels seal off so there is a double trauma situation present. The cells, deprived of oxygen from the blood, shortly begin to die and the area takes on a dark splotchy blue or black color," Spring said.

"Remember, anyone suffering frostbite is assumed to be hypothermic, suffering from low body temperature. It is vitally important to warm the whole body, so get the patient to a place of warmth immediately. Until emergency aid arrives, it is advisable to warm the affected area in water at 100°-105°. Remember!! Never, never, massage the area to restore circulation. The friction caused by rubbing the area only further ruptures weak cell walls and worsens the condition," Spring warns.

If an individual's body temperature drops below 96° F, you should seek medical help because that person may be suffering hypothermia. Do not attempt car transport of the patient. Hypothermia may become life threatening.





Actually, the loss threw second-place into a three-way tie between Bovina, Olton and Kress. Olton proved to be winners two days in a row by winning the coin toss on Saturday to represent the district.

But in reality, the loss on Friday night cost the Mustangs the playoffs, because with a win they could have clinched a spot in post-season play.

Olton took the lead on a 57-yard pass interception return by Gilbert Garcia, with Troy Don Allcorn kicking the PAT.

A little later in the first quarter, Bovina tied the game at 7-all when Jesse Gonzales ran 42 yards to paydirt. Jose Gomez kicked the point to tie the score.

That's the way the score remained until with six minutes left in the third quarter, Allcorn booted a 36-yard field goal, which turned out to be the margin in the game.

Bovina would have had one more touchdown, as Michael Shepherd intercepted an Olton pass and ran it back, but a clipping call against the Mustangs erased the score.

Coach Larry Helton said that Bovina really committed a clip during Bovina really cl the runback, so he didn't feel "cheated" by the call.

The coach gave plaudits for the play of Martin Contreras and Mark Clayton, who excelled at their line positions both on offense and defense. Jesse Gonzales, who scored Bovina's TD, also stood out both ways, and Danny Silva was credited with a good defensive game.

Bovina finished its season with a 4-6 record, and Helton pointed out that with just a little luck, the record could have been 8-2. Four of the team's losses, to Happy, Dexter, Cooper and Olton, were by a touchdown or less, and with just a little different bounce of the football, things could have been quite different.

"I learned a lot this year--like having to teach kids how to play new positions every week (due to injuries). One thing which should help us next

year is that we'll have a bunch of players back who got a lot of experience," Helton said. He indicated the yellow tags on the Mustangs' depth chart, which indicated that 12 sophomores were in the offensive and defensive lineups at





**FETTUCCINE SUPREME** 

1-8 oz. pkg. Philadelphia creamed cheese softened, 1/4 cup butter or margarine, softened, 2 T. parsley flakes, I teaspoon dried whole basil, 1/4 teaspoon pepper, 2/3 cup boiling water, 1-8 oz. Fettuccine, 1 garlic clove, minced, 1/4 cup margarine, melted, 1/3 cup parmesan or ormano cheese.

Beat cream cheese, 1/4 cup softened margarine or butter, low speed until blended, add parsley, basil, pepper and mix well. Add boiling water, beat until mix is smooth. Cook Fettuccine noodles according to package and drain well. Rinse noodles in warm water and set aside. Saute' garlic in 1/4 cup butter or margarine until tender, combine garlic mixture with noodles and toss gently. Add cream cheese mixture and 1/4 cup parmesan cheese, again toss gently. Place in serving dish, sprinkle with remaining parmesan cheese. Yields 6 to 8 servings.

# School Corner

Bovina High School has begun a new reading program this year. Called the "Learning 100 Reading Lab" it is a multi-media communication skills system designed underachieving, serve undereducated, and/or learningdisabled students on the secondary and adult levels.

The system provides instruction at reading levels ranging from first through seventh level. Learning 100 is organized into learning units called cycles of instruction. A cycle of instruction is a carefully planned sequence of learning activities which introduce vocabulary, concepts, and skills, and provides instruction, evaluation, reinforcement and extension.

Students are entered into the program at their own level of ability as established by various testing methods. Auto-instructional and audio-visual techniques such as the combo-eight reader, cassette tapes, DuKane reader and an Apple II computer program, increase both involvement and learning time for each student by permitting him/her to respond to every question and exercise, and by furnishing immediate reinforcement. Many of the materials and techniques are self-pacing so that each student can progress at a suitable rate. Selections include information in the areas of economics, arithmetic, social studies, and science as well as everyday living and reading enjoyment.

Personalized instruction is possible because the instructor has many opportunities to work with individuals or small groups during times when the majority of students are involved in independent learning.

One of the most unique aspects of the program is that the student achieves success in reading comprehension because he/she begins at a level of comp. This encourages even the most reluctant student to have more successes. Each subsequent achievement adds to the basic reading knowledge of a student. As students begin to realize they can read and understand, they are encouraged to put these new skills to use in everyday living. We make every attempt to turn non-readers and reluctant readers into functioning citizens who can be responsible for themselves in an adult society. Success in an endeavor is the key.

The program can also be expanded to meet the needs of advanced and college-bound readers.




