vised regulations is granted a total of 14 weeks in the calendar year during which employees need be of work a day or 56 hours in a workweek.


The revised regulations are intended to clarify the requirements for the seasonal exemption and include the standards which the Administrator has used in the past in making seasonal industry determinations, as authorized by Federal law. In addition, Mr. Rogers said, certain industries which handle or prepare agricultural commodities in their raw or natur-al state will be able to qualify for he exemption,

The revised regulations follow the Administrator's publicity an-nounced proposal of February 21 to make such revisions. Interested persons and organizations have had an opportunity to present their views since that time. Copies of the revised regulations, Part 526, may be obtained from Wage-Hour offices located in Dallys, Houston, New Orleans, Oklahoma City, Little Rock, and Albuquer-

June 30, 1953 is the final date that applications for new grower wheat allotments may be accepted. If there has been no wheat seeded on your farm in 1951-1952 or 1952 and you wish to grow wheat in 1954, come to the county PMA Office and make an application. If you have grown wheat on your farm in any of the above vears and the history has not been reported to the PMA office, you should make the report so that the farm may be set up as a modernly appointed, which will handle 30 or more guests, and in the main quarter of the beauti-ty PMA secretary.




