Christmas Gift Wrapping

Instead of waiting to wrap the far ly's Christmas gifts all at once, why not wrap as you shop? With only a few to do at a time, alone in the house you'll be able to do a better job and eliminate lastminute pressure. Even if you should decide later to switch around some of the gifts, all that's necessary is to change the outside gift tags.

Tips for movey-stretchers from the Gas Appliance Manufactures Association: Make cream go further by adding one part of undilu-ted evaporated milk to four parts of cream. And when you're beating egg whites for meringue, add two teaspoons of cold water to cach egg white, for a "bonus" of extra meringue.

Caring for Tra Burners

After washing the top burners of your gas range in hot soapsuds, rinse well, shake off excess water and wire the burner surface with paper towelling. If they're aluminum burners, use steel wool or the new foam rubber "scrubber" to remove stubborn stains. Then set burners upside down in a warm oven to dry thoroughly before replacing and lighting them, the Gas Appliance Manufactures Association suggests.
