POLITICAL TASK FORCE NEWS

The Political Task Force would like to thank all of the members for their participation in the N.O.W. meet the candidate night. All of the candidates except Jackie Sullivan participated in the panel. There were 80 to 90 persons in the audience which makes it the best attended candidate night of the year. The candidates seemed quite surprised that there were so many persons interested in women's issues.

The Political Task Force wants to urge all members of NOW to consider their qualifications and potential as a political candidate. There are a lot of women with a lot to give. Of course your first thought will be that you could not possibly do it. However, we have learned two major things from being involved in the 76 campaigns: 1) we really had no GOOD choices in any race and 2) we are as intelligent, as informed, as clever, 1) Write Sen. Bentson and Tower and as mature, as concerned as ANY person running for public office this year. There are many many members of NOW who are much more qualified for political office than most of those persons we had to vote for. So, PLEASE consider YOUR qualifications!!

A PANHANDLE PHYLLIS SCHAFELEY

Daisy Moore, a Bible-toting grandmother against women's lib carried 9 out of 10 counties in a step toward becoming the first womean legislator from her Panhandle District. Daisy is against the E.R.A. and was quoted in the Avalanche Journal as saying "I think there are a handful of women-libbers who are trying to give all women a bad name -- and someone has to take a role to stop them before they go too far". She will face the incumbent in the November election. If you know anyone in her district, please warn them in case they are not aware of the need to keep Daisy OUT of the Legislature!!!

STOP S.1

S.1 is the proposed Federal criminal statute. It dates back to 1966 when President Johnson appointed the National Commission on Reform of Criminal Laws. The Commission's majority report was a liberal-conservative compromise, However in 1971, the Nixon Administration felt that the commission's report was not sufficiently styled to its "law and order" taste. According to the Texas Civil Liberties Union, parts of the new bill would improve the law but some of the provisions of the new bill are so detrimental to civil liberties that so long as they remain it would be better to do without the new bill. There have been recent amendments to the bill. However, John Duncan, Executive Director of the T.C.L.U. characterized S.1 as "unamendable". WHAT TO DO??

ask for a copy of S.1 indicating that you have heard of its repressive nature. 2) Write your Senators and Representatvies a letter about the sections that you feel most strongly should be eliminated or changed and askthat they work to amend or vote against the bill. 3) Inform all your friends of the dangers of S.1.

Before we become involved in any case it must be determined that the most good for the most women can be accom plished by directing our energies to that case. Therefore, there will be times when we just simply will not be able to aid an individual. This should be kept in mind if someone approaches you with a problem. Please explain this policy so no one feels that we have ignored their request for assistance.

1920-1976 = 200 YEARS?

"We hold these truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain inalienable Rights, that among these are Life, Liberty and the Pursuit of Mappiness."

I cannot, on July 4, 1976, celebrate 200 years of freedom and independence. For the undeniable truth is that when Thomas Jefferson wrote his historic words, he did indeed mean that all men are cre-

ated equal.

We've all read Abigale Adams' letter to her husband, John, asking that he "Remember the Ladies" in writing the suffrage laws of the new country. But how many of us know his not-so-famous reply, "As to your extraordinary Code of Laws, I cannot but laugh." He offers her no rational reason, but says merely, "Depend upon it, we know better than to repeal our Masculine system." In the face of such evidence, I cannot accept the excuse that the Declaration of Independence means men "in the generic sense." We women were excluded from the noble aspirations of the Continental Congress, as were Indians, black men, and nonproperty owning white men.

PHILOSOPHERS AND WOMEN

On the subject of good and evil in the world, Pythagoras wrote: "There is a good principle which has created order, light and man; and a bad principle which has created chaos, darkness and woman."
This was a thinker, an enlightened man who played a major role in the evolution of ideas on our planet! Plato thanked the gods that he was free (neither slave nor woman), and Aristotle suggested we regard the female as afflicted with a kind of natural defectiveness. These notions, put forth by philosophers over 2000 years ago, seem to have been used as a rationale for dismissing women as fit subjects for the study of the nature of humankind. We must, therefore, not only continue the fight for equality in our society, but we must also give strong encouragement and support to those of our sisters who would add to and enrich the world of ideas.
