THE PARMER COUNTY Junior Livestock Show has once again been concluded, and again in 1984 the show was a big success.

It is quite a chore to produce a show of this nature, which being a countywide venture, requires the work and cooperation of a number of people from the various corners of the county.

But it always comes about, and most times appears to be a well-run, well-organized event.

The steer judge for the 1984 event, Dino Cornay, made the comment that the county showbarn was the nicest facility he had seen for a show on the county level.

Those of us who have watched the county show grow from being staged first from a patio encircled by barracks, then later to a school bus barn, have come to appreciate the showbarn, and the efforts that went into building the facility.

Even though the weather for the 1984 show was nice and warm for the most part, we still had one extremely windy day, and one participant at the show was heard to remark that day "Aren't you glad we still aren't over at the bus barn?!"

Several times in recent years, the showbarn has been the salvation of the show, when large snowstorms have hit on the week of the show. Prior to the showbarn, the show would no doubt have been postponed at least a week in these cases. And when you have your animals at a certain stage, this can sometimes completely ruin your project's chances in the show.

Many folks in recent years have also cheered the leaders who worked and saw to it that the community center-showbarn was built when it was. With today's high costs for construction, along with the depressed farm market, raising money for such a facility today would almost be an impossibility.

Yet, today's leaders are able to come up with a brainstorm. It has been determined that some sort of ventilation, or aeration, is needed in the showbarn, to take care of the animal waste smells.

Show superintendent Terry Copley secured donation of the Grand Champion Goat from Greg Salyer, which was auctioned off during the premium sale. Due to re-selling the animal several times, the auction succeeded in raising around \$1181.25, which should come close to providing the equipment that is needed.

And the final bidder, A.L. Black, donated the animal back to its original owner.

We salute these officials, and supporters of our shows, both on the local and county level.

And most of all, a big cheer for the youngsters who are raising their project animals. Many of them have found in recent years that it is a tough task to show a profit on their projects. This encourages better thrift in buying animals, although the exhibitors and their parents are limited as to how they can cut the corners on rising costs.

Livestock show officials are discussing a plan which would enable a higher percentage of the animals at the county show to make the premium sale.

As it now stands, those exhibitors whose animals don't make the premium sale are virtually assured that they will have a tough time having a profitable project.

A tip of the hat is in order for Bovina High School's ag mechanics class, who helped solve the seating problem at the county show. The class, made up of juniors and seniors, constructed two units of steel bleachers which they took to the showbarn.

The new stands were very attractive as well as practical, and we extend our thanks to the group. Also joining in was a non-class member, Toby Dutton, who helped paint the bleacher seats.

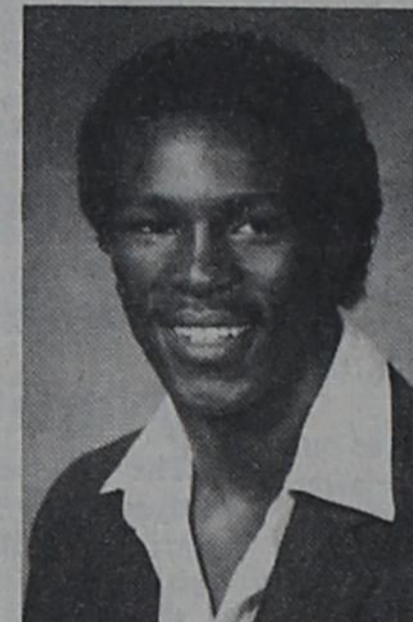

Bovina's FFA and 4-H Club youngsters won their share of honors at the Parmer County Jr. Livestock Show held last weekend in Friona.

Terry Moore made it two years in a row by capturing the Grand Champion Lamb banner. In fact, Bovina might be considered to have a "hammer-lock" on the county lamb show, since exhibitors have won six of the last seven grand champion awards given in the show, including four in a row.

Moore won the banner with his Suffolk entry. He also had the breed champion Hampshire, and his sister Tracy entered the reserve champion Hampshire lamb. Mark Clayton had the champion fine wool lamb.

The barrow show was fairly dominated by Friona and Lazbuddie entries, but Toby Dutton came up with the reserve breed champion with his heavyweight Yorkshire barrow, and Mike Morris had a class winner in the mediumweight Hampshire division.

# Mustangs Are Upset By Hart Longhorns

The Bovina Mustangs saw their fortunes rise, then fall during action the week ending Friday, February 3.

The Mustangs outraced Springlake-Earth on Tuesday, 63-48. That same night, Farwell handed Kress its second district loss, to give Bovina undisputed first place in district.

But on Friday, the Mustangs were upset by the Hart Longhorns, 55-52. The loss dropped Bovina back into a tie with Kress and Farwell in district standings.

Richard Shepherd has been nursing an injured ankle, and his absence from the lineup has been sorely felt.

In their game with Springlake-Earth, Bovina pulled away from a 16-14 first quarter and 29-23 halftime lead for a 15-point win, 63-48.

It is a wonder that fouls didn't cost the team, as five (that's right) players on the Mustang team fouled out of the contest. Shepherd, who wasn't intended to play, was forced to see some action as the "bench" finished the game, whether they wanted to or not.

Four players, led by Michael Shepherd's 15 points, were in double figures for the Mustangs.

Springlake-Earth missed 21 free throws, more than enough to reverse the game's outcome. The Wolverines hit 16 of 37 attempts. Bovina hit 19 of 31, with Michael Shepherd hitting nine of eleven.

Friday's game at Hart started out innocently enough. In fact, after three quarters, it looked very much like the Mustangs were going to capture their sixth district win against a single loss.

But a last-ditch rally by the Longhorns brought them from behind. Bovina had held quarter

leads of 18-4, 26-18 and 40-30 in the game.

Hart outscored the Ponies, 25-12 in the final quarter. Fouls again hurt the Mustangs, as Hart hit some critical free throws down the stretch for the win.

Bovina's district mark slipped to 5-2, and 21-4 for the year.

Michael Shepherd and Blake Scaff each scored 14 points to pace Bovina's scoring.

## Junior Varsity Mustangs Drop Overtime Game

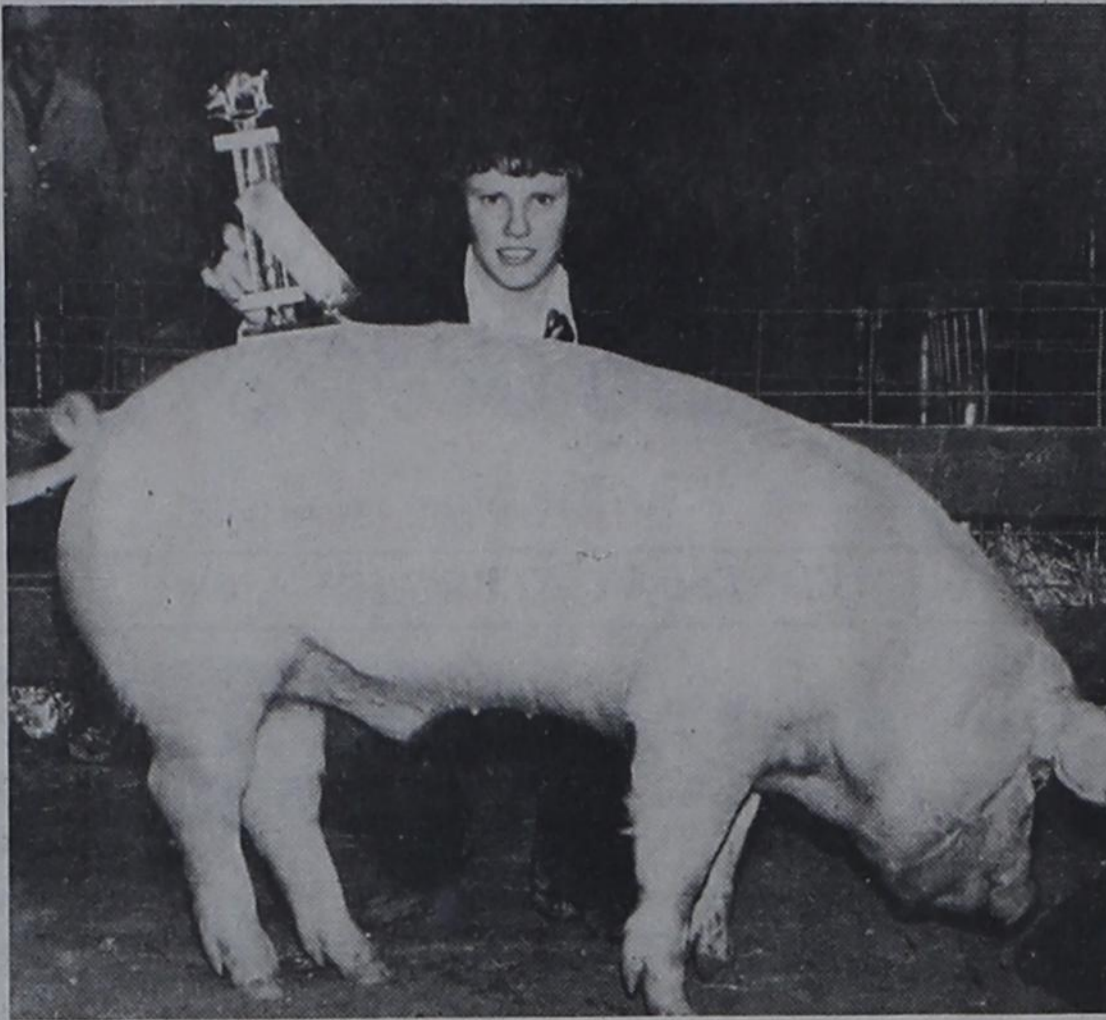
The Mustang junior varsity dropped a 40-38 overtime battle at Hart last Friday in a hard-fought battle.

Hart held the lead after the first quarter, 13-7, but Bovina rallied for a 20-17 halftime lead.

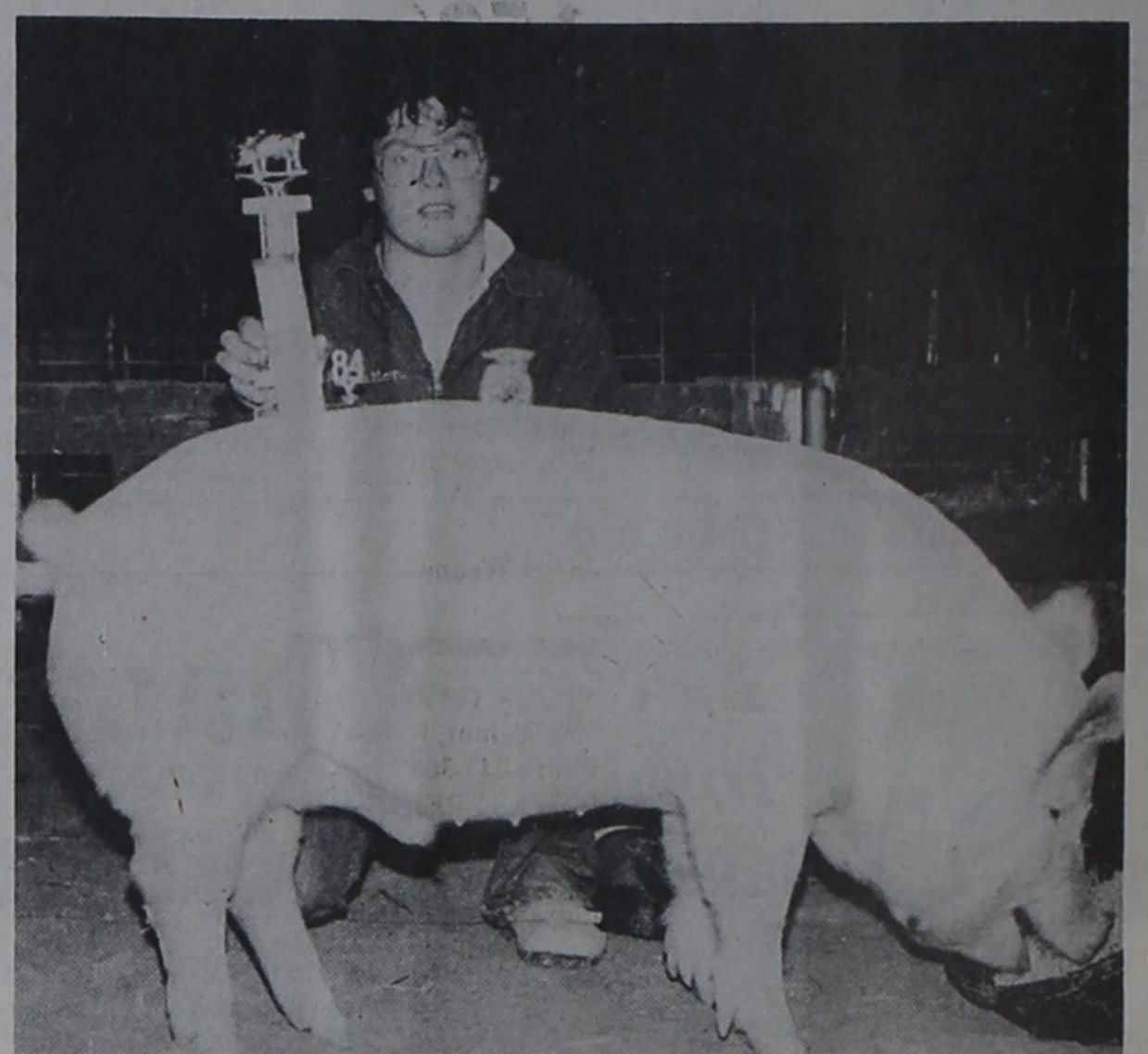

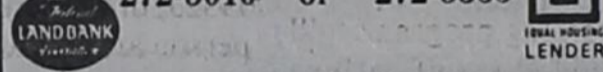

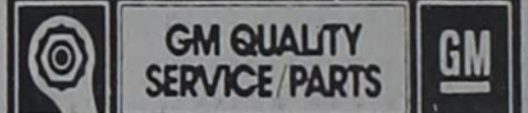

## Around The House

By LAURA JACOBS

Heating your home may take as much as two-thirds of all the energy used there. Here are some everyday things you can do to save energy and maintain comfort.

Set your thermostat conservatively--begin by setting the thermostat as low as you can, 68 degrees to 70 degrees. Turn it even lower for night time or while you are away for extended periods. During extremely cold weather, do not turn the thermostat so low that the heating system must labor to reach the 68-70 degrees daytime temperature when you reset it.

Avoid the temptation to turn the thermostat higher if you feel chilly. Instead, put on additional layers of

clothing for warmth.

Ventilate correctly--use exhaust fans in kitchen and bathroom sparingly during cold weather. They remove the warm air from the house, thus wasting energy.

Window treatments--you will be more comfortable in cold weather if you keep your windows covered. Windows are a major source of heat loss in most houses.

In winter, shutters, shades, or draperies can be used effectively to reduce heat loss on the cold side of the house. On the sunny side, windows should be uncovered when the sun shines to let in the most solar heat. Be sure your windows are clean to allow the maximum radiant heat to enter.

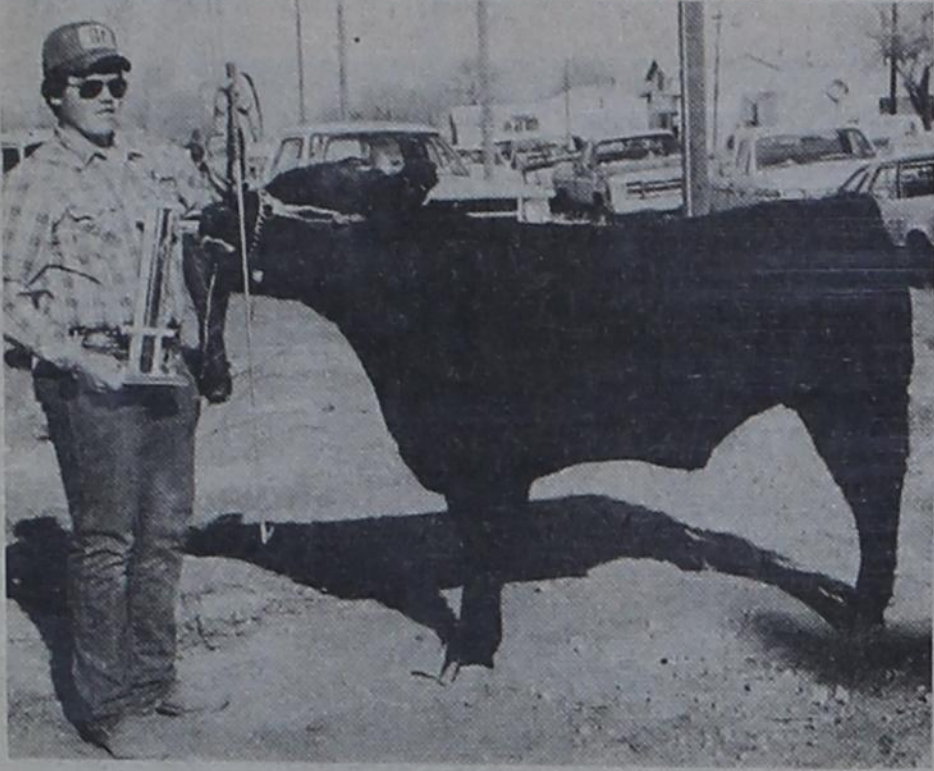

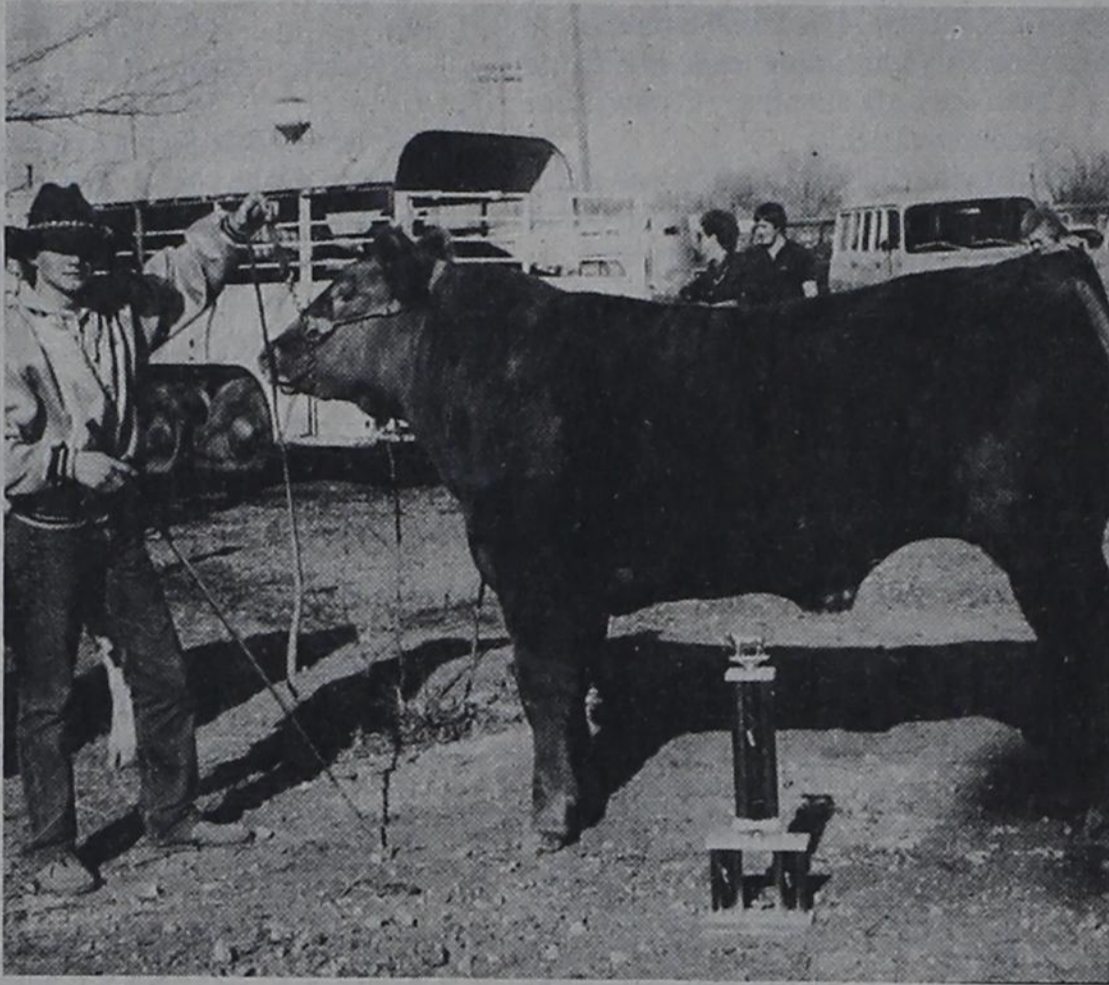

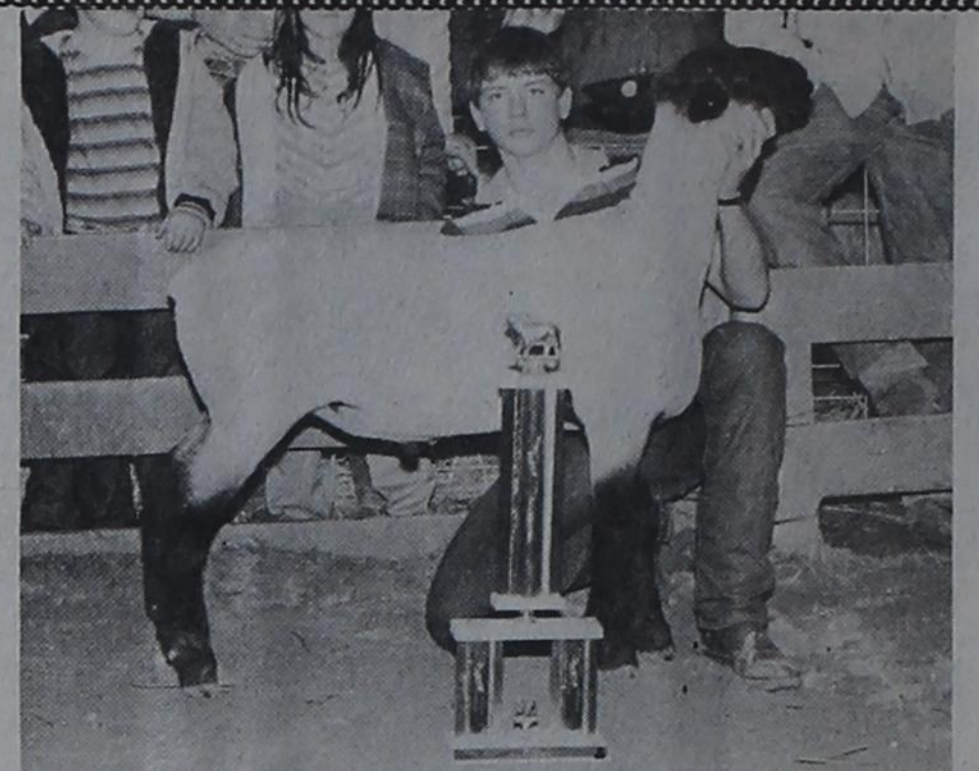

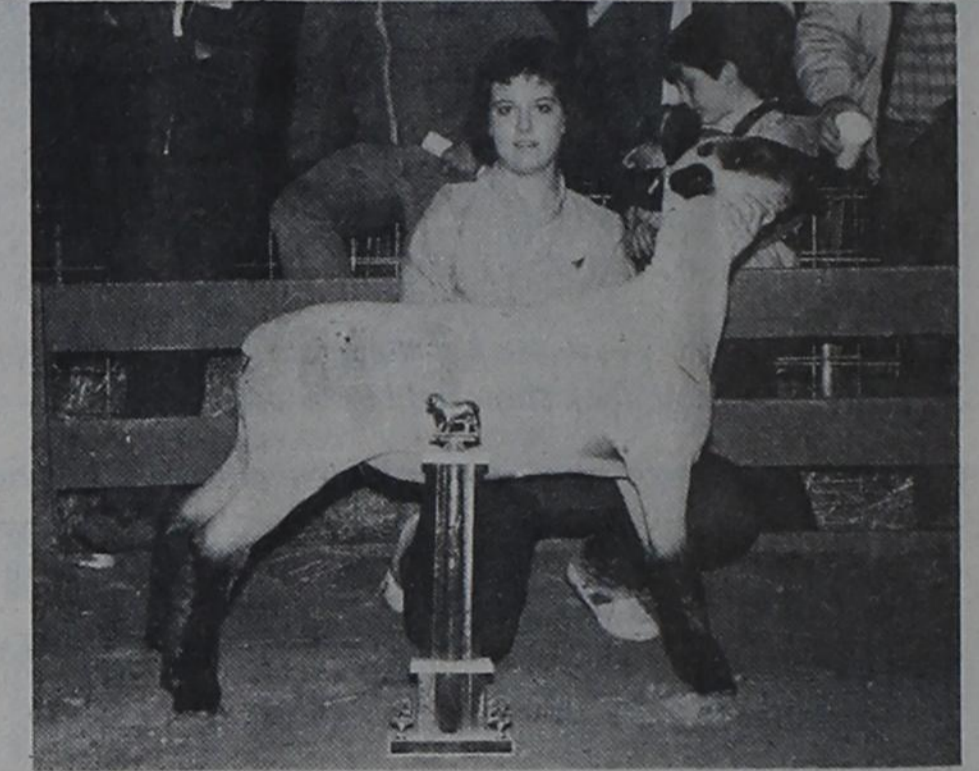
