MISD will dedicate school Sunday

Formal dedication cermonies are scheduled Sunday to dedicate \$1.4 million in school construction on MISD facilities here.

The formal dedication will take place at 3 p.m. Sunday and tours of the facilities will be conducted by Merkel High Student Council members until 5 p.m.

MISD voters approved the \$1.4 million project by a 2-1 margin in a called bond election in September of 1978. The money built a new vocational agriculture shop, a multi purpose center at Merkel Elementary, a junior high gym and a new high school building. The money also payed for installing central air and heat in

Merkel Elementay and Merkel Middle School. Monies earned from interest while part of the bond funds were invested are also being used for addition maintenance and repairs on MISD facilities.

Haney and Sivley Construction were the major contractors on the project and their crews will have a few touch items to complete before they will receive their final ten per cent payment.

School construction was halted for about one month because of a union strike of local painters and Haney and Sivley managed to complete the construction within 20 days of the set construction deadline, after extra days were allowed for inclimate weather and the strike.

MISD Superintendent Bill Everett said, "We want all of the local citizens to attend the ceremonies Sunday and it was scheduled to start late so people wouldn't miss the Cowboy game.'

Badgers bump

James Turner's 12 yard run in the final period lifted the Badgers to a 14-8 win over Hawley in Hawley Friday night as the Badgers won their second game of the year.

Turner capped a 6 play, 54 yard drive with 4 minutes left in the game that broke on 8-8

The Badgers wasted no time in scoring as Sal Acosta's interception and 15 yard return put the Badgers in business on Hawley's 28 yard line. Sophomore quarterback Sammy Tumlinson hit Dusty Barnhill for the first score on an 11 yard scoring strike to put the Badgers out front 6-0.

Tumlinson then hit Willie Marsh with a short pass for the two point conversion and the Badgers led 8-0.

Hawley came back with about three minutes left in the first half and tied the score as quarterback Calvin Cooley hit receiver Jim Bob Barbee with a 40 yard touchdown pass.

The Badgers warpped it up late in the game with the 6 play drive that ended with Turner's 12 yard run. Bart Pursley picked up 21 yards on that drive on a run on a 3rd down and 8 to go situation.

The Badgers have plenty of time to prepare for the last game of the year, scheduled for Nov. 14 here against Albany

A Badger win would guarantee the Badgers a tie for fourth place and the Badgers could be as

high as third. That prospect prompted Badger Head Coach Byron Shelley to say, "A third or fourth place finish would be a lot better than they picked us to finish this year."

Shelley expressed concern over the coming game against Albany and said he thought they were the most under-rated team in the district because of their speed. Shelley said one of their receivers runs a 9.8 100 yard dash and said they have three very fast runners in the backfield. .

The Badgers should go into the game fairly healthy. Receiver Randy Martin is still not 100 per cent due to an ankle injury, lineman Ricky Mathewson injured his knee against Hawley, but should be ready to go by the 14th and freshman Michael McCoy was lost for the year two weeks ago against Rotan when he suffered a broken ankle. He has been released from Hendrick Medical Center following successful surgery on the ankle.

In other action last week, the 7th grade lost 12-6, the 8th grade won 14-6 and the Junior Varsity, led by Jimmy Mendez's two touchdowns, blasted Hawley 31-12. Gary Tutt got a touchdown in the win and Coach Shelley said quarterback Keith Beddingfield had his best game of the year. The Junior Varsity record now stands at 2-4-2.

Attorney answers state suit

Merkel City Attorney Allen Glenn filed in 104th District Court Friday the city's response to a lawsuit filed by the state last month and alleging four violations of the state's health regulations concerning the landfill operations.

Glenn filed the response and did not request a dismissal of the suit. Glenn did request, "The defendent (Merkel) denies each and every, all

and singular, the material allegations in said plantiff's (The State) petition and demands strict proof thereof."

District Clerk Irene Crawford told the Mail Tuesday, "the next move is the State can request a hearing and Judge Neal Daniel will grant that request when his calendar is clear.'

The State can now either request the hearing, or drop the suit.


