'Jury' trial teaches Nolan County man lesson about equity courts

and Constitutionally well informed, has paid an \$88 fine in Justice of the Peace Precinct 1&2 court following a jury trial, in which he was found guilty of violating Transportation Code 545.413.

If you are not familiar with this portion of Texas legalese, you might know it better as the "seat belt law."

It seems Tinnin discovered the difference between common law and equity courts, and it "was a valuable lesson," he says, "even though it cost me \$88

plus time and travel." It all started on December 13 when Tinnin was driving north of Post on U.S. Hwy 84, on his way to visit customers in Lubbock. Between Post and Southland, Tinnin stopped in response to the flashing red lights on top of Texas DPS trooper Chris Wischkaemper's patrol car. Wischkaemper ticketed Tinnin for not wearing a seat belt. According to Tinnin, the highway patrolman was traveling southbound (in the opposite lane) and spotted Tinnin going northbound. "I'll say one thing," Tinnin comments, "you have to respect his keen eye to have been able to spot me across the median

After going through the routine of computer checks to see if there were any outstanding warrants, Wischkaemper issued the citation and Tinnin was on his way to complete his sales calls.

Measured options, pled not guilty On December 15 Tinnin stopped in Post to visit Justice of the Peace Sheila Melton about the incident.

"When I first met with Judge Melton," he says, "we discussed my various options that I could do on the ticket. That was when I decided to challenge the citation and the fine Judge Melton wanted me to pay. I asked for a jury trial. She said that the trial might be in early January, due to the impending

retirement of the county attorney, but she would let me know.
"Then I stopped by The Post Dispatch, delivering a letter to the editor. I guess that may have been the reason that the trial was moved up to December 27... Judge Melton had called me on December 18 to tell me about the trial date. I called back to ask for a continuance, and her secretary said she didn't think that would be a problem. I needed a continuance because we were leaving on a family Christmas trip December 19 and would not return until December 25... giving me only one day to prepare for the trial. On Tuesday, December 19 Judge Melton called to inform me that she would not grant a continuance.

'I got a note later, dated December 21, which said that the fine would be \$62 including court costs, but that the county attorney would recommend to the jury a maximum fine plus court costs if the jury found me guilty. She said she had mailed jury cards notifying potential jurors of the December 27, 2

"On the day of the trial I showed up for court, got there a little early, and wasn't sure what I was supposed to do. The jury was there, they were brought in for selecting the jury panel. There were, I think, 21 people who were in the jury pool. I was seated at the front table and was introduced to county attorney Preston Poole. We began to discuss the procedures and he explained some of the protocol to me. He was friendly and cordial.

"I told him what I wanted to do and what my plan of action was, to give the jury a copy of an article from The Post Dispatch about trial by jury. I wanted the jury to know that they could judge my actions as well judge the law. I also had some statistics that I had gleaned from the 1995 World Almanac, with rates of death for various causes. I was going to compare and extend the seat belt law to the extreme, like comparing it to the situation with health hazards. I gave the example of the high rate of death due to heart attacks, brought on by excessive consumption of cholesterol.

Not allowed to inform jury anything to do with the case. he said he would ask the jury during the selection process whether or not they agreed or disagreed with the seat belt law, and if they disagreed, he would strike them from the jury panel.

"That's when I told Mr Poole that if only the people who agree with the law are chosen to serve on the panel, then it nothing more than a kangaroo court. Well, he got really upset, turned red in the face, and told me that he would have me held in contempt of court. So I apologized and emphasized that I did not mean to offend him or the court, I was just trying to voice my opinion that

Roger Tinnin of Nolan County, a man whom I believe is strong on principles if you don't get any dissenting opinions from the juror about the law, then basically the jury is stacked against the defendant.

"The trial began and Mr Poole addressed the jurors, telling them who he was and that he had been county attorney for 30 years and this would be his last case. His presentation lasted about 15 minutes. He told them about some of the rules they would have to go by and them to answer yes or no as to whether or not they agreed or disagreed with the seat belt law. There were about three people in the first 12 that answered yes and they were scratched.

"Then I was allowed to speak and I told them that I was restricted from giving them a copy of the article, but that didn't mean that I couldn't read it... so I began reading the article which was written by Lysander Spooner in 1852. Before I got past the first paragraph, Mr Poole jumped up and interrupted me, telling the jury that he had talked to the publisher about that, and there was a difference of opinion. Poole said it would be the same as putting drunks on a DWI case. I was told that I could not continue with that reading.

Decided not to testify "My part of the jury selection went rather quickly after that and we went

directly to trial. I had been told before the trial began that if I wanted to testify, I would have to ask myself questions and then answer them, and then



Council hears committee report on sales tax increase plan

Members of the Mayor's quality of life committee met with the Post City Council Tuesday evening, presenting the committee's report for consideration by the council. No action was taken the at "work session," which was called for the sole purpose of hearing the committee's report.

Mayor Jim Jackson introduced committee chairman Lewis Earl, who briefed the council on the purpose of the committee and how the one-half cent sales tax funds could be spent for economic development. He then introduced subcommittee chairmen Pat Walker, Marita Jackson, Jim Plummer and JoAnn Mock.

Walker gave a brief history of previous attempts at economic development in Post, beginning with a 1960s effort called the Post Industrial Foundation, which collected more than \$180,000 in private funds, resulting with no additional industry. Walker said that experience led to a review of the city's assets by an expert from the state, who surveyed Post and criticized the city's (Continued on Page 3)



I would also have to answer the prosecuting attorney on cross-examination. I had not prepared to ask myself questions, and did not know how to go about

doing that, so I decided to not take the stand on my own behalf. I later discovered that my decision not to testify was a factor in the jury's decision to find me guilty.

"After the jury was impaneled, Texas DPS trooper Chris Wischkaemper was called to the stand by the prosecuting attorney. The trooper answered yes to all the questions put to him by Mr Poole, essentially going through the complaint form step by step... was the defendant driving a passenger vehicle, was he wearing a seat belt, is the defendant over 15 years old, was the violation on a Texas roadway... etc. The witness verified that I was driving northbound and the officer was driving southbond officer was driving southbond.

"When it came my turn to cross-examine the trooper, I presented the questions I had prepared, including establishing his name and personal information. I asked him if he knew how the seat belt law came to be, and he said the legislature voted it in. I asked him if he voted for it and he said no, and no to the question did he know anyone who voted for it or were even contacted by any legislator about it. He agreed with me when I asked if he understood that the rule was forced on the people by the federal government threatening to withhold

"I then asked the trooper if he knew why we had this seat belt law. He said the law was to save lives and that it saves money. I then pointed out to him that the number one killer in America is cardiovascular disease, or heart attacks. I also asked if he was aware that there are 22 times as many people die from heart attacks as do those in vehicle accidents... he said he could believe that.

"Just then Mr Poole objected, saying that I was asking the officer medical questions, for which he had no expertise. I told the judge that I was not asking medical questions, but seeking the opinion of the witness about statistics. She said it didn't matter, that I could not continue with that line of questioning. "I then asked a series of questions relating the day of the accident: (1) Did you notice anything suspicious about my truck? He said no. Was I speeding? He answered no. Was I driving dangerously? He repeated, no. Were there any warrants out for my arrest? He again said no. Then I asked him he had seen his mom and dad on a drive down from Lubbock to Post and they weren't wearing their seat belts, would he have written them a ticket? He said he couldn't answer that question.

"My last question to the trooper meant to settle the issue of intrusion into people's private lives... I asked him, would you be willing to accept a government agency or a person who works for the government to come into your house and write you a citation if you weren't eating the right kinds of food or eating foods that might cause you some day to have a heart attack? He never answered the question, Mr Poole objected and the judge upheld the objection.

"Mr Poole told the jury that he had proved all the points in the complaint and then I was allowed my summation. I reminded the jury that more people are killed by heart attacks every year than are by motor vehicle accidents. But before I could get out the point that we don't allow the government to order us to eat the right foods, Poole interrupted me again. He informed the jury that it was not their ability to judge the law, that they were not on the jury to judge the law. Then he used the drunk on a DWI case again. After his five minute interruption, I completed my summation.

"I reminded the jury that I was not speeding, I wasn't endangering anyone else's life, there was no one on the highway who was endangered by my driving. I broke no law that day, and that was the end of my statement.

"The jury returned in about 15 minutes, asking the judge what was the maximum fine and then came back and announced their finding that I was guilty. The judge fined me \$88.

"After it was over, Mr Poole told me he hoped that I had learned a lesson from this... he was nice, but I don't think he understood the impact of this lesson. I learned something, that's for sure, and what I learned is not to expect Constitutional guarantees of a fair and impartial trial in a court of equity."

Deputy was unhappy with letter An interesting side note to this trial was Tennin's recollection of comments made by the deputy escorting the jury in and out of the courtroom. "He told me that he did not appreciate the letter to the editor I wrote, and was angry at the publisher for printing it. Later, while the jury was deliberating, he made a little oke with the judge about how the 20 people who died over the Christmas holidays would have wished that the trooper had stopped them and gave them

"I paid my fine, but I still don't feel it is right for the law to pull people over and issue tickets for not wearing seat belts. It's also not right to issue tickets for not wearing helmets or for not having life jackets in boats. I know they are trying to save lives, but to fine people for not doing those things is basically an attack on our Constitutional rights to privacy and it's none of the government's business if people choose not to follow these silly rules."





What we don't know about the budget battle

by Stephen Chapman

With \$1.6 trillion at stake, the federal budget is perfectly designed to foment bitter disagreement among the American people. That explains the ongoing standoff between President Clinton and congressional Republicans, who have deep policy differences that may never be resolved.

Despite all the quarreling, there are some basic propositions on which most people seem to agree. Unfortunately, they are all badly mistaken. Impeding our understanding of the budget battle are three popular myths:

The plans to balance the budget will finally restore fiscal discipline. Actually, experts say that if the budget is balanced in 2002, it will quickly go into deficit once again. "We talk a great deal about balancing the budget by 2002, but nary a word about how to keep it in balance," says economist Michael Boskin, who chaired the Council of Economic Advisers under President Bush. "We'll need a huge tax increase to pay for Medicare after 2002.'

The problem is that entitlement spending, the real source of our current budget gap, will continue to grow faster than our ability to pay for it. Susan Tanaka, vice president of the Committee for a Responsible Federal Budget in Washington, says that such expenditures on the elderly, currently 35 percent of the budget, would rise to at least 40 percent under the Clinton plan and 42 percent under the Republican plan. The Medicare cuts they envision

are too small to head off the next budget crunch. None of the blueprints deals with an entitlement system that is out of control. A presidential commission reported in 1994 that at the rate we are going, entitlements and interest payments will consume every nickel of federal revenue - leaving nothing for defense, national parks, highways, Head Start or anything else. The competing budget plans put off all the hardest decisions until the next century.

The fight is no longer about whether to balance the budget; it's about how. Since 1982, presidents and Congresses have reached five different agreements to balance the budget. None has achieved that goal, and no deal struck now will achieve it either.

The perennial pitfall lies in the spending and revenue estimates used to map out future budgets, which often turn out to be far rosier

than reality. This time, relying on projections made by the Congressional Budget Office, both sides assume we won't have a recession anytime in the next six years — even though we are nearly five years into the current economic expansion. Since the end of recognize that violence against people or property are clear violations World War II, no expansion has lasted as long as nine years; the average is three.

The Rockies may not crumble and Gibraltar may not tumble, but sometime between now and 2002, the economy will stall. When it does, spending will rise, revenues will fall, the chance to balance the budget will vanish over the horizon — and the politicians will say it

The Republicans are mounting a major attack on spending. Liberals think this is catastrophic and conservatives think it is wonderful, but both are misinformed. Last spring, House Budget Committee deriving their just Powers from the Consent of the Governed chairman John Kasich of Ohio unveiled an ambitious proposal to Notice the inclusiveness of this statement... "that among these reduce federal expenditures. It called for eliminating more than 300 are..." In other words, "Life, Liberty and the Pursuit of programs and three Cabinet departments -- Energy, Education and Happiness" are not the only absolute rights... they are merely Commerce. Those departments survived. Most of Kasich's plan among the rights to be guaranteed by the Constitution.

Kasich wanted to abolish programs. He realized that cutting them is like mowing dandelions: They just grow back. The only way to reduce federal spending for good is to pull them out by the roots.

But most of his GOP colleagues, particularly in the Senate, were not so bold. They decided it's politically easier to trim a program than to kill it. Under Congress' plan, only a handful of programs would get the guillotine they deserve. One GOP target after another endures: the National Endowment for the Arts, the Corporation for Public Broadcasting, Amtrak, the Legal Services Corp., the Small Business Administration and more. (Forget the Defense Department, where Republicans never even tried to cut spending.)

This is the Republican Revolution? So far, it looks like nothing more than a bargain-basement Great Society.

All three myths contribute to a still greater misperception — that our leaders have finally discarded the habits that produced 25 years of growing expenditures and chronic red ink. Those habits are alive

White people are divine...

You've really got to hand it to white people, particularly white men. Ask any race expert why blacks, as a group, earn less income than white people. Five will get you 10, the answer will be racism. Given black history and the everlasting "legacy of slavery," racism is a plausible answer. But racism doesn't affect all blacks the same way. The

fact that white people exempt some blacks from the burdens of racism and do it in ingenious ways, leads me to the conclusion that they have divine powers. "Williams," you say, "we proudly accept your divinity conclusion, but how do you reach it?' According to one study, as far back as 1969, black males who grew

up in homes where there were magazines, books and library cards had incomes identical to whites from similar homes and education. The obvious conclusion is whites discriminate against blacks from homes without magazines, books and library cards. How they do it is a mystery to me. I haven't seen any white people at least not that many - peeking into the windows of black houses to see who had books, magazines and library cards.

Another study points out that in the 1970s, black husband-andwife families outside the South earned as much as white husbandand-wife families outside the South. Then by 1981, black husbandand-wife families, in which both had a college degree, earned slightly more than identical white husband and-wife families, and that was true nationwide. I can understand how God might know that a black man is married to white man with a college degree, but it's mindboggling how white employers would have the same information.

Racism is a two-way street, and blacks are also guilty. You ask: What's the evidence? Race experts teach us that wherever there's disparity there's racism. Look at the announcement and photos of the starting lineup of any professional football or basketball game. It's so much of a tragedy that, cherishing equality of opportunity, I become ecstatic when a photo of a white player comes up on the screen. What else, other than racism, can explain how blacks, who are 13 percent of the population, are 66 percent of professional football players and 80 percent of basketball players? Some people might try genetic explanations like white men can't jump or black guys run like monkeys. I don't buy it; it's racism.

You never see Chinese or Japanese football and basketball players,

at least not in the starting lineups. Again, a disparity, and again, racism. Initially, one might think of it as an injustice, but it just as soon could be payback Everybody knows that blacks have a higher infant mortality rate than whites, and it is caused by racism. It turns out that whites have a higher infant mortality rate than Chinese, Japanese or Filipinos. This can only be chalked up to some mysterious Far Eastern form of racism, particularly when coupled with the fact that Asians receive less prenatal care than whites. Another disparity is seen in the fact that the proportion of Asian American students who score over 700 on the math portion of the Scholastic Aptitude Test (SAT) is double the number of whites.

There are many racially rooted disparities resulting from one form or another of group wonderfulness, but the most bothersome one to me is a sex disparity. Men are 50 percent of the population, and so are women, but men are struck by lightning six times as often as women. I want to know what whoever is in charge of lightning strikes has

If we have no absolute rights... then we are doomed as a constitutional republic

It saddens me to read Senator Hutchison's pathetic rebuttle to my December 28 editorial, in which I pointed out that she fails to comprehend, or perhaps does comprehend and chooses to ignore, the importance of those unalienable rights specified by the Declaration of Independence and guaranteed by the Constitution for the United

In response to Senator Hutchison's recent letter, let me point out that she seems to misunderstand the thrust of my original editorial. It was not designed to stifle her freedom of speech concerning the proposed constitutional amendment to restrict that free speech when it comes to "desecrating the flag." The intent of my earlier comments was to point out that Senator Hutchison, by her own words, believes that "none of our rights, including our First Amendment rights, are absolute."

I must emphasize that her comment about how I so "violently" disagreed with her is not supported with fact. Anyone who knows me and knows how I behave, knows that I may be lots of things, but violent is not one of them.

Was I guilty of violence? I re-read that editorial, and I could find no distinguishing words that met the definition of "violent." I trust the Senator is not

implying that my words are examples of "criminal conspiracy." Also, Senator Hutchison's use of the bombing in Oklahoma City as some sort of example of First Amendment right is not only foolish, it is downright irresponsible. It takes no Constitutional genius to the issue, and shame on her for dragging that destructive event into

But, let's get back to the real issue that she attempts to avoid.

I quote from the Declaration of Independence: "We hold these Truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty and the Pursuit of Happiness. That to secure these Rights, Governments are instituted among Men,

What are our absolute rights? So, then, what are these absolute rights, the ones Senator Hutchison brushes aside with such ease by saying the government may place

"limitations on constitutional rights." Among them are Life ... living, the act of living, the day-to-day sustenance of one's life, the ability to live, work, play and be who one wants to be ... without interference from any government, as long as one does not violate the rights of another.

Among them are **Liberty**... do we need a definition of this? To be liberated, to be free to do as one chooses, to go and come and not to do as one chooses... to speak, and act and live without the interference of government or the use of force by anyone else. No restrictions may be placed on one's individual liberty... as long as one does not violate the rights of another.

Among them are **Pursuit of Happiness**... and for each person happiness has its own definition... for you it might mean the pursuit of a career, for me it might mean the pursuit of a hobby... for someone else it might mean the pursuit of religion... freedom to pursue one's own interests, without the interference of any government or force by anyone else... as long as one does not violate the rights of another. Surely Senator Hutchison does not believe that any of these rights should or could be restricted? If so, then I continue to urge her resignation from office, for if she still believes that "none of our rights, including our First Amendment ones, are absolute," then she cannot possibly uphold the oath of office which she took to serve us as our senator.

For if she believes, as she has said in her letter, "that the right to bear arms shall not be infringed, but that doesn't mean we can carry a loaded pistol onto a commercial airplane," then she obviously is willing to violate her oath of office.

Is it right to keep and bear arms?

The act of carrying a weapon anywhere, even in church, is not a violation of anyone's Constitutional rights... the act of using that weapon against another except in self defense, that is a violation of Constituenal rights.

Senator Hutchison is caught up in that socialistic and fascist world of "prevention" of evil through government controlled edicts... none of which ever actually produce prevention, but do in fact create the

Examples of crazy people walking into crowded churches and other places, shooting and then killing themselves, is frequently in the news. Yet those people caught in the crossfire, who believed that no one would ever burst through the doors of a church, shooting innocent people, are either dead or survived to wonder why the law did not protect them from this violence.

False sense of security Law does not protect anyone... nor does it prevent violations of Constitutional rights... it only gives "law-abiding" people a false sense of security. Meanwhile, had at least one of the members of the church congregation, or passenger in a hijacked airplane, had the courage to exercise his or her Constitution right to keep and bear arms, the murderer might have been cut short of hurting or killing

Fundamental rights, those specified in the Declaration of Independence and those guaranteed by the Constitution for the United States, including those in the first 10 amendments, may not be restricted nor limited. To do so violates the very basis and

foundation of what was once a constitutional republic. With political leadership as indifferent to our Constitution as is Senator Hutchison, our once proud Constitutional Republic is merely a shadowy figure lurking behind the ugly curtain of mass hysteria, commonly known as democracy... As my friend Norman McCoy of Amarillo said recently, "democracy is just like a lynching mob, the crowd roars for the hanging, and the minority gets strung up..." all in the name of "majority rule."

The senator talks about how most Americans want this or that... and justifies unconstitutional acts as somehow okay because it is the will of the people ... and then calls infringement on our rights as legal,

and quotes Supreme Court rulings to back her belief.

Does making it (il)legal make it right? Well, I remind the senator that the Supreme Court held for more than 100 years that slavery was legal... but we all know that it wasn't right and it wasn't Constitutional... I won't take the space to list all the other "legal" absurdities which have been maintained over the years in the name of "democracy" and at the expense of the minority. Germans know what I mean... in the 1930s it was legal to murder people for their religious beliefs.... but we know that it wasn't right. A law may be legal, and something might be illegal in the eyes of a

law, but neither of those conditions make the law right... the true test is the Supreme Law of the Land... and that is not the U.S. Supreme Court's idea of what is right or wrong... it is the Constitution itself... and it is clear, it is unequivocal and it is common sense. It is the common law of the land.

Kenneth F. Montgomery

Kenneth F. Montgomery, whose belief in the power of education led him to be one of the prime philanthropists in the field, died at home January 14, 1996 of natural causes.

He felt that his fortune was in the ability to help others, which he did tirelessly. He was a witty man, a raconteur with the ability to bring a smile to all in any given situation.

His desire to aid people in search of higher education has been a central theme in his life. Himself a beneficiary of an education provided by his uncle, who married the widow of C.W. Post, he provided scholarships for students at Dartmouth College, Harvard University, Notre Dame University, Stanford University Law School, and Culver Academy. He was particularly interested in providing opportunities for minorities and in encouraging law school graduates to pursue public interest careers.

At Dartmouth College he and his wife, Harle, established the Montgomery House. It was created in 1977 to expand the opportunities of a college experience for students by bringing outstanding figures, not only from the academic world, but from non-academic spheres as well. Mr Montgomery then moved into a legal career, becoming a partner in Wilson & McIlvaine, a Chicago law firm. He maintained an active litigation practice until the 1980s.

He was an active member of the Democratic Party, receiving a John F. Kennedy Public Service Award in 1988.

Mr Montgomery served as a trustee of Rush-St Luke Presbyterian Hospital, Lake Forest College, Stanford Law Board of Visitors, Notre Dame Law School, Advisory Council for the Art Institute of Chicago, Sustaining Fellow of the University Club of Chicago.

Disciples of Jesus

I was recently struck by the thought of what it truly meant to be a disciple of Jesus Christ. If we had been there when Jesus was on

a disciple of Jesus Christ. If we had been there when Jesus was on earth would we have been a committed disciple.

If we lived out our faith then in the way we live it out now would people have looked at us strange and asked, "Are you really a Disciple?" Do we live it out the way they did?

I was struck by the concept of being a "disciple," not so much about being a "Christian." "Disciple" was the primary term used to refer to Jesus' followers in the New Testament. It simply means a follower. Only later at Antioch were they called Christians.

To be a Christian today is one thing: to be a disciple seems to be


To be a Christian today is one thing; to be a disciple seems to be

something more. The term implies more than one who adheres to a prescribed doctrine but one who is a follower of a person – Jesus Christ. The last two thousand years of Christianity has somehow muddled our perception of our faith and we have lost the vibrant dimension

of being a follower of Jesus Christ. Read the gospel accounts. See what Jesus said about being His disciple. Notice the lives the disciples lived. Clearly, as disciples they had the highest level of commitment. They walked with Him and learned from Him. He taught them to live as He lived – in

humility, in love, in forgiveness, in sacrifice, in perseverance. In the days of the Book of Acts the people realized "that they had been with Jesus." Pray that we would live in such a way that our world would say the same of us!




