Post has received more than 7 1/2 inches of rain during the month of August, thanks to the last week's downpours triggered by Hurricane Dolly. Rains over the past few days, including Tuesday night's 1/10 of an inch, have boosted the year-to-date total to more than 14 1/2 inches for the year, according to sheriff's department reports. Overall Garza County moisture has given grasses a much needed soaking and many tanks are filled.

# GMH to close Sept. 30

Garza Memorial Hospital will officially close its doors at the end of this month but hospital officials are working fervently to ensure the continued use of the facility as a 24-hour ambulatory clinic.

Board members, in a special called meeting held Thursday, voted to close the financially struggling hospital effective Sept. 30, according to Maritta Reed, administrator of the facility. They hope to see the clinic open Oct. 1.

A declining in-patient rate which has dropped to less than one patient per day, an area-wide increase in the use of managed health care, and increased costs in maintaining an in-patient facility subject to state and federal regulations have had a significant impact on the hospital's finances. Last month, for example, the hospital was forced to pay almost \$15,000 to provide the emergency room coverage required by the state, Reed said. That amount is projected to climb to just over \$18,000 in September.

"It's a tight time frame for everybody, trying to get the plans for the ambulatory clinic worked out by Oct. 1, but when we considered the financial condition of the hospital for the past year and having lost Mike Cahill and Dr. Shen Chen it seemed like the best thing to do for everyone concerned," said Reed.

Cahill, a physician's assistant, resigned from the 26-bed facility several weeks ago. Dr. Chen turned in his resignation Aug. 26. His resignation will be effective Sept. 30.

Although many of the details have yet to be ironed out, Garza Memorial Hospital officials have been working with representatives

of Methodist Hospital in Lubbock for several months, negotiating the possibility of creating a 24-hour clinic, Reed said. The board's goal was to explore options which would allow continued use of the Garza Memorial Hospital facility while continuing the provision of 24-hour emergency health care services to Post-area residents. One of the options eyed was the operation of a detox center at the local hospital. That option, however, would require the hospital to recruit new physicians, a task that can be costly time-wise and money-wise, Reed

Local hospital officials met with Methodist representatives Tuesday evening to continue working toward an agreement on the opening of a 24-hour clinic in the Post hospital.

A formal agreement has not been approved by the Methodist System board but all indications are that the two entities will enter into a lease agreement, probably for a period longer than a year, Reed said. The emergency room services will remain basically the same, with the provision of lab and X-ray services.

Plans call for the local hospital district to remain intact, with Methodist providing assistance in the provision of indigent health care at a capped amount per year, said Reed. Hospital district taxpayers will continue to be represented by an elected board. Members of the board will serve as part of an advisory board which will meet with Methodist officials on a regular basis to review the new facility's operations.

The Garza Memorial Hospital District will be responsible for funding the renovations necessary to convert the hospital into an

ambulatory clinic, according to Reed. These monies will ultimately be paid back to the district through its lease agreement with Methodist.

While there are no firm numbers to work with currently, Methodist officials have agreed to work to retain as many of the hospital's employees as possible, the administrator said. They will also assist







## **Food Briefs**

'Going for the gold' includes good nutrition

The games may have ended, but future Olympic athletes should make sure that good nutrition is part of their routine.

"If young athletes neglect their diets, their performance and, ultimately, their health may be affected," said Dr. Marta Fiorotto, a researcher at the USDA's Children's Nutrition Research Center and an assistant professor of pediatrics at Baylor College of Medicine in Houston.

Fiorotto said swimmers, cyclists and runners need additional carbohydrates and all young athletes, especially females, need to get enough iron and calcium. She recommends:

Energy-boosting snacks like low-fat granola, peanut butter and jelly sandwiches or dried fruits.

Carbohydrate-rich foods include breads, potatoes, pastas and rice.

Iron-rich foods such as lean read meat, legumes and whole grain and fortified cereals.

Pacify pint-size passengers with healthy snacks

Taking the family on a road trip? Don't forget nutritious snacks for your pint-sized passengers.

Nutritionists at the USDA's Children's Nutrition Research Center at Baylor College of Medicine recommend bite-sized snacks like fresh fruit, dry cereal and carrot sticks. String cheese, crackers, graham crackers, oatmeal cookies and low-salt pretzels are also healthy choices.

Parents also should ice down plenty of single-serving cartons of fruit juice, a quart of milk and a bottle of water.



Who Will Inherit Your IRA?

One way to keep IRA money out of Uncle Sam's hands as long as possible is to name a child or grandchild beneficiary. When, at 70 1/2, you must start withdrawing assets according to an actuarial formula based on your joint life expectancy, you get a longer payout (not that long, though; a nonspousal beneficiary adds only 10 years). If you die before 70 1/2, that heir can take out everything within five years - and pay taxes on it -- or withdraw according to his or her own life expectancy, a better tax

A spouse can roll over the proceeds to his or her own IRA, perhaps naming other, younger beneficiaries. If the money is left in your IRA, there's no penalty for a spouse tapping it before 59

After 70 1/2, though, a nonspousal beneficiary is locked into your payout plan. The termcertain method fixes the percentage taken out each year. In the recalculation method, it changes each year, but the account must be emptied -- and taxes paid -- shortly after you die.

# What is this common law stuff really all about?

There is much confusion regarding what the Common Law really is all about. The term "Common Law" is universally recognized by reputable scholars as being the equivalent of the Latin "Lex Non Scripta" or "The Un-Written Law." This unwritten law was alive and breathing among the entirely self sufficient society of the Anglo-Saxons, prior to the invasion and occupation of their lands by the Norman conquest of 1066 a.d. Relevant citations read as follows:

"Before the Norman conquest of England in 1066, the people were the fountainhead of justice. The Anglo-Saxon courts of those days were composed of large numbers of freemen, and the law which they administered, was that which had been handed down by oral tradition from generation to generation. In competition with these popular, non-professional courts, the Norman King, who insisted that he was the fountainhead of justice, set up his own tribunals. The judges presided over these royal courts were the agents or representatives of the king, not of the people; but they were professional lawyers and the courts over which they presided gradually all but displaced the popular, non-professional courts" (Common Law Pleading by George L. Clark, Laywers Co-Op.,1947).

"The Anglo-Saxon tribunals had been open to all; every freeman could appeal to them for justice. But there was no corresponding right to sue in the king's courts. That was a privilege which had to be purchased by any suitor who wished to avail himself of royal justice. These privileges were issued to suitors by the king's secretary or chancellor, and the document which evidenced the privilege was

called an original writ" (Clark, 1947).

So we see, that the Common Law does have a beautifully clear, crisp history. And this is without even opening up the very controversial discussion regarding what appear to be very solid linkages to the activities of both Christ and Moses of the Biblical accounts. We can keep that one on the back burner for our public discussions, because the average modern-day scholar just goes crazy when the biblical

linkages are mentioned. But "Magna Carta" of 1215 a.d. was an attempt by the Anglo-Saxon barons to get the Norman King John to commit to following the Anglo-Saxon "Common Law" as was at that time already established among that conquered people. John and those kings following him, routinely disregarded this monumental historical agreement, but it stands still today as the single most significant historical bulwark against the minions of tyranny. One such being is that intellectual derelict Garrett Epps, commentator on the "Freeman Standoff" for the Oregonian, and legal professor at the University of Oregon, who amazingly stated "Magna Carta" has no relationship with modern American Jurisprudence.'

One scholarly libertarian named Lysander Spooner in his 1852 classical "Essay on the Trial by Jury," has devastatingly tied our American 7th Amendment's protection of the "Common Law" directly to Magna Cart's legendary phrase of "the Law of the Land." Also, modern scholars universally recognize that the "law of the land" is the equivalent of "due process of law" as set forth in the 5th Amendment. These classical phrases are passionately and powerfully explained as locking in the rights of all juries everywhere at all times to use their "consciences" and only their consciences in deciding whether to unanimously declare that you or I are guilty of any alleged crime and thus should go to jail or have our property stolen from us by government thieves.

The bottom line for the Common Law is clearly explained in Spooner's "Essay," that during the trial process, the jury comes together, and in that particular instant, they then define law, and only then, as it applies to the case before them. The beauty of this process becomes more clear when it is fully comprehended that the jury must be unanimous in its decision, before you or I or any defendant is to have his property or liberty infringed upon by the

Clearly then, all legislative enactments, judge-made judicial precedents, executive orders, or other modern-day military police state gobbledy-gook, falls by the wayside, as the jury sits down to adjudicate the guilt of you or me or any other defendant with their consciences. The implications for this unfolding Common Law dynamic for modern Americans is mind-boggling. The Common Law clearly is a "Silver Bullet," in chopping the "war powers" judicial enforcement mechanism right down to its knees. The 7th Amendment

clearly gives us this horsepower. If taken to its logical conclusion, we may actually establish court process without any judge ruling on admissibility of evidence, rules of procedure, or holding anyone in contempt of court. The jury could responsibly administer these decisions, under the guidance of a competently elected foreman, if they choose to do so, under the guidance of their consciences. We could create Common Law Jural Societies which have no need what-so-ever for sitting legislatures, or

for governmental employed judges. I would encourage all readers to obtain copies of Spooner's "Essay" in order to understand comprehensively what the "Common Law" is really all about. If America is to permanently break the chains of tyranny, then this 1852 publication needs to be in the hands of

# The GOP's bogus drug attack

Republicans like to talk about the limits of what the federal government can do. But when Bob Dole hears of a teen-ager in Phoenix or Atlanta lighting up a joint, he immediately concludes that it's Bill Clinton's fault for

letting it happen. Drug use is rising among adolescents, and, as with everything else that has gone wrong lately, the GOP is sure it knows the source of the malice. When the

latest statistics were released last week, Sen. Orrin Hatch (R-Utah) spiral of drug abuse since President Clinton took office." An aide to Dole told Newsweek the issue makes a perfect weapon against Clinton: "(He) slashed the drug czar's budget. Drug use is up. That's

all that people need to know.' What Hatch and Dole overlook is that the big jump came in 1995, which just happened to be the same year that Republicans gained control of Congress. Does that mean the GOP caused it? Maybe so. Seeing Newt Gingrich become speaker of the House could have driven a lot of people to seek a chemically induced escape from reality.

But the whole exercise in tracing blame is the moral equivalent of astrology. Fashions in youthful rebellion don't take their cues from the rhetoric, or even the policies, emanating out of Washington. Teenage drug use rose back in the Nixon-Ford years — presumably not because the two presidents were such mellow guys. This latest increase began not under Clinton but under George Bush. Drug use waxes and wanes for reasons that no one really understands.

The Republican charge that Clinton gave up the fight against drug abuse fails on two counts. First, he didn't. Under his last budget proposal, federal spending on all drug-control efforts would be onefifth higher than it was in Bush's final budget. Second, the GOP Congress made its own cuts in prevention programs authorized by

Nor can the trend be ascribed to lax law enforcement or a failure consequences. But that doesn't mean the kids will be listening. of national will. Since 1992, the number of people in federal prison for drug crimes has increased by 20 percent, while state prisons have seen a 17 percent increase. We are still locking up drug offenders as fast as we can turn the key, but a lot of kids pay no mind.

Neither the Democrats nor the Republicans would admit it, but the truth is that even with the recent rise, juvenile drug abuse is hardly an epidemic. In 1979, 14.2 percent of kids aged 12 to 17 used marijuana at least once a month. Today, the figure is just 8.2 percent. Cocaine use remains exceedingly rare, with only one teenager in 125 using it monthly - compared with one in 52 in 1982. The percentage of kids who have ever tried illicit drugs has also plummeted over the last two decades.

Another fact that neither Clinton nor Dole chooses to publicize is that the destructive drug most popular among American teen-agers is alcohol. More than one out of five 12- to 17-year-olds drinks at least monthly — and 7.9 percent of kids get drunk that often.

People tend to minimize the occasional teen-age beer blast as kids being kids. But, as drug policy scholar Mark Kleiman of the University of California at Los Angeles notes, alcohol is the drug on which kids "are most likely to get pregnant, commit crimes, get in fights or drive recklessly." No one wants to acknowledge that it's more dangerous for teen-agers to get drunk than to smoke marijuana. But it is.

Nor does anyone want to say something else that is obviously true: The vast majority of kids who experiment with dope will not become drug addicts. Republicans think kids are encouraged to use marijuana when they hear that the president's press secretary — not to mention the president — tried it when he was young. But Republicans from Gingrich to New York Rep. Susan Molinari have made similar disclosures.

The real lesson of these confessions is not that drug use is morally acceptable. It's that, contrary anti-drug propaganda, you can experiment with illicit drugs and still go on to live a successful and productive life. Contemplating this latest report, we ought to keep in mind the reassuring certainty that most of the teen-age users won't still be using drugs a decade from now.

Certainly, kids ought to be discouraged from using illicit drugs, the 1994 crime bill, giving the president far less money than he asked just as they should be discouraged from having sex, guzzling beer, driving fast, and doing other things that can have terrible

According to Ms. Kriho's attorney, Paul Grant, the jurors seated earlier has been subjected to extensive "voir dire" questioning, the process by which the defense and especially the prosecution attempt to exclude jurors they believe might be prejudiced against their case. (A few decades ago, such questioning was limited

to asking if one was a blood relative of a principal. These days, jurors can be asked to fill out questionnaires containing hundreds of questions, from what church

they belong to, to what model car they drive.)

But it was late in the day, and everyone was tired. They simply asked Ms. Kriho whether she could think of any reason she should not be seated.

Laura Kriho has been active in the past in political campaigns to legalize hemp - the marijuana plant - in Colorado. Twelve years ago, she had once received a deferred sentence on a minor drug charge, herself, but had been assured it would be expunged from her record if she remained on her good behavior for two years, which she did.

Laura Kriho said she could not think of any reason why she could not do justice by the 19-year-old defendant. She believes, to this day, that she was a fair and impartial juror, that she took seriously her duty to weigh the facts of the case, as assessed through the honest filter of her conscience. She was seated.

In the jury room, 11 jurors - carefully pre-screened to guarantee they were in favor of the War on Drugs - wanted to convict. Laura Kriho disagreed. In the course of their discussions, she allegedly

mentioned the likely sentence. The judge had specifically instructed the jury not to consider the possible sentence while deliberating. Outraged at not being allowed to end this and go home, a fellow juror "snitched" on Laura Kriho by passing a note to the judge. Outraged himself, District Court Judge Kenneth Barnhill called the jury in, declared a mistrial, and charged juror Kriho with contempt of court, obstructing justice, and perjury, the last for failing to volunteer facts about her political opposition to the drug war, and her own youthful drug offense ... even though she was never specifically asked about them.

The trial of juror Laura Kriho has been set for Sept. 30, somewhere near Denver. She could face a jail term exceeding six months, and an unlimited fine. It has been estimated that even a modest defense will cost \$10,000.

Colorado attorney Paul Grant: "I think what happened in this case is, the prosecutor thought he had a slam dunk, and they just got outraged.... This judge is very enthusiastic about getting convictions in drugs cases. He sees himself and the prosecution on the same side; they're both enforcing the law.

"No one's ever seen this done before in Colorado. The glare of publicity ought to be shined on this case and send them scurrying away in the darkness.

"Voir dire was supposed to guarantee the defendant a fair and neutral jury, but instead they're using it to 'clean up' the juries (and get rid of) those opposed to the court's policies. They don't want an independent jury. They believe it's their jury.

"The standard is supposed to be 'a reasonable doubt.' But the way they're using voir dire now, starts jurors thinking: 'Is there anything that would make me hesitate to convict?' That instruction violates the presumption of innocence. I think it's a very dangerous instruction.

"Juror misconduct, which is what they're charging, generally involves bringing in outside influences. On appeal, they generally won't accept an affidavit from a juror who says he misunderstood the instructions and regrets voting guilty. So you can't bring in questions about how the jury deliberated when it weighs on the other side, when it might help the defendant.

"The judge was miffed that Laura didn't follow his instructions. Well, how can he instruct the jury how to deliberate? He told them not to think about the sentence, he told them not to question the wisdom of the law. Why have a jury, if they can't think? If this is successful, we're going to need a law in Colorado that a judge has to warn jurors of their rights, that they can be imprisoned if they deliberate the wrong way.

"If this goes to trial the other jurors will be called as witnesses against a fellow juror. How can Laura get a fair trial when the jurors are being instructed that jurors can be thrown in jail for not deliberating according to the judges' instructions? They're going to want to read the judge's mind and give him what he wants and not

"And that's what he wants, to do away with the independence of the jurors. So why have a jury at all? I don't see how this case can go forward at all; it essentially destroys the jury system."

Attorney Grant is correct. The purpose of the guarantee of a trial by jury before the government can kill us, imprison us, or take our property -a guarantee repeated in no less than three of the first 10 amendments to the Constitution - is that the citizenry should have a direct, personal veto power over the enactments of the Legislature, as well as the executive power to arrest and punish.

A thousand years of common law dictate that a unanimous decision of 12 jurors - meeting in private, with no state officer to listen or interfere -is required; never a simple majority. Nor does the state have any recourse if they acquit.

Should we thus be concerned that juries will decline to convict and punish murderers, robbers, rapists? Of course not. Well over 98 percent of the populace agree such violent felons need punishment - probably rougher handling than they're getting now.

But one juror in 12 will tend to represent 8.3 percent of the people. Thus, enactments which are not supported by at least 92 percent of the populace cannot withstand the test of the unanimous, randomlyselected jury.

Do 92 percent of the populace agree that we should jail or otherwise punish drug users, purveyors of pornographic videotapes, people who chop down trees or build sheds on their own land, or otherwise-law-abiding citizens who want to own an M-16 rifle, with or without the stock cut off?

They do not. Thus, if we had the randomly-selected juries we were guaranteed - rather than juries purposely stacked by the state - most prosecutions in such cases would fail. Prosecutors would stop bringing such cases, just as they gave up prosecuting those who harbored fugitive slaves in the 1850s.

## West Texas citizens establish common law court in Lubbock

History was recorded in Lubbock following a special training session here. Citizens participating in the of Lubbock as district judge and Thelma Luttrell of Lub bock as district clerk. The court will meet the first Saturday of every month

> to hear cases filed with the clerk. Citizens voted to set the first Saturday of every month as the regular court date, and delegated the responsibility for locating an appropriate courtroom to the judge and clerk. The court will hold an administrative and procedural session Saturday at 4401 79th Street in Lubbock, beginning at 1

Chief District Judge Timothy Perkins of the Milam District Court in Dallas, administered the oaths of office to the new court officials. An official recognition for the court by the Republic of Texas Provisional Government was also accepted by citizens, who affixed their signatures to the historic document.

"West Texas has never had a common law court," Republic of Texas Magazine publisher Wesley Burnett told the assembled citizens, "and not since 1865 have any Texans been offered redress of grievances through common law, although this right is guaranteed by both the Texas and U.S. constitutions."

Based on the foundations of common law as practiced in Republic of Texas courts prior to the "war for southern independence," the court will accept cases which involve the violation of rights to any person, individually or to the person's property.

"Our courts accept cases from any Texas citizen or inhabitant of Texas," former Milam District Court clerk Jay Enloe explained during the training session. "There must be an injured party, a real person," he added, "a situation where a real person has suffered from a violation of constitutional rights."

Enloe gave the example of obvious crime, such as burglary, theft, assault and unconstitutional acts by elected officials. "No one is above the law," Enloe added, "there are no titles here, no protection from accountability."

### AG Offers Enrollment Guides

Racial and ethic student enrollment need not erode if Texas colleges and universities follow raceneutral guidelines recommended last week by Texas Attorney General Dan Morales.

Morales said state colleges and universities could boost minority enrollment, although a March federal court ruling put limits on affirmative action.

In a letter to state higher education officials, Morales said that in addition to applicants' test scores and grades, schools should consider age, gender, talents, military service, leadership, public service, hometown, employment history, extracurricular activities, financial status and family socio-economic history.


"Our young, minority children must know that with hard work, sacrifice, commitment and perseverance, educational and professional opportunities await them," Morales said.
