Greene to retire, Plummer picked as municipal judge

Term begins July 1

Jim Plummer was appointed by the Post City Council Tuesday

night to serve as the new municipal judge.

Plummer, a former council member, was one of three candidates interviewed by the council during an executive session. His appointment was voted on and announced in open session.

According to City Manager Rick Hanna, Plummer will train with the current municipal judge for the next two months and attend a week's worth of schooling in Austin before taking over the post. Plummer is tentatively scheduled to take over the position from the retiring judge in July.

Plummer resigned from the Ward 2 councilman's post several weeks ago. Appointed to fill his vacant council position was former city councilman Marion Cruse, who was sworn in prior to Tuesday's regular monthly meeting.

In other business, the council:

· Reviewed and discussed at length a proposed sanitation ordinance. The council agreed the item requires further review and no action was taken.

After completing his telephone call, Mrs Bilbo reported that her husband began yelling and cursing her and striking her in the face. He then brought the couple's six and eight Mrs. Bilbo was asked to wait in the patrol unit parked on the year-old sons in to watch, telling the boys that she had been "disobedient" and he "was having to straighten her out." Mrs Bilbo reported she was kicked, hit in the face, had her arm twisted and was

> choked during the alleged attack. Gary Bilbo is alleged to have then fetched a gun and forced Mrs Bilbo to sit with him and their sons on the floor while he was "playing with the gun, loading and unloading" it and pulling the trigger when there was no bullet in the chamber, according to Mrs Bilbo's report. At one point he pointed the weapon at her and asked her if

> she was "ready to die." He also pointed the gun at his own head. sons to put on their pajamas and he sat down and ate the meal Mrs Bilbo had brought home for him, Mrs. Bilbo's report says. Then he allegedly returned to the kitchen and resumed the physical attack against his wife. Again he retrieved the gun and pointed it first at his wife's head, then at her throat. Bilbo told his wife she could leave and take their sons but "if I did he might just kill us all as we walked out the door," she reported.

> After Mrs Bilbo decided against trying to leave, she said her husband advised her to go take a bath and "get ready because I haven't

> hurt you yet." Mrs Bilbo sustained numerous bruises and injuries to her face and was bitten at least once in the shoulder, according to reports.

Community garden project helps youth

Mayor Jim Jackson provided his tractor and plow, and Curtis Hudman loaned the use of his lister.



Lawmen busy with 16 arrests and jail transfers

Editor's Note: We publish the names of those people charged with the violation of the rights of other individuals.

Sixteen arrests were made by local law enforcement agents during the past week, according to reports made available at the Garza County Sheriff's Department. Several of. those arrested were transported to jails in Dawson and Lynn counties as local jail officials continue to address the issue of overcrowding.

On March 31, a 32-year-old male was arrested for child support violation (transferred to Dawson County facility April 2). Four arrests were made on April 1, including three men, ages 43, 39 and 39, arrested for revocation of probation (two were transferred to Lynn County and one to Dawson County April 2). The fourth arrest made on April 1 was that of a 23-year-old male arrested on a DPS warrant (released the same day on a \$1,344 bond).

Four arrests were made on April 3. A36-year-old male was arrested on a parole warrant (April 3 transferred to Dawson County), a 27-year-old female was arrested for selling alcoholic beverages to a minor (released the same day on \$1,500 bond) and a 40-year-old male was arrested for no driver's license (released on time served, fine paid). Also arrested was a 48-year-old female, Guadalupe Torres, on charges of theft under \$50 (released the same day after paying fines and court costs).

Gary Bilbo remains in custody and, due to overcrowded conditions at the local jail, was transported to the Dawson County Jail April 2. Bond for the charge of aggravated assault family violence (exhibiting a deadly weapon in the act of an aggravated assault), a second degree felony, has been set at \$150,000. Bond for the charge of deadly conduct (displaying a firearm in the direction of another individual), a third degree felony, has been set at \$5,000. A family violence protective order was also granted against Gary Bilbo the day after the incident.

A conviction on the family violence charge could carry a sentence of two to 20 years in the state penitentiary and/or a \$10,000 fine, according to Ratke. A conviction on the deadly conduct charge could carry a two to 10 year sentence and/or a \$10,000 fine.



Too many jury trials in California?

When common court practice comes into conflict with our rights and protections against high-handed government action — the kind of rights specifically guaranteed us by the U.S. Constitution and its Bill of Rights - which shall prevail?

The U.S. Supreme Court will get another chance to decide, after agreeing March 30 to hear a land use case out of Monterey, Calif.

In the case Monterey vs. Del Monte Dunes, the real estate States, than according to the rules of the common law." development firm Del Monte Dunes at Monterey Ltd. sued the oceanfront California city after failing in numerous attempts to win permission to build a residential complex on its 37-acre parcel there.

The successful lawsuit contended that — by blocking productive use of the land — the city had "taken the land for public use" (under a process which lawyers style "inverse condemnation") but was refusing to fairly compensate the property owners for their loss, as required by the Fifth Amendment.

One of the main points at issue is whether plaintiffs had a right to English version from which the rest of us are reading, of course. a jury trial. They got one, in this case, and the jury awarded them \$1.45 million.

that such a lawsuit is entitled to a jury trial, even though jury trials are not generally allowed when a local government buys private property outright, forcing such sale via its claimed power of "eminent Las Vegas Nev. 89127. domain."

In their appeal, lawyers for the city argue the 9th Circuit court's ruling directly conflicts with another federal appeals court ruling on the issue and "departs sharply from the accepted procedure for litigating such claims in both federal and state courts."

But of course, the proper and essential role of a jury is to apply the common sense and conscience of the community to the question of whether government is running roughshod over the rights of the individual — a decision which no fewer than three articles of the Bill of Rights assure us shall never be left up to the sole discretion of some government-salaried judge.

When "planning and zoning" restrictions grow so onerous that a private property owner is effectively forbidden from doing anything on his property but standing there and watching the birdies, the high court has repeatedly held - first in the case of a similar waterfront lot in North Carolina, and then in the case of a hardware store next to a bike path and "green belt" in Tigard, Oregon — that a "taking" has in fact occurred, and that the government must pay for the land in question, whether it officially sought to take title or not.

Obviously, compensating all affected landowners would be prohibitive, so the real effect of such rulings is to make government



Voters prefer legislators for I&R

It is rare to see three incumbent legislators defeated in the primaries. But last month, voters were very efficient at sending a clear message to incumbents who took positions opposing Initiative & Referendum (I&R) rights for Texans.

Four-term Representative Ted Kamel of Tyler and Representative Caroline—Galloway of Dallas each told the Texas Eagle Forum they agreed that "Initiative & Referendum is good for local governments but would create "mob-ocracy" if implemented statewide, because it would usurp the responsibilities of elected officials."

Rep. Kamel had previously signed a written pledge to support I&R. The third defeated incumbent, Bill Roman of Bryan, neither signed the pledge supporting I&R nor responded to the Eagle Forum Survey.

Representative Nancy Moffat of Southlake stated that she was undecided on whether I&R for Texans would mean "mob-ocracy." Trying to duck the issue provides no safe cover. Moffat is now in a runoff.

Senator Michael Galloway of The Woodlands, who has voted for I&R in past sessions, defeated Bill Leigh, who indicated to the Eagle Forum he believed I&R would lead to "mob-ocracy." In the race for Railroad Commissioner, Tony Garza told the Eagle Forum he disagreed with them and supported I&R. He defeated Steve Stockman, who was undecided on the issue.

Texans, by a margin of 68 percent to 20 percent, support I&R for themselves. This three to one margin extends across all demographic groups. Therefore, no one should be surprised that voters singled out for defeat legislators who are determined to keep the I&R right from them.

Leaders of the Texas Eagle Forum, Mrs Shirley Spellerberg and Mrs Cathie. Adams, have adopted, without vote of the membership, a position that I&R for Texans is "mob-ocracy." Since there are no "mob-ocracies" in the 24 states with 1&R rights, do they think Texans are inferior people?

Governor George W. Bush has been clear on the subject: "Initiative and referendum make government more responsive to its citizens, neutralize the power of the special interests and stimulate public involvement in state issues." Candidates for legislative office would do well to listen. Mike Ford, Initiative for Texas







High-Tech Aid for Your Hearing

As the first generation exposed to live concerts and loud, continuous music approach their 50's there has been an increase in premature hearing loss. Noise pollution in general, at both our home and workplace has greatly increased over the last half century. While there are now regulations protecting our hearing at the work place, for some the damage has already been done. How is your hearing? Take this quick test: Go to a quiet room and rub your thumb and index finger together a few inches from your ears. You should hear a soft scratching noise. If you do not you may be one of the 7 to 8 million Americans that would benefit from a hearing aid

Diminished hearing is by no means life-threatening, but it can limit your ability to function optimally. Also, long term impairment, if untreated, can cause social and psychological isolation. This is unfortunate as some simply deny they have a hearing problem, while others acknowledge their hearing loss but are to embarrassed to seek help.

If you have concerns about your hearing contact your medical provider for advice. The solution may be as simple as cleaning out impacted wax from the ear canal, or making some adjustments in your medications. If a hearing loss is suspected your provider may refer you to an audiologist for testing who can measure and treat your hearing impairment.

There are dozens of hearing aid manufactures, but all aids have some common features. A microphone in the device converts sound to electrical impulses. An amplifier then boosts the signal to a speaker that changes the signal back into sound. All are battery powered with a volume control. There are three basic styles of hearing aid. Behind-the-ear (BTE), In-the-ear (ITE) and In-thecanal (ITC). Which type that would be best for you depends on your degree of hearing loss, on lifestyle, dexterity and cosmetic concerns.

Cost is a consideration as the least expensive BTE type are between \$500-\$900. The most expensive ITC models are between \$900-\$4000. There are digital models of the ITC and BTE type, but recent studies have shown they do not justify the additional \$500 to \$1000 more per device over the high end analog models

It may take weeks to get used to a hearing aid. Most models are capable of a wide range of adjustments. To ensure optimal usage one should work closely with the audiologist during this period. One should insist on trying the hearing aid for 30 -60 days before concluding the sale.
