## **United Way** campaign reports big shortfall

The local United Way campaign, which will wrap up Dec. 31, currently stands at about \$8,000, well short of the \$22,000 goal. United Way Chairman Rodney Tidwell said Monday that donations are still coming in, including a sizable one expected from the employees of the Giles W. Dalby Correctional Facility, but the campaign needs more funds in order to reach its year 2000 goal.

# Dalby facility boosts United Way funding

Employees of the Giles W. Dalby Correctional Facility hope to provide a \$10,000 shot in the arm to the Garza County United Way campaign in the next few days.

According to the facility's Ruby Williams, the unit's employees have generated an estimated \$10,000 for United Way through various fund raisers and payroll deductions.

"We just put on our roller skates and went to work," said Williams, a former United Way board member.

Under the direction of the facility's United Way campaign coordinator, Deanna Branham, and her committee, Dalby unit employees conducted a bake sale, the Santa Fest, a raffle and several early morning breakfasts since fund raising began in late October. Additionally, the facility's 234 employees participated in payroll deductions that boosted the donation effort by more than \$8,000.

"MTC always encourages community participation," Williams said, "and our people have worked really hard and did a lot of fun things to get this done.

"Through it all, we've had a lot of fellowship and a lot of hard work. I think it speaks very well of our employees. We just really want the community to understand we are a positive part of the community. We're family people, and we recognize the needs here in our community."

Williams said the unit's final fund raising efforts will be wrapped up in the next few days, allowing them to present their contribution to local United Way officials prior to the end of the 2000 cam-

"That is major," said Rodney Tidwell, chairman of the Garza tion.

County United Way. "What they've done is really, really great. Without them, I don't know what we'd do."

To date, the local United Way campaign stands at about \$8,000, short of its projected \$22,000 goal. This year's United Way effort is slated to end Dec. 31.

"We really appreciate them coming forward and stepping up to the plate," Tidwell said.

Williams said the Dalby unit's employees are already looking forward to participating in the 2001 United Way campaign. Early plans indicate next year's Santa Fest will be bigger and better, and Williams indicated they hope to begin fund raising efforts for United Way earlier than the last quarter of the year.

This year's Santa Fest, the first such event, was conducted earlier in the month. It raised about \$400 for the United Way effort.

In addition to the push for United Way, employees of the Giles W. Dalby Correctional Facility spearheaded an Angel Tree drive which will assure that 82 local children will receive Christmas gifts this holiday season. Facility officials worked closely with the elementary school counselor to find children in Head Start through fifth grade to receive toys and clothing purchased for the Angel Tree

The Dalby unit's Angel Tree project has attracted the attention of a handful of other local businesses and agencies who also participated. "People have been so generous," said Williams. "We feel good about

## State, county code enforcers rip thousands out of hands of travelers

## It's not always happy holidays for Garza County visitors

The two Justice of the Peace courts in Garza County reported coltraffic code violations.

they are part of a gigantic legislative scheme, which considers all who travel to be doing so within certain boundaries of an incorporated area, therefore the "subjects" are required to follow the corporation's rules.

The traffic code is one example of the corporate form of government imposed on Texans, in violation of the guarantee of a republic form of government.

The "Transportation Code" is not even a law, it does not have the constitutionally required Secretary of State certification of publication as part of the statute. Perhaps that omission is based on the fact that there is no constitutional authority for corporate government to enforce corporate rules in violation of basic constitutional guarantees, such as liberty, the right of travel from one place to another.

Although most Texans think of themselves as free to move about as they wish, they discover their true status as corporate "citizens" once they become victimized by the corporation's policy enforcers.

The Texas transportation code is nothing more than a corporate policy, and since the State of Texas is a corporate subdivision of the incorporated U.S., then all who live or travel inside those boundaries are considered corporate subjects, bound to obey corporate

Because of the extortionate expense of defending the right of declares the holder to be an "operator of a motor vehicle." Acting as agents for the state, local code enforcers filed 197 cases travel in the corporation's court system, most Texans meekly submit to the extortion and voluntarily gave up their right of travel by declaring themselves "motor vehicle" operators, through applications for certificates of title as well as "motor vehicle" licenses.

Although the Texas transportation code applies only to those Most, if not all of these victims of highway theft, have no idea that people involved in commercial use of the highways, it is obvious that the vast majority of "criminals" tagged in highway traffic fines were paid by "volunteers." Very few, if any, of those victims realize

One of those policies is the registration of privately owned modes that the cars and trucks they drive are not included in the regulations related to the transportation code, unless the original owner voluntarily submitted to the corporation policy.

> The Texas Transportation Code defines commercial use of the highways as those carrying passengers or property for hire. Cars and trucks, which are not used for hire in carrying property or passengers, are not "motor vehicles" as defined by the code.




He died Sunday, Dec. 10, 2000.

There is one Christmas carol that has had me baffled. What in the world do leaping lords, French hens, swimming swans, and especially that partridge who won't come out of the pear tree have to do with Christmas? Here is the explanation:

From 1558 until 1829, Roman Catholics in England were not allowed to practice their faith openly. Someone during that era wrote this carol as a catechism song for young Catholics. It has two levels of meaning; the surface meaning, plus a hidden meaning known only to members of their church. Each element in the carol has a code word for a religious reality which the children could remember.

The partridge in a pear tree was Jesus Christ.

Peace. Patience, Kindness, Goodness, Faithfulness, Gentleness, Self-control. The ten lords a-leaping were the ten commandments.

Eleven pipers piping stood for the eleven faithful disciples. Twelve drummers drumming symbolized the twelve points of belief in the Apostles' Creed.

Rather than my usual fall schedule of teaching in the Economics Department at George Mason University, I taught "The Economic Foundations of Legal Studies" at the university's School of Law to first-year law students. Economics is no stranger at George Mason's Law School. It's home to the Law and Economics Center directed by Frank Buckley. Under the leadership of

Mark Grady, the study of economics is a required integral part of the law

In fact, GMU Law School has a national and international reputation for excellence in the relatively new field of law and economics. It's important for legal practitioners to have at least a working knowledge of economics. Why?

In their jobs as attorney generals, judges, and sometimes legislators, an understanding of economics might help them avoid grossly uniformed pronouncements and harmful policy. Let's look at just a couple of cases where a bit of economic understanding might help. When there's a natural disaster, prices tend to skyrocket. That's what we saw in the wake of hurricanes Andrew and Floyd. States' attorney generals threatened to prosecute businesses for "price-gouging." They simply didn't understand the role of prices. What kind of behavior serves the social interests in the wake of a disaster? At least two: People

gas and so on), and producers should produce more. Rising prices create incentives for consumers to abandon reckless consumption and for producers to produce more. Rising prices not only accomplish those two goals, but they do so voluntarily. Another important concept for legal practitioners is opportunity cost — there's no free lunch. Say you've been selling coffee to me from your large inventory for \$6 a pound. Crop disaster in Brazil spikes the world coffee price to \$10 a

pound. What will you charge me now? If you said at least \$10, go to the head of the class. Why? Because the opportunity cost of coffee is now \$10. What coffee cost before the disaster is irrelevant

That's no different from the fact that even though you might have paid The fight for liberty has been won! The battle has ended in freedom's victory! only \$40,000 for your home 30 years ago has nothing to do with its price today. What it costs to buy a similar home helps determine today's selling price. What's the relevance?

Atwater later pleaded "no contest" to three seat belt violations, paying \$50 for each. She was also charged \$110 in towing fees.

As the 20th century reaches its end, here at The Future of Freedom Foundation we have been taking stock of the prospects for liberty in the 21st century. On the plus side, the evil face of totalitarian collectivism has passed into the dustbin of history, and hopefully forever. Communism, fascism, and Nazism are closed chapters with few advocates and defenders left — except for some bands of Marxian and socialist true believers on American academic campuses around the country, who seem permanently resistant to either

logic or facts. Everywhere around the globe the free market is hailed as the only path for prosperity and innovation. Trade, commerce, and free enterprise are heralded as the new standard for judging and constructing economic policy. Privatization and economic liberalization are declared to be the guiding principles for nations around the world. So clearly, freedom has triumphed!

If only it were so. Unfortunately, once we take a look behind the banners and the catch-phrases, the reality is very different. In fact, freedom in America is under attack from practically every direction. The Constitution When OPEC actions led to a surge in gasoline prices, some of our that was given to us by our Founding Fathers has been transformed into a pliable "living document," which is twisted and bent to serve the changing fads and fashions of every special-interest group and a wide variety of ideological dreamers and political meddlers.

No corner of our society is free from the intrusive and manipulating hand of government. Our businesses and industry are regulated. Control over the use and disposal of our private property has been usurped by every level of government. Our income and wealth are heavily taxed. Our personal and consumption choices are confined within the paternalistic oversight of both liberal and conservative social engineers claiming to know what is good for each and every one of us.

In the name of a government war on drugs, our homes are invaded, our possessions rifled through and confiscated, and our lives threatened and sometimes forfeited. In the name of a government war on racial and sexual inequality, we are told how to speak, how to act, how we may manage our businesses, and with whom we may associate in various social settings. In the name of a government war against illiteracy, a political elite dictates the content of the education our children receive and indoctrinates the youth of America to be spies on their parents and obedient foot soldiers in a campaign for cultural and ecological social engineering.

They almost always had one primary goal: to formulate marketoriented policy prescriptions in the arena of political debate as concrete alternatives to the proposals being made by the interventionists and the welfare society. We conceived of an organization that would deal with and reply to the erroneous and dangerous arguments for more government control, but not in the context of limited and makeshift proposals to do battle with every concrete piece of statist legislation coming before Congress and

Instead, we would use the opportunity of refuting these statist policy proposals to formulate and defend the ideal of the fully free-market society. By using this as our benchmark and standard, we would not only demonstrate the errors and mistakes in the various interventionist-welfare statist policies but clearly outline the final freedom ideal in every facet of life that should be the point on the horizon towards which we should always be trying to move as a society.


#### New Deal outguns 9th graders





## South Plains producers approve weevil tax

The last piece of the puzzle is finally in place for boll weevil eradication on the South Plains.

Cotton growers in Cochran, Hockley, Terry, Lubbock and portions of Crosby, Dickens, Garza and Lynn counties, recently voted 2,996 to 732 in favor of establishing the Southern High Plains-Caprock eradication

The Texas Department of Agriculture announced the results of the grower mail-in referendum this week. The four-to-one ballot approval creates a 1.2 million-acre active control zone in these eight counties - the largest of eight active eradication zones in Texas.

Boll weevil eradication efforts in these zones are operated and governed by cooperative efforts between producers and the Texas Boll Weevil Eradication Foundation. Growers in the Southern High Plains-Caprock zone also voted to pay \$12 per acre for irrigated land and \$6 per acre for dryland fields to fund their 5-year eradication program at a total cost of \$105 million. If all goes well, control efforts will begin next fall.

"The last piece of the boll weevil eradication puzzle is finally in place on the High Plains. In order to get good control of this destructive pest, we now need 100 percent grower participation-cooperation," said Steve Verett, executive vice president of Plains Cotton Growers Inc., headquartered in Lubbock. Droughts in 1996 and 1998 didn't slow the weevil's progress. Their rapid spread in the past five years leads Texas A&M University entomologists to conclude that weevils have far north as cotton can be grown in Texas.

Recent weevil overwintering studies conducted by these scientists indicate as much as 65 percent of overwintering weevils successfully survived recent winters on the Plains. Once those weevils emerge from overwintering sites, they seek nearby cotton fields. Spraying to control weevils can cost growers as much as \$60 per acre or more during the growing season.

"Eradication is a good, long-term investment for the entire region. By assessing themselves a control 'tax,' growers are trading the uncertainty. of high annual control costs for a lower, known control cost for the next few years," said Jim Leser, extension cotton entomologist at: Texas A&M's Lubbock Research and: Extension Center. "The effort pays" off. We see that when we look at the dramatic decline in weevil numbers: in zones where eradication has been: under way for one or two years.

"The first year of diapause: eradication spraying cuts weevilnumbers dramatically. Subsequent spraying in following years then: pushes weevil populations down to: near zero. That helps put more lint: and more dollars back into producers' pockets."

So, when citizens voluntarily apply for a certificate of title to their "motor vehicle," they have placed themselves under the jurisdiction of the corporate (state) traffic laws, which can constitutionally only apply to those who voluntarily declare themselves owners of "motor vehicles."

The system is perpetuated by ignorance and the expensive fees required to defend against the highway theft program. Those who enforce the corporate rules have the full backing of legislative thieves and a judicial system that puts corporate rules above constitutional guarantees of individual rights.

Under the current Texas legal system, it's a "no-win" situation for most people, except those who wear a corporate badge and those who live off the regular highway revenue producing program.
