# City, County agree on joint project funding

missioners' Court, the two government units agreed to continue jointly funding several community activities.

A big chunk of the discussion involved the Garza County Sheriff's Department proposed budget of \$602,000, with the city agreeing to fund one half of the budget. Sheriff Kenny Ratke explained that the budget did not include any pay raises for the staff.

The sheriff and Garza County Judge Giles W. Dalby also explained that the county may have to add a deputy to supervise county prisoners who perform outside maintenance tasks. Dalby said that the grounds outside of the Dalby Correctional Facility will have to be maintained by the county, following a decision by the Federal Bureau of Prisons that inmates at the Dalby facility will not be allowed to work outside of the fenced

"We'll have to keep the grounds outside the fence," Dalby explained, "and it looks like we'll have to use county prisoners." That will require at least one additional deputy, at an estimated cost of \$34,000 per year.

City and county officials also aired differences over the costs of operating the community center. The original agreement called for the city to pay for "capital improvements" while the county would pay for operational expenses until the county's expenses matched the original investment by the city.

An update on exact costs by each government unit was being prepared, with plans for the community center board to review and make a recommendation to both the county and city as to the current financial standing.

Following the joint meeting, city council members took up a short agenda, which included an agreement to buy heavy equipment through a state operated coopera-

The annual Harley Sadler Show, "How the West was Fun," will be the next production featured at the Garza Theatre.


Initial performances of the play will be this weekend, Friday, Saturday and Sunday. Additional performances are set for Aug. 9-10 and 16-17.





from 1958 to 1960. Photos of Elvis and Simon fill a showcase. "I knew him real well," says Simon. "We used to talk all the time while we were in Germany. He did everything we did. He didn't ask for favors. They wanted him to go to special services

and entertain, but he said no. He wanted to serve with his buddies. He pulled guard, he pulled KP. He liked being with us because we wouldn't ask him for autographs or anything. He said his Army years were the best two years of his life because he felt so free."

Simon was an Elvis fan before meeting Elvis. "I bought some of his records here and there, and a few of his things. Then after I met him and came back, I started buying more and more."

Simon wanted to keep Elvis's name alive. He couldn't afford to buy all the Sadler Show" at the Garza Theatre. Elvis paraphernalia he wanted to because he just didn't have the money. He went back to college, got his degree and started teaching. When he got a little ahead financially, he started buying more and more Elvis items and eventually opened his museum.

Simon's car license plate reads ELVIS V. He has a replica of the house where Elvis was born in Tupelo, Mississippi. A walkway around his house carries the names of some of Elvis's most popular songs. The museum is a two-story affair built in and above Simon's garage. Nothing is for sale.

He bought the lot next door for two annual events held the weekends closest to Elvis's birth and death. He's expecting a big crowd this year, the 25th anniversary of Elvis's death in Graceland (August 16, 1977). This year, an Elvis festival will be held August 17 featuring music, food and fun.

The day-long celebration is topped off with an appearance by an Elvis impersonator. Simon has bleachers for the fans and they're usually full. Children come dressed like Elvis. Simon wrote a song about Elvis called "All

Hail to Elvis Presley." Once he and Elvis attended a football game on their post in Frieburg, held Tuesday morning for Ellis Elec-Germany. The game was between the post at Freiburg and a post around Frankfurt. It was open to civilians. Thousands of German residents flooded the stadium. "They all came to see Elvis, not the game. So the Military Police facility are sales dealers for Zenith escorted Elvis from the stands. They thought he might get hurt."

Elvis's Dad Vernon took up residence in Freiburg while Elvis served in Germany. A BMW dealer gave Elvis a new sports car for the daily commute from the post to his Dad's house. Elvis left the service as a sergeant.

"Elvis seldom went out. A lot of girls hung around the front gate in hopes of getting a glimpse of Elvis. One of those girls was a 13 year old named Priscilla. She and Elvis later married.'


"We're confident they will make the citizens of Texas proud.'

The U.S. Supreme Court ruled in the Cleveland school voucher case, Zelman vs. Simmons-Harris, that taxpayer funds that go to parents who might use the money to enroll their children in religious schools was constitutional.

One need not be a rocket scientist to understand why.

The Constitution's First Amendment says, "Congress shall make no law respecting an establishment of religion ..." Devious and ignorant lawyers, judges and politicians exhibit little respect or understanding of the Framer's intent behind the First Amendment.

England had an established church — the Church of England supported by the taxpayers. Its members were given privileges that were denied to members of other congregations. The Framers were Englishmen and feared the creation of a similar state church in our country.

If state and local governments choose to finance education, and they give parents a voucher to be spent at schools of the parent's choosing, only an intellectual or a person with legal training will see that as government establishment of a state church — a Church of United States.

Constitution's "establishment of religion" clause. Why? Because people of the Jewish faith might use their food stamps for the purchase of kosher food, and that too should be seen as the government establishing a state church.

The same applies to those who'd give part of their Social Security check as their weekly church offering. The First Amendment arguments by opponents of vouchers and school choice have always been bogus. Now that the U.S. Supreme Court has held it as such, they will no doubt shift their focus to:

school choice." That, too, is bogus. Try a little math. Take Washington, D.C., which spends over \$10,000 per student for education whose web page at www.creators.com. student achievement would be dead last if Mississippi chose to secede

from the Union.

Suppose Washington gave each parent even a \$5,000 voucher — that wouldn't mean less money available per student. To the contrary, holding total education expenditures constant, it'd mean more money per student remaining in public schools. School choice opponents are also dishonest when they speak of saving public schools.

A Heritage Foundation survey found that 47 percent of House members and 51 percent of senators with school-age children enrolled them in private schools in 2001. Public school teachers enroll their children in private schools to a much greater extent than the general public, in some cities close to 50 percent. This also applies to the black

Jesse Jackson, for example, sent his son to Washington's most elite private school. One particularly insidious argument of voucher opponents is that vouchers will "skim" away the more academically talented students whose parents want better and safer schools for them. That's a vision that's hideous and rotten to the core.

It says that such students should be held hostage, unable to escape rotten schools and be academically destroyed, in the name of saving public schools at some distant, yet undetermined, unpromised date. One of the strongest arguments in favor of educational vouchers and With that kind of reasoning, food stamps would also violate the choice is: When a society decides to publicly finance a good or service, it doesn't follow that it must be publicly produced.

> We publicly finance F-16 fighter jets, but there's no government F-16 fighter jet factory. That same principle applies to education. We can publicly finance education, but where it's produced should be determined on the basis of economic efficiency. Where can we get the biggest bang for the buck?

> All the self-serving arguments of school choice opponents are bogus. Saving public education is not the same as, and may indeed be exactly the opposite to, saving children.



### 'Taxpayer two-step' robs city, county property owners

Last week the Post City Council and the Garza County Commissioners' Court sat down at the table, as they do every year about this time, to do what I call the "Taxpayer Two-Step."

This little dance pits taxing "partners" at odds with one another over who pays how much for what the other for shared projects. Each taxing authority is doing a two-step, trying to shift its burden onto the other.

This dance started back in the early or mid 1980s, and has evolved into a rather sophisticated "let's see if we can out step our partner." Guess who ends up paying the fiddler for this dance? Taxpayers of course, and it doesn't make much difference whether it comes from the "city pocket" or the "county pocket," property owners are going to

Of course, county property owners, outside of the corporate city limits, hope this shifting of expenses will benefit them, while city only property owners hope just the opposite.

Any way you look at it, this dance is nothing more than a "spinaround," where nobody really wins, except perhaps the corporate government officers who tick off the many reasons why this dance should continue.

Taxpayers, on the other hand, are going to pay, one way or the other, because our incorporated government units have the power to steal from us. As long as that theft program continues, we're in for more dances like this one.

Until we rid ourselves of this immoral theft (taxation), we suggest that city and county corporate officers divest themselves of this "twostep" dance and take full responsibility for the property that they own and their constitutionally required functions.

The county has its constitutional obligations to fund law enforcement, the courts, jail, roads and indigents. The city has responsibility for maintaining water, sewer and streets. It may also enforce its city codes, but should not expect the county to pay for any of those services.

Likewise, the county should pay its obligations without looking to the city for financial support.

The current sharing of jointly funded projects is a confusing hodgepodge that creates more problems than it solves, and is a

management nightmare. Those who own the property should be expected to maintain and fund what is needed. Just as it makes no sense for private property owners to share expenses of each others property, it also makes no

sense for government. Let's bring some common sense back to government and place responsibility for maintaining property on the owner of record. It's time for the dance partners to call off the annual ritual.

Morales is a Post High School


