Garza County voters will join voters across the state Tuesday in Green Party. filling a variety of political offices.

At the county level, there are no contested races. Giles W. Dalby is Smith, Rep.; Margaret Mirabal, Dem. running uncontested as the Democratic Party candidate for county county treasurer; Mason McClellan, Precinct 2 commissioner; Mike Green Party. Sanchez, Precinct 4 commissioner; Sheila Melton, justice of the peace for Precincts 1-2; and Dee Justice, justice of the peace in Precincts Yanez, Dem.; Quanah Parker, Lib. • Chief Justice, Supreme Court 3-4.

For the post of district judge, 106th Judicial District, Republican Lib. candidate Carter T. Schildknecht is seeking to return to her post. She is being challenged by W. Calloway (Cal) Hufaker.

At the state level, the mudslinging ads funded by at least two of the gubernatorial candidates are expected to fuel a healthy voter turnout. Republican Rick Perry, who took over the governor's role

following the election of George W. Bush to the office of U.S. president, is vying to return to the office, but Democratic challenger Tony Sanchez hopes to move in instead. The Libertarian Party candidate for governor is Jeff Daniel, while Rashmi Mahajan is the Green Party's contender.

Running for lieutenant governor are Republic David Dewhurst; Democrat John Sharp; Libertarian Mark David Gesaner; and Green Party candidate Nathalie Paravichal.

The court also approved a new agreement with the City/County Ambulance committee for the operation of the Emergency Medical Services here. 





The Post freshmen and junior varsity combined last week to earn a 20-18 victory over the visiting Shallowater Mustangs.



"I'll Work for You."

When our Texas founders drafted our state's constitution, they envisioned a citizen legislature made up men and women from different walks of life who would meet for 140 days every two years, do the business of the state, and then go back home. Serving in the Legislature was meant to be just that, service. It was never meant to be a full-time profession.

Well times sure have changed!

Today, many candidates for the Legislature spend hundreds of thousands, even millions of dollars, getting elected and then once they are there, staying elected to a job that pays \$600 dollars a month. The question of whether a Driver's License is required in Texas applies both to the traveling public and transportation. And can be answered by a precise study of the Texas Transportation Code.

Before addressing this question, it should be noted that the only right way to interpret the law is to allow it to interpret itself within the letter of the law. A pair of indictments for DWI/third offense resulted in two arrests Oct.


Two individuals were jailed on charges of theft under \$50 on Oct. 26, as was another picked up for public intoxication.




