Early voting opens for hospital bond, school board, city sales tax

district and health care district elections is under way.

and the Garza County Health Care District will go to the polls May 3 to decide a variety of posts and proposals; however, voters can cast their ballots early by personal appearance through April 29.

Early voting for the city and health care district is being conducted at city hall during regular business hours. Early balloting in the school district election is being offered at the Post ISD administration building.

City ballots will ask voters to fill the mayoral and three vacant council seats, as well as to consider a pair of propositions. Proposition 1 will ask voters to decide on the adoption of an additional sales and use tax at the rate of one-half of one percent to offset a corresponding reduction in the ad valorem tax rate.

U.S. Justice Dept. approves central voting for GCHD

A single central location will be utilized for balloting during the Garza County Health Care District May 3 election.

According to a April 3 letter from the U.S. Department of Justice,s Voting Section, the health care district has been authorized to set up a single balloting station during the upcoming election.

Plans call for the health care district to set up tables in the Post Community Center on election day. Each of the tables will represent a county commissioner,s precinct. Each voter will be required to cast his ballot at the table that corresponds with his voting precinct.

Early voting by personal appearance, which began earlier this week and will run through April 29, will be conducted at City Hall during regular business hours.

Voters within the health care district will be filling two open board of directors, posts. Incumbent Zoe Kirkpatrick and newcomer Terry Bartlett are the only candidates seeking election.

Also, voters will be asked to voice their opinion on the proposal to construct and operate a new hospital facility in Post. The proposal calls for the construction of a \$10.5 million, 10-bed hospital/24hour ER/rural health clinic to be built through the sale of tax-revenue bonds. To meet the financial obligation, which is projected to be paid off over a 15-year term, district officials have proposed a tax rate increase of approximately 30 cents per \$100 valuation.

Proposition 2 will deal with the proposed adoption of a sales and Early voting by personal appearance in the local municipal, school use tax at the rate of one-half of one percent to fund the creation of a 4B corporation that will oversee the finance, management, acqui-Voters in the City of Post, the Post Independent School District sition, transport and furnishing of water through the Slaton water supply project

Mayor Archie Gill will run unopposed in his bid for re-election, and two council members - Juanita Pantoja in Ward 1 and Dick Odom in Ward 2 - will have no opposition in their bids to return to two-year council positions. A fourth candidate, Joshua Whiteley, is running for an unexpired, one-year term in Ward 3. That council seat, previously filled by appointment, was left vacant following the death of Councilman John Redman.

Eight candidates will compete to fill three open Post ISD trustee seats in the upcoming school board election. Candidates, as they will appear on the ballot, include Rex A. Cash, Diana Gonzales Looney, Alexa M. Collier, Mark E. Short, David Davis, Delbert Wartes, Milton Williams and Scott Creech, according to district officials. Cash, Looney and Short are the incumbents.

The three open positions are at-large seats with three-year terms. In the health care district, two candidates - incumbent Zoe Kirkpatrick and newcomer Terry Bartlett - will seek a pair of open positions on the district's board of directors.

Voters also will be asked to decide the proposal to construct and operate a \$10.5 million, 10-bed hospital/24-hour ER/rural health clinic to be built through the sale of tax-revenue bonds. To meet the financial obligation, district officials have proposed a tax rate increase of approximately 30 cents per \$100 valuation.

In other matters, Dalby said that the juvenile detention center management change looks to be on track with Cornerstone.

Without telling his father, he had enlisted in the Confederate Army. The following morning, heartbroken, the father asked permission of his superiors to give his son a full military burial, despite his enemy status. His request was only partially granted. The Captain had asked if he could have a group of Army band members play a funeral dirge for his son.

The request was turned down since the soldier was a Confederate. But out of respect for the father, they gave him one musician. The Captain chose a bugler. He asked the bugler to play a series of musical notes he had found on a piece of paper in his son's uniform. This wish was granted. The haunting melody, we now know as "Taps"... used at military funerals was born.





Does political power mean economic power?

Much of the '60s and '70s civil rights rhetoric was that black political power was necessary for economic power. In 1967, Clevelanders heeded Malcolm X's infamous "The Ballot or the Bullet" speech with the election of Carl B. Stokes, who became the nation's first black big city mayor.

As of 1999, blacks were mayors of 29 major cities; that includes Philadelphia, Detroit, Cleveland, San Francisco, St. Louis and Washington, D.C. In some of these cities, blacks are also city

councilmen, superintendents of schools and chiefs of police. That this is a major achievement is without question and a fine commentary on America's racial progress, especially when we consider the fact that blacks were mayors in cities where blacks are a small minority, such as: Des Moines, Denver, Houston, San Francisco and

By no means does it demean black political achievement to ask a more important question: What does black political power mean for the lives of ordinary black people? In other words, is political power a necessary condition for economic power?

Let's look around. Japanese and Chinese-Americans faced gross discrimination in our country, but when's the last time you heard of them worrying about how many congressmen they have or going into a tizzy worrying whether a Reagan or Bush presidency would mean the end of their handouts? By the way, Japanese and Chinese-Americans have median family incomes higher than white Americans — in the case of Chinese-Americans, 58 percent higher.

Other discriminated-against minorities in America who've eschewed the political arena are: Koreans, Arabs and Armenians. For the ordinary person, what's more important: economic power or political power? I think it nearly goes without saying that economic power empowers the individual; it gives him the power of self-determination.

Political power empowers, and even enriches, the political elite; for them, getting out their constituent vote is the be all and end all. This observation has nothing to do with race. Economic power empowers

people of any race, and political power empowers the political elite of any race.

While black politicians have preached that political power is a means to gain economic power, whether it has done so is a testable proposition. We only have to examine the socioeconomic status of black Americans in cities where blacks hold considerable political power, cities such as Washington, Newark, Philadelphia, Detroit, Cleveland, Memphis and others.

What we'll find in those cities are grossly inferior education, welfare dependency for much of the population, unsafe neighborhoods and citizens, both black and white, who can't wait for the first opportunity to get out. Let me be clear. I am not stating a causal link between black political power and the living conditions and welfare many of its citizens in It's simply an argument that the expectation that political power will translate into economic power for the ordinary citizen is apt to be disappointing. But there're some political steps that black politicians can take that can create an environment for economic power.

Crime exacts a huge cost on people least able to bear it. High crime makes everything worth less, whether it's houses or businesses. Among other things, it means fewer neighborhood consumer choices and neighborhood employment. Black politicians should develop a ruthless zero tolerance anti-crime policy.\

Rotten education in these cities where blacks hold dominant political power needs to be addressed, but that's more difficult. Black politicians are beholden to and serve the interests of the powerful teachers' unions, and not the voters who elect them to office. Otherwise, they wouldn't begin to tolerate the near systematic destruction of learning opportunities for generations of black children.

A solution is to break the education monopoly through educational

The 'Drug War' helps terrorists

The U.S. government has become quite accustomed over the years to orchestrating world events to fit its own agenda. In our name, the government keeps American troops in over half the countries of the globe, openly supports brutal regimes, and uses its intelligence agencies to manipulate the policies of foreign governments.

But no matter how hard it tries, the play never seems to unfold as scripted. Still, it is in the name of the "War on Drugs‰ that the US truly excels ir showing how poorly equipped it is to act as director of international affairs. Since the 1970s, administration after administration has sought to enlist foreign nations in its jihad against arbitrarily prohibited, but nonetheless popular recreational drugs.

For the drug war has lead to the enrichment and expansion of vicious terrorist groups around the world, even the one responsible for the horrible attacks on 9/11. Sadly, the government continues to ignore the warning signs and feeds the mouth that bites us all.

In the "large regions‰ where they rule, they serve as the de facto government, supplying schools, sports teams, and security to local peasants. With the support of indigenous farmers, they grow coca and opium with impunity, raising incredible sums of money to finance their terrorist activities and, worse, create the conditions for international cooperation with other terrorist groups, a fact made clear by a recent anti-terrorism report which showed Hezbollah training camps in the "tri-border region‰ of Brazil, Argentina and Paraguay,

The connection between drugs and terrorism is not exactly the world,s best kept secret. In March, 2002, in a statement before the Senate Judiciary Subcommittee on Technology, Terrorism, and Government, Senator Jon Kyl of Arizona reported that "opium production in Afghanistan [under the Taliban] accounted for 72% of production worldwide‰ and was used to "shelter Osama Bin Laden Hillary, she has no use for losers. and other Al Qaeda terrorists.%

He similarly indicated that Bin Laden "provided protection to heroin processing labs, was a part owner in numerous labs, [and] part owner of one load shipped to the U.S.% Even a casual knowledge of economics is enough to understand that, rather than hurting the drug trade, the drug war is its greatest boon. The popularity of drugs effect that interdicting or limiting the supply of a given drug may have will merely be to raise the price it brings on the market even further, meaning larger profits to those who deal in drugs. And in the Latin American and radical Islamic countries where the dealers are typically terrorists, this means more money for terrorism.

Even the Office of National Drug Control Policy inadvertently admitted the effect of its own policies by broadcasting national advertisements telling people who use drugs that they are supporting terrorism. If helping to put money in the pockets of drug dealers is

- 2. That each Presiding Judge shall appoint not less than two or more than five qualified election clerks to serve and assist in conducting said election; provided that if the Presiding Judge actually serves as expected, the Alternate Presiding Judge shall be one of such clerks.
- 3. That early voting shall be conducted by personal appearance and by mail at the early voting as designated in "Exhibit B," which exhibit is incorporated herein and made a part of this Order for all purposes. During the period early voting is required or permitted by law, being April 16, 2003 through April 29, 2003, the hours designated for early voting by personal appearance shall be from 8:00 a.m. to 5:00 p.m. on each day except Saturdays, Sundays and legal state holidays and the early voting clerk shall keep said voting place open during such hours for early voting by personal appearance.
- 4. That an early ballot board is hereby created to process early voting results, and Billie Windham is hereby appointed the presiding judge of said board. The presiding judge shall appoint at least two other members of the board.
- 5. That all resident, qualified electors of the District shall be entitled to vote at said election.
- 6. Not happy with editorial

I hope this letter helps define my position when use of a credit card is approved at the county level. I would agree that it is inappropriate to use any credit account of Garza County for personal use.

I want to clarify what is considered personal use. Personal use is for the singular benefit of an individual and outside the realm of the needs relating to a job. We require purchases by law enforcement personnel for the completion of the employee's job that must be paid for by the employee, and I call these job-related purchases. The nature of the job-related equipment purchases is found predominantly in the law enforcement area.

Your recent reference to personal use, I believe, does not accurately explain the intended use of the charges. Only job-related purchases are approved for the expenditures of tax dollars. These charges by law enforcement personnel are for job-related equipment and are required by the county (i.e. boots, uniforms, handcuffs, firearms and holsters).

Law enforcement personnel are provided an allowance of \$25 per month to help with these job-related expenses.

The Commissioners Court procedure is to review and require three signatures for approval on every account payable that is provided by the county treasurer. Bills that the treasurer brings to the Court are preapproved by an appropriate elected official. In this procedure, the Court monitors expenditures for all department budgets.

These accounts are public record.

County records show that any inappropriate charges have been reimbursed when discovered by normal review by the county treasurer and Commissioners Court. Charges deemed inappropriate but charged in good faith by an elected official may still be refused payment with county funds. I am convinced that this system is effective and does comprise the proper oversight relating to our county's funds.

The County Commissioners Court is in the process of clarifying and specifically speaking to issues concerning the expenditure of funds. My understanding of our present system of elected official accountability and the Commissioners Court scrutiny of accounts payable is adequate and much more efficient than normal business use of a purchase order system.

I can assure you that I am aware of the personal and professional

responsibility my job entails and do take these responsibilities seriously. I do claim that the recent editorial on April 10 is incisive at best. The article 'Just say, "Charge It to the County" casts a slanderous climate on the Commissioners Court and displays an inciteful and erroneous report of the facts that have been presented to you. I believe that your job to report the facts about a news event carries a responsibility to be accurate and honest. This article is neither.

Please consider the position that I have stated early in this letter and realize the demands that the county puts on employees just to carry out their job requirements. We then make efforts to be fair and reasonable when making employee demands on one hand and then expending funds on the other hand.

Garza County holds that its dealings with the citizens are due and demand the highest standards.


