Human skeletal remains recovered Sunday at LAH

Human remains were found floating in Lake Alan Henry early Sunday evening by a Lubbock family boating on the lake.

The body, which was clothed and intact, was discovered at about 7 p.m. between the public boat ramp and the dam, or about three-quarters of a mile from the dam, according to Constable Daniel Yarbro.

The remains were turned over to the medical examiner's office in Lubbock for an autopsy and possible identification.

The body was recovered in an area close to the scene of a boating accident that occurred 15 months ago, Yarbro said.

Brownfield resident Aaron Smith, 45, was a passenger in one of the two boats that collided in that accident, which occurred on April 23, 2005. Despite numerous searches of the lake, Smith has been missing since the accident and presumed dead.

Yarbro said autopsy results "will take some time."

Post ISD realizes major climb in certified values

Certified values for property within the Post Independent School District took a significant jump, according to a report delivered to district trustees July 11.

A report from the Garza Central Tax Appraisal District delivered to the school board shows values that will be used to figure taxes for the 2006-2007 school year marked a "pretty big increase," according to Post ISD Superintendent Marlin Marcum.

Values within the school district totaled \$534,669,530, meaning that each penny of the tax rate will generate \$53,466 for the school district.

The board reviewed revenues for the coming school year and established spending priorities.

Work on the budget and tax rate continues. Once a proposed budget and tax rate are determined, the proposals will be subject to public hearing prior to being voted on at the Sept. 29 meeting of trustees.

In other business, board members:

- Set as recommended by the state a \$2,000-per-year pay raise

for each teacher in the Post ISD.

Hired 10 new personnel, which Marcum said satisfies the bulk of the school district's vacancies. New hires include teachers Kimberly Reiter, Candus Dawson, Cathy Sawyer, Nonnie Peters, Betty Smith, Sandra Harper, Kathi White and Thomas Greenwood; Mitchell Moses, a coach/teacher; and Nora Bryan, counselor.

- Approved a budget amendment.
- Reviewed the tax appraisal district's budget.
- Tabled action on worker's compensation coverage.
- Reviewed and approved, with some suggested changes, the district's student and employee handbooks.
- Approved the District and Campus Improvement Plans.
- Received the superintendent's report, which included an update on the construction of the new cafeteria. Marcum said the project is currently ahead of schedule and on budget.

Classes for the Post ISD will begin Aug. 14. New teacher in-service begins Aug. 7, while the remainder of the district staff will report for duty Aug. 8.

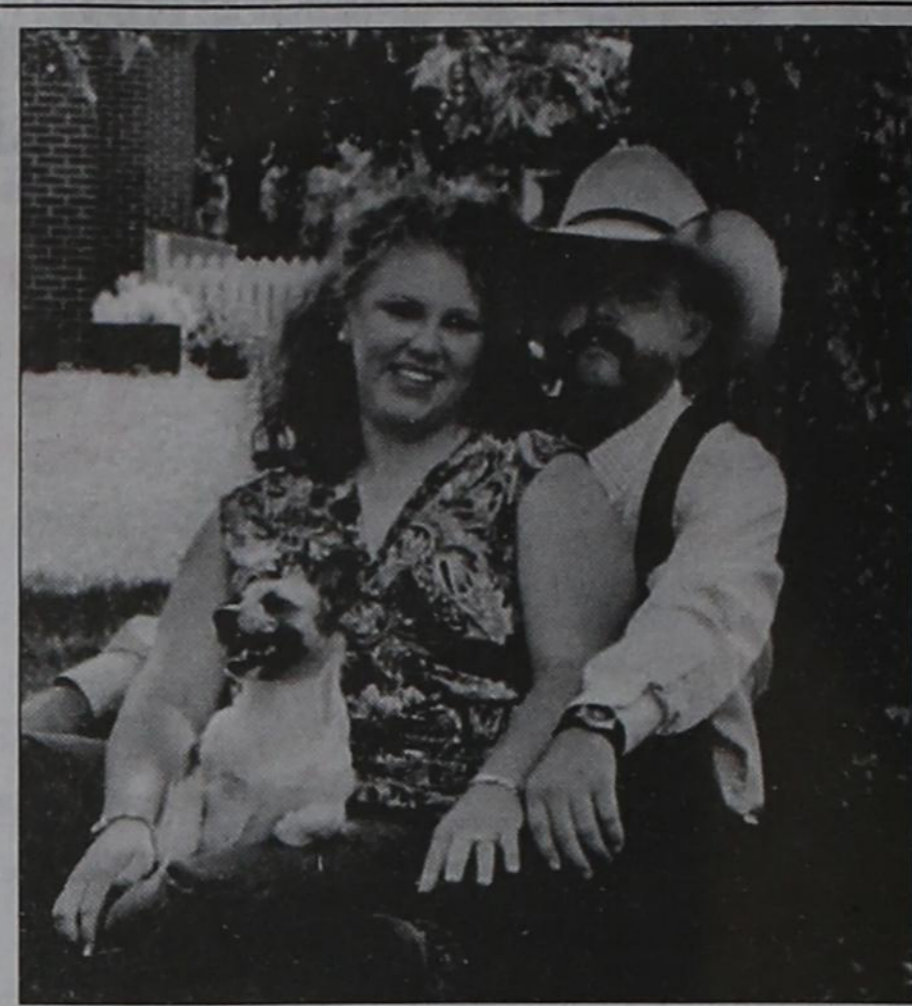

Walker earns degree, working on master's

Patrick Shane Walker of Lubbock, formerly of Post, graduated with a degree in political science from Stanford University on June 18.

He already is working on a master's degree, having been admitted to the university's master's program simultaneously with his final year of undergraduate degree work.

In each year of his collegiate career, Walker was included on the National Dean's List, which represents the top half of 1 percent of all college students in the nation.

The son of Pat N. Walker and Carlina L. Walker, Walker is a native of Post and attended classes at the First Baptist Church Christian School through the fourth grade. He said he attributes his passion for learning to the First Baptist Church Christian School preschool classes where

he learned the value of hard work and an inquisitive mind under the guidance of Mary Margaret Norman and Nancy Flannigan.

Under their influence, Walker also was introduced to wonders of travel, which remain a part of his life. As a junior at Stanford, he joined a "semester at sea" program that allowed him to visit and study several Western European countries.

After moving to Lubbock, Walker was enrolled in Frenship Middle School and placed in the school's gifted and talented program. It was during this time of his life that Walker's father promised him a trip to Europe if he maintained academic excellence and earned admission to a top university.

Walker graduated as the Frenship High School Class of

2002 valedictorian, never having received a grade lower than an 'A.' He was accepted to six of the top universities in the nation, including Stanford.

Earlier this month, Walker and his father left on a six-week tour of Italy, France and England. During the trip the two will visit World War II battle stations and the ancestral homeland of Ireland. After returning to the U.S., they will visit the World War II moment in Washington, D.C., Gettysburg and Liberty Island, in honor of their immigrant parents.

Walker has plans to serve in the Peace Corps, AmeriCorps or the military after completing work on his master's degree. Following that sabbatical, he plans to enroll in law school in preparation for a career in public service.

**GCHD clinic realizes
June profit of \$15,231**

The Garza County Hospital District clinic posted another financially successful month in June, totaling more than \$15,231 in profits, according to a report delivered July 20 to district board members.

According to the monthly clinic report, the PNS-operated clinic recorded 671 visits, 1,200 procedures and had revenues of \$56,854 and expenses of \$41,623 for the month.

With last month's profits, expenditures for recent upgrades to the clinic now have been covered, and Dr. Ben Edwards, the clinic's physician, was able to draw his first bonus, according to the report.

In other business, district board members:

- Received a report from the board's Wayne Edwards, who reported that he and Ray Bagby are continuing to look at potential sites for a new clinic facility and talk to people around town about the proposal. Edwards said the proposal for a new clinic remains a priority, although no decisions yet have been made as to what direction the hospital district may pursue. No action was taken following the report.
- Tabled action on the employee personnel policy.
- Approved the sale of foreclosed property at 107 E. 4th St., Lot 4, Block 155, Original Town of Post.
- Approved financial statements and bills.
- Received the indigent care report. The month of June began with 14 clients. Two were screened, one approved, and one client no longer qualified for indigent care. The program ended the month with 14 clients. Total expenses for June were \$4,559, with a year-to-date total of \$26,889. A total of \$73,110 remains in the indigent care budget for the current fiscal year.
- Heard from district administrator Shirley Taylor, who presented a copy of the Garza County Tax Appraisal District's adopted budget. Taylor also presented an updated board member list.

The hospital district's next regular board meeting is scheduled for 6:30 p.m. Aug. 17 in the Citizens Bank Community Room.

On God's Word

The Church is at home...Part 1

Let's take some time to let God's word teach us about the church.

The word church came from the earlier known Greek word *ekklesia* which basically referred to an assembly of people and must be understood according to the context. According to Acts 19, a church was spontaneously convened in Ephesus after the apostle Paul had spent many days teaching the Gospel of Jesus Christ. Two of Paul's companions, Gaius and Aristarchus, were captured and hauled into a theatre or stadium. According to verse 32, "the assembly was confused." The word assembly comes from the exact same Greek word as church, *ekklesia*. Based on the context, this church was not an assembly of believers.

The churches exist any place where believers meet for fellowship. At the same time the church ultimately exists and lives in the homes of believers. Romans chapter 16 includes a long salutation to a number of Christian believers. Paul starts with Phebe who was considered a servant of the church in Cenchrea. Next he greets Priscilla and Aquila and the church in their home (Romans 16:3-5). He salutes them who are of the household of Aristobulus (16:10), and them of the household of Narcissus who are in the Lord (16:11). Then he finishes with, "the churches of Christ salute you."

Paul starts his letter to the Corinthians with, "Unto the church of God which is at Corinth, to them that are sanctified in Christ Jesus, called to be saints, with all that in every place call upon the name of the Lord" (1 Corinthians 1:2). In this same letter Paul relayed, "Aquila and Priscilla

salute you much in the Lord, with the church that is in their house" (1 Corinthians 16:19).

In Paul's letter to the Colossian believers he writes, "Salute the brethren which are in Laodicea and Nymphas, and the church which is in his house" (Colossians 4:15). He also writes to Timothy saying, "For if a man knows not how to rule his own house, how shall he take care of the church of God?" (1 Timothy 3:5). If a man does not make sure that God's love is living in the overall life of his family and home, then how can he spiritually take care of the church of God in his home?

Paul salutes the church in Philemon's home, "Paul...and Timothy our brother unto Philemon...and to the church in your house." (Philemon 1:1-2). If we applied Paul's letter to Timothy, we could say if Philemon does not know how to rule his own house, then how could he possibly take care of the church of God in his house.

Imagine going to church in a believer's home. The small group gathers together in the living room singing songs together, praying and listening to a teaching. Afterward, some stick around and share stories of how God has been working in their lives during the week. Maybe somebody needs ministering during this sweet time of fellowship. Or somebody else sits at the dinner table after the organized meeting and listens as a stronger believer opens up the word more perfectly. It is possible...it is very much possible.

Why are Americans so angry?

I have been involved in politics for over 30 years and have never seen the American people so angry. It's not unusual to sense a modest amount of outrage, but it seems the anger today is unusually intense and quite possibly worse than ever. It's not easily explained, but I have some thoughts on this matter. Generally, anger and frustration among people are related to economic conditions; bread and butter issues. Yet today, according to government statistics, things are going well. We have low unemployment, low inflation, more homeowners than ever before, and abundant leisure with abundant luxuries. Even the poor have cell phones, televisions, and computers. Public school is free, and anyone can get free medical care at any emergency room in the country. Almost all taxes are paid by the top 50% of income earners. The lower 50% pay essentially no income taxes, yet general dissatisfaction and anger are commonplace. The old slogan "It's the economy, stupid," just doesn't seem to explain things.

Some say it's the war, yet we've lived with war throughout the 20th century. The bigger they were the more we pulled together. And the current war, by comparison, has fewer American casualties than the rest. So it can't just be the war itself.

People complain about corruption, but what's new about government corruption? In the 19th century we had railroad scandals; in the 20th century we endured the Teapot Dome scandal, Watergate, Koreagate, and many others without too much anger and resentment. Yet today it seems anger is pervasive and worse than we've experienced in the past.

Could it be that war, vague yet persistent economic uncertainty, corruption, and the immigration problem all contribute to the anger we feel in America? Perhaps, but it's almost as though people aren't exactly sure why they are so uneasy. They only know that they've had it and aren't going to put up with it anymore.

High gasoline prices make a lot of people angry, though there is little understanding of how deficits, inflation, and war in the Middle East all contribute to these higher prices.

Generally speaking, there are two controlling forces that determine the nature

of government: the people's concern for their economic self interests; and the philosophy of those who hold positions of power and influence in any particular government. Under Soviet Communism the workers believed their economic best interests were being served, while a few dedicated theoreticians placed themselves in positions of power. Likewise, the intellectual leaders of the American Revolution were few, but rallied the colonists to risk all to overthrow a tyrannical king.

Since there's never a perfect understanding between these two forces, the people and the philosophical leaders, and because the motivations of the intellectual leaders vary greatly, any transition from one system of government to another is unpredictable. The communist takeover by Lenin was violent and costly; the demise of communism and the acceptance of a relatively open system in the former Soviet Union occurred in a miraculous manner. Both systems had intellectual underpinnings.

In the United States over the last century we have witnessed the coming and going of various intellectual influences by proponents of the free market, Keynesian welfarism, varieties of socialism, and supply-side economics. In foreign policy we've seen a transition from the founder's vision of non-intervention in the affairs of others to internationalism, unilateral nation building, and policing the world. We now have in place a policy, driven by determined neo-conservatives, to promote American "goodness" and democracy throughout the world by military force—with particular emphasis on remaking the Middle East.

We all know that ideas do have consequences. Bad ideas, even when supported naively by the people, will have bad results. Could it be the people sense, in a profound way, that the policies of recent decades are unworkable—and thus they have instinctively lost confidence in their government leaders? This certainly happened in the final years of the Soviet system. Though not fully understood, this sense of frustration may well be the source of anger we hear expressed on a daily basis by so many.

Bush countenances Middle East violence

The administration of George W. Bush has done some contemptible things in its five and a half years, but what it's doing now in the Middle East could be a new low. Innocent civilians are dying in Lebanon and Israel, but the administration's position is that the time is not right for a ceasefire. By no coincidence, this is also Israel's position.

At a joint appearance with Egyptian Foreign Minister Ahmed Aboul Gheit, Secretary of State Condoleezza Rice was asked whether the U.S. should tell Israel to stop the brutal bombing of Lebanon; she replied, "We all want a cessation of violence. We all want the protection of civilians. We have to make certain that anything that we do is going to be of lasting value.... We have to deal with underlying conditions so that we can create sustainable conditions for political progress there."

This obviously did not sit well with Gheit, who hastened to speak even as Rice began to leave the podium: "A ceasefire is imperative.... We have to bring it [the fighting] to an end as soon as possible."

But Rice wouldn't let Gheit have the last word, at least not that word: "We all agree that it should happen as soon as possible — when conditions are conducive to do so."

What conditions must be achieved before the killing stops?

Here is what Rice, and President Bush, are saying: we will support a ceasefire when Israel is ready for one. This stance is detestable. It should shame all Americans.

If you want to understand the evil here, imagine assembled in a large room all the hundreds or thousands of Lebanese and Israelis who will die or be injured in the next several weeks that Israel says it needs to achieve its goals. Now imagine President Bush addressing them:

"Ladies and gentlemen, you and your children will be killed or maimed in the coming weeks. I'm sorry about that, but the conditions are not conducive to a ceasefire. I'm sure you all understand."

During her press appearance Rice explained that the Middle East has been racked by violence for years and thus needs conditions that will make a sustainable peace possible.

With that in mind, Mr. Bush might tell the assembled future war casualties, "Yes, the hostilities could stop immediately, and you would be spared—but only until war broke out again, maybe months or years from now. So I'm sure you can see why we don't support a ceasefire until it can be permanent."

How many of the assembled would think, "He's right. What's the point of my children and me living a few more months or years if we might be killed anyway should things flare up again? I agree. We might as well die now."

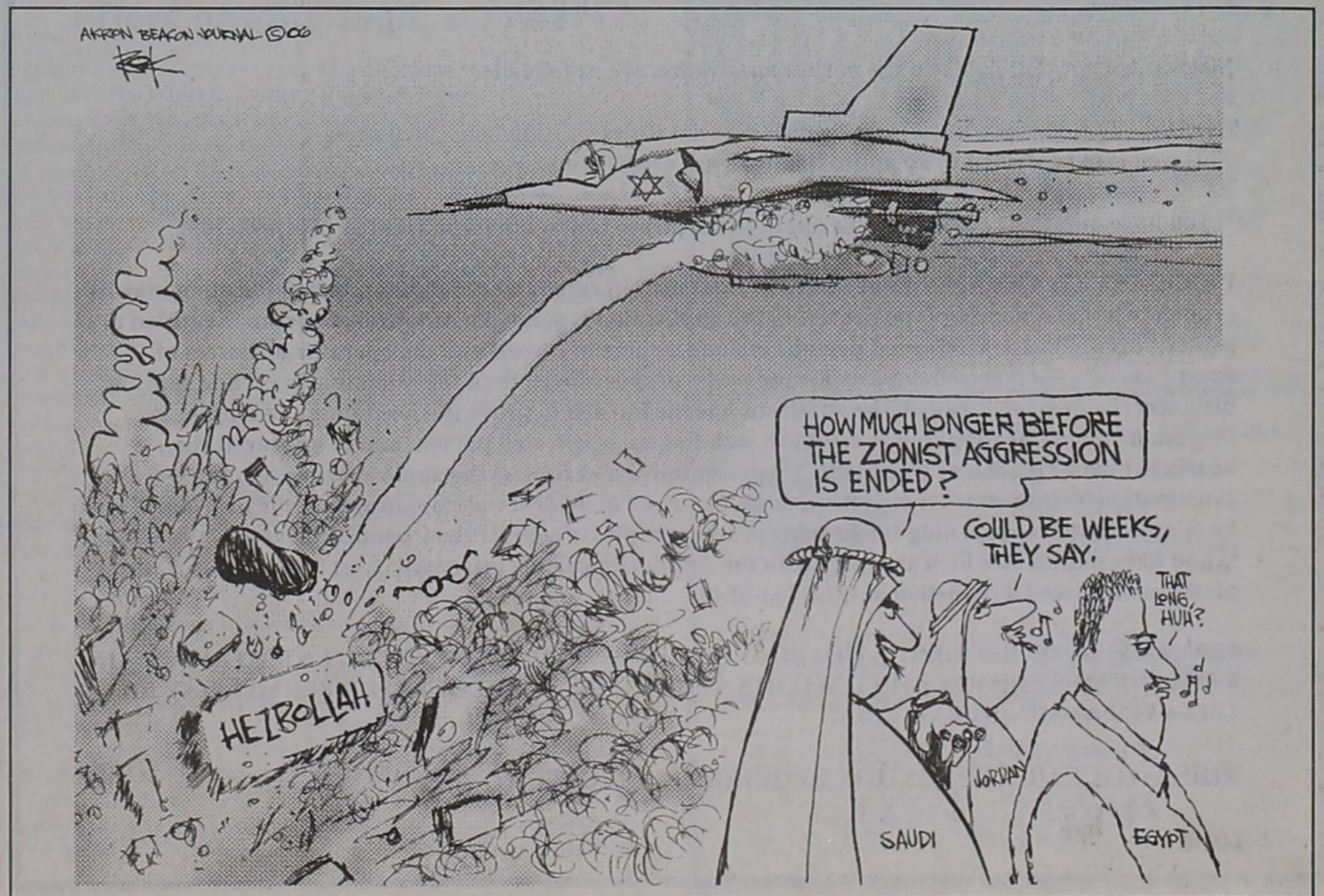
To ask the question is to answer it. All the soon-to-be-dead-or-mutilated would be desperate to take their chances with an immediate ceasefire. How dare these politicians play God with their lives?

One is at a loss for words to express how outrageous the

administration's position is. The least any decent, civilized person can do under the current circumstances is demand an immediate end to the killing on both sides. To say, as Bush and his minions say, that the killing may go on until one of the parties has accomplished its goals is to countenance murder and mayhem. This is nothing less than moral depravity. And it is not mitigated by Bush's meaningless request that Israel "limit" civilian casualties and damage to infrastructure.

What will it take to make the American people see that "their" government behaves like a criminal gang?

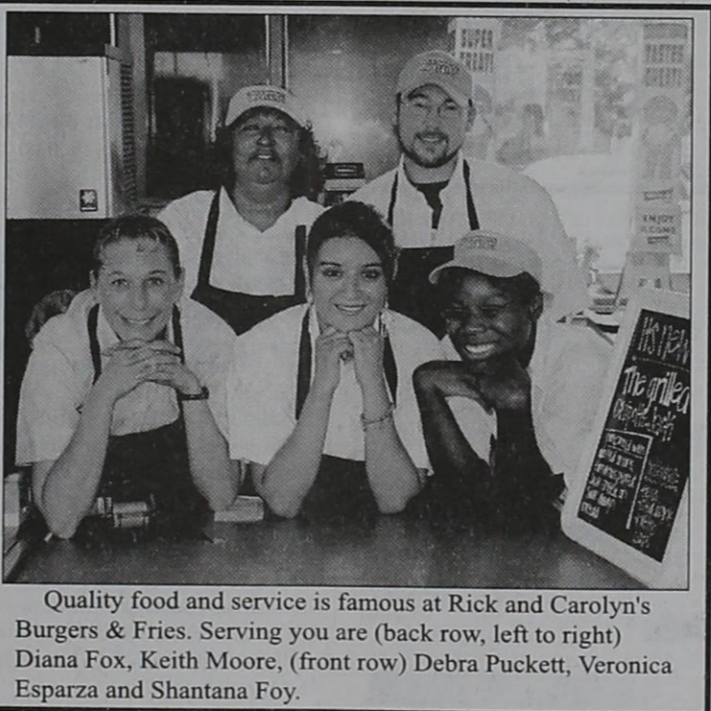

LAH Water Quality Monitoring Plan

In 1994 the City began a water quality Sampling Program to establish baseline water quality data as Lake Alan Henry began to fill.

Water samples are collected from four (4) separate locations and analyzed monthly.

The City then tracks the data from year to year to determine trends and fluctuations of various parameters. Some of the indicators analyzed on-site include pH, temperature, conductivity, salinity, clarity of water and reduction/oxidation coefficient.

After the water samples are collected, they are delivered to

City labs for further chemical analysis.

Further data collected include total dissolved solids, nitrates, nitrites, total phosphorous, suspended solids, chlorides, sulfates, fluorides, alkalinity, fecal coliform, and oil and grease (Petroleum Hydrocarbons).

Currently, water quality analysis shows that Alan Henry's water quality is very good for a West Texas lake.

Cotton Market Weekly

July 23, 2006
Cotton futures on the New York Board of Trade ended lower for the week after rallying Wednesday in response to USDA's July supply/demand report.

July's 2006-07 U.S. cotton forecasts included offsetting reductions in supply and demand which left ending stocks unchanged. USDA reported U.S. production was reduced marginally to 20.5 million bales, despite larger planted area in the department's June 30 acreage report, as drought was expected to raise abandonment in the Southwest region well above the historical average. Domestic mill use was reduced to 5.5 million bales based on recent lower consumption levels. Exports were reduced to 16.6 million, consistent with the lower available supply.

The world's 2006-07 balance sheet is expected to have offsetting production and consumption. World cotton production was reduced mainly in the United States and Australia while consumption was reduced mainly in India, the United States, Korea, and Thailand. World trade was virtually unchanged, and the world stocks forecast was raised less than one percent.

For 2005-06, marginal adjustments in U.S. domestic mill use and exports, which reflect recent activity, reduced estimated ending stocks 100,000 bales to 6.5 million.

"It's still a very 'show me' market that's not easily convinced by USDA data as concerns for the U.S. crop and some unfavorable conditions in parts of our cotton growing universe appear to be coming to a head," said one market observer. "USDA's first official crop report in August as well as an expected host of new overseas information from USDA attachés, will hopefully put some end to the speculation, or at the very least, give us a little less to speculate about," he concluded.

Meanwhile, USDA reported net export sales of 71,400 bales of U.S. cotton in the week ended July 6 were 70 percent less than the previous week and 64 percent less than the four-week average. Primary buyers for the week were China, Turkey, Bangladesh, and Mexico.

Export shipments of 362,600 bales were eight percent less than the previous week and nine percent less than the four-week average. Major destinations included China, Turkey, Mexico, and Indonesia.

On the spot cotton market, online trading by producers in Texas, Oklahoma and Kansas in the week ended July 13 totaled 9,373 bales compared to the previous week when 15,909 bales were traded. Average prices received by producers in the most recent week ranged from 49.39 to 51.55 cents per pound compared to 49.44 to 50.42 cents per pound the previous week.

In other news, mostly open skies were reported this week in the Texas Rio Grande Valley, and producers there are preparing for the upcoming harvest. Picking is expected to begin soon on more mature fields. Seasonable temperatures persist in the Upper Coastal Bend, and moisture would be welcome to help fibers in bolls to fully mature as the plants are entering the heavy fruiting stage. Intermittent thunderstorms moved through the Texas High and Rolling Plains this week with some producing detrimental high winds. Although it is too early to assess the damage to the crop, some fruit loss is expected.
