### Judge Dalby earns **Judicial Award**

It seems only fitting that Garza County Judge Giles W. Dalby was the first recipient of the Giles W. Dalby Award for Judicial

Dalby, who will retire at the end of the year after 34 years of and by noon on Thanksgiving service to Garza County residents, was presented with the award at a Nov. 16 reception dinner for retiring county judges hosted by the Texas Association of Counties and the Texas Judicial Academy.

The award was established to recognize Dalby's "character, integrity and service to the judiciary, county government and community," according to the wording on the plaque awarded to

During his more than three decades of community service, Dalby has held leadership roles in several organizations, including past president of the West Texas County Judges and Commissioners Association and the Texas Association of Counties, as well as chair of the Texas County and District Retirement System and the Judicial Education Committee.

In 2004 he was awarded TAC's Trailblazer Award.

"From his early days in office when he personally defended county government on the steps of the Capitol during the constitutional convention of 1974, he remained an active leader," Sam Seale, TAC executive director, said during the reception. "He has served as a role model, mentor, supporter and friend to us all and indeed, set the standard for this important public service.... We felt there would be no better way to demonstrate our deep-felt appreciation and admiration for him than to make sure that the role he has established in his service remain a goal for county judges in the future."

Dalby will retire as the longest-tenured constitutional county judge in the state.

#### Local search for missing woman rescheduled for this weekend

Inclement weather conditions forced the postponement of last weekend's local search for a missing Lubbock woman, but the promise of warmer temperatures Saturday has prompted organizers to reschedule the event.

Gary Pringle of Lubbock, who has extensive experience as a private investigator, is organizing the search that will begin at 11 a.m. in the Post City Park - weather permitting. Volunteers are needed to help search up to three areas of Garza County.

#### Local men arrested in November burglaries

Two local men were arrested on Thanksgiving Day in connection with a pair of burglaries that occurred the same week.

Officials with the Garza County Sheriff's Department arrested Owen Gilbert Jr., 21, of Post and Preston Scott Washington, 18, who claims Post and Lubbock as his home. The arrests were made as a result of evidence recovered at the scenes, Deputy Tommy Binford said.

On Nov. 21, personnel with the Phillips 66 Grubs #2 reported a burglary. Large amounts of food products and Carmex lip balm were taken, Binford said. Entry was gained by force.

Early on Thanksgiving, a plate glass window was broken, allowing entry into the local Radio Shack. Watches, speakers, MP3 players, cell phones, an electric guitar and \$300 in cash were taken. The burglary was discovered the same day.

Both burglaries were reported to the sheriff's department, one of the individuals believed to have been involved was in custody. He confessed to both incidents, as well as a break-in at the Phillips 66 that occurred in June, Binford said.

Three hours later, the second individual was arrested.

Most of the property taken in the burglaries was recovered.


#### Two juveniles arrested for vandalism at gins

A pair of local youths was arrested late last month in connection with vandalism and a burglary that occurred Nov. 4 at the Graham and Close City

The males, ages 14 and 16, were taken into custody by Garza County Sheriff's Department officials on Nov. 21 and were being held in the juvenile detention facility, according to reports. The names of the teens were not

released because of their ages. The arrests were made as a result of tips called in to the sheriff's department, Deputy

Tommy Binford said. On the morning of Nov. 4 Close City Co-op Gin personnel went to work to find substantial damage. Using a forklift, vandals had picked up a four-wheeler and dropped it on its side and the forklift's forks were jammed into the smaller vehicle. The four-wheeler then was rammed

into the side of the wood-frame office, causing damage to the wall and the window.

Grounded pipes that serve as part of the gin's scales were damaged, and a wheelbarrow was flattened. Also, a pipe that extends through the air from the gin to the burr house was pulled apart. Gin workers found one of the forklifts still running when they arrived.

Binford said the amount of damage done to the Close City facility qualified as a felony criminal mischief, a state-jail

felony. At the Graham Gin office, a satellite office of the Slaton Co-op, all of the office windows were knocked out. A computer,



The Christmas season has officially begun for me. Christmas decorating is done and I've seen "A Charlie Brown Christmas" for perhaps the 30th time! There is nothing more poignant than when Linus steps into the spotlight on the school auditorium stage and explains the meaning of Christmas...by quoting scripture. This favorite scene certainly dates the cartoon. I'm not sure this could happen on a school stage in 2006.

Another lesson from the Charlie Brown Christmas special: You'll remember the very sparse, neglected Christmas tree that Charlie Brown picks. The other kids decide that with a little love and attention, the tree can be transformed. Sure enough...that made all the difference. Let's make an effort to be especially mindful of fellow human beings during this time of year who might also be transformed by some love and attention.

TRADITION OF THE CANDY CANE

I've been doing a little reading about our Christmas traditions and it is interesting to me that many of these originated in Germany.

For example, legend tells us that the candy cane was first introduced in Germany in the 1670s.

A choirmaster handed out "sugar sticks" to keep the children quiet during the long Christmas Eve service. He bent the sticks to make them look like a shepherd's crook. At this time the candy canes were white. The first record of candy canes in our country was in the 1840s when a German American immigrant in Ohio decorated his house with the white candy.

I didn't find information on when the red stripes were added to the candy canes, but one reference states that "all pictures from the 19th Century show the white candy canes," but pictures after 1900 show the red stripes. It is most likely at this time that spearmint and wintergreen flavoring was added to the candy.

Now candy canes are available in many different colors and flavors yet after many, many years the red & white candy remains a favorite for decoration, stocking stuffers and a holiday treat!







#### On God's Word

#### Suffer with the suffering members ... 1 Corinthians 12:14-27

Last week we looked at 1Corinthians 12:14 -27 and learned more about the one body of Christ. According to verse 25 there should be no schism in the body of Christ and the members should have the same care for each other. When one member suffers, all the members will suffer with it. If one member is honored, then all the members will rejoice with it.

There are many examples in today's life that can be applied to the above scripture. I would like to bring up one area in particular. That involves government officials in a country of free people like the united States of America. Within the body of Christ there may be people who serve in government positions whether elected or appointed.

Christians in government positions may lose track of their underlying responsibilities and authorities. Soon they make decisions and pass laws that are unconstitutional and against the law of the land. More often than not, they do it for what seems to be good causes. In the end, the government officials start to feel as if they are being attacked and persecuted.

This is not necessarily the best option.

In all areas of life, the members of the body of Christ can make wrong or hazardous decisions that result in others standing against them and even seeking to punish them. Yes, this can happen to Christians. It is especially tempting to make mistakes when given the power of State and local government. With good intentions, they believe a good cause is served by using the power of the State to legislate and enforce rules for areas that may or may not be against God's will. While there are many people who like the codes that regulate underlying constitutional rights, there are many other Christians who stand and speak out against the same regulations.

This puts the body of Christ in an interesting situation. Christians in government positions can become targets of heavy scrutiny and even law suits. They become the suffering party. Yet spiritually there is not a conflict when applying 1Corinthians 12:14 -27. In the body of Christ it is possible for the members to suffer with the suffering officials and help them to endure the suffering, while at the same time help them to see their error as well as learn and grow more and more in the Lord.

Although we focused on the area of government officials, this is true for all areas of life. God's people can easily make decisions and do things that result in their own suffering. With God's love, grace and mercy, we can still suffer with them with out condoning their actions that lead to the suffering.

## The passing of a giant

by Walter E. Williams

liberty as society's highest end will always remember his steadfast support of treating abuse as a medical problem. the principles of personal liberty.

Professor Friedman, above all, was an economist's economist. During his professional life, his research on statistical techniques, consumption behavior and monetary theory became part and parcel of today's accepted wisdom among economists. His research on monetary theory and the role of money in an economy has provided central banks worldwide with the knowledge, whether they use it or not, for monetary stability.

Professor Friedman will surely be remembered for these intellectual contributions, but what he'll be remembered for the most is his steadfast support for personal liberty. In 1947, he joined with Friedrich Hayek and 40 other free-market academics, mostly economists of international distinction, to form the Mont Pelerin Society. The Society's founding purpose was to reduce the academic isolation among liberty-oriented scholars at a time when socialism was seen as the wave of the future.

The Mont Pelerin Society now boasts more than 500 members worldwide, eight of whom have been Nobel Laureates. I'm proud to be a member.

Friedman's first big step into public policy issues, as an indefatigable defender of personal liberty, came in his 1962 book "Capitalism and Freedom." In it he argued that educational vouchers were the solution to poor education; free markets make racial discrimination more costly; government regulations are the primary sources for harmful monopolies; and Social Security is an unfair and unsustainable system. At the time these weren't popular ideas, even seen as heresy, but today they are much more widely accepted.

In 1980, Professor Friedman co-authored "Free to Choose" with his wife, Rose Friedman, which was written as a follow-up to his 10-part PBS series with the same name. Among the topics discussed: The Great Depression was not a failure of capitalism, as so often claimed, but a failure of government,

> Friedman made a major intellectual contribution to the formation of a voluntary army. In testimony before President Nixon's commission on eliminating the draft, General William Westmoreland said he did not want to command an army of mercenaries. Mr. Friedman interrupted, "General, would you rather command an army of slaves?" Gen. Westmoreland replied, "I don't like to hear our patriotic draftees referred to as slaves." Mr. Friedman then retorted, "I don't like to hear our patriotic volunteers referred to as mercenaries. If they are mercenaries, then I, sir, am a mercenary professor, and you, sir, are a mercenary general; we are served by mercenary physicians, we use a mercenary lawyer, and we get our meat from a mercenary butcher."

Whether one agreed or disagreed with Professor Friedman, they found him to be a friendly, witty and tolerant person. My first encounter with him occurred during the mid-1960s while I was a graduate student at UCLA and he was a visiting lecturer. I've since forgotten my statement to him during a lecture, but I recall he had patiently replied, "Walter, you don't really mean that," and proceeded to show me why.

During my guest-hosting stints on the Rush Limbaugh show, Professor Friedman was a guest on several occasions. His responses to caller questions demonstrated the real teacher in him — the ability to explain complex phenomena in a way that ordinary people can readily understand.

In terms of his scholarly output and worldwide contributions to ideas on liberty, Professor Milton Friedman was the 20th century's greatest econo-

## End the other war too

The war in Iraq goes on, but we shouldn't let it overshadow the war at home — one that frequently takes the lives of people who don't deserve to die. It's known as the War on Drugs, but it's really a war on people who themselves are not making war against anyone. Too often individuals minding their own business are killed by government officers. In the name of decency, this war

By now many people have heard that an 88-year-old Atlanta woman who lived alone was shot dead November 21 by police raiding her home on the basis of a confidential informant's claim that he had bought crack cocaine from a man at that location. However, according to the Atlanta Journal-Constitution, the unidentified informant says the police told him after the shooting to email. lie about the drug buy.

Kathryn Johnston, whom the newspaper said was "described by neighbors as feeble and afraid to open her door after dark," was killed as police, executing a no-knock warrant, forcibly entered her home. Johnston fired on the men with a rusty pistol she kept for protection in her rough neighborhood, wounding three police officers. Returning the fire, the police killed Johnston. The injuries to the police were not life-threatening.

The police story has changed several times, raising serious credibility questions. For example, the police said they found narcotics in Johnston's home, but later they said they found only a small amount of marijuana, which is not regarded as a narcotic. The FBI is investigating.

This sort of thing happens all too often. As Radley Balko documents in the Cato Institute White Paper "Overkill: The Rise of Paramilitary Police Raids in America,"

"Over the last 25 years, America has seen a disturbing militarization of its civilian law enforcement, along with a dramatic and unsettling rise in the use of paramilitary police units (most commonly called Special Weapons and Tactics, or SWAT) for routine police work. The most common use of SWAT teams today is to serve narcotics warrants, usually with forced, unannounced entry into the home.

"These increasingly frequent raids, 40,000 per year by one estimate, are needlessly subjecting nonviolent drug offenders, bystanders, and wrongly targeted civilians to the terror of having their homes invaded while they're sleeping, usually by teams of heavily armed paramilitary units dressed not as police officers but as soldiers. These raids bring unnecessary violence and provocation to nonviolent drug offenders, many of whom were guilty of only misdemeanors. The raids terrorize innocents when police mistakenly target the wrong residence. And they have resulted in dozens of needless deaths and injuries, not only of drug offenders, but also of police officers, children, bystanders, and innocent suspects."

The fact is, without the War on Drugs atrocities such as the killing of Kathryn Johnston wouldn't be happening. It is the very nature of victimless crimes that pushes the police to use unscrupulous tactics. In a victimless crime, such as an illegal drug transaction, there is no complaining witness, no one with an interest in reporting the crime to the police. After all, the buyer and seller willingly participate in the transaction. Thus, the only way the police can detect the criminal activity is to set it up themselves or encourage informants. But the opportunity for corruption in these tactics is immense. For example,

informants looking for a favor from the police have an incentive to provide false information. You have only to read the newspapers to find details of corrupt law enforcement in connection with drug prohibition.

In a free society adults have the right to ingest whatever they want. It's no business of the government. But if it makes such peaceful private activity its business, law enforcement will inevitably turn to measures that jeopardize the lives of people who have harmed no one else. ### **Monetary Inflation** is the Problem

The financial press reported last week that the value of the U.S. dollar plummeted to a 14-year low against the British pound, and weakened against the Euro and Yen. Many financial analysts predict continued rough times for the dollar in 2007, given reduced expectations for economic growth at home and less enthusiasm among foreign central banks for holding U.S. debt.

This decline in the value of the dollar is simple to explain. The dollar loses value as the direct result of the Federal Reserve and U.S. Treasury increasing the money supply. Inflation, as the late Milton Friedman explained, is always a monetary phenomenon. The federal government consistently wants to spend more than it can tax and borrow, so Congress turns to the Fed for help in covering the difference. The result is more dollars, both real and electronic—which means the value of every existing dollar goes down.

Federal Reserve Chairman Ben Bernanke faces two basic ongoing choices: raise interest rates to prop up the dollar, but risk pushing the economy into a recession; or lower interest rates to stimulate the economy, but risk further declines in the dollar. This unfortunate dilemma is inherent with a fiat currency, however.

Of course Mr. Bernanke inherited this tightrope act from his predecessor Alan Greenspan. The Federal Reserve did two things to artificially expand the economy during the Greenspan era. First, it relentlessly lowered interest rates whenever growth slowed. Interest rates should be set by the free market, with the availability of savings determining the cost of borrowing money. In a healthy market economy, more savings equals lower interest rates. When savings rates are low, capital dries up and the cost of borrowing increases.

However, when the Fed sets interest rates artificially low, the cost of borrowing becomes cheap. Individuals incur greater amounts of debt, while businesses overextend themselves and grow without real gains in productivity. The bubble bursts quickly once the credit dries up and the bills cannot be paid.

Second, the Fed steadily increased the monetary supply throughout the 1990s

So what are we to make of the fact that conservative Americans donate 30 percent more to charity than liberal Americans? A new book called "Who Really Cares," by Syracuse University professor Arthur Brooks, is not going to please the Howard Dean crowd. The book states flat out that religious Americans who vote Republican are far more likely to be generous to the downtrodden than secular-progressives.



The statistics say that religious Americans give four times as much money to charity each year than secular people and are 23 times more likely to volunteer to help people than folks who never attend church. And here's another crushing stat: If liberals donated blood at the rate conservatives do, the nation's blood supply would rise 45 percent.

So in this season of giving, Christmas, a word some liberals don't like to say, it might be worth pondering just who is really looking out for the have nots. The leftist media often portrays conservatives as mean, cruel and insensitive to the plight of the downtrodden. But, as the tax returns of multi-millionaires Dick Cheney and Al Gore prove, the media image is false. The vice president gives millions to charity, Mr. Gore very little.

So the next time you hear a big government liberal bloviate about helping the poor, please trot out the statistics mentioned in this column. And then tell that person that in America today giving money to charity seems to be the right thing. What's left is not even close.



#### Boys Will Be Boys...But Do You Know Why?

There's more to understanding and getting along with boys and young men than the old adage "hammers and nails and puppy dog tails." "A male's way of thinking, emotional processing and physiological characteristics influence his behavior and relationships," said Steve Talbert, counselor with the Lubbock Independent School District.

"Recognizing this can help you work better with the young men in your life, in home, school or community situations."

In the first two to five weeks of life, a fetus receives its biological programming from its DNA. Those destined to become males undergo a testosterone wash throughout the body. This wash imbues the fetus with more muscle mass, a higher sex drive, higher levels of aggression and male physiological characteristics, Talbert said.

"Aggression in this context means competitiveness," he said. "Testosterone also imparts three distinctive behavior patterns in males. The first is a search for instant or quick gratification.

The second is a tendency to move quickly into problem solving. The third is a tendency to prefer activities which allow physical expression."

This biological wiring also affects how boys and young men deal with their feelings and emotions, he said.

For example, boys often release their feelings in quick bursts of displayed energy by slamming doors, flying off the handle or hitting something. This is action-release expression, Talbert said. Males are also hard-wired for suppression/delayed reaction.

They often delay or "stuff" their emotions because their brain moves them quickly into problem solving mode.

"Problem solving, connecting their feelings with a safer object, helps them process and then release their emotional energy. Experts call this displacement objectification.

"Because males are hardwired for these responses, boys and young men may need some guidance for expressing their emotions. "When you see a boy crying, understand that he is processing hard emotional data at a fast and confusing rate," Talbert said.

"Help him find a comfort zone. Let him retreat and process the emotional data, but let him know you will help him put it in perspective when he emerges."

The physical expression that boys and young men often display is sometimes misunderstood, Talbert said. "Physical expression/aggression is how boys connect with others," he

"But don't confuse this with violence. Aggression is hardwired in their brain. Violence is a learned behavior.

"You have to allow for some testosterone-driven aggression, but it should be tempered and directed by nurturance from an Alpha male.

Boys and young men learn appropriate male behavior from adult men. They have to learn how to appropriately express

their aggression." When boys and young men act out inappropriately, they need discipline but the discipline should be directed solely at the behavior.

"Punish the behavior, not the person," Talbert said. "Don't shame boys. This can wreck their self-esteem, especially in the company of their peers. Provide a clear explanation of right and wrong behavior, and the purpose of the rules you

"Keep an open line of communication. Make regular dates to talk to them. Connect with them through action and activities. Discuss their problems honestly and focus on solutions. Listen to them, but don't lecture, let them know that you understand.

"Don't wait to talk to them about sex, drugs and other tricky topics. Provide a safe environment for your communication with them. These things will go a long way in helping you understand the 'manly men' in your life."



The team competes at the Borden County Tournament this


#### Grisham tapped for honors team





need to house federal, low-security, adult, male, non-U.S. citizen, criminal aliens. The EA considers potential impacts to the natural and manmade environments including land use, economics, air quality, noise, transportation, utility services, cultural, aesthetic, and hydrological and biological resources, among other topics at each facility. The Bureau is seeking comments on the EA. The 30day comment period will end on January 11, 2007. Comments concerning the EA should be sent to: Pam Chandler, Chief,



#### Search for missing woman continues this weekend

Tuesday. "If I have 10 I'm going to search. This is a prime area where she could be."

Eighteen local residents turned out last Saturday to participate in the search, but Pringle said extremely cold temperatures helped lead to the decision to postpone the event.

"I'd really like to encourage those 18 people to come back out," he said. "I really appreciate their interest in helping out and hope they

The subject of the search is 61-year-old Peggy Merimon, who disappeared Aug. 9 along with a co-worker from the Lubbock State School. The two were last seen getting into a rusty silver- or gray-colored older-model Buick or Dodge driven by a Caucasian man.

Merimon's co-worker, Kay Harrelson, was found dead near Shal-

Pringle said he wants to search three areas in Garza County: just above the Caprock around the deserted roads and buildings leading up to the Macy Ranch; along Hwy. 380; and south of Post at a roadside area surrounded by brushy, overgrown terrain. These areas have been singled out because a suspect has been identified, and cell phone records indicate the suspect may have traveled to these locations shortly after the Lubbock women disappeared.

According to Pringle, the suspect was in Post on the Friday night immediately following the disappearance of the women in August. It is believed the suspect slept in his car, which was parked near the flags on the Garza County courthouse square, and traveled to Possum Kingdom Lake during that weekend.

Merimon is described as being between 5 feet, 6 inches and 5 feet, 8 inches tall and weighing approximately 150 pounds. She has green eyes and brown hair with red highlights and was last seen wearing black Capri pants, a white T-shirt and an oversized blue Oxford shirt with the sleeves rolled up. She also was wearing reading glasses and had a pink ribbon in her hair.

Pringle said searches for the missing woman are planned for each Saturday. The local search will begin at 11 a.m. to allow Pringle to get the Lubbock search under way, then travel to Post to oversee the effort in Garza County.

The search in Garza County likely will run until about 5 p.m. Pringle asked that anyone interested in participating who has a "gentle riding horse" that he could use during Saturday's search should contact him at 806-554-9856.
