■ Roll of Honor monument recognizes nearly 200 of Garza County veterans

The east lawn of the Garza County Courthouse contains the Centennial Plaza that pays tribute to our county heritage. The engraved bricks contained in the area provide a history lesson that was especially moving if you were an early voter for the recent General Election.

courthouse to cast your early vote, you passed a poignant reminder of the Garza County freedoms we enjoy.

The veteran's section of the Plaza contains almost 190 engraved bricks commemorating

The Union Army veteran honored, Lewis W. Coleman, was the grandfather to Post resident Annie Laura Francis. "My grandfather was born in Tennessee and joined the Union Army because he didn't believe in slavery," Mrs. Francis explained. "He & his wife moved to Texas in 1916 and bought a farm in Garza County. He died in 1938 at the age of 94."

Great grandfather of Post resident Carol Confederate Army. His memorial brick states that he served from 1861 to 1865. Mrs.

Laws, Brannon win local contests

The 2008 General Election proved to be an historical event the entire country. Although 148. first African-American to hold the office of President, Garza County voters and the State of Texas disagreed. In this county, McCain/Palin received 1355 votes; Obama/Biden 375 and Libertarian candidates Barr/ Root 15.

Early voters in Garza County made history with a total of 1071 votes cast. Total ballots cast in the 6 Garza County precincts reached 1774. This number represented 60% of the registered voters in the county.

In the race for Garza County Attorney featuring two write-in candidates, Mike Munk received 672 votes narrowly defeating Arimy Gradine Beasley with 638 votes. Voters kept incumbent

896 votes. His opponent, Phil Mathews received 835 votes.

Ted A. Brannon defeated Cain Abraham in the Precinct 3 Commissioners race. Brannon for Garza County as well as received 196 votes; Abraham Unopposed county the national vote elected the races included Judy Bush, Tax Assessor/Collector; Gary L. McDaniel, Commissioner Precinct 1; Daniel A. Yarbro, Constable Precinct 1 and Eric D. Cravy, Constable Precinct 2.

Other winners in Garza County were: Joe Heflin, State Representative District 85; Robert Duncan, State Senator District 28; Randy Neugebauer, US Representative District 19; and John Cronyn, U.S. Senator.

Concerning one of the biggest elections in history, Garza County Clerk Jim Plummer said, "Many people spent many hours to prepare for this election and it paid off for all involved. I was very impressed with the professionalism exhibited by the poll workers, the ballot board County Sheriff Cliff Laws with and my office staff."

The last 3 years she attended Verbena, she won a trip to the Carlsbad Caverns for having the highest grade-point in the whole school, then the next year to Pike's Peak and then the last year to the Texas Centennial.

Mary stayed at home to take care of the family and to run the farm when Richard was in the Navy Air Corp during WWII. After the war, Mary & Richard built a home in Lubbock and Richard entered Texas Tech. Mary tutored him through 5 years of college. While he was at home in the evening with the children, Mary went to work as cashier for Walgreen and helped during the day with their real estate business. Before his graduation, Richard opened an oilfield supply business and they moved this business to Lovington, NM in 1950, calling it "Red Bird Company." Mary managed this business for about 15 years until they leased it out. She worked for LeRoy Sumrald after her divorce and then for Gordon M. Cone

as his bookkeeper. She was a lifelong Methodist, being baptized on her 16th birthday in the Lucas family tank, a short distance from the Verbena Church. She was a Sunday School teacher and when she joined First United Methodist Church in Lovington she was active in the Susanna Guild. Hill Country to the High Plains in the panhandle and the rich forests in East Texas, our state is a varied panorama of unique terrain.

As a result, it should come as no surprise that Texas is the second most biologically diverse state in the nation, with hundreds of species of animals and plants who call our state home.

A look at just one segment of nature-wild mammals—reveals the remarkable variety within Texas 'animal kingdom. Texas has more than 180 species of native mammals. Included are deer, coyotes, river otters, bobcats, jackrabbits, and whales in our Gulf waters. Some come to mind more easily than others, such as the state small mammal, the armadillo, and the state flying mammal, the Mexican free-tailed bat.

History helps us recapture some of the first wild mammal sightings in Texas. Notes from the 1854 expedition of U.S. Army Captain R.B. Marcy were published in the book "Through Unexplored

from the rolling green of the Texas Texas." In one episode, the calls of wolves came frighteningly close to their campsite: "An hour had not elapsed, before we had a beautiful concert of whines, yells and barks from a pack of at least one hundred wolves, who ... kept up their hungry serenade until day dawned."

Another mammal spotted by the Marcy expedition, the prairie dog, became known as "an icon of the grassland." The Army explorers entered "an extensive prairie dog town" estimated at 100 square miles, with "a population not to be exceeded by any city in the world." It has been estimated the prairie dog population in Texas peaked as high as 800 million a century ago.

However, over the years, the range of Texas prairie dog towns has shrunk to less than one percent of the area they once occupied, largely because of government-sponsored extermination. Several other mammals were hunted to the point of extinction, while a number declined as they suffered a loss of habitat through expansion of towns, cities and cropland.

The jaguar, red wolf and grizzly bear are some of the mammals no longer found in the back country of Texas. Others that disappeared are making a comeback, including desert bighorn sheep, black bear and bison.

A number of mammals, once domestic, became wild. The feral hog is a prime example. These mammals, notorious for being a nuisance to farmers and landowners, multiply rapidly and rampage through the Texas countryside.

Continuing research and education contributes to greater understanding and respect for wild mammals. The Texas Parks and Wildlife Department and U.S. Fish and Wildlife Service, along with universities, private landowners, wildlife and conservation groups, generate important knowledge. Texas families and individuals can see native mammals firsthand at our 51 state wildlife management areas and 17 national wildlife refuges.

mammals may have faded. But not all is lost, especially if we remember the wisdom of the first Texans. "For the Indians of the Plains, every plant and animal had not only its place but its right to exist in the all-enveloping harmony" of nature, Texan J. Frank Dobie once wrote.

Texas will never revert to its original, natural condition, but knowledge of the past, coupled with renewed concern and care for native mammals and all living creatures, can help accomplish what Texans do best: build a better future.





Weekly Inspirations

GO AND DO LIKEWISE!

This sermon illustration has always stayed in my mind over the years, so this week I would like to relay it you in the hope that the spiritual truth of it may bless you as much as I have been blessed. Throughout the course of history, there has been immeasurable speculation about just exactly what Heaven and Hell might be like.

One very interesting comparison has been this story. A particular man was allowed to see both Heaven and Hell one night in a dream. He dreamed that he first descended into a dark hole which opened up into a cavernous room. In that room there were many emaciated and starving people all sitting around a beautifully prepared and adorned banquet table. There was in the middle of that table a very large bowl of stew which smelled more scrumptious than anything he had ever encountered in his life.

Each person sitting around that table also held in their hands a large spoon. The interesting thing was that the spoon was uncommonly long handled. In fact, the handle to each spoon was so long, that every person at the banquet table could easily reach the pot of stew and dip their respective spoons into the stew. The tragedy was that the spoons were so long, that try as they may, the guests at the feast could not place the stew from the spoon into their mouths. They were in terrible anguish, hunger and suffering. This picture of Hell disturbed him greatly.

The man then dreamed that he left that awful place of torment and arose into a beautiful tunnel of light. At the end of that tunnel, he was once again in a large room, prepared with the very same banquet table. There were numerous guests all around the table, laughing and joyous. And yet, they each held the very same long handled spoons in their hands. The guests all appeared to the man to be well nourished and happy. There was simply one difference. Each of these guests was dipping their spoon into the bowl and feeding each other.

Do you see the difference? Those in that horrible place could only dwell upon their own individual dilemma and therefore, were enraptured in torment and starvation, while those in Heaven were seeking to meet the needs of the other, and therefore, were in abundance and joy.

Such a simple story this may be, but it brings to light a truth that Jesus Christ Himself taught His Disciples in Matthew 22: 37-40, "Jesus replied: "Love the Lord your God with all your heart and with all your soul and with all your mind." This is the first and greatest commandment. And the second is like it: "Love your neighbor as yourself." All the Law and the Prophets hang on these two commandments." NIV

In Luke 10: 25-37 Jesus taught us that same principle in the parable of the good Samaritan, "On one occasion an expert in the law stood up to test Jesus. "Teacher," he asked, "what must I do to inherit eternal life?" "What is written in the Law?" he replied. "How do you read it?" He answered: " 'Love the Lord your God with all your heart and with all your soul and with all your strength and with all your mind'; and, 'Love your neighbor as yourself." "You have answered correctly," Jesus replied. "Do this and you will live." But he wanted to justify himself, so he asked Jesus, "And who is my neighbor?" In reply Jesus said: "A man was going down from Jerusalem to Jericho, when he fell into the hands of robbers. They stripped him of his clothes, beat him and went away, leaving him half dead. A priest happened to be going down the same road, and when he saw the man, he passed by on the other side.

So too, a Levite, when he came to the place and saw him, passed by on the other side. But a Samaritan, as he traveled, came where the man was; and when he saw him, he took pity on him. He went to him and bandaged his wounds, pouring on oil and wine. Then he put the man on his own donkey, took him to an inn and took care of him. The next day he took out two silver coins and gave them to the innkeeper. 'Look after him,' he said, 'and when I return, I will reimburse you for any extra expense you may have.' "Which of these three do you think was a neighbor to the man who fell into the hands of robbers?"

The expert in the law replied, "The one who had mercy on him." Jesus told him, "Go and do likewise."






