

City Council Approves Kate Increase

In a regular meeting of the Post City Council Jan. 6, 2009, the council voted unanimously to approve new water and sewer rates as recommended by the City Manager. These new water and sewer rates will be reflected on the January, 2009 billing.

Earlier this week, Garza County received a Certificate of Occupancy from Roger Fields, representing the Post City Engineer. This approval from the city put the Sheriff's Department one step closer to occupancy of the new jail facility.

"Completion of the Garza County Law Enforcement Center brings the county's investment within the Post city limits over on an annual basis. the past ten years to

approximately \$60 million," explained County Judge Lee Norman. "This includes the construction and expansion

of the Dalby Unit, construction and expansion of the Detention Center and now the jail facility."

During a special meeting of the Commissioners Court on January 1, Judge Norman and the commissioners made a thorough visual inspection of the facility and compiled a punch list of items that would need attention prior to the move to the new building. "Now that we have a Certificate of Occupancy from both the county and the city, we can move forward quickly," Judge Norman said. Dispatcher operations were relocated to the new facility in December. Telephone service should be complete this week.

Sheriff Cliff Laws is looking forward to the time when all offices, operations and prisoners are housed at the new location. "Once we have the prisoners here that are currently being held in Spur and Tahoka, we will no longer be paying those entities," Laws said. "We'll also eliminate transportation for trial and medical care.

This will allow for much more efficient use of Garza County personnel."

Late in December the jail facility received a certificate from Texas Jail Standards stating that the Garza County jail meets all of their qualifications. "Actually, TJS requested pictures of our jail and told us that we had a model facility," Sheriff Laws said. Texas Jail Standards will continue to inspect the Garza County facility In addition to

also have space for constables, the game warden, marketing director, DPS officers and emergency management. When the jail is at full capacity, the staff will be approximately double what it was

at the previous facility. Garza County has projected an annual savings of approximately \$200,000 by having a jail that will have capacity for all prisoners in one location within Garza County. In addition, the county is forging relationships with other entities such as Immigration Customs Enforcement, so they can utilize available space in the county facility to house their prisoners. Agencies that enter into this type of arrangement with the county will pay a fee for the service.

"Our goal is to have a facility that will benefit Garza County and have the means to pay for it," Sheriff Laws explained. "We have also given consideration to the future needs of the county. The priority of law enforcement isn't to make money for the county; however, when possible it should lessen the burden on the county."





Local voters returned the incumbents to the Post City Council, but opted to usher in a pair of fresh faces to round out the Post ISD board of trustees. In the municipal election, Tommy Basquez earned 46 votes to retain his Ward 3 council Post, defeating Janet Dean, who had 35 votes, and former council member Josh Whiteley, who received 16 votes, according to reports from City Hall.

A Post man who was serving a 30-year sentence before he was relased 29 1/2 years early has been re-arrested and returned to the custody of the Texas Department of Criminal Justice.

During their May 28 meeting, Garza County Commissioners failed to approve the reimbursement of funds to the City of Post for a joint project authorized by the county two years ago.

Trustees for the Post Independent School District discussed budget development during their May 20 meeting. Revenues, projected revenues and expenses based on payroll projections were the primary topics discussed, according to Superintendent Marlin Marcum. A portion of the discussion focused on what plans trustees have for payroll for the

coming year, he said. Members of the Post city Council and the Garza County commissioners Court met in joint session to discuss the coming fiscal year. County Judge Lee Norman asked Post City Council members to pay 50percent of the law enforcement budget and urged the entities to enter into an inter local agreement concerning law enforcement efforts within the city and





### ARE THESE THE GOOD OL' DAYS? - Part 2 How 60 years of game management has enhanced wildlife populations

By Russell A. Graves

Big game

In 1945, Texas big game was already recognized as a significant source of recreation and income for hunters and landowners. Partly due to poor land use practices and screw worm infestations, white-tailed deer were relegated mostly to the Hill Country and South Texas, with pockets of deer in suitable habitats scattered over much of the lower two-

thirds of the state. Today, it is no secret that whitetail populations are booming. "From 1939 until 1990, TPWD was heavily involved in trapping and relocating of whitetails," says Mitch Lockwood, white-tailed deer program leader for TPWD. "In that time, approximately 34,000 deer were moved from the higher density areas of Texas to those areas with very low numbers of deer."



Lockwood explains that the combination of relocation efforts, white-tailed deer research conducted on wildlife management areas such as the Kerr, and working with private landowners has been key to species population growth from 238,000 in 1939 to more

than 4 million today. "The contributions of private landowners to the success of Texas white-tailed deer are huge," emphasizes Lockwood. "Almost all of the management takes place on private lands. Private landowners and hunters are the ones doing habitat and population management on virtually all of the Texas deer range. They are setting prescribed burns, removing noxious brush species, and promoting a healthy habitat through their actions."

Because of landowner interest and involvement, other species with smaller statewide ranges are also Call

showing signs of growth. For example, both the mule deer and the pronghorn antelope ranges have expanded in the time since the book's publication. Mule deer, according to the book, were only found in a single pocket in the Palo Duro Canyon in the Texas Panhandle with the majority of the population found in the Trans-Pecos region. Today, mule deer are still found in abundant numbers in the Trans-Pecos and have expanded their ranges over much of the Caprock Escarpment area of the Panhandle and South Plains, as well as in the Red, Canadian and Pease River basins.

Pronghorn antelope, with a range specific to the wide open country of western Texas, nearly doubled in numbers from 1941 until 1990, when a prolonged drought affected their populations over much of their Trans-Pecos range.

"For desert animals like the mule deer, I would have to say that

the good ol' days will come and go with the rain," explains Clayton Wolf, big game program director for TPWD. "Landowners can do things to mitigate circumstances during a drought, but history has shown us that prolonged droughts will have a negative impact on overall numbers. It appears that West Texas is currently in a recovery mode, and mule deer are doing well and have been for several years."

Wolf agrees with Lockwood on the role of private citizens in game animal successes. "The private citizens' role is critical. Most deer were stocked on private lands, and it is private landowners who provided the habitat and the protection during the restoration years. Hunters also played an important role, because without the revenue from the sale of hunting licenses, we

wouldn't have had the resources to trap and relocate deer and enforce game laws." Any questions or comments? Contact Russell at rus-





#### 60 Years Ago January 6, 1949



# un-n-tacts for Brain-iacs THE NOT JUST FOR KIDS PAG

During the Revolutionary War, only one country came to America's aid fighting the British for Independence. France had been our ally and friend. To celebrate this friendship, a French sculptor, Frederic Bartholdi, came up with the idea to build a massive statue to honor our friendship and freedom. The French would

build the statue as a gift to America. The Americans would build the pedestal and base where the enormous statue would stand. The original plan was to have the gift completed by the 100th anniversary of the signing of The Declaration of Independence. Building the largest manmade structure took longer than anticipated (9 years). Only the torch would be displayed (see picture) by the celebration in 1876. But, by 1884, 214 crates were shipped to America. It took workers 6 months to reassemble the massive lady. On October 28, 1886, fireworks lit up the New York Harbor at the dedication of Liberty Enlightening the World. Today she is known as The Statue of Liberty, recognized around the world as a symbol of liberty, freedom and opportunity.

Give me your tired, your poor, Your huddled masses yearning To breath free, The wretched refuse of your Teeming shore. Send these, the homeless, Tempest-tost to me, I lift my lamp beside the golden door.

At the bottom of the Statue of Liberty you will find the above poem written by Emma Lazarus. The young poet sold the poem to help raise money to build the base. Today her immortal words have come represent the meaning behind the lady holding the torch of freedom.



"Liberty Enlightening the World"

The Statue of Liberty has been the focus of many major celebrations. In 1976 thousands of boats poured into New York Harbor to surround the statue and celebrate our nation's 200th birthday. In 1986 the nation celebrated the 100th birthday of the statue with the largest fireworks display in United States' history.
