"He was a very intelligent man. He read and researched a lot," said Vicki Gray, who worked with Cahill at the clinic in Post. "He genuinely cared for his patients and met very few people he did not like." Gray said that she and Cahill talked on the phone "every couple of years" to catch up on family and local news; however, she remembers that it has been 3 or 4 years since they last talked.

Tanya Vernon of Post, who also worked with Cahill, remembers him as "a very caring person." Vernon said that he always joked with her, telling her that intelligent people have messy





It doesn't take much to trigger my memories of Cuba – just low water pressure. That's what I remember about our hotel - the very puny water flow to the bathroom sink. I also remember the bidet. My parents and I analyzed the prominent piece of porcelain and decided it was most likely for washing feet. We didn't.

Here on the farm I know to blame the lack of water pressure on a switch at the well. It's fixable. As for Havana, I sometimes wonder if Fidel Castro got things running better when he took over. Was water pressure at the top of his honey-do list? Was it a guerrilla campaign promise?

If I ever go back to see how things have changed, I'll want to stay at the same hotel. It's just down the street from the alligator factory, for lack of a better name for the place that tried to sell us shoes and purses and suitcases made from alligator hide.

Indeed, everybody in Havana tried to sell us stuff, even a pitiful old woman hawking one lime. Daddy just gave her

> Back to castanets, peddlers sold pairs to tourists. Already carved on one castanet was "Habana," Spanish for Havana. They'd take their pocketknives and carve any person's name on the blank castanet - anyone's name but mine. They simply thought we Anglos couldn't spell "Habana." My monolingual parents were persistent enough, after getting stuck with one "Habana-Habana" pair of the clickers, to get another seller to carve "Hanaba" on a blank one.

The Workforce Solutions South Plains Board of Directors recently approved new income eligibility guidelines for Child Care Assistance provided by the agency. The board recently received additional childcare assistance funding through the American Recovery and Reinvestment Act (ARRA), which was designed to increase the number of children in care for low income individuals. The ARRA funding enabled the Board to establish higher income guidelines.

The former childcare assistance income requirements for the South Plains region were established in 2003 at 185% of the Federal Poverty Guidelines. The new guidelines allow child care assistance to be provided to those individuals whose income is at 75% of the State Median Income Estimates published in the Federal Register. It is estimated that the new eligibility standards will allow childcare funding for eight hundred additional children.

The new criteria became effective October 1, 2009. Workforce Solutions Child Care Services expect to see the increase in both part-time and full-time childcare. For more information on Workforce Solutions Child Care Services, call toll-free 1-800-658-6284.

Ralph introduced himself, and then both men began walking to the baggage claim area to pick up the professors luggage. After only a few moments, the professor noticed that Ralph kept disappearing. Once, the Sergeant stopped to help and elder man walking with the help of a cane who dropped his suitcase spilling all of its contents onto the tiled floor. Next, Ralph paused to give someone directions who appeared to be lost. Then, Ralph stopped to lift up two little boys who were trying as hard as they could to see the Santa Clause in the center of the Airport. Every time Ralph would walk back up to the professor with a large friendly smile upon his face. And, the professor couldn't help himself and asked, "Wherever did you learn to do that?". "Do What?" Ralph responded back

"Where did you learn to treat people the way that you do?", the professor curiously inquired further. "Oh," Ralph said, "Well, I guess it was during the War," Ralph then proceeded to tell the inquisitive professor about his two tours of duty in Vietnam. How it had been his job to clear out mine fields. How he had tragically seen fellow soldiers blown up while performing this vital task to clear the way for troops. And then Ralph taught the teacher an invaluable lesson. "I learned to live between the steps, sir. Because you see, I never knew whether my next one would be the last." he told the professor. "I decided right then and there, to take everything that I could of the moments between when I picked up my foot and when I put it back down. Every step I took was a whole new world. I guess it's been the same ever since then." Ralph concluded. What a powerful lesson for you and I today! And I truly believe that each of us owes a lot to the Ralphs of this country. 



Italian food is one of my favorite things to eat works fine if you aren't a wine drinker and don't as well as prepare.

I came up with this recipe after I saw a similar one in a cook book that called for bacon in spaghetti instead of the traditional ground meat or meatballs. I'm a big bacon fan, peppered bacon to be exact, and I don't think you can go wrong with bacon in just about anything. Heck, I even put it in my chili.

The recipe that gave me the idea had only a few ingredients. As you will see, I've loaded it down.

Over the years, I've tweaked this recipe into a very hearty meal that tends to please those eating it. I've added this here and that there and the following recipe is the final product of a few trials and errors.

I don't really have a name for it except for "My Spaghetti" but I guess you could call it whatever you like. I'll call it "Loaded Spaghetti" for today's column because it is loaded with goodness.

A few tips before the recipe – I prefer to use Hormel diced pepperoni. Also, I always use Angel Hair for this recipe but any pasta would probably do. As with all Italian dishes, this one is better after it sits overnight. If you make the sauce the day before you plan to eat it and refrigerate it. the next day it is all the better. Any kind of sauce works, I've used plenty. The one I prefer is in the recipe.

**Loaded Spaghetti** 

Ingredients 3/4 lb. peppered bacon 18 oz. bag pepperoni 1 large onion, diced 3 cloves garlic diced 1 container fresh, sliced mushrooms have wine on hand)

1 26 oz. jar spaghetti sauce (i usually use Ragu Roasted Red Pepper and Onion but your favorite should be fine)

28 oz. cans of Hunt's Roasted Garlic tomato sauce

1 14.5 oz can Hunt's Basil, Garlic and Oregano Diced Tomatoes Angel Hair pasta

#### Directions

Chop the onion as chunky or fine as you like, chop the garlic and chop the pepperoni if you were not able to find them already diced. Dice the bacon into just larger than bite-size pieces.
