# Shattered Dreams to give students rude awakening

It was May 5th, 2011, a quiet afternoon at Post High School, when suddenly all the high school students were hurried out of the building by their teachers. They gathered around two crumpled vehicles and stood in silence, staring at the shattered glass and the blood- covered bodies that lay in and around the vehicles. As the students arrived at the bloody, dreadful scene, sirens began to fill the air. Soon two ambulances quickly arrived to find a crowd gathered around a senseless tragedy. Officers and paramedics began to check the victims and assess their injuries. They found one teen to be already deceased at the scene. Another had a serious head injury. Injuries ranged from minor cuts and bruised to more severe fractured and broken bones. As they questioned the passengers and drivers they soon discovered the driver of one of the vehicles was an under-aged, intoxicated young man who was responsible for

the accident. Rescuing the victims began with cutting passengers out of the cars, checking pulses, placing the wounded in the ambulances, and even one needing to be air-lifted on a flight for life helicopter. A body covered by a white sheet lay in stark contrast to the

pavement the victim's body lay on. A young, innocent life lost, one who had not been guilty of the distracting behaviors that teens often do while driving, such as drinking and driving, driving and texting or any one of the many things that can easily distract even an adult. In this mock scenario, two teens would lose their lives on this beautiful May morning. Instead of looking forward to a summer filled with family, fun, and the many things teens look forward to in the summer, this family was looking at facing the devastation that drinking and driving would have on their family. The tragedy of the sight before the students was a display of Shattered Dreams.

Shattered Dreams is a mock wreck site in which the scene is acted out by students and volunteers of the paramedic police departments. No one is truly harmed, but the scene is set to make an impact on the students who works to warn students about the dangers of drinking and

The idea of putting my family through something like that for the sake of a text message frightens me beyond words. I respect the Brown family and thank them for going around to our schools and probably elsewhere, to talk to students about what can and what will happen. I will always R.A.B. (Remember Alex Brown) and respect everything her family taught me about texting and driving, wearing a seatbelt and speeding.

#### Deadly Conduct Filed On Local Resident For Confrontation With Garza County Deputies

Deadly conduct was filed on a local resident by the Garza County Sheriff's office on May 5th, 2011. At about 6:47 pm members of the Garza County Sheriff's Department PATROL DEPUTIES/ SPECIAL WEAPONS AND TACTICS TEAM responded to the 200 block of South Ave. E in reference to a possible suicidal man armed with a "long gun." As officers responded to the area, one shot was reported to have been fired by the suspect who was by then alleged to be down. As officers continued to approach the scene, the complainant advised dispatch that the suspect was back on his feet and still armed with the fired "long gun". The suspect then entered the complainant's residence with the weapon. A subsequent tactical operation was instigated and led to the

apprehension of the suspect who had hidden himself inside the residence. Tactical SWAT officers were able to negotiate the suspect's surrender without further shots being fired by the suspect or the officers participating the arrest. The suspect is currently incarcerated in the Garza County Jail awaiting arraignment. Officers are investigating why the suspect discharged the firearm. Preliminary investigation leads to the belief that the incident stemmed from the consumption of alcohol and a domestic dispute. suspect was charged with Deadly Conduct, a Third Degree Felony.

# Counterfeit Ring Operating In Garza County

On May 4th at 11:45 am a Hispanic male entered into United Supermarket located at 123 North Broadway Street, in Post, Texas and attempted to cash a counterfeit check, which had been issued to him in his own name by a checkcounterfeiting ring believed to be operating out of the Dallas Fort Worth area. Upon presenting the check to be cashed, the cashier became suspicious and the Garza County Sheriff's Department

was called. "The checks are very well made counterfeits which appear to be legitimate on the surface, but upon closer inspection, are found to in fact be completely counterfeit," states Lt. Mike Taylor of the Garza County Sheriff's office. He went on to say, "It is believed that at least one check was actually passed on a previous date."

# Firefighters to hone skills at wildfire academy in Lufkin

LUFKIN, Texas - Firefighters from across the nation will gather next week for the 14th Annual East Texas Interagency Wildfire and Incident Management Academy.

Texas Forest Service is effectively. joining with the City of Lufkin and Angelina College to host the firefighters attending the 10-day academy that kicks off May 17.

Courses offered at the academy are part of a standardized, national training curriculum developed by the National Wildfire Coordinating Group, an organization that facilitates coordination between parment agencies.

The coordinating group also teaches the incident command system, a standardized method for managing an incident safely and

Classes include dozer operations, GPS orientation, resource ordering and firefighter training at beginner and advanced levels.

No ministering allowed.


Speaking of ministries, maybe waiting rooms are my personal calling. The challenge to inject life into stagnant settings prompts me to act. I can't help it.

Isn't that just how it goes in a waiting room? Just when you're starting to have fun, they make you leave.



Walter Duckworth's story continues as he reflects on finishing the school year in Snyder, then he came back to Garza County, making several more trips in 1906 with the Llano Ranch and the OS Ranch.

In the fall of 1907 I finished school at Snyder. Post had started building in the meantime. We had rented a house and moved in Bud and I went to work for Mr. Post and the Double U Company. The County was organized in 1907 and O.B. Kelly became sheriff and Bud Boren was the county judge. Mr. Post had bought the Llano Ranch in 1905, giving the Llano people two or three years to move out and get rid of the cattle. I made one more trip with them in the fall of 1906 after school was out. We drove the herd to Hereford, where we had to wait on the cars (train) for four days. I was thrown from a horse and broke my ankle and had to ride back home in the calf wagon. I stayed in a hotel in Hereford until they shipped out the thousand head. Back in Post, I soon had a job with the Double U Company for the winter.

Bud was over a gang of men grading streets and building tanks for Mr. Post, and the last tank they built was on the north

side of the town section. They worked on this tank for several months before it was finished and it took a regular flood to fill it. It was the largest tank in the county and people began going in swimming. So on Mr. Post's next trip to Texas, he saw the need for the tank for recreation, fenced it off in a pasture and called it Two Draw Lake. It got to be a regular show place, and was long a favorite spot for fishing and swimming.

In the meantime Post had grown into a full sized town and a sold his interest and retired in 1954. very popular place. In one large rock building, Mr. Post had left all the upstairs in one large room for entertaining and dancing. On holidays and at Christmas time we would have all-night affairs, with all the ranches "moving in."

Our family had a house built in town and George was made manager of the Llano Ranch. Bud still had a gang doing dirt work on various jobs. He had dug a reservoir just under the caprock. He also was working on waterworks in town, as we had outgrown the temporary system built earlier.

We had all grown up here in Post. Ira Lee completed his elementary education at Graham Chapel and was a member of the second graduating class of Post High School in 1914. After graduation he attended the University of Texas in Austin. He

joined the U.S. Army during WW-I and upon his discharge in 1919, he returned to Post. In November of that year, he married Miss Janie Warren, who worked at Warren's Drug Store as a

During the 1920's, the First State Bank became Citizen's National Bank, which in 1933 merged into the First National Bank. Ira Lee managed the bank from the early 1920's until he

Ira Lee and Janie had two daughters, Francis Lee Camp and Mary Margaret Norman.

Walter continued with his job at the Double U Company, changing jobs each time something better came along. He worked in the cotton mill until 1925 when he started working for Texaco, Inc., as their first agent in Post, and staying with the company for 30 years until his retirement in 1955. Bud and George worked until their jobs were finished and then went into the cattle business.

**Property Tax Protest and Appeal Procedures** 

The law gives property owners the right to protest actions concerning their properry tax appraisals. You may follow these appeal procedures if you have a concern

- the market or appraised value of your property
- the unequal appraisal of your property the inclusion of your property on the approxal roll
- · any exemptions that may apply to you the qualification for an agricultural or timber appraisal
- the taxable status of your property
- the local governments which should be taxing your property
- the ownership of property the change of use of land receiving special appraisal any action taken by the chief appraiser, appraisal district or appraisal review
- board that applies to and adversely affects you.

Review by the Appraisal Review Board

If you can't resolve your problem informally with the county appraisal district (CAD) staff, you may have your case heard by the appraisal review board (ARB).

The ARB is an independent board of citizens that reviews problems with appraisals or other concerns listed above. It has the power to order the CAD to make the secessary changes to solve problems. If you file a written request for an ARB hearing (called a notice of protest) before the deadline, the ARB will set your case for a hearing. You'll receive written notice of the time, date and place of the hearing. If necessary, you may request a hearing in the evening or on a Saturday or Sunday. Prior to your hearing, you may ask to review the evidence the CAD plans to introduce at the hearing to establish any matter at issue. The CAD might ask you for a copy of the evidence you plan to present. The law provides that before a hearing on a protest or immediately after the hearing begins, you or your agent nd the CAD shall each provide the other with a copy of any writt ntended to be offered or submitted to the ARB at the hearing. To the greatest extent practicable, the hearing will be informal. You or a designated agent may appear in person to present evidence or you may send notarized evidence for the ARB to review at your hearing. The CAD representative will present evidence about your case. You may cross-examine the CAD representative. The ARB will make its decision based on the evidence presented. In most cases, the CAD has the burden of establishing the property's value by a preponderance of the evidence presented.

In certain protests where the owner has submitted an independent appraisal before the hearing, the chief appraiser has the burden of proving the property's value by clear and convincing evidence. You can get a copy of a protest form from the appeaisal district office at

Note: You shouldn't try to contact ARB members outside of the henring. The law requires ARB members to sign an affidavit saying that they haven't talked about your case before the ARB hears it.

Review by the District Court or an Arbitrator or SOAH

After it decides your case, the ARB must send you a copy of its order by certified mail. If you're not satisfied with the decision, you have the right to appeal. If you choose to go to court, you must start the process by filing a petition within 60 days of the date you receive the ARB's order. In certain cases, as an alternative to filing an appeal in district court, you may file, not later than the 45th day after you receive notice of the ARB order, a request for binding arbitration with the county appraisa district. In certain cases originating in certain counties, as an alternative to filing an appeal in district court, you may appeal to the State Office of Administrativ Hearings (SOAH). An appeal to SOAH is initiated by, not later than the 30th day after you receive notice of the ARB's order, filing with the chief appraiser of the county appraisal district a notice of appeal with the applicable filing fee.

You must pay either the amount of taxes due on the portion of the taxable value not in dispute or the amount of taxes due on the property under the order from which the appeal is taken.

#### Deadline for Filing Protests with the ARB

Usual Deadline

On or before May 31 (or 30 days after a notice of appraised value was mailed to you, whichever is later).

Late protests are allowed if you miss the usual deadline for good cause. Good cause is some reason beyond your control, like a medieal emergency. The ARB decides whether you have good cause.

Late protests are due the day before the ARB approves records for the year. Contact your appraisal district for more information.

Special Deadlines

For change of use (the appraisal district informed you that you are losing agricultural appraisal because you changed the use of your land), the deadline is not later than the 30th day after the notice of the determination was mailed to you.

For ARB changes (the ARB has informed you of a change that increases your tax liability and the change didn't result from a protest you filed), the deadline is not later than the 30th day after the notice of the determination was mailed to you.

(You may insert deadline for protests concerning omitted property if doing so would avoid taxpayer confusion.)

If you believe the appraisal district or ARB should have sent you a notice and did not, you may file a protest until the day before taxes become delinquent (usually February 1) or no later than the 125th day after the date you claim you received a tax bill from one or more of the taxing units that tax your property. The ARB decides whether it will hear your case based on evidence about whether a required notice was mailed to you.

The deadline is postponed to the next business day if it falls on a weekend or holiday.



#### ZZE, PLANE, BOSS, ZZE PLANE BY MICHAEL F. TAYLOR

Several years ago, Joyce and I were scheduled to attend a week long District Church Pastoral Training Retreat. And due to the distance, we decided that flying would be much quicker and safer than driving such a long way. Everything seemed to be going wonderfully and we had a marvelous time, right up until the time that we made our final flight connection. It seems that as we traversed through several states, our beautiful weather here in West Texas was replaced with some "no so pleasant" weather a few states north. In fact, we wound up in a pretty rough rain and wind storm which the pilot couldn't seem to get above. Now, knowing that we were on a trip for the church, I had worn my pastoral clothing which made it rather obvious that I was a minister. The plane would shake and shudder every twenty to thirty seconds and you could actually hear the power of the wind and rain as it pelted our aircraft. And then, without warning of any sort, our plane hit a particularly strong part of the storm and I guess an air pocket developed. The plane which was flying at a horizontal angle, suddenly dropped at least a thousand feet! Not by nosing forward as the pilot would do to lower our altitude, but simply dropping like an elevator does as it descends from the 100th floor to the basement. It was fast, it was scary, and it was unannounced!

Joyce looked at me with concern on her face, but the poor older lady sitting on the seat next to us had an expression of sheer terror. She grabbed my arm and starred directly in my eyes and uttered these words, "Pastor, don't you think you ought to do something to stop this about now!" with a hushed and subdued voice. I immediately replied back, "Well yes ma'am. I'd be happy to pray, but understand one thing. I'M IN SALES, NOT MANAGEMENT!"

Have you ever felt like that? Like your plane was going down! Well, if you have I would like to encourage you today. I may not be able to calm all the storms of your life, but I know the Man Who Can! And His name is the name above all others. He is the King of Kings, the Lord of Lords, and the Calmer of all the storms. In Luke, Chapter 8 well all recall the account of the Disciples as they were in distress over the storm, "22 One day Jesus said to his disciples, "Let us go over to the other side of the lake." So they got into a boat and set out. 23 As they sailed, he fell asleep. A squall came down on the lake, so that the boat was being swamped, and they were in great danger. 24 The disciples went and woke him, saying, "Master, Master, we're going to drown!" He got up and rebuked the wind and the raging waters; the storm subsided, and all was calm. 25 "Where is your faith?" he asked his disciples. In fear and amazement they asked one another, "Who is this? He commands even the winds and the water, and they obey him."

And if you read on in Luke, you see that not only did Jesus calm the weather, but he also casts out a Legion of demons from a man, "26 They sailed to the region of the Gerasenes, which is across the lake from Galilee. 27 When Jesus stepped ashore, he was met by a demon-possessed man from the town. For a long time this man had not worn clothes or lived in a house, but had lived in the tombs. 28 When he saw Jesus, he cried out and fell at his feet, shouting at the top of his voice, "What do you want with me, Jesus, Son of the Most High God? I beg you, don't torture me!" 29 For Jesus had commanded the impure spirit to come out of the man. Many times it had seized him, and though he was chained hand and foot and kept under guard, he had broken his chains and had been driven by the demon into solitary places. 30 Jesus asked him, "What is your name?" "Legion," he replied, because many demons had gone into him. 31 And they begged Jesus repeatedly not to order them to go into the Abyss. 32 A large herd of pigs was feeding there on the hillside. The demons begged Jesus to let them go into the pigs, and he gave them permission. 33 When the demons came out of the man, they went into the pigs, and the herd rushed down the steep bank into the lake and was drowned."

Did you catch that part where the demons themselves acknowledged who Jesus is? Son of the most high God! Wow! Isn't it wonderful for us to know that the Son of the Most High God is there to calm all of our raging storms. God bless each of you this week and don't worry about this old plane you are flying in. God is still in control.





# An EPA Attempt to Re-Extend Its Regulatory Tentacles

In a well-produced brochure touted as its Clean Water Framework, the Obama Administration last week announced its updated and revised policies governing the Nation's Waters. Included in the initiatives it discusses is "updated draft guidance regarding Clean Water Act (CWA) jurisdiction."

Those of us now familiar with the Administration's attempts to use the EPA as a vehicle for circumventing the wishes of past the slick ad copy and beautiful glossy photos of National Park scenes and families on vacation for something far less wholesome.

A matter of contention for the last thirty years has been what is to count as "waters of the United States" as it is these waters that the EPA is charged with protecting via the CWA. Ceaselessly and relentlessly this Agency has tried to broaden its jurisdiction by broadening its definition of what is to count as these waters.

Two important Supreme Court cases in the past ten years have reined in EPA's attempts. Declaring in 2001 that "isolated, non-navigable intrastate ponds" could not be taken to come under CWA jurisdiction "based solely on the presence of migratory birds" it freed them from the clutches of EPA

regulatory hands.

Of particular relevance to the current updated EPA Guidelines is a 2006 ruling asserting that CWA jurisdiction should be limited to only those waters having a "continuous surface connection" to other "jurisdictional waters."

Its efforts significantly hampered in the wake of this ruling, the EPA simply chose not to pursue hundreds of potential water pollution cases in its pipeline, according to MSNBC, Congress and the Courts are naturally prone to want to look work brochure calls "the complex evidence needed to establish that [various river] tributaries" fell under the CWA. It now had, said MSNBC, the burden of showing that, "intermittent streams, swamps and marshes flowed into navigable waters."

> Accordingly, 2007 EPA Guidelines instructed its officials to "first analyze whether an ephemeral stream or seasonal wetland leads to federal waters" before attempting any legal action alleging pollution.

> The whole point of the recently released EPA Draft Guidance is to supersede these previous instructions by once more allowing it to bring as many of these Court-shielded waters as possible back into its regulatory reach — thus thwarting Court wishes under the guise of following them.

Under its new Guidance, EPA officials freely admit that extend its regulatory tentacles to these waters.

compared to how things stand currently, "the number of waters identified as protected by the CWA will increase."

Its strategy for bringing these waters back into its fold is to employ as a standard for "waters of the US" in addition to the current one requiring a "continuous surface connection" to navigable waters an alternative one proposed by Justice Kennedy at the time of the original 2006 ruling requiring only a "significant nexus to traditional navigable waters." Defined because of what the recently released Clean Water Frame- as occurring when waters in question "significantly affect the chemical, physical and biological integrity of other covered waters" it would include many of the waters it wants to bring back in. New EPA Guidelines will now insidiously consider waters under either standard to be "waters of the US" under CWA jurisdiction.

## Pure Thuggery

For the organized labor movement in America, desperate times apparently call for desperate measures.

With private sector unions continuing to lose favor in the marketplace and public sector unions facing fresh scrutiny from cash-strapped state governments, organized labor finds itself at a crossroads. Even though its coffers have been replenishe d thanks to a steady infusion of borrowed government money, labor's future is far from certain — and the fear

within the ranks of union leaders is palpable. In an effort to regain the offensive, union sycophants on the National Labor Relations Board (NLRB) have fired a shot ac ross the bow of the American free market

Last month, the NLRB alleged that aircraft manufacturer Boeing's decision to locate a new manufacturing facility in South Carolina (as opposed to Washington State) constituted an illegal retaliation against striking union workers. That claim is laughable — particularly in light of the fact that Boeing has added 2,000 new union jobs in Washington State since announcing its South Carolina decision.

Of course this complaint isn't about law or logic — it is about repaying a political debt, at least in the short-term.

Unions gave more than \$100 million to Barack Obama and Democratic congressional candidates in 2008 — and that's just their direct contributions. They also ran an extensive voter registration and mobilization effort, which was staffed by

an estimated 450,000 union "volunteers."

Not surprisingly, it didn't take long for Obama to begin reciprocating for labor's benevolence.

To start with, he named longtime union-backer Hilda Solis to run the Department of Labor. Then he picked Teamsters' attorney Wilma Liebman to head the NLRB. His first White House political director, Patrick Gaspard, was also a former labor operative.

Obama followed up these and other pro-union appointments by rescinding Bush-era disclosure requirements for labor leaders -re-opening the door to all manner of corruption (at the expense of the workers he claimed to be fighting for, ironically).

These moves were just the beginning, though. Obama successfully steered tens of billions of dollars to unions through his socialized medicine law and his so-called "stimulus." Not only that, he rewrote American bankruptcy law to "reprioritize" Chrysler and GM claims in labor's favor.

Clearly no one should have been surprised, then, when Obama's NLRB goons upped the ante by telling a private company where it was going to locate its new facility. After all, if Obama can make private citizens buy health insurance, what's to stop him from making private companies locate their factories in pro-union states?

Just days after his inauguration, Obama made it clear that his "spread the wealth" mentality applied to unions as well.

"We need to level the playing field for workers and the

unions that represent their interests, because we know that you cannot have a strong middle class without a strong labor. movement," he said.

Obviously, Obama knows that this fight is about much more than paying back unions — it's about doing lasting economic damage to right-to-work states. Obama's NLRB isn't just trying to block Boeing from moving to South Carolina it is putting any company that wishes to move to a more competitive business environment on notice that it must first navigate a hostile federal bureaucracy.

Many companies will likely see that as a sufficient disincentive to relocate domestically - which will naturally result in American jobs going overseas.

Whether the Obama administration wins or loses its Boeing complaint is a short-term issue involving one state — but the "chilling effect" that this complaint could have on jobs and capital investment in right-to-work states is a long-term issue affecting nearly two dozen states. Obama's administration has made no secret of its contempt for the free market. In fact, the only real positive to come from the Boeing flap is that this contempt has now been laid bare for all to see.

Obama and his union allies have moved beyond political payback and into the realm of pure thuggery. The only question now is whether pro-free market leaders in Congress have the courage to stop them.

# Is it Jimmy Carter All Over Again?

It feels like we've been here before.

The malaise-filled economic train wreck of the Carter years has risen zombie-like from the ash heap of history to inflict its special brand of pain and suffering.

On May 6, the Bureau of Labor Statistics (BLS) reported that unemployment rose from 8.8 percent to 9 percent in April. That includes a 205,000 increase in joblessness in the household survey.

Coupled with slowing growth, increasing inflation, and a continued recession in housing, not to mention the spiraling \$14.333 trillion national debt, the economic storm clouds emerging on the horizon for 2012 are dark indeed.

Specifically, growth has slowed down to 1.8 percent in the first quarter, and inflation is up over the past year, with producer prices up 5.8 percent and consumer prices up 2.7 percent. Making matters worse, home prices are again on the decline as foreclosures rose 6.53 percent in March.

Fiscally, when Obama's first budget was enacted, the national debt stood at \$11.909 trillion, and it has already increased by \$2.4 trillion. By November 2012, the gross debt will be over \$16.627 trillion according to the Office of Management and Budget, meaning he will have been directly responsible for a gargantuan \$4.718 trillion increase. That's a 39 percent run-up in just four years!

Obama's biggest problem is that none of this was supposed

to happen. The federal government has seen fit to spend, borrow, and print more than \$2.4 trillion to prop up the economy and save government 'jobs' that, in the end, could not be saved. In the past three months, the public sector has shed 60,000 jobs as the so-called 'stimulus' and QE2 runs out this

He promised to keep unemployment below 8 percent, to cut the deficit in half, to lay the groundwork for a robust, stable recovery, to prop up home values, and to stop the foreclosures. None of that has happened.

The best the Obama Administration could muster in response to the April jobs' report was that it was "pleasantly surprised" by the news, as top economic advisor Austan Goolsbee said. Huh? Pleasantly surprised? What was he talk-

Goolsbee disregarded the 205,000 increase in unemployment, saying it was probably because of an increase in job seekers. The only problem there is that those not in the labor force (i.e. those who gave up looking for a job) increased by 131,000 in April, while the civilian labor force measure only increased by a mere 15,000. So, there's not a tremendous increase of those seeking jobs. If anything, there's been a big decrease.

Really, the only source for Goolsbee's optimism was the Bureau's establishment survey, which measured an increase of 244,000 jobs in its survey of employers. However, the household survey, which is a broader measure of all Americans, shows a decrease of the employed by 190,000. It's hard to be optimistic based on that.


Also, U-6 unemployment rose again to 15.9 percent, a total of 24.39 million people who want full-time work and can't find it. That number in particular is why Obama will be in big trouble come 2012, because it's one that is not likely to decrease significantly between now and next year, when folks will be making up their minds.

The fact is, \$2.4 trillion of government "stimulus" later, if the recession had simply been allowed to run its course to begin with, the economy would have naturally found its bottom, and resources would have necessarily been reallocated out of the public sector with greater speed. We'd already be

The Keynesian "stimulus" that was pursued was a very specific set of policies around a theoretical framework. If borrowing, printing, and spending trillions of dollars were a valid theory to prosperity, then it should have worked -Obama got everything he wanted.



Veterinarians are there no matter what the problem or smell. It's our career choice. A career that's comparable to marriage.
