Readers who reside in the Spur Independent School District are urged to take note of two maps we have published this week.


In order to satisfy a law suit brought against the school by the League of United Latin American Citizens, the school district is changing their method of electing trustees. In previous years, they have been elected at large. This year minority districts have been identified and only voters who reside in these two districts will vote in the trustee election.

We appreciate Spur superintendent Oran Hamilton providing the maps. They may be difficult to read for they have been reduced considerably to be included in this week's edition. We decided to go ahead and run them this week because March 23 is the final day to get a place on the ballot in the Trustee election set for May 7. One big difference in the trustee election is that candidates DO NOT have to reside in the district they run in. Spur ISD has been divided into five districts and only Place 1 and 2 will be elected this year. Candidates must reside within the Spur School district, however. Two trustees will be elected at large but NOT this year.

Spur residents may be confused further when the City Council changes over to the ward system which will NOT be in effect for this year's election. However, the Council has already decided to go to the ward system where two representatives will be elected from each ward. The Mayor will still be elected at large.

This will add a member to the Spur City Council as it will be expanded from five members, plus a mayor, to six members and a mayor.


I hope everyone is not totally confused. But we'll move on to other things, just in case you are.

Spur Trustees Consider Contracts, Accept Resignations, Call Election

The Spur School Board of Trustees held their regular meeting Monday night which included two executive sessions.

The board went into executive session at 7:35 p.m. to hear grievances from Irma Sanchez and Jeanette Scarlett. The board adjourned from executive session at 8:24 p.m. and no action was taken.

In other business:

- the board ordered a trustee election for May 7, 1994 to be held in the Willie Room at Dickens Electric Co-Op. Trustees will be elected for Place 1 and Place 2. Reuben Waddell was appointed as election judge.

- the board voted to accept the resignation of Business Manager Belinda

Arnold effective upon a replacement being named.

- the board also accepted the resignation of Michael Gonzales as Spanish Teacher effective at the end of the 1994 school term.

- the board went into executive session at 8:36 p.m. to discuss personnel and teacher contracts. The board came out of executive session at 10:34 p.m. with no action taken.

- the board then voted to re-hire all Elementary teachers as recommended by Superintendent Oran Hamilton, subject to assignment/reassignment.

- the board then voted to re-hire all Secondary teachers, as recommended by the superintendent, subject to assignment/reassignment, with the exception of Cheryl Anderson and Jim Devenport.

- the board voted to table action of the contract of Jim Devenport.

- the board voted to table action on the contract of Cheryl Anderson.

- the board voted to change the May 13 Snow Day to May 6 and have May 13 as an Early Out Day.

- the board cast ballots for the Educational Sectional Center Region 17 Board of Directors.

- the board voted to amend the revenue budget to show an increase of \$1,554,708 in line item 101-5772.00 to reflect the Jayton W.A.D.A. purchase.

- the board discussed the possibility of purchasing class picture albums with the help of the Spur Ex-Student Assn. The superintendent will bring a cost estimate on the albums to the next regular board meeting.

The meeting adjourned at 10:40 p.m.

Commissioners To Meet Monday To Discuss Prison Financing

A meeting to discuss financing the expansion of the Dickens Detention Center has been set up for next Monday according to Dickens County Judge Woodie McArthur.

The judge reports that a group from Dallas is interested in making a proposal in regard to the financing. "They have offered to put up a \$10,000 as a forfeiture if they can not come up with an adequate financing program," he said.

The county is considering adding about 250 beds to the current 150 bed population.

In other business, the Commissioners' accepted a bid from Yellowhouse

Equipment Co. for a maintainer for Precinct 2 at a cost of \$39,450, which was the low bid. It was for a John Deere model. The other bid was for a Caterpillar maintainer on a bid of \$62,929.

The county will be advertising for bids for a maintainer in Precinct 1 to be received by April 11.

Russ Edinburg, Nell Martin and Kelli Cash were appointed to two year terms on the Dickens County EMS committee.

The commissioners agreed to advertise for bids on a new car for the Sheriff's Department.

It was reported that a 1987 Chevrolet

1/2 ton pickup had been purchased from state surplus for the road department. Cost of the vehicle was \$1,900.

The Farm to Market Road project was discussed and no action taken pending further study in regard to right of way, etc.

Justice of the Peace in Precinct 1 reported 90 cases and revenue of \$4,991 while Justice of the Peace Precinct 3 reported 31 cases and revenue of \$4,744.

County Court heard seven appeals from JP court.

Reports were heard from the Road Superintendent, Treasurer and Extension Agent.

March 23 Is Final Day To File In Spur School, City Elections

March 23 is the final day for candidates to sign up for a place on the ballot for the May 7 Spur ISD school trustee election and for the Spur City Council election.

Donald Harris has signed up to run for Place 2 in the Spur School trustee election while four candidates have filed in the City election. They include Sparky Eckles, Place 5, Tom Condron Place 4 and Leonard Todd and Cecil Britton for Place 3.

At Dickens, three City Council members' terms will be up for election. They include Tim Walker, Ben Kautz and Bobby Laster.

In the Patton Springs School trustee election, three terms will be expiring. They include Mike Smith, Clifford Mayo and Bob Porter. Mr. Mayo and Gary Bridge have signed up for a place on the ballot.

Early voting in the Democratic primary run-off on April 12 will be April 4-8.

There will be two run-offs in Kent County. One will see Mattie Hilton meeting Nora Lea Cooper in the JP race and the other will pit Don Trammell against Elmo Martinez Jr. in the race for Com-

missioner, Precinct 4.

There will be three local run-offs in Dickens County on April 12. Billy George Drennan will face Geary Blasingame for County Commissioner Precinct 2 while Duane Durham and John Nichols are in a run-off for Com-

missioner, Precinct 4.

Justice of the Peace Precinct 3 will also have a run-off election between Robert Waddell and Sandra Jo Taylor.

There will be at least one run-off in state office where Richard Fisher will meet Jim Mattox for the Democratic nomination for the U. S. Senate seat.

Practice will be in the high school gyms. Games schedules will be announced at a later date.



Jim Mattox, Richard Fisher Face Bloody Battle In Demo Run-Off



AUSTIN — As expected, Gov. Ann Richards won nomination for a second term in the Democratic primary March 8 and will face George W. Bush, eldest son of the former president.

Meanwhile, Sen. Kay Bailey Hutchison — who earlier faced trial on ethics charges — easily defeated six Republican opponents. The outcome of an April 12 runoff will determine her Democratic challenger.

Hutchison, who won a special election in June to fill the seat vacated by Lloyd Bentsen when he was appointed treasury secretary, will face either former Attorney General Jim Mattox or Dallas investor Richard Fisher.

Running a distant third in the Senate race was U.S. Rep. Mike Andrews, who gave up a safe House seat to make the race.

Mattox and Fisher squared off immediately for what is certain to be a bloody runoff battle.

"I challenge voters to come up with anything positive to remember Jim Mattox by. This guy represents slash-and-burn negative politics. Mine are the politics of change and optimism," Fisher said.

Mattox, noting Fisher's past support of Ross Perot, said his opponent was "not the kind of Democrat that ought to lead the troops into battle." Mattox also pointed to Fisher's "pattern of contributing to Republicans and opposing Democrats."

Kirk New Secretary of State
 Secretary of State John C. Hannah will be replaced by Ron Kirk, a Dallas lawyer and chairman of the state General Services Commission.

Gov. Richards picked Kirk to fill Hannah's unexpired term, as Hannah has been nominated by President Clinton for a judgeship for the U.S. District Court Eastern District.

Kirk, a former Democratic assistant city attorney of Dallas and a registered lobbyist, has been involved in studying ways to make government more efficient as a member of a legislative panel, the Council on Competitive Government.

Following the footsteps of Austin lawyer Myra McDaniel in 1984, Kirk is the second black to be appointed to the post. He is a native of Austin and is a partner in the Johnson and Gibbs law firm.

Voter Turnout Hits New Low
 The Secretary of State's office says only 17.5 percent (1.5 million) of Texas' voters made it to the polls on March 8 — the weakest showing in Texas history.

The previous low was recorded in 1986 when only 20 percent of the voters participated.

Of the nine million Texans eligible to vote, 550,000 voted in the GOP primary and one million cast ballots in the Democratic primary.

Grand Jury Probing Bledsoe

A Travis County grand jury is expected to rule this week on allegations that former Assistant Attorney General Gary Bledsoe conducted private business on government time.

Bledsoe, president of the Texas chapter of the NAACP and chairman of the Travis County Democratic Party, was put on administrative leave with pay from his state position in October and resigned in January, amid rumors Attorney General Dan Morales forced him out. Morales denied it, but was criticized by civil rights activists and the African American community.

The *Houston Chronicle* reported in September that Bledsoe con-

ducted NAACP work during normal business hours. Bledsoe denied wrongdoing and said he compensated the state by working on state business after hours and weekends.

Allegations against Bledsoe arose after the Travis County District Attorney's office began investigating Sen. Hutchison for allegedly using her office and employees to conduct personal business.

Casino Gambling Poll
 Texans are deadlocked on whether Las Vegas-style gambling should be welcomed in Texas, according to a recent poll.

The Texas Poll, conducted Feb. 4-12, found 48 percent in support of legalized casino gambling, 46 percent opposed and 6 percent undecided.

The Texas Riverboat Association has unveiled plans to seek legislative approval for a constitutional amendment that would enable Texans to decide whether to authorize casino-style riverboat and dockside gambling on a local-option basis.

Former state Rep. Lloyd Criss of La Marque, who heads the pro-gaming riverboat group, said he was "not encouraged by the poll one way or the other."

Other Highlights
 ■ Gov. Richards has appointed McAllen lawyer Ruben R. Cardenas to the Transportation Commission. Cardenas, former chairman of the Texas Public Safety Commission, will complete the unexpired term of Henry Munoz III, who resigned citing personal reasons. The appointment is subject to Senate confirmation.

■ U.S. Rep. Craig Washington, D-Houston, became the first incumbent defeated in the nation's mid-term congressional elections. Houston City Councilwoman Sheila Jackson Lee ousted him from the seat once held by Barbara Jordan and Mickey Land.

■ A new study by Donald Huddle, a Rice University economist, says immigrants — both legal and illegal — cost Texas \$4.68 billion more in 1992 than they paid in taxes. The study shows illegal immigrants cost the state \$1.02 billion, while legal immigrants cost \$3.6 billion.

SPUR IS VISITED BY A "TWISTER" WED.

A miniature tornado struck Spur Wednesday afternoon causing some little damage to property and much excitement among the residents and students at the high school building. The twister struck the southeast corner of the city demolishing two small buildings at the cotton yard, and then traveled diagonally across town to the high and junior high school buildings where it crashed several windows and caused a near panic among the students. No one, however, was injured. The tornado continued on the northwestern course increasing in violence and doing considerable damage in the farming belt just north of the city. A small house on the Day place was completely destroyed and household goods scattered over the countryside. The front porch and the roof of the J. B. Haralson home was torn off and blown onto the cow pen killing one of the calves and maiming several others and scattering his fences over the fields. Mr. Haralson was at home alone when the storm struck and was holding the front door shut against the high wind when the roof and porch were torn off. He escaped injury and states that it happened so quickly he was not even excited. Further damage has not been reported.

5-12-33 BARNEY JOHNSON HAS LEG BROKEN IN BALL GAME

Sunday afternoon of the past week Barney Johnson, manager of the Wooten Wholesale Grocery co. of this city suffered a badly broken leg in a ball game at Jayton. In some way, Mr. Johnson

The fire is thought to have started from electric wiring in the ceiling of the building. As Others See It...

...And Say It!

 Privatization is a word that is tossed about as a way of controlling the spiraling cost of government. Under privatization, government would contract for services with a private business rather than providing the service themselves.

Many see this as a new idea, but for one Illinois community, it has been working for nearly 25 years.

According to an article by Michael

A. Finch of the Heartland Institute, Crestwood, Illinois, has been in the middle of a quiet policy revolution for two-and-one-half decades. Elected in 1967, Crestwood Mayor Chester Stranczek immediately went to work by eliminating the water and sewer departments.

In the 24 years since then, he has contracted out virtually everything, from bookkeeping to street maintenance to

water and sewer repair. The village (as they are called in Illinois) has four full-time police officers and no full-time firefighters. In fact, the entire village workforce consists of 17 people; next year it will be 14.

The village's entire budget is \$1.5 million, while other villages of its size average budgets of \$5 and \$6 million. Corporate taxes are only 44 cents per \$100 of assessed valuation; most cities are at least \$2 to \$3. Next year, business licensing fees will be \$1 per year, other cities charge \$100 and up.

In 1993, Crestwood returned to its residents a 26 percent refund on 1992 Cook County property tax bills. The only catch? You had to live in your Crestwood home for at least a year. That's it. In all 3,200 residents will receive refund checks ranging from \$150 to \$1,500.

"By 1997, we plan to give back 100 percent refunds on property taxes," the mayor said.

Critics say that the village must have lousy services, the schools must be under-funded and the kids under-educated. In fact, Crestwood schools are among the best in the state, and Chicago residents would be quite happy to be "stuck" with the services that Crestwood has. Free garbage and recycling pick-up; residents over 55 get free snow plowing, free shuttle bus service, free lawn care and free shrub trimming. And even with only four full-time officers, Crestwood has one of the lowest crime rates in the Chicago area.

Mayor Stranczek says all of these services and savings are due to privatization. When asked why other communities have not followed Crestwood's lead, the mayor believes he has the answer. "It's all a question of politics. You're talking about a lot of patronage jobs. Neighboring mayors have told me, if they implemented these reforms, they would never get re-elected."

The fear of not being re-elected may have been true when Stranczek was first elected, but I would bet that most mayors would be returned to office by a landslide each election if they could produce such savings.



Library Notes

The Dickens County-Spur Public Library Board and I wish to thank the Church Directory sponsors for the Area Church Directory that appears weekly in The Texas Spur. Each time there are a few paragraphs that spot light some phase of better living usually centering around the family. The title last week was "Your Library Is Free, But Its Value Is Incalculable." Naturally that caught my eye. I hope you read it. Most of the materials listed there we have, but we have not been established long enough to afford the music records and tapes mentioned nor books on tape--possibly sometime in the future we can. We do have a selection of 12 to 15 video tapes a month provided by the West Texas

Library System. Each first Monday of the month I received a new collection. The last week of the month, I box them up and send them to Matador.

Some patrons may have noticed that we are cancelling your name on the card in a new way. This is so that no one can tell who has read a particular book. It is causing some dissatisfaction because some folks are saying, "I want to see if I myself have read book. I read so many by the same author that I sometimes forget the titles that I have read." We are sorry to have to black the signature out, but a new law went into effect last September 1 titled Patron's Right to Read Privacy Act, or something to that effect. We had not really done anything about it until Ruth Kinnersley with the West Texas Library System, called my attention to the fact the last time she visited our library. Our library board must work up a privacy policy and have it posted in the library. There will be more on this subject after our March board meeting.

I have just received the 1994-1995 Texas Bluebonnet Award master reading list of 20 titles. These titles were selected by the Texas Bluebonnet Award Committee after receiving suggestions from librarians, teachers, students and others. If a certain percentage of the books are read by a primary or elementary student and reported to their teacher or school librarian, the student gets a vote on the one book they enjoyed the most. These books are of varying lengths and difficulty. A book may be counted if a teacher or parent reads the book to the child.

Spur elementary school participates in the Blue Bonnet Award program, so students come to the Public Library looking for those books. We will try to have as many of them as possible. From the 1993-1994 list *Shiloh* by Phyllis Reynolds Naylor has been selected by Texas school children as winner of the







A PCG representative will conduct the election, review and answer questions about recent and planned PCG activities.






He is also an active volunteer with the Dickens County EMS and the Crosby County EMS where he is a first responder.



Agriculture Is State's Second Largest Industry At \$36 Billion

Agriculture is big business in Texas. In fact, it is the state's second largest industry, generating more than \$36 billion in economic activity and providing a paycheck for one out of five Texans.

But Agriculture Commissioner Rick Perry says that Texas producers are not about to rest on past laurels, as they continue to work hard to make the state a leader in American agricultural production.

"National Agriculture Week is the one time of year we officially salute these producers who have a significant impact on the Texas economy and help make Texas the leader it is," Perry said. "But we should remember their outstanding efforts and honor the hard work all of our producers every single day."

National Agriculture Week is March 14-20, 1994, and Perry points out the tremendous contributions that make Texas the second-largest ag-producing state in the nation.

*Texas has about 130 million acres in agricultural production and rangeland, approximately 78 percent of the state's total land area.

*Texas leads the nation in Upland cotton production and during 1993 produced 5.1 million bales, about one-third of the total U.S. crop. That was enough cotton to make almost 2 billion pairs of denim jeans!

*Texas also ranks number one in the nation in the total number of cattle and calves (14.8 million head); all sheep and lambs (1.71 million head); and all goats (1.96 million head). There are more cattle in Texas than the human population of Florida, and more sheep and goats in the state than there are people in Arkansas.

*Texas farmers and ranchers add about \$12 billion to the state's economy through sales of crop and livestock commodities.

*Texas producers harvested 118.4 million bushels of winter wheat during 1993, enough to bake more than 8 billion

loaves of bread.

*Texas ranked fifth in total agricultural exports in 1992 with a total of \$2.6 billion. Each \$1 billion in export sales creates 27,000 new jobs. Production from one in three acres of cropland is sold overseas.

*Value of Texas fresh market veg-

etable production was more than \$270 million in 1993. Spring and summer onions added more than \$90 million to the total.

*Texas corn production hit a record 212.8 million bushels in 1993, enough for almost 4.5 billion pounds of corn flakes.
