THE WINTER OF 1981-82 isn't even a month old yet, as the calendar goes, and yet it has already made its mark as one of the worst in history, as far as the weather goes.

Even Galveston and Padre Island received snow. We're not sure whether those places ever had recorded snow previous to last week

toll for the winter weather thus far.
We have had a couple of very cold

stand. And the moisture has been
practically non-existant.

## Commissioners Talk Re-Mapping Issue

Parmer County Commissioners have been discussing the reapportionment of the county's precincts in recent meetings.

At the regular meeting January 11, the court approved the latest proposal by Bickerstaff, Heath and Smiley, Austin law firm, for re-drawing the county's precinct and voter precinct lines.

This proposal leaves the city of Bovina intact, and gives a portion of Friona to Jack Patterson of Precinct 2. It also gives a part of Friona to Commissioner Raymond McGeehee of Lazbuddie

of Lazbuddie.

The latest proposal showed projected population as follows: Precinct 1: 2,749; Precinct 2: 2,720; Precinct 3: 2,810 and Precinct 4:

The court also had hired workers to spot check in the city of Friona to see if the present population was about the same as it had been when the 1980 census was taken.

In a special meeting of the commissioners on Monday, a group of Friona citizens met with the court, basically protesting the fact that the city would be divided into three voting boxes, thus causing confusion as well as added election costs.

The court agreed to postpone action on the subject, but told the

### Bovina Gets Tax Rebate

State Comptroller Bob Bullock Thursday sent payments totaling \$34.7 million to Texas cities with the one percent city sales tax.

The payments, the first of 1982 to the nearly one thousand cities who collect the tax, totaled \$1.6 million more than these cities received in January of last year.

Most of our area sales tax rebates were down from the past payments. In Bovina the rebates this period amounted to \$642.88, which was down from \$1,925.89 this time last year, which denoted a decrease of 66.62 per cent.

Dimmitt, county seat of Castro County, saw a decrease of 18.53 per cent from last year, as their sales tax rebate came to \$7,784.26, down from last years payment of \$9,555.02.

Farwell recorded a 8.52 per cent reduction in sales tax rebates for this period; Earth was down 32.86 percent and Friona recorded a reduction of 3.02 per cent. In Deaf Smith County, Hereford recorded a drop of 13.74 per cent, and Muleshoe, the Bailey County seat, showed a drop of 10.48

It was announced Sunday that the Amarillo Panhandle Hall of Fame named Hereford coach Don Cumpton as "Coach of the Year" in football when the selections were made at 2 p.m. in the Amarillo College Ordway Auditorium.

Cumpton, a Bovina native, came to acclaim by ushering his Hereford Whitefaces into the State AAAAA semi-finals.

The Hall of Fame honored athletes and coaches of the year in football, basketball, track, golf and tennis and also held an induction ceremony for three new Hall of Fame members, as well as presenting four special achievement awards when the fete kicked off at 2 p.m. Sunday in Amarillo.

In his fourth year at Hereford, Cumpton led the Whitefaces to a 13-1 season in 1981 which is recorded as the best in the school's history.

Hereford Whitefaces won 16 games in a row including three final games of the 1980 season before they lost to Lake Richardson Highlands in the state football semi-finals. Highlands went on to capture the state's 5A state title in football in 1981.



"We did not decide to play the game until the last five minutes of the game," was the comment from Coach Neal. "Richard Shepherd played well, and Greg McClaran came off the bench and really played excellent."

Bovina led by as much as five points in the third period, but due to lack of concentration the Fillies let this one get by them.

"Our major problem was that we under-estimated Kress, and we were not concentrating on the game," commented Coach Paul Topliff.

"Our guard corps was not playing well, and we just have to have at least one of those players to score in double figures in order to win. We were not too effective on the boards and Kress just out-hustled us."

In the boys game against Springlake-Earth, Bovina took an early lead and never gave it up, beating the Wolverines 55-47.

"Charlie Trimble had his very best game ever against Springlake-Earth," said Coach Neal. "He was really hitting from the middle, and showed that he has lots of ability. Also, we tried a new offense and the kids were adjusting to it well."

"We had a problem of getting over confident after running up a 12 point lead, and nearly gave the game away at the last, but pulled it out in the last minutes to win. We have been playing just good enough to get by, but I have a felling that this will soon change."

In the girls game, Bovina nearly beat last year's district champs, but fell instead, 56-50.
