SINCE THE REAGAN administration has embarked upon a program of austerity, cutbacks and fiscal responsibility, there are any number of federal programs which should come under scrutiny.

Chief among these is the Davis-Bacon Act of 1931, a 50-year-old relic of Depression Days, which costs American taxpayers billions of dollars every year.

What the Davis-Bacon Act does, is determine the "prevailing wage" for a locality, in which a government contract is being awarded. The only catch is, that the "prevailing wage" is usually double what the actual wageearners are receiving.

The law was passed when wageearners were being exploited, taken advantage of by unscrupulous contractors. But in today's world, with federal wage and hour laws, the Davis-Bacon act isn't even needed.

In a public housing project in Chicago, for example, a contractor could hire a few old-time janitors for simple jobs, but today he cannot do this. A janitor could change a burned-out light bulb, but the public housing project has to call in a union-wage electrician.

A janitor could replace a broken toilet seat, but a union plumber is required. If a pilot light goes out, a union pipefitter, courtesy of Davis-Bacon, is summoned. Who pays for this extravagance? You guessed it.

An official of the Chicago Housing Authority, testifying in Washington recently, said he thought the Davis-Bacon Act was costing Americans from \$15 to \$20 billion per year.

ANOTHER AREA IN which government could save money is in closer scrutiny of itself. The Justice Department contends that as much as ten per cent of federal expenditures may be eaten up by waste, abuse and fraud.

Why not a closer scrutiny of ALL non-essential spending?

For instance, there is a law which allows the General Services Administration to spend one-half of one per cent of new federal building costs on works of art.

As a result, a sculpture consisting of four large steel plates propped up by telephone poles was erected outside a new federal building in Huron, South Dakota, much to the dismay of local citizens, who petitioned to have it removed.

In Columbia, South Carolina, citizens picketed to protest the \$65,000 cost of a 7,000-pound aluminum structure in front of a federal building.

In all, the above program has cost taxpayers over \$6 million, and continues uncontrolled in the new

budget. Then, there are programs such as the Texas Rural Legal Aid program, whose main acts since its inception has been to file suits against the U.S. Government--the very hand that feeds it, and created it to begin with.

It has been a mind-boggling situation to those of us who do not understand the complexities of government to realize that government can create an entity, pour hundreds of thousands of dollars into it, and then sit back and allow that entity to use the government as its

number one whipping boy. If this were going on on a local basis, the TRLA would have lasted just about a week--or until such time as the first anti-government suit was filed.


Chamber Meet Re-Scheduled

Bovina Junior Livestock Show Set February 16

Preparations are being made for the Bovina Junior Livestock Show to be held in Bovina's livestock barn beginning at 3 p.m. Tuesday, February 16.

According to Lawrence Widner, vo-ag instructor and general superintendent of the show, weighing-in will begin Tuesday morning at 8:30 a.m. and will continue until 11 a.m. Official weight judge will be Houston Bartlett.

Judging of the animals will begin at 3 p.m. Tuesday with the steers and heifers, which will be shown outside the show barn. Judging the steers, heifers and swine will be Billy Labier, Portales 4-H agent.

There will be two classes in the cattle division--beef heifers and market steers.

At approximately 4 p.m., the lamb

judging will begin and there will be 8-9 classes of lambs, including two classes of fine wool cross lambs, three classes of Hampshires, three classes of Suffolks, and one class of Southdown and other breeds. Lambs will be judged by Ross Caviness of Causey, N.M., a livestock and lamb breeder.

Following the lamb judging, there will be a Pee Wee lambs show which will involve the younger exhibitors, who may show a lamb of their older brother or sister, or a borrowed lamb.

By around 6-6:30 p.m., barrows should begin showing and each of these classes will be divided into weight classes for each breed. The breeds will include Chesters, Durocs, Hampshires, Spots and Polands, and all other pure breeds, as well as Crossbreeds.

According to Widner, there should be about 100 barrows and six gilts showing in the swine division. There will be approximately three

steers and three heifers as well as 65-70 lambs to be shown in the Bovina show, in addition to the above named number of swine entered in the show.

Prizes will be awarded to the winners of Grand Champion and Reserve Grand Champion in each

Ribbons will be awarded to exhibitors who make first through sixth place in each class and rosettes will be awarded for Reserve Champion in the lambs and barrows

Best showmanship winners will receive a sterling silver belt buckle in each species for a total of three (Continued on Page 6)



We received in the mail recently a send out from Senator Bill Sarpalius, who was, prior to his own political career, an aide to House Speaker Bill Clayton. The Senator from Hereford had several important things to remind us concerning Clayton, and I quote briefly: "Bill Clayton is one of the finest public servants this state has ever had or will ever have. He came to Legislature 20 years ago, armed with only native intelligence, a sense of fair play and a desire to serve and not to take from the state."

"Bill Clayton, the farmer from Springlake, appointed the first black, the first woman and the first Republican House Committee Chairman in this century. He did this out of fairness."

It was obvious, from reading over Sen. Sarpalius' column, that his affection for Clayton was total, and it has been evident in the past and throughout the entire recent past, that Bill Clayton's reputation, has, indeed, stood the test of time.

I thought that one comment the senator made was especially fitting when he named Clayton, "the farmer from Springlake."

Farmers and farm people are the types who will share their last bite

with a stranger, and go out of their way to help anyone in need.

I just hope that, whoever takes over the reins of the Speaker's chair will have the same commitment to the farm families that Clayton has had in the past.

Because the people in need most now are the farmers.

Due to some problems with names in engagement and wedding announcements, we thought that perhaps some of the following tips might be helpful when turning in a press release on something of this type.

First of all, when turning in something as important as a wedding or engagement announcement, it might be well to underline the man and woman's first and last names, so as to do away with any mistakes in names of the two persons involved.

Also, if a last name could be easily mistaken for a middle name, such as Lane, Allen or Kent, etc., please circle this name and indicate that it is a last name, not a middle name. This is especially confusing when a parent has remarried, or something, and the last name of the parent is different from that of the child.

It would also be nice if engagement or wedding announcements could be type written, therefore avoiding handwritten errors. I know that I cannot write as legibly as I can type, and I am sure there are others out there who can't either, so a typed announcement is often the best way to avoid any mistakes.

It might also be helpful to call our attention to any unusual spellings of names or if a child's name is different from that of his parents, or even if the child has a married name he or she will be using instead of their maiden name, or vise versa.

These are just a few things that one may do when turning in a wedding or engagement announcement in this paper and avoid mistakes.

Then, if mistakes happen, it will be on our part or the part of our makeup team, and not the submitter, or you.




If you have children involved in reading and you do not understand the program, let me suggest that you visit your teacher. The teacher will be very glad to sit down and talk with you concerning the total program.



Two People Killed On Highway 60

Two New Mexico residents were killed Saturday, January 30 when the pickup truck they were in collided with a tractor-trailer rig on U.S. 60 near Friona.

Killed were Vonnie Jasper, 55, and Virginia K. Heine, 50, both of Roswell, N.M., said a Texas Department of Public Safety officer.

The accident occurred two miles southwest of Friona, the officer said.

The tractor-trailer rig, operated by Robert Dwayne Holt, 38, Springdale, Arkansas, was traveling northeast at the time of the accident when it hit an icy spot in the road and slid sideways, the officer said.

Holt is charged with criminally negligent homicide, said DPS Sgt. Billy Don Scott of Hereford. The violation is a Class A misdemeanor and carries a penalty of one year in jail or a \$2,000 fine or both, he said.

DPS Trooper Jim Bishop of Farwell, Texas, is the officer in charge of investigating the double fatality.

Holt was freed on \$2,000 bond, with arraignment set for Wednesday morning.



"The eighth graders avenged an earlier loss to Farwell with a one point win," was the statement from Coach Phelps.




