
General Election November 7, 1972

Section 1. That Section 2, Article VIII, Constitution of the State of Texas, be amended to read as follows:

"Section 2. (a) All occupa-tion taxes shall be equal and uniform upon the same class of subjects within the limits of the authority levying the tax; but the legislature may, by general laws, exempt from taxa-tion public property used for public purposes; actual places of religious worship, also any property owned by a church or by a strictly religious society for the exclusive use as a dwelling place for the ministry of such church or religious socie-ty, and which yields no reve-ability rating of more than 50

BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF TEXAS: and services of the United States who is classified as dis-abled by the Veterans' Administration or by a successor to that agency; or the military ser-vice in which he served. A vete-ran who is certified as having a disability of less than 10 per-cent is not entitled to an exemption. A veteran having a disability rating of not less than 10 percent nor more than 30 percent may be granted an exemption from taxation for property valued at up to \$1,500. 

"Section 61. All district offi-cers in the State of Texas and all county officers in counties having a population of twenty thousand (20,000) or more, ac-cording to the then last preced-ing Federal Census, shall be compensated on a salary basis. In all counties in this State, the Commissioners Courts shall be authorized to determine whe-ther precinct officers shall be compensated on a fee basis or on a salary basis, with the ex-ception that it shall be manda-tory upon the Commissioners Courts, to compensate all jus-tices of the peace, constables, deputy constables and precinct "Section 61. 

The proposal for submission must be approved by a vote of two-thirds of all the members elected to each House, entered by yeas and nays on the journals. "A brief explanatory state-ment of the nature of a pro-posed amendment, together with the date of the election and the wording of the proand the wording of the pro-position as it is to appear on the ballot, shall be published twice in each newspaper in the State which meets require-ments set by the Legislature for the publication of official notices of officers and departments of the state government. The explanatory statement shall be prepared by the Secre-tary of State and shall be approved by the Attorney Gen-eral. The Secretary of State shall send a full and complete shall send a full and complete copy of the proposed amend-ment or amendments to each county clerk who shall post the same in a public place in the



(s) Three Thousand Dollars (\$3,000) of the assessed taxable value of all residence homesteads as now defined by law shall be exempt from all taxation for all State purposes. 
