A TEXAS BOY IN A TICA.

Carlsbad Current.

The following letter to the S. . Antonia Standard is from Jim Smith who will be remember ed as having worked in the shops here in 1895. Bar o Creek,

East Africa, Portuges Territory

June 13, 1900.

Dear Walter and Bunk: As Fromised, I will write. Cuess you will be supprised to hear from me. Well, I made the tip fine; wasn't sick any more after the first eight days at sea: was so sick then, however, I fee off about thirty pounds and have never beed able to regain it since I landed in Beira, East Africa, one month ago with \$60. She lasted me four days, when it was all gone. Every time you turn a corner it costs you \$5. But the dis plenty of work here. A man with a fair education can do well here, or a good tradesman, and they pay you not less than \$125. a month; but every time that you go and get a meal she costs you 75 cents and isn't as good as army grub and you know how we used to kick in the army; and when you take a drink she coste you 25 cents.

I landed 1,700 miles south of sere, at Cape Town, and came up the country towards the Transvaal and went broke and had to go to work, and you all know that nearly broke my heart; but I got a good job as a fireman on the Radada le Duisa ville de la cua in phys are our.

a month, but she costs me \$ 75. for board and \$25. for whiskey, so I have a pretty good sala-

This is a worse place than Fort St. Philip, Louisiana; they can't hardly get men to work here in the summer, it is winter here now. Ev ery man that works for the railroad company is furnished from one to three negroes to help him. I have got two, one to shovel coal and an other to do my washing: they work for\$2.50 a month and their board and clothes; they don't eat any thing but rice and don't hardly wear any clothes; but they are kept in their place better here than the negroes are in the states.

They are not allowed to walk on the sidewalks; they run in the streets like dogs. I am going to stay here until the war is over and then I am going into the Transvaal.

I am in the Portugese territory and can't get out, for the line is guarded and no one but soldiers can cross it until the war is over, unless you get a pass from the portugese war of-London. Any one who goes across without a pass will be given four years in prison, so you see I am tied up, but I dont care much so long as I hold my job.

I have not seen George Bent, I heard that he

was in Cape Town.

Jack Miles and Dock Moss are making \$140. a month and their board; they both have their saddles with them and they are a great sight to the people here. Jack loaded a fellow up that he could rope a zebra on a horse and so he has not seen a zebra since he has been here

AMENDMENT TO THE CONSTITUTION Of the State of Texas, to be Voted on Tuesday, November 6, A. D. 1900.

[H. J. R. No. 35.]

JOINT RESOLUTION, amending Article 8, of the Constitution of the State of Texas, by adding thereto Section 20, providing for the organization of irrigation districts, and for the levying and collection of a tax for the construction of reservoirs, dams and

Be it resolved by the Legislature of the State of Texas: That Article 8 of the Constitution of the State of Texas, be amended by adding thereto Section 20, as fol-

Section 20. In addition to the powers of taxation granted in the foregoing sections, it shall be lawful for the Legislature of Texas to authorize the land owners of the counties of Archer, Baylor, Clay, Wichita and Knox to organize irrigation districts in said counties without regard to county line.

In making provisions for the said of construction of irrigation works within said texas it shall be lawful to levy taxes and create an indebtedness to rest as a charge on and be secured by a lien on the irrigable land for the use and benefit of which said irrigation works have been or may be constructed. The Legislature may authorize such taxes and indebtedness as may be necessary to construct irrigation works within said territory, but no taxes shall be levied nor indebtedness created in any district until authorized by a two-thirds vote of the resident land owners therein whose lands are susceptible resident land owners therein whose lands are susceptible of irrigation from the proposed works.

The Governor is hereby directed to issue the necessary proclamation for submitting this amendment to the gary proclamation for submitting this amendment to the qualified voters of Texas, on the first Tuesday after the first Monday in November, 1900, at which election all voters favoring the amendment shall have written or printed on their tickets "For amending Article 8, of the Constitution of Texas, so as to permit the formation of irrigation districts in Archer, Baylor, Clay, Wichita and Knox counties," and those opposed to said amendment shall have written or printed on their tickets "Against amending Article 8 of the Constitution of Texas, so as amending Article 8, of the Constitution of Texas, so as to permit the formation of irrigation districts in Archer Baylor, Clay, Wichita and Knox counties,"
