

Voting Dates

January 12 - March 6, 1990 is the period for absentee voter to submit an application for absentee mail ballot for the general primary. Application may not be submitted earlier than January 12 (is considered submitted at time recieved by county clerk.) Application must be received by county clerk before close of regular business in clerk's office on March 6. Febuary 9 - 'April 3, 1990 is the period for absentee voter to submit application for absentee mail ballot for runoff primary. Application may not be submitted earlier than Febuary 9. Application must be received by County Clerk before close of regular business in clerk's office on April 3. February 11, 1990 is the last day for eligible unregistered person to submit application for registration as a voter in time to vote in the general primary. Application by mail is considered submitted at the time it is placed in the mail. Application by mail is timely if post office cancellation mark indicates February 12. Last day for voter to notify registrar of change of residence to another precinct in same county in time to vote in that precinct in general primary. Registrar must receive the notice by this date.

March 9, 1990 is the last day for voter to vote absentee by personal appearance in general primary.

March 11, 1990 is the last day for eligible unregistered person to submit application for registration as a voter in time to vote in runoff primary on April 10. Application by mail is considered submitted at the time it is placed in the mail. Application by mail is timely if post office cancellation mark indicates March 12. Last day for voter to notify registrar of change of residence to another precinct in same county in time to vote in that precinct in runoff

Chester Puda awoke in the early morning hours Friday January 5 to the alarming bark of his dog. He soon realized that his storage building, ajacent to his mobile home, was in flames.

flames, "it took no more than 10 minutes, to be completely covered in flames." stated Puda, "It was the dog that saved us, I'm going to buy that dog the biggest T-Bone Steak he's ever seen." added Puda. Chester and Diana Puda have 5 children, Jacob, Jaime, Jennifer,

Justin and Jessica. No one was harmed, but the blazing fire engulfed all of their possessions with the exception of a box of the childrens clothes and the family photographys. The photographs miraculously servived the fire when a piece of the ceiling fell over them and protected

them from the surrounding flames. Local firemen quickly arrived on the scene and with the proper equipment extinguished the fire. It is speculated that a pan of turpentine with engine parts soaking overnight, must have ingnited.

"The heater in the adjacent office was turned off, to the best of my knowledge", stated Puda, "It's hard to believe that the fumes from the turpentine could have traveled that far away"



Gay was a close, trusted friend and supporter and will be sorely missed by this writer as well as many other friends and surviving family members. Gay was one of those rare people whose thoughts were always on how to help someone else more than thinking about how someone could help her. Gay is survived by her father Milton Simmons, 92, of Brackettville & Spofford, a sister. Betty Moses of Brackettville, and two brothers Chester and Joe Simmons, both of Austin, and several nephews and nieces. Gay was put to rest in the County Cemetary in Brackettville on Tuesday, January 9th. Farewell, old friend, you go to a better place.

The Kinney County Grand Jury met on Friday, January 5th, and heard evidence in two criminal cases involving suspects from Kinney County. Joseph Weldon Bailey, Jr., 59, was indicted on three counts of Aggravated Sexual Assult on a Child. Bailey was arrested by this writer and Chief Deputy David Luna on December 6, 1989 and has remained in the County Jail in lieu of bonds totalling \$155,000.00. Bailey is also charged with two misdemeanor crimes, Unlawful Carrying of a Weapon (handgun), and Resisting Arrest. It is anticipated that Bailey will be arraigned before District

Judge George Thurmond when District Court convenes in Kinney County on January 22, 1990. Another suspect in a felony crime was re-indicted by the Grand Jury after hearing additional evidence in her case, she too will probably be arraigned on January 22nd.

A majority of the Kinney County Commissioners Court finally took action on the appointment of a Tax Assessor-Collector based on good business sense and devoid of petty, personal politics. Chief Deputy TAC Martha Pena Smallwood was appointed by a 3-1 vote of the commissioners court on Monday, January 8th after a short discussion on the matter on several points brought out by County Attorney Tully Shahan as to the need of the county to have such an appointment made.

As you may remember, the Sheriff and TAC Office was separated by majority vote of the people at the November, 1988 General Election thereby creating the new, individual office of TAC and adding a TAC to the list of elected county officials of Kinney County. After several weeks of political maneuvering by the commissioners court, ex-commissioner Tim Ward was appointed as Interim TAC to serve until the next General Election (Nov. 1990) as required by law. This move by the commissioners left an extremely bad taste in the mouths of a large number of Kinney County residents, taxpay-

ers, and voters as they believed that Chief Deputy TAC Martha P. Smallwood should have been appointed as TAC due to the fact that she had been running the office for 5 years and was the ONLY qualified candidate for the appointment.


Tim Ward's recent announcement that he is a candidate for the office of County Judge was an automatic resignation as TAC and once again there was an official vacancy in the office. State law provides that upon a vacancy in an elected office the Chief Deputy of that office may carry on with the duties of the office until such time as an appointment may be made by the county commissioners. There was some discussion by the commissioners about not filling the vacancy with an appointment as a new TAC will be elected this year to serve our the remainder of the unexpired term of office. However, recommendations from the various state agencies with which the TAC office works on a daily basis were all for an appointment. Judge Seales, Executive Director of the Texas Association of Counties stated, "the law abhors a vacancy in an elected office and an appointment should most certainly be made by the commissioners court as soon as possible after such a vacancy is created."

County Commissioners Bill Bizzell, Rosemary Subar, and Ruben Fuentes should be commended for their businesslike approach to the issue. They looked at all aspects of the situation and made their decision and took their action in appointing Chief Deputy Martha P. Smallwood as TAC based on what's best for the county and "the right thing to do". The newly appointed TAC, Martha Smallwood has appointed Rachel Clements as her Chief Deputy TAC. Congratulations to both Martha and Rachel for their patience and perseverance in the face of extreme adversity over the past year. Perhaps, at last, the TAC Office can be free of the political maneuvers and power struggles that have been so destructive to morale and the office can go on with county business.

Martha Pena Smallwood, the newly appointed TAC is a candidate for the position of TAx Assessor-Collector and the unexpired term of the office and I, for one, am fully supporting her in her election as she is the only candidate with the education, training and experience in the duties and responsibilities of the TAC Office. Her six years experience as Deputy TAC fully qualifies her for the

health educator and health counselor to children and families, resource person to classroom teachers and administrators, child advocate in times of crisis and liaison between home, school and community. It is fitting that we attempt to increase the public's awareness of

professional registered nurses managing and providing school health services and recognize the contributions the school nurses make toward the future of Texas children.

Therefore, I, William P. Clements, Jr., Governor of Texas, do hereby designate the week of January 22nd through 26th, 1990, as: School Nurse Awareness Week.

several other important management factors that must be considered for a profitable beef herd. Timely supplemental feeding, reproductive vaccines, and highly fertile bulls are among some of these items to be considered.

A common sense approach to supplemental feeding (when the animals cannot obtain nutrients from forage or body storage) might include the following:

---feed salt and 8-12 percent phosphorus supplement of similar calcium content free choice year round unless the mineral is already in a supplemental feed.

--- inject or feed vitamin A if more than 4-6 months pass without much green in pastures. The drier the weather, the more attention vitamin A deserves.

--- always, feed enough protein to maintain a 6 percent plus protein ration of maintenance of rumen function. Additionsl will be needed for milk production, growth, and other factors.

---use cow condition or fatness as a guide to additional feeding.


Less of weight or condition suggests more energy. Because of negative associated effects on digestion when adding grain to forage diets, energy supplementation is seldom financially rewarding as protein supplementation alone. However, energy supplementation may be necessary for survival if forage is limited in amount, cows are in extremely poor condition, or weather is unusually severe, or where a combination of these things exist.

These recommendations primarily deal with beef cattle and some adjustments must be made for sheep and goat production.





In about a week to 10 days, they'll get hard, then pretty soon, just fall off. A paste mixture of castor oil and baking soda is fantastic for in-growm toenails.

It's also good for your pets. If they look a bit sick, then put a few drops on the paw and let them lick it off. I know our big dog had a rash on its stomach so bad the poor dog could hardly walk, every evening I sat and rubbed a mixture of castor oil, olive oil and peanut oil on her stomach, within a week the rash had cleared up and her coat was shiny like gold. Now if you have muscle pain, in your arm, legs or joints it's best to heat the oil and then massage it in.

1/4 cup hot water 1 egg 2 tea vanilla 11/2 cups corn flakes

1 cup semi-sweet chocolate chips. Preheat oven 350 degrees. Sift together flour, baking powder and salt. Blend margarine and sugars in large mixing bowl until fluffy. Add egg, water and vanilla, Gradually stir in flour mixture. Gently blend in chocolate chips and corn flakes. Drop by teaspoonful onto greased cookie sheets. Bake 5 or so minutes or until cookies are set and golden brown. cool and store tightly covered.

Here's a good hint that we dieters

can use. I've read several different methods of making this, but this one sounds the best. Yogurt cheese (not really a cheese) is a delicious useful, and easy-to-do substitute for higher calorie cream cheese, or sour cream, both we love. Line a colander with double layer of cheesecloth. Spoon yogurt into the colander and set over a bowl, cover lightly with plastic wrap and refrigerate from 2 to 24 hours. The cheese is ready to use in two hours if you want a consistency of sour cream. A thicker consistency will be abtained by letting it drain for as long as 24 hours. This is more like softened cream cheese. This when blended for a few seconds with low-fat cottage cheese and seasoned to taste with onion salt, celery salt, and garlic powder, makes a delicious dip for celery, carrots, cauliflower, and broccoli. The Kiowa and Comanche Tribes in 1858 commanded the western portion of what is now Oklahoma. Three years before the Civil War these Indians lived there and subsisted upon the great herds of buffalo that ranged the land.

From here the two tribes raided to the north against the River transportation and south against the frontier settlements of Texas.

In this same year the Battle of Little Robe Creek took place in the Antelope hills across the Canadian River.

The responsibility of protecting the frontier was put on the shoulders of a small Texas Ranger force headed by captain John S. Ford better known by the nickname "Old Rip"

In May of 1858 Ford gathered one hundred and two rangers and supported by friendly Caddoe, Waco, Anadarko, and Tawakonie Indians, led by Shapley P. Ross along with Captain Sul Ross, who later became a Texas governor went after the Indians.

Ford trailed the Indians to their

attack took the Rangers through the camp. The Rangers turned and came back through the camp and met the returning enemy warriors who were returning from a hunt.

Suddenly a rider appeared on an iron-gray stallion, and the Comanche carried a long lance with a white flag blowing in the wind.But Ford wasn't talking peace and ordered his men to fire on the strange figure. But the Comanche rode through the trail of bullets and galloped parallel to his attackers. He was finally brought down under the murderous gun fire. Seventy-five Indians were killed and two rangers killed and three wounded when the battle was over.

The body of the brave Comanche was examined after the battle and it was found he was wearing a Spanish Armor that had been handed down in the tribe. Many such cases were found in other tribes in the Indian tribes.

The Battle at Little Robe Creek didn't really stop the raiding tribes but it marked the turning point for the conquest of the Comanche and

Small Business Administration to Begin Assistance Loans

WASHINGTON D.C. -- Congressman Albert G. Bustamante announced today as a service to interested constituents that the federal government has begun a loan program to provide financial relief to victims of severe weather and rangefires in Texas.

The U.S. Small Business Administration (SBA) will accept applications for Economic Injury Disaster Loans (EIDLs) from eligible small businesses and small agricultural cooperatives (without credit elsewhere) that have experienced serious financial difficulty as a result of certain agricultural disasters.

The EIDL program will assist agriculture-dependent businesses and agricultural cooperatives who lost substantial sales or experienced other forms of economic injury due to losses incurred by farmers and ranchers to whom the business usually sells. In some cases, this may include businesses which are unrelated to purchase goods and services at their normal levels.

In addition to agriculture-dependent businesses, nurseries are eligible to apply if they have been affected by the drought. Small businesses claiming to have been physically injured by the adverse weather or rangefires are not eligible for SBA economic injury loans.

The interest rate for loans processed under this designation in four percent for small business concerns and small agricultural cooperatives without credit available elsewhere.

Oklahoma and New Mexico are also Businesses in Bexar, Dimmit, Kinney, Maverick, Medina, Uvalde, Webb, and Zavala Counties have until July 17, 1990 to file an application. Numerous other counties in Texas and several counties in




