Zaffirini Visits

State Senator Judith Zaffirini (D-Laredo) today (Feb. 1) kicked-off her re-election campaign in Brackettville. She seeks a second term representing the large and diverse 20-county 21st senatorial district which stretches from this area to Wilson and Bee, north to Seguin/ New Braunfels/and south to Duval/Jim Hogg/Starr

Counties.

There has been an increase of reported livestock thefts in area counties over the past few months, particularly from livestock owners and ranchers with property located close to town. These thefts are costly and disturbing to the owners and has caused increased expenses in law enforcement efforts related to livestock thefts in Kinney, Val Verde, and Edwards counties.

One such report was received from Del Rio based rancher, Pat Rose, Jr. on Wednesday morning, January 31st. Mr. Rose who has ranching interests in Kinney County called to report that thieves had entered his sheep and goat pens adjacent to the football field in Brackettville sometime Tuesday night, January 30th and took two registered Angora goats valued at \$300.00. A 6 hour investigation into the crime by this writer led to the arrest Wednesday afternoon of three local men and the recovery of a registered Angora Billy. The other goat taken in the crime had been killed, butchered, cooked, and eaten by the three suspects and friends the night of the theft.

Evidence developed at the scene indicated that at least two persons entered the pens and caught the goats. They then pushed the goats through the fence, led them around the inside west end of the football field, under the bleachers and back down to near the fieldhouse where they were loaded into a vehicle which then fled the scene. Further evidence developed during the investigation led to a description of the vehicle which then led to the arrests of the three suspects.

Gerado "Jerry" De Hoyos, 22, Juan R. "Johnny" Martinez, Jr., 17 and Armando "Mando" Estrada, 18, all of Brackettville, were charged with Class A Misdemeanor theft and booked into the county jail Wednesday afternoon. They were released on Thursday morning on bonds totalling \$1,500.00 set by Justice of the Peace Alvin Hall. Trial date for the three suspects has been set for February

20, 1990. Would-be livestock thieves should take note that future cases of this nature will result in 3rd degree felony charges being filed against them if caught under a special provision of state law relating to livestock theft of one or more cattle, horses, sheep, swine, or goats, or any part thereof. The maximum penalty upon conviction on a 3rd degree felony is not less than two years nor more than ten years in the state prison and/or a \$10,000.00 fine. A word to the wise: "If it ain't yours, leave it alone!"

Letter To The Editor

An established Kinney County business reports loss of trade resulting from TexCor plans for a so-called NORM waste dump in Kinney County, 1/2 mile from Spofford and 10 miles from Brackettville-Fort Clark Springs. On Dec. 7,1989, Elsa O'Rourke, of O'Rourke Realty, wrote to the Texas Real Estate Commission as follows:

"A toxic waste dump might be installed ten miles from our community. The land site has been purchased and a license to operate it has been applied for. Local citizens have formed as a group to fight it. Final approval has not been granted to the company at this time and might not be.

What are our responsibilities to our out of town customers wanting to locate in this small resort retirement community? Do we tell them about he dump now or wait until it is here?"


On Jan. 3, 1990, the commission

responded thus: "Your letter inquires as to whether you have a duty to disclose the potential purchasers that a toxic waste dump may be ten miles from your community. Section15 (a) (6) (A) of the Real Estate License Act states that a license may be suspended or revoked when it has been determined that a licensee has made a material misrepresentation or failed to disclose a known defect to a potential purchaser. Rule 531.2 of the Rules of the Real Estate Commission provides that a broker is to avoid misrepresentation, in any wise, by acts of commission or omission. Rule 531.1 (a) imposes the duty to treat other parties to a transaction fairly on real estate brokers. Therefore, if your information indicates that the dump may prove a health hazard, a public nuisance or in other ways have a detrimental effect on property use or value, the information should be disclosed in accordance with the section and rules cited above. "...If the seller fails to authorize you to make disclosure, then you may wish to advise the seller that failure to make the disclosure could expose you to civil liability and disciplinary action against your real estate

license...' O'Rourke Realty, in compliance with this commission response and with commonly accepted ethical standards, has informed prospective buyers about TexCor plans and activity. In nearly all instances the result has been abandonment of immediate purchase plans, replaced by a "wait and see" attitude. Potential customers voice reluctance to making an investment in an area possibly destined to become a monster dump.

It may be that the commission mention of "civil liability" resulting from failure to disclose has potential implications for any such transaction, whether completed by brokers or by private sale. Such a determination will have to be arrived at in the future, if court actions ensue.

(The term "toxic waste dump" was used in the O'Rourke inquiry because much of the material intended for storage is not only radioactive but also poisonous or toxic in the environment. Uranium mill tailings, for example, were described in a Texas State Senate Committee report in 1989 as "...lakes of sulphuric acid and radioactive dirt...")

has a short life because it fills with lime. I found during the winter months every time there was a wind from the north I was surrounded by coughs, sneezes and running noses; they said it was cedar pollen (pollution).

You know by now this is satire. It makes as much sense as these scarey tear jerkers prattled by people with nothing else to do. Wherever you go you will find disquieting physical problems and in today's society the best place to put the blame is on "pollution." 





(4) Commissioners Court Meetings The County Judge should preside over each and every meeting of the Commissioners Court. He should be well versed on the agenda items, thus being prepared to lend guidance and recommendations as to the resolution of each item in an expeditious manner. He should carry out the decisions made by the court in a timely manner. Failure to follow through undermines the effectiveness of the Court. "Order" is a fundamental requirement in conducting a business like meeting. Much confusion and turmoil can be avoided if standard "Rules of Order" are

employed by the presiding official. The County Judge should work closely with the Commissioners in the overseeing of County Roads. He can assist with the purchasing of materials and supplies, labor management and equipment maintenance. County roads should be analyzed closely for potential hazards that can present a liability to the County taxpayers.

Grants should be actively pursued. There are many sources for grants and our County meets many of the requirements for eligibility.

(5) County Court Cases The Judge should work closely with the county Attorney, law enforcement officers and other elected officials in the timely disposition of Court Cases. A monthly docket call is imperative in the legal process. The County Judge should coordinate with these officials so that all concerned could set their schedules accordingly. Procrastination in hearing cases proves to be a dis-service to the law abiding citizens, who want to see justice pervail.

(6) Working with other governing

bodies The County Judge should work closely with the City of Brackettville, Ft. Clark Springs, City of Spofford and the B.I.S.D. A united effort could avoid a duplication of services and coordinate future development. (7) Encouraging Economic Devel-

opment in Kinney county our local merchants. These people children.

have made an investment in our community. They provide needed goods and services which are so important to all of us. Every dollar spent at home benefits our County as a whole. When monies can be kept in circulation in the local community the oppurtunities for growth are endless. New business should be pursued. (8) A Master Plan for development I would like to see a Master Plan developed whereby future needs can be planned for in advance. Capital improvements could be scheduled according to there priority. Priorities could be established thru public hearings thus permitting citizen input to play a major role in the future development of our County. (9) Historical Preservation

Efforts should be made to restore these structures and put them back into There needs to be better communi-service. Our County should capitalize on the tremendous opportunity we have in this area.
