Teacher Career-Ladder Bill 2566 Unconstitutional

AUSTIN - The Texas Supreme Court today ruled that House Bill 2566, the teacher career ladder bill passed by the 71st Legislature, is unconstitutional.

In its ruling, the Supreme Court reversed an earlier judgment by Travis County District Judge Scott McCown. The lawsuit, filed last July by the Association of Texas Professional Educators, challenged the procedural adoption of HB 2566. ATPE maintained in its lawsuit that the version of HB 2566 approved by the Legislature was not the same as the statute signed by the Governor.

In a decision issued Sept. 11, Judge McCown ruled that the "enrolled bill rule" applied to HB 2566 and that he was prevented from looking past the bill as signed by the Governor, Lt. Governor and the Speaker of the House. McCown further stated that "making exceptions to the rule or abolishing the rule should be done by the court of appeals or the (Texas supreme court."

With the Supreme Court's ruling, teacher career ladder decisions will be based on the previous statute, House Bill 72. ATPE had maintained that HB 2566 was inherently unfair because it imposed additional requirements for career ladder advancement on Texas teachers, many of whom had spent up to five years satisfying the criteria that existed under HB 72. HB 2566 added, among other things, stricter criteria for advancement onto career ladder level three and moved to the use of current-year appraisals without transition.

"We are really excited that the court has seen fit to right a wrong," said ATPE State President Carolyn Little. "Now that the confusion with HB 2566 has been cleared up, Texas teachers can go about the business of

teaching schoolchildren." "We are very pleased with the Supreme Court ruling," added ATPE Executive Director Doug Rogers. "We are disappointed that the other teacher associations didn't join us in this lawsuit to correct a

constitutional error. We hope that during the current special session we can work toward satisfactory improvements to the career ladder."

ATPE, the largest independent, nonunion educatiors' association in the state and nation, has a statewide membership of 50,400, which consists mostly of classroom teachers but also includes administrators, paraprofessionals, retired educators, education students and public mem-

Lloyd Davis Jr. and his son Lloyd 'Lee' Davis III were the fortunate survivors of a devastating plane crash, located on 3348 Las Moras Rd. in front of the Seminole Indian Cemetary.

The father and son team arrived at the Fort Clark airport early Sunday morning to take the T-50 Cessna to their own private airport. During take off one of the engines cut out. 'The right engine quit, I didn't have enough runway to land again, I knew I had to keep my speed up to land again." stated Lloyd Jr.

"We were going to circle around and land again, but in coming around I was slowly losing altitude, I was going to land on the high way but a power line got in the way, when we caught the power line we were probably going about 85 mph." he

After the plane crashed Lloyd Jr. picked up his son and started walking in hopes of finding a phone. The first home they came to was vacant. They started on down the highway and had walked about a mile when James Bader drove by and picked them up

and took them to the clinic. They suffered minor cuts and bruises, but no broken bones.

The airplane, built in 1942 and of the "Sky King" series used in WWII as an advanced training craft for pilots, was completely destroyed.

According to some Fort Clark residents electricity was cut off at 10:50 A.M. when the wing of the plane hit the power line.

Texas Dept. Human Services

Now Offers Adoption Programs

AUSTIN-The Texas Department of Human Services (DHS) is now offering programs to help adopted children who are victims of past abuse or neglect adjust to their new families.

"Finding permanent families for children who were abused by their birth parents isn't enough," said Gwendolyn Gordon, DHS spokesperson. "They need to learn how to live in a healthy family environment, and their adoptive families need to understand and learn how to cope

with the effects of the past abuse." Parent education and support groups. 24-hour crisis intervention and counseling for all family members are among the services available to eligible children and families. To qualify, the adopted children must

have been in DHS custody or received adoption assistance benefits from DHS. An estimated 1,400 adopted children under age 18 and their families will take advantage of the post-adoption services during the fiscal year ending August 1990.

Supporting children and families after the adoption is complete will help them form solid, permanent relationships, said Gordon. "We believe it will make a real difference in achieving family unity and permanence," she said.

House Bill 1806, passed during the last regular session of the Texas Legislature, authorized DHS to provide the services. State funds totaling \$2,249,610 will be spent on the services during fiscal year 1990, and additional funds were appropriated for fiscal year 1991.



Letter to the Editor the current crisis in school funding. I Last week, the Governor's Task

Force on Public Education announced its plan for funding public schools. The task force plan would do little to abate the crisis in Texas school finance. The plan calls for \$174.6 million in

new state money to achieve equity, and that is not enough.

Other proposed plans range from \$600 million to \$1.1 billion in 1990-91 to achieve the equity required by the Texas Supreme Court in the Edgewood ISD v. Kirby decision. The plan offered by the Governor's Task Force is unacceptable.

TASB believes that \$800 million is the minimum amount that must be infused into our public education system in the 1990-91 school year. Additional state taxes must be raised during the upcoming special session to meet this immediate need. The Supreme Court decision clearly states that "equalizing educational opportunity cannot be relegated to an 'if funds are left over' basis."

The task force plan continues the over-reliance on the local property tax to fund education that led to the Edgewood ISD v. Kirby decision and

am asking you to alert your legislators of the critical needs of public education in your area and to tell them that local property taxpayers cannot continue to bear the lion's share of public education funding. The "no new taxes" rhetoric is untrue. The Legislature has simply transferred the responsibility of paying for mandated programs to local school boards and local taxpayers. Our state leaders must be told that we expect them to do the right thing for the schoolchildren of Texas and that we will support them and an increase in state taxes. We must send two messages to our

legislators immediately: 1.At least \$800 million in state aid is needed for next school year; and 2. To generate this revenue, a tax

bill must be passed in the special Together, we can make our message heard. Together, we can ensure a

brighter future for all Texas schoolchildren. Thank you for your willingness to speak out.



Warren is top gun at the Frontier Gun Shop at 204 No. Street. He can fill orders for new guns for sports-



The Rev. Edward Philip Bush II spent most of his life working to improve life for those entrusted to his spiritual care.

He initiated several religious projects in San Antonio and Mexico and directed many churches.

"He was the type of man who acted on his convictions," said his daughter, Bette Boyd of San Antonio. "He always took some action that reflected his feelings."

Bush, 68, died Saturday from a brain tumor.

Born in 1922 in Danville, Va., Bush graduated from high school there in

He continued his education at the University of Virginia and received his degree in 1943. Bush was the youngest student to graduate magna cum laude that year.

He joined the Army Air Force during World War II and rose to the rank of cadet. He left the service in 1945.

Bush went on to complete his education at the Virginia Theological Seminary and graduated with honors

in 1948. Directed 5 churches

After being ordained an Episcopalian priest. Bush was given his first assignment - to direct five churches at once in Camden Parish, Va.

His next assignment was slightly easier-he only had to look after three churches in Northampton County,

In 1954, Bush became the director of St. Luke's Episcopal Parish in Alexandria, Va.

In 1960, duty called him to San Antonio, where he joined St. Luke's

Episcopal Church.

At St. Luke's, he organized the Mission Congregation of the Holy Spirit, which operated the Gate House, a downtown coffee shop that featured Sunday worship services.

He later taught at Wheatley High School and Sam Houston High School until 1976.

Bush left San Antonio to become rector at St. James' Episcopal Church in Hebbronville and Grace Church in Falfurrias. In 1981, he moved on to St. James' Episcopal Church in Del Rio, where he stayed for five years.

While in Del Rio, Bush formed Mission San Andres, a mercy organization, in Ciudad Acuna, Mexico. After finishing his work there, Bush returned to San Antonio and taught at Brackenridge High School until his retirement last year.

Even after retiring, Bush continued to offer his time and services to local hospitals and churches.

'Very dedicated'

"He was very dedicated to the church and his purpose," his daughter said.

Other survivors include his wife, Nancy Hodge Bush of San Antonio; three other daughters, Anne Tepichin and Julia Lindow, both of San Antonio, and Sara Burns of Houston; a son, Edward Philip Bush III of Dallas; a sister, Julliene Rapp of

Austel, Ga; and 10 grandchildren. A memorial service will be held at 11 a.m. Monday at St. Luke's Episcopal Church with the Rev. Joseph DiRaddo and Rev. Joseph Bushannan officiating.

The body will be cremated.

all these healthy things I'm learning, traveling, and celebrating birthdays, I forgot there might be anyone interested in the basics us old timers have made, seems like, millions of times such as pot roast, meat loaf, and creamed beef. This week I want to share with you some of my favorites. Lets start with Beef Pot Roast: I always make a big one, so I can freeze half and still have left-overs.

About a 4 lb. chuck roast

1/4 cup water 1 TBS Worcestershire sauce

Trim excess fat from meat: heat in fry pan to get fat for browning meat. Mix flour, salt, and pepper, coat meat with mixture, brown on all sides meat with mixture, brown on all sprinkle the Worcestershire sauce over the meat. Sometimes as my meat is browning I add one medium sized onion, chopped, and an envelope of onion soup mix. Add water, as needed, to prevent overbrowning. Cover tightly and cook over low heat, or in oven at 350 Degrees until tender, cooking time will be 21/4 to 31/2 hours depending on thickness of meat. Be sure and brown the meat without flour coating first. Now lets get onto a delicious Roast Beef: About 4lbs. of boneless chuck roast

and commercial meat tenderizer.

Treat your roast with the tenderizer, preheat oven to 325 Degrees, add salt and pepper, place roast on rack in a shallow roasting pan. Insert meat thermometer if you like, in center of meat. Bake about 11/2 to 21/2 hours depending on the doneness desired. To test doneness, pierce the meat with a sharp, pointed knife and check the color. If you use a thermometer, temperature of meat should reach 140 Degrees for rare and 160 for med., and 170 for well done. For easier slicing, let meat stand 15 to 20 minutes before carving then carve across the grain.

Since this one's my children's and grandchildren's favorite, let's get on to "S.O.S." we all know what that means. There's several variations, you can use chipped beef, bacon, or hamburger. Decide which meat you like best, then we'll begin. The chipped beef is the only one you have to add about 2 TBS of fat or oil, to saute. With bacon or hamburger I use 1/2 lb. Saute until crisp and chop in tiny pieces. Drain off all the fat, except 2 TBS. to thin, now add 2TBS flour, and stir until blended with the oil this is how you have smooth

stirring. The secret to good gravy is the constant stirring. Then add salt to taste, most all of your milk items will require a bit more salt. I also use a dash or two of cayenne pepper. Stir until its the consistancy you like. My grandchildren like bacon, and its so good, even the poor dogs don't get a taste, it's all gone.

You may serve SOS over toast, eggs, noodles, or vegetables. I have so many varieties of meat loaf in front of me, there's not room for them all, so what I'll do is give you the basic's, that's what is in most all meat loaves. For each lb. of meat use:

one egg about 3/4 cup of milk

salt and cayenne pepper to taste one to two cups of bread crumbs 1 small onion or one pkg. onion soup 1/4 cup ketchup

Put the egg in large mixing bowl, beat until fluffy, add milk, and bread crumbs, let set until bread crumbs have soaked up all the liquid, then add meat, and stir until well blended, add onion, or soup mix, salt, pepper and ketchup and blend well. Shape into a loaf and place in a shallow baking pan, bake about an hour in 350 degree oven.

Here's a neat idea--shape the meat (usually 1/21b. per person serving) mixture into individual servings and place them side by side in a loaf pan. Here are the additions, or variation you can add or change. Instead of the bread crumbs, you can use either one

1 cup cream of wheat

1 cup oat meal 1 cup bran cereal

or 1 cup of left over mashed

potatoes. For a bit more taste, you can add:

1/4 cup green pepper chopped fine 1 TBS Worcestershire sauce

or ½ cup barbecue sauce Meat loaf is a fun dish, you can add just about anything, after the basic's,

to suit your taste buds. This last favorite of the day is another slow cooker which everybody loves, Swiss Steak:

about 2 lbs. boneless beef chuck or round steak

meat tenderizer 1/4 cup unsifted flour salt and pepper to taste

2 TBS cooking oil 6,oz, can tomatoes med. size onion-sliced

As we approach election day, March 13, I believe it is important that each voter know as much as possible about each candidate and his or her background. I would like to point out some of the accomplishments made during my 11 years in public service.

As City Manager: the following improvements were made to the overall operations of the City of Brackettville during my 2 year

1.) The Utility Department a.) An improved cost - saving method of record keeping and billing was developed.

b) Gas leaks were reduced from a 40 percent to under 5 percent, unaccountable. All gas meters were re-calibrated.

c)Water leaks were reduced from 30 percent to 10 percent unaccount-

d) A new water main was installed on Sweeney St. with funds received from a C.D.B.G. Block Grant.

2.) Fire Department a) For little cost, a 6X6 Rural fire truck was obtained from the Texas Forest Service. This enabled the Fire Dept. to cover rural, rough-terrain

b) A new Fire Truck Chassis was purchased in 1979. I arranged and I took the existing pumping unit to Texas A&M University to be reworked and placed on the new truck chassis. This method saved the City approximately \$30,000.00. Insurance premium cost in Brackettville and Fort Clark were reduced, when this unit was placed into

c) Approximately 15 new fire hydraunts were installed, for broader fire protection coverage; Hence, Insurance Premiums were reduced

with-in these areas.

3.) Concrete drainage ditches-were completed through the downtown sections of the City, under a C.D.B.G. Block Grant.

4.) Low water crossings with walk-bridges-were installed on Las Moras Creek under another C.D.-B.G. Block Grant.

5.) A new back-hoe-was purchasec under a lease purchase plan with yet, another C.D.B.G. water improvement grant, which paid for this new unit at no cost to the local taxpayers. As County Commissioner, the

following improvements were made to the overall operations of the County during my 8 years of service: When I was elected Commissioner in 1980, the County was in serious financial condition. The previous administration had paid no attention to a balanced budget. Chronic budget amendments were being made, resulting in a large debt to our local bank. 2.) With a referendum passed by the voters we were able to consolidate the following offices and depart-

a) Four J.P. precincts were consolidated into one County-Wide

dept. expenses were cut in half. All of these changes reduced expenditures by eliminating a duplication of services, cutting over-head, better management of personnel, less capital outlay, better equipment maintenance and the reduction in the amount of equipment needed.

3.) The Commissioner's Court and the County Sheriff negotiated a contract with the U.S. Marshal's Service to begin handling Federal prisoners. The basic operational cost of the jail would be necessary, with or without, the prisoner care program: therefore, the revenues that are generated, more that off-set the expenses necessary for the basic operation of the jail. These funds have helped the County's cash flow problems and have created employment opportunities.

4.) As a result of the procedures being implemented, the following changes were made in the County's Finances, Beginning with my first year as a Commissioner through my 8 year tenure:
