Three Car Collision Leaves

One Dead, Two Injured

A three car accident, two miles east of Baird on I-20, has left one woman dead and two persons injured.

Pronounced dead at the scene by Baird Justice of the Peace Bobby Curtis, was Laura Morris, 51, of Lone Oak. Her body was taken to Parker Funeral Home and will be transferred to Memorial Funeral Home in Tyler for services.

Injured in the accident were Mr. and Mrs. Henry (jo) Boring of Dallas. They were taken to Hendrick Medical Center in Abilene.

Boring, 49, received a broken arm,

leg and ribs, while his wife, 45, sustained lacerations.

Mrs. Morris was traveling westbound in the right lane of I-20 when her car swerved into the center lane, hitting a second car driven by Rocky Dean Hogan of Odessa. He was reportedly uninjured in the accident.

The impact sent both cars onto the center median, where Hogan's vehicle overturned and came to rest. Ms. Morris' car continued to travel into an east bound lane of I-20, striking the Boring car head-on.

overpayments will occur because the individual failed to notify the VA of an increase in his or her income during the year.

Veterans in receipt of nonservice-connected disability pension, and widows and children receiving death pension, are paid benefits if their annual income remains within certain limits. Veterans, widows and children receiving VA benefits under the new pension law which went into effect January 1, 1979, must report immediately any change in their income. Failure to do so may result in an overpayment in benefits, as any adjustment required must be made on the first day of the month following the change. If they wait until the end of the year to report income increases, the VA must make the necessary payment adjustment retroactive, thus cre-

ating an overpayment for each month involved. In most instances, the VA benefits are reduced dollar for dollar under the new pension law. Those under the old pension law are receiving the frozen rate of VA benefits to which they were entitled on December 31, 1978, and such payments will continue unless their annual income exceeds the limit



Dialing To Mexico Changed

New procedures are in effect for U.S. customers calling Northwestern Mexico, reports a spokesman for Continental Telephone. Major cities involved in the change are Tijuana, Mexicali, Ensenada, Culiacan, Mazatlan, Hermosillo, and Ciudad Obregon.

Under the change, callers can dial 70, plus the eight digits in the Mexican telephone number. The procedure is the result of Mexico's revised national telephone numbering plan. All Mexican telephone numbers in the new 70 region will begin with the numberal 6, essentially creating a new area code 706 for U.S. callers.

Previously, callers used area code 903, plus seven digits to reach this area. Area code 903 has been taken out of service.

The changes do not apply to other parts of Mexico, which can be reached by dialing area code 905 or by asking for operator assistance.
