Shahan Honored On Oth Birthday

The man who brought movies to Brackettville and Kinney County, James T. "Happy" Shahan, was honored by several hundred of his friends and relatives during ceremonies at the Fort Clark Springs swim park Saturday evening.

The occasion was to celebrate "Happy's" 80th birthday (this past Monday) and to recognize his many contributions to the Brackettville and Kinney County area. FCS board member Barry Williams was emcee

for the evening. After reviewing Happy's birth in Whitehouse and his early years as a star basketball player both in high school and at Tyler Junior College and Baylor University, Williams then held the crowd in awe listing Happy's many accomplishments during his more than half-century of

residency in Kinney County.

Williams then introduced Brackett News Publisher and owner Jewel Robinson, who presented Shahan with congratulatory letters from Governor George Bush, Lt. Gov. Bob Bullock, United States senators Phil Gramm and Kay Bailey Hutchison, U.S. Congressman Henry Bonilla, State Senator Frank Madla and State Representative Pete Gallegos.

Next up was Brackettville Rotary Club President Frances McMaster, who acknowledged Happy's many contributions to the club of which Shahan is the sole surviving charter member.

Jerry Jordan, a former star basketball player at Baylor University and longtime family friend brought chuckles from the audience when he related the time he went to interview at Baylor for a spot on their team.

Jordan said he was told by school officials that all he had to do to secure entrance into Baylor was go and work during the summers on this cattle ranch in Brackettville. Texas, where all he would have to do is drive a cadillac around.

"Well, I backed that cadillac up one time in four years, and that was to get gas. Most of my time was spent digging post holes," Jordan said.

FCS Board President Frank Cheaney thanked Shahan for his being an "active and avid supporter of Fort Clark Springs, as well as benefactor throughout its existen-

A highlight of the evening came when Brackettville Mayor Carmen Berlanga and Kinney County Chamber of Commerce President Larry Sofaly each read resolutions from the city and county officially designating July 24, as "Happy Shahan Day." As of Saturday, July 24, will forever be known as "Happy Shahan Day" in Brackettville and Kinney County - a "day of celebration" honoring Shahan's many contributions to the city and county.

Williams then announced that Kinney County Judge Tommy Seargent and the commissioner's court also approve naming the park on the north side of the Nutrition Center on Ann Street as the "Happy Shahan Park."

Gene Poag Jr., who co-owns with Happy, Celebrity Management and Alamo Village Music, Inc., based in Nashville, then presented Shahan with letters of congratulations from longtime business associate and past president of the Nashville Songwriters' Association, Clarence

Selman and from country music legend Tom T. Hall.

Poag then read a proclamation from Tennessee Governor Donald Sondquist on behalf of the people of his state appointing Happy an "Official Tennessee Ambassador of Goodwill."

Hollywood producer, director and screenwriter Frank Dobbs, who has filmed seven projects in the Brackettville area over the last three decades, brought an emotional close to the evening when he recalled that if it wasn't for Happy Shahan he wouldn't be in the film business.

Dobbs filmed his first project - an industrial film - at Alamo Village in the early 1960s.

"My dream commenced then and I've been dreaming ever since. I learned how to dream at the foot of the master, James T. "Happy" Shahan," Dobbs said.

Dobbs said when he thinks of Happy, he is reminded of the closing scene in Lonesome Dove where a newspaper reporter is trying to interview Woodrow Call as they are walking across that now famous bridge.

The reporter said he has been told that Call is a man of vision.

Call, keeping his eyes straight ahead as he walks, answers the reporter, "Vision? A hell of a vision.'

"That's Happy Shahan," Dobbs said.

As a final tribute, a plaque was unveiled that will be permanently mounted in the Kinney County Courthouse. The plaque's inscription reads: In honor of James T. "Happy" Shahan, husband of Virginia Webb Shahan, Kinney County rancher and businessman, six-time mayor of Brackettville, "Father of the Texas Film In-





Sheriff's Corner

In a case of vehicle burglary in which a Ft. Clark resident reported the theft of a .357 magnum revolver occurred the night of Tuesday, July 18, 1995, Sheriff's Department investigators have received valuable assistance in clearing the case with the arrests of four (4) Brackettville youths in Uvalde County the night July 21, 1995 by Uvalde County Sheriff's deputies. One of the four arrested (2 juveniles and 2 adults) had the stolen revolver in his pocket. Ironically, one of the adult aged youths claimed the revolver as his own, which of course, put him in the position of "claiming" and being in possession of stolen property. Uvalde County authorities have filed felony charges on the one "claimed" the revolver and he has been released on a \$3,000.00 bond. The investigation into the original vehicle burglary will continue and further charges against those involved are pending.

At approx. 1:35 a.m. the morning of July 20, 1995, the Sheriff's Department received a call from a Border Patrol dispatcher in Del Rio advising that Southern Pacific Railroad personnel had contacted the Border Patrol to advise that one of their trains had hit a person either walking or lying next to the railroad tracks west of the intersection of the Pinto Creek crossing and Standard Lane. Further investigation into the report by Border Patrol agents and Kinney County Patrol Deputy Karl Chism resulted in the location of the injured man, and illegal alien from Mexico. The man had suffered compound fractures of the left leg and a broken shoulder. He was transported to Val Verde Memorial hospital by the Kinney County EMS

At approx. 7:40 a.m. the morning

of Thursday, July 20, 1995, the Sheriff's Department received a call from Ft. Clark Security of a possible burglary of a Ft. Clark residence. This writer responded to the call and upon arrival at the scene it was determined that vandals had broken into and "trashed" the house, doing considerable damage to the front door and the interior of the residence, which was unoccupied at the

on Page 4 of the Friday, July 21, 1995 issue of the Del Rio News Herald titled "Smith Wins Contest; Receives \$1,000.00 U.S. Savings Bond", may have felt some of the same emotions I did when I read it. Interest in the subject matter, pride in the strength, courage, and ability of the young man who wrote the letter and his loyalty to his family, and sadness that an honest young man such as Dale Smith has had to experience and suffer the humiliation and trauma at the hands of overzealous state and federal law enforcement officers serving a government that is being allowed to treat honest, hardworking American citizens in this manner, and in many cases, worse. I also felt (and feel) a tingling of apprehension that the current trend of government interference and opression into and of the lives of Americans will only get worse as time goes on unless freedom loving American citizens don't somehow get it stopped and make the power-mongers of the current government realize that "government", be it local, state, or federal, works FOR the people, and SHOULD NOT be constantly working against them and trying to

gain control and domination over

I, like many Kinney and Val Verde County residents, know the Smith family and some of the details of the governmental harassment and terrorism they have suffered at the hands of radical, over-zealous state and federal law enforcement agents and agencies over the past 2-3 years.

Richard and Beth Ann Smith, and their family, are NOT criminals, they are NOT murderers, rapists, child molesters, etc.. They are an hardworking honest. American ranch family who believe in the freedoms that are supposed to be guaranteed by our Constitution to live their lives without government domination and control and without the excessive, intrusive, and obsessive government interference into their lives that has become so prevelent in these days and times.

Perhaps I can relate to the stress, strain, trauma, and anger they feel because I, too, have suffered and am suffering some of the very similar governmental harassment and terrorism since I also became a 'target" for government control and domination. The Smith family's "nightmare" began on March 10, 1992, mine began on May 22, 1994. Theirs and mine have continued since they began with no end in sight. Of course, we are not the only Americans being terrorized by the government, and we are not the only Americans whose homes and property have been entered by government "agents" armed with 'search warrants" which were and are only thinly disguised excuses to allow "government" agents to enter the homes and property of Americans and "steal" their papers and property, most of which have NO relation whatsoever to the alleged "crimes" for which we are being investigated and will, in all likely-hood, never be returned.

It seems extremely ironic to me that the commander of the some four hundred (400) "commando" agents of the FBI, the BATF, U.S. Marshals, and other federal law enforcement agencies who gave the orders to "kill on sight" members of the Randy Weaver family in Ruby Ridge, Idaho after those "commanhad surrounded and terrorized the Weaver family for several days received a promotion, and two of the agents that received any disciplinary action against them at all only received 15 days off, (an order that resulted in the murders of Weaver's 14 year old boy by shooting him in the back, and the murder of his wife by blowing her head off with a highpowered rifle while she stood in the doorway of their home holding her 10 month old baby in her arms). Yet the state and federal government are trying to ruin me personally, politically, and financially because they allege that I was a "spectator at a dogfight"? Somewhere in there I am missing the logic in their thinking!

It seems to be that the mind-set of state, federal, and some local law enforcement agencies and agents have changed dramatically over the past few years. A long-time, now retired, federal agent and I were discussing this dangerous trend a few days ago and he hit it right on the head when he stated that "we are policemen, NOT "commandos", we are here to do a job SERVING the American people, not to suit up in black suits, ski masks, and ATTACK the American people as if they are our enemies." Another close friend of mine who is currently a "team leader" of one of the elite military commando units stated to me recently, "There is a certain mind-set that kicks in when you suit up with tactical gear, machine guns, rocket launchers, and don your black ski masks, a mind-set that most assuredly SHOULD NOT be used against the American people, and should be used ONLY against the foreign ememies of our country." I think both of them are right and it is past time for the people of this country to stand up and demand that these type tactics are stopped, and most especially so when they are being used against Americans who are being terrorized by the radical, over-zealous enforcement of "special interest" laws that were passed in the first place by professional politicians trying to hold on to their jobs by appeasing the many radical "special interst" groups that want to dominate and control the thoughts and actions of all other Americans and force us to think and do as "they" do!







Make Good Compost

County Agent

Instead of throwing grass clippings away each time you mow your lawn, put them to good use in a compost pile. Compost is good source of organic matter for gardens and flower beds. Furthermore, composting is an excellent way to dispose of garden debris, leaves and similar plant material.

The simplest composting method is to alternate 4 to 6 inch layers of plant matter, such as leaves or grass, with 2 to 4 inches of good garden soil. Add manure, if available, and sprinkle commercial fertilizer on each layer of plant matter to speed up the decomposition process. Use a cupful of fertilizer with a 1-1-1 ratio per 10 square feet.

The top layer of the compost pile should be soil and surface should form a basin to hold water. Water each layer of organic matter before adding the soil layer. Water the pile thoroughly when completed. Add water as needed to keep the material moist but not soggy. Leaves decompose very slowly if they are too dry.

Turn the compost every three to four months to aerate the material and speed decomposition. Within six months to a year, your compost will be ready to use and you'll be glad that you saved those grass clip-

Irrigation Tips For Hot Water

Here are some timely tips to get the most from irrigation water so as to keep plants and lawns healthy

while keeping watering costs down. 1. Practice slow, deep watering to allow roots to penetrate deeper so that plants become more stressresistent.

2. Soaker hoses and drip irrigation systems work well on trees and shrubs. It's more efficient to water at night or early in the morning because evaporation is less at these times. However, remember that watering at night promotes diseases in lawns and shrubs.

3. Too much water can be as hard or even worse on plants than not enough. Apply water no faster than the soil can absorb it and give plants time to dry out between irrigation instead of keeping the soil wet constantly.

4. Plants on mounds or slopes suffer from drought stress more easily than those on level areas, so these require more frequent watering.

5. Never fertilize landscape plants when the soil is dry. It is best to water one day, apply fertilizer the next day, and then water again. Fertilizer will do no good unless it is dissolved and moved into the soil.

6. Treat water as a valuable resource. Use it to water plants when needed but do not waste water. Although considered a renewable resource, good water supplies are becoming scarce in



Lawyers **Advertising Rules**

(AUSTIN)--Texas consumers will benefit when new rules on advertising for lawyers go into effect on July 29. The State Bar of Texas rules will help ensure that more accurate and verifiable information is provided to the public in advertising by attorneys.

The State Bar's Advertising Rules Committee, which oversees the screening and processing of lawyer advertisements, has already begun pre-screening ads submitted by attorneys. The committee, which began accepting the ads for preapproval on July 3, has already received 250 applications, mostly from attorneys who currently advertise.

The State Bar hired a full-time manager to assist in reviewing applications.

Advertisments that are submitted for pre-screening and do not comply with the rules will be returned to attorneys who can then make the necessary changes. If the ads appear without the recommended changes, the committee can file a grievance through the State Bar's disciplinary system. Lawyer ads that are released to the public and filed with the State Bar without prior committee approval will be referred directly to the Bar's grievance system if they violate any of the advertising rules. The committee hopes that the review process will cut down on the number of grievances filed for noncompliance with the advertising

It is also a goal of the Advertising Review Committee to educate lawyers and their advertising agencies about the new rules and how to comply with them. Current plans include holding a joint seminar with the Texas Association of Broadcasters and publishing and distributing a booklet on the rules.

The new rules are designed to protect the public from false and misleading advertising practices by:

*prohibiting attorneys from making claims that cannot be substantiated;

*requiring lawyers to honor advertised fees during the time the advertisement is used; *require that written solicitations

be clearly labeled as "ADVER-TISEMENTS"; *requiring the advertising lawyer to disclose that a case or matter will likely be referred to another lawyer;

*requiring attorneys to disclose how percentages of settlements are computed for fees.

According the Dickie Hile, Chair of the Bar's Advertising Review Committee, "the most common violations in lawyer advertising in Texas that I've seen relate to statements of board certification and claims of being a specialist, failure to state how contingency fees will be calculated, and failure to disclose that cases or matters will probably be referred to another lawyer."



There is one package that has me a bit confused. It is tied fast with a string, and has a label on it, "string too short to use" - a little hard to explain but there it is!


Just open that sun-porch door and the memories of a life time come pouring out - would that everyone had such a reminder of a long and happy life!






