## **Culverhouse Wins** At Lake Park


her summer of golf with an impressive win in her division at the Lake Park Junior Golf Classic in Lewisville on August 7-8 by shooting a 35-42 77.

## **Testing Schedule For Warning Siren Begins**

How can you tell the difference between a fire call, a storm warning, or a "we are in immediate danger warning (such as when a tornado has touched down in our area)"? It is difficult to describe in writing how to interpret the siren call, but we will do our best.

The siren sounds off every day at noon, pay attention to the sound because if you hear it any other time you must remember that it is only a test to ensure that the siren is operational and that there is nothing

to be alarmed about. If there is a fire call you will hear three short tones in a time period of

60 seconds. A storm warning is indicated by a steady tone over a period of three minutes.

If we are in immediate danger, such as a tornado which has touched down in our area, the siren will sound just as it does when there is a fire call except that it will last three minutes as opposed to one minute.

Next Monday, Tuesday and

Wednesday there will be scheduled testing of the siren, if you will listen for the siren at the times listed below you can figure out how to interpret the sounds. If you have any questions feel free to call PCI AT (210)563-2332 and ask for Tony Parker.

## **Upcoming Workshops Reveal Treasures Of Big Bend Ranch**

PRESIDIO--Three upcoming programs at Texas' largest and one of its most majestic state parks offer visitors an up-close look at the unusual geology, desert plantlife and disparate birdlife of the Big Bend region.

Big Bend Ranch State Park, as part of its management goal to open up the environmentally fragile land to more visitors through guided tours, is offering three September workshops.

Texas Conservation Passport holders may sign up for the Sept. 23-24 seminar "Useful Plants of the Chihuahuan Desert" to be conducted by park ranger and West Texas naturalist David Alloway. The twoday workshop will provide a look at how people have used Chihuahuan Desert plants for 12,000 years.

The workshop, which costs \$210 and includes meals, lodging and handson activities, will begin at the Barton Warnock Environmental Education Center in Lajitas. Alloway will guide participants to the park along the River Road from Lajitas to Presidio, stopping to identify medium-high and high desert elevation plantlife along the way.

Through afternoon workshops, evening programs and field trips, participants will learn how to use some of the desert plants for food, beverages, fiber, medicine, fuel, dyes and construction. "A wide variety of plants out here can be used for medicinal purposes," Alloway said. "And there are about 200 species of edible Chihuahuan Desert plants."

On the second day, Alloway will lead a rare tour to the usual and ruggedly beautiful Solitario area of the park, a severe desert terrain created by a collapsed volcanic dome that contains formations dating 520 million years ago and unusual plantlife that has adapted to the harsh climate.

On Sept. 26-27, a private guide will lead participants on a "Journey Through Time," a narrated tour of the Solitario. Pierre Dekoninck, a naturalist with an keen knowledge of geology, will lead visitors to the Solitario Shutup, one of the most dramatic canyons in the vast 276,494 acre park that lies just west of Big Ben National Park.

During the workshop, participants will learn on the first day about the fascinating 275-million year geological history that covers the evolution over millennia that saw the land undergo a transformation from what was once part of a shallow sea, to beaches, to tropical forests to woodlands and finally the desert. The second day will included a guided 12-mile hike through the canyon and a box lunch. The \$245 fee includes all meals and lodging at the ranch and program actvities. Future Solitario hikes are planned Oct. 31-Nov. 1 and Nov. 28-29. No Texas Conservation Passport is required, though reservations must be made by calling 915/371-2523.

Jim and Barbra Hines of Big Bend Birding Expeditions will take birders Sept. 29-Oct. 1 through Big Bend Ranch State Park to view a dazzling array of birds migrating north from Central America and Mexico.

The Fall Migration Birding workshop fee of \$300 includes field trips, evening programs, insturctions on identification, meals and lodging at Big Bend Ranch. The Big Bend area is home to 400 different species of birds, including some endangered species like the peregrine falcon and rarely spotted Mexican bird species. The Hines keep a low guide-client ratio to ensure optimal sightings and instruction.

Early reservations should be made by calling 915/371-2356. A birding workshop future is scheduled Oct. 13-15.

## **Richard Peace Guest At Rotary**

Have you noticed the low water level at the Amistad Dam and wondered about it? Members of the Brackettville Rotary Club have the answer. Richard Peace, professional engineer and project manager for the International Boundary and Water Commission at the Amistad Dam and Power Plant Project, spoke to the group on August 10 and held a lively question and answer session.

Mr. Peace said the present water level equals approximately the 1986 recorded low of 1,077.7 feet, but he reported that the level has been slowly rising at about five millimeters a day. Recent local rains wouldn't affect the level. Only very heavy rains here like the remnants of a hurricane would raise it. The major run-off area for Amistad is linked to the Pecos River, Devil's River, and the Rio Concho River in Mexico. A smaller source is Colorado snow which produces about 900 cubic feet of water yearly. Amistad was the second of three

dams planned for flood protection, conservation of water for power and recreational use. The first dam was Falcon, Amistad was second to be built, and the third may never be

constructed. The recreational use is managed by the International Park Service and is limited to a fringe around the lake which disappears when the water level is low.

The sixteen gates visible on the dam are used only for flood water. Five more exist on each side of the dam under water which release flow downstream. Release of conserved water is controlled by the state and the amounts and recipients are decided on the basis of contribution. Gauging stations at specific sites account for the water received and

water level is that repair of sink holes is made easier. Mr. Peace said that task is now being addressed.

## Hunting, Fishing Licenses Now Available

AUSTIN--With the onset of hunting season just a few short weeks away, Texas sportsmen are reminded it's time to renew licenses. According to the Texas Parks and Wildlife Department, hunting and fishing licenses are now available at over 1,800 locations statewide, including most major retail outlets.

Hunting and fishing licenses are valid from Sept. 1 through Aug. 31, however, licenses purchased between now and the end of August may be used immediately.

Individual Texas resident hunting or fishing licenses cost \$13 each, or \$25 for a combination resident hunting and fishing license. Residents who turn 65 years of age after Aug. 31, 1995 may buy a discounted \$6 Special Resident Hunting License and a \$6 Special Resident Fishing License. Those senior citizens ages 65 or older prior to Sept. 1, 1995 are exempt from the Special Resident Fishing License requirment, unless they desire a trophy red drum tag. Non-resident general hunting licenses cost \$250, while non-residents under 17 qualify for the Special Resident Hunting License instead of the general license.

According to TPWD officials, new licenses will be made available at additional outlets as license orders are received from certified licensing deputies.

While new licenses are on sale now, the special \$35 Annual Public Hunting Permit will probably not be available until sometime next week and the Bay and Bait Shrimpers license is expected to be available later in the month, due to late changes in regulations.

Sportsmen may also renew licenses over the phone prior to Sept. 1 by calling 1-512-389-4409 or 1-800-895-4248 (TX LIC 4U) after Sept. 1 Visa and Master Card accepted.

Licenses may also be renewed by mailing a check or money order to TPWD License Division, 4200 Smith School Road, Austin, TX 78744. Texas Driver's License and mailing address information are required when ordering by phone or mail. For more information on licenses call 1-800-792-1112 or your local **TPWD** law Enforcement office.



#### ANNUAL RAM **PERFORMANCE TEST**

The annual ram performance test will be conducted by the Texas Agricultural Experiment Station at Sonora in 1995-96. The delivery date for rams in this year's test will be September 8-11, 1995. The field day is scheduled for March 14, 1996. I have complete information about the test including the costs and entry form in my office. Please let me know if you are interested.

#### **NEW FIRE ANT KILLER**

One of the most effective products to fight the fire ant is a logical approach. Stopping ants from growing to maturity is a proven method. A product called "Logic" is now approved for use on lawns and in horse pastures with approval for cattle pastures coming soon. It is an insect growth regulator that mimics an insect hormone, and redirects development of the ants. It prevents new worker ants from being developed in treated colonies and the colonies slowly decline. It takes four to six months to really see a difference in the fire ant population, but you will enjoy the benefits for up to a year. So just like the similar flea products, you'll have to be patient and let the cycle of development be broken.

#### WATCH FOR SPOTS ON TREES IN HUMID SUMMER

There have been a number of trees affected by actinopelte and anthracnose disease this summer due to the humid weather conditions. Actinopelte leaf spot is caused by a fungus that infects the foliage of the tree during the wet years. Spot Anthracnose also occurs during wet years. The two diseases are most often seen on oak trees that are stressed, especially red oaks in transplant shock or iron deficiency.

Actinopelte Leaf Spot is characterized by circular spots ranging from gray to brown to dark brown. These spots form on the upper leaf surface and may be isolated on the leaf or numerous but still distinct. Severely infected leaves will drop off the tree prematurely.



Spot Anthracnose is characterized by brown spots that vary in size and shape but generally the size of a small fingernail. These spots usually track the veins of the leaf. The margin of the spots should have a distinct change from normal green color to brown. This fungus rarely causes severe defoliation.

Control of both of the diseases is very similar. First, determine if the tree is under stress. When an infected tree has been transplanted recently, check for proper mulching, water only when needed, and apply low amounts of fertilizer to ensure steady and uniform rate of growth. If the tree appears to be iron deficient, apply the appropriate amount of iron. Improving internal and surface drainage can reduce the susceptibility of the leaves to these two fungi.

Before planting, try to determine if a drainage problem might exist for the proposed site. To check for an internal drainage problem, dig a hole about 36 inches deep during a rainy period and fill the hole with water. If the water drains in 24 to 48 hours, you should not have any problems. If, on the other hand, the water has not drained after 48 hours, you will probably need to select a tree that can tolerate more water on the roots or fix a drainage system where the water will not stand in that area for that long a period.

Treatment of the infected trees is relatively simple. Try to correct any stress situations. Rake up the infected leaves and place them in your compost pile or destroy them. If you do not remove infected leaves, leaves will become infected. A fungicide will control the disease if you decide to treat. For Anthracnose, Daconil 2787 should work and for Actinopelte leaf spot, Dithane will work. Be sure to read and follow all label directions.



## **Flying-Keeping Students Safe**

LAUGHLIN AIR FORCE BASE, Texas--After climbing eight flights of stairs, you finally reach the top of the tower. From high above the flightline, your view is as far as the eye can see.

There are approximately 35 supervisors of flying (SOFs) who are designated as 47th Operations Group commander representatives to monitor all local flying. "We're appointed to make decisions on the flying operations at Laughlin," said Capt. Gregory Powell, 47th Opeations Support Squadron. "It entails making decisions about the flying status and what different types of aircraft can do, where they fly and what patterns they fly. With all that goes on up there, the SOF is the one controlling the status of the aircraft," Powell said.

Besides monitoring the local flying, the SOF stays in contact with the 47th OG commnader to keep him updated on the status of all flying operations.

Before becoming a SOF, by regulation, one must be a flight commander or hold a higher position. Once in the position of flight commander, the squadron commander can then nominate someone for a SOF position. Nominations are based upon a pilot's knowledge and experience of the local flying operations. Once selected, names are forwarded to the operations group commander,

After being selected, they must through several weeks of training," Powell said. "SOF candidates do four tours of three to four hour shifts in the tower performing the duties of a SOF." SOF candidates go up into the tower and are taught the duties of a SOF, and then perform those duties while being supervised. Further duties include handling in-flight emergencies and severe weather conditions.

During an in-flight emergency the SOF, being the supervisor, ensures the situation is being handled accordingly. The SOF talks to the pilot to find out what the emergency is and what he has done up to that point. From there, the SOF will call the squadron commander and the operations group commander to notify them of the situation, and what is being done about it.

Weather conditions that arise may call for a weather recall. The SOF must contact the Radar Approach Controllers so they can set up the patterns for all aircraft to land, and alerts maintenance crews in case there's a need to tie down the aircraft or bring them into the hangars.

"In any situation, the SOF needs to bring a perspective that is 'outside' the situation and ensure everyone's safety," Powell said. A SOF must always keep his eyes and ears open to the traffic in the air. SOF's are there to help train pilots and to keep the skies over Laughlin safe.







I enjoyed the summer. It was a busy time. We had 10 staff development days during the summer of 1995. Teachers could avail themselves of the opportunity to attend 5 of the 10 (split sessions). Three were voluntary. Two were not. We've worked hard to get our act together in regard to curriculum and instruction.

\*Every teacher has been given time to study the curriculum of their teaching assignment. The focus should be much better at Brackett ISD this year.

\*Every teacher has been given time to work out a scope and sequence for the curriculum. When will the specific essential outcome be taught during the year?

\*Every teacher has had time to work on assessment. How will the teacher test to see if the curriculum has been learned? The Abacus Instructional Management System is the key to much of what goes on here. Thanks to the Hillcrest Foundation for providing us a file server, 12 new computers and 4 printers so that we could individualize our curriculum. So, major improvement number 1 is in the area of curriculum and instruction. I hope this will always be number 1.

We have an excellent staff. There are lots of changes in teachers and in support positions. Oh, we lost some great ones. Seems like schools always do. But, the replacement folks and new positions are high quality people. I sense a renewed dedication to getting the job done.



When you work with a competent team, it makes the job so much easier to get done. I hope that our instructional team will team with our business community, parents and all of Kinney County to give Brackett students the best educational opportunities possible. All of us are involved in the education of our young. They are our hope for a future. We need all of you on the team!

The buildings and grounds look superb. New carpet at BHS. New tile in the halls. Nice. Students will notice. Everything is shiny and clean. Our staff of custodians & maintenance folks have done an outstanding job this summer.

If the enthusiasm that I see in cheerleaders, band, football and volleyball are any indication, our students are ready to get back to BISD and have the greatest year ever. Folks, I am so pleased with what I see here. It's been a while coming. You have to plant the seed before the harvest. I do believe that our kids believe in themselves. They think that they can compete & win. Certainly, we have had successful programs in the past, but overall...look for marks of greatness this year.

I want to thank Superintendent Mills, principals & school board for a job well done this summer. There is no reason that our small school can't be a pacesetter. We can solve problems. We can prepare kids better than any other school. It takes a great staff, supportive parents, students that want to learn, a board that enables programs to flourish, and a community that believes in the young students. We have it all right here in Brackettville.

The Pastor's Pen'' Many years ago the Danish

theologian Kierkegaard made an interesting observation ... "Most of us spend our life building mansions for ouselves and in the frantic process of going through life, wake up one day only to discover we have forgotten how to really live." Oh, that we could just "wake up" a few days sooner!

Jesus talked frequently about the abundant life, about finding joy in our lives. One of the last things he said to his disciples the night of the Last Supper was about his joy being in them. John 15:11 "These things I have spoken to you, that my joy may be in you, and that your joy may be full."

Joy as Jesus used the term was an inside thing, something that happens on the inside and is really unrelated to outward circumstances. It is why he could talk about joy in one of the darkest moment in history and more particularly in his life. This is why Paul could talk about joy while he was in prison awaiting execution, or why he could give thanks to God in the midst of a storm at sea. That is why some people can sustain great tragedy in their lives and still keep on functioning and offering thanks to God, even for the trials.

I like the way Archbishop Ramsey put it: "The life of a Christian ought to be like the ocean, with the surface constantly battered about by a storm but miles and miles below the deep peace, unmoved tranguility.

We still need your ideas for future volunteer project so please let the Board or Management know. Our intent is still to start with a monthly project and with the return of our winter members to take on a more aggressive program.






**PAR-3 GOLF**

#### SESAME FRIED CATFISH

#### **Ingredients:**

- 1 pound genuine U.S. farm-raised catfish fillets
- 1 egg (or 2 egg whites), lightly beaten
- 1/2 cup sesame seeds
- 1/2 cup (approx.) flour for dredging Vegetable oil for pan-frying

#### **Dipping Sauce:**

- 1/4 cup soy sauce
- 1 tsp crushed garlic
- 1/2 tsp grated fresh ginger
- 1 Tbsp brown sugar
- 2 Tbsp sake or white wine

#### **Directions:**

Bring oil to medium-high heat in a heavy frying pan. While oil is heating rinse the catfish fillets and pat dry with paper towels. Dredge fillets lightly in flour, dip in beaten egg and coat thoroughly with sesame seeds. Sauté catfish over medium heat one fillet at a time for approximately 2 to 3 minutes per side.






