THE BIG NEWS around Bovina this week is that Bovina High School will be in the basketball playoffs for the second year in a row.

Not only that--the school will have both its boys AND girls in post-season action, on the bi-district level.

After going for 22 long years without having the Mustangs win a district title, the boys have done it twice in a row.

And Coach Marks Lanham deserves a lot of the praise. Lanham took on the job of coaching both the boys and the girls teams this year, which is something of a rarity in these days of specialization.

But Lanham didn't just "take on" the added responsibility--he made the most of his opportunity. Both the Mustangs and the Fillies have won more than 20 games each, and the 20-victory mark in basketball is always the mark of a successful season.

After their final district games, the Mustangs had a 24-4 season record, and the Fillies stood at 21-7.

Of the Mustang losses, one was to Texico, which was virtually unbeaten in its district in New Mexico the last time we noticed. Another loss was to Adrian, who won the championship of District 1-1A. Bovina avenged this loss by beating Adrian three times.

One district loss was to Kress, and the Kangaroos will join Bovina in the playoffs. The Ponies lost to Kress by five points, and two games later suffered a three-point upset loss to Hart. The Bovina boys came within ten points of posting a perfect 10-0 district record for the second season in a row.

While the Mustangs had to rebuild, with just one starter, Richard Shepherd, back from last year's team, the Fillies are also quite a success story.

The team had a good nucleus of players returning from the previous year, but it mainly needed a shot of confidence. Coach Lanham has apparently given them that, along with a lot of drills in the fundamentals.

The playoff has been a 21-win season, including nine wins in a row during the middle of the schedule.

On Monday, when a lot of teams were involved in tie-breaker games to see who goes to the playoffs and who doesn't, it was sure nice to know that the local teams had their playoff tickets "already bought."

That's what a lot of hard work can accomplish. Congratulations to a fine group of boys and girls, and to Coach Lanham, on a job well done.

IN BASKETBALL

BHS Gains Two Playoff Spots

Bovina High School will have both its varsity boys and girls teams in the post-season playoffs.

Up until last season, basketball fans would have given you the shirts off their collective backs just to make the playoffs, period. When the Mustangs won the district title in 1983, it was the first for boys basketball since 1961. The Fillies had last been in the playoffs in 1965.

So, to say it's unusual for both teams to be going to the playoffs is putting it mildly. In a word, it's GREAT.

As of Tuesday, both teams were in the unusual situation of having the playoff berths nailed down, but not knowing who they would be playing, nor when or where.

None of those questions could be answered until after Tuesday night, when the picture could begin to clear up. Announcements about the playoff details will be made at school as soon as arrangements have been made, officials say.

The Fillies are expected to play their bi-district game on Friday. They will play either Seagraves or Morton. Those teams were to play Tuesday night (February 14) for the District 6-AA title.

The Fillies are in the playoffs by being district runners-up. The rule was instigated last year by the UIL whereby two teams advance in the playoffs from each district. Olton's girls won the district title with a 9-1 record. Bovina finished at 7-3.

The Mustangs won their second consecutive district title with an 8-2 league mark, and they will meet the runner-up team from District 6-AA (either Shallowater or Seagraves), next weekend, probably Friday, February 24. Shallowater and Seagraves were playing for district runner-up honors this week.

It was important that the Mustangs emerged as district winners rather than runners-up, since the runners-up, Kress, must meet District 6-AA champ Morton, the defending state champions who are loaded once again, in the first round action.

Coach Marks Lanham, who guided both the Fillies and the Mustangs to the playoffs, said he was very pleased with the situation. "We hope to be able to win--with both teams--in our playoff games, but getting there is the main thing. From here on, everything additional is gravy," he said.

Lanham cited last Tuesday night's games against Farwell as being extremely critical for both teams.

"It was a crucial game for the girls, because with the win, the Fillies clinched second place and the runner-up playoff spot."

Lanham said the Fillies played a steady game. "We missed some free throws in the first half, or the halftime lead would have been more comfortable," he said.

Leading scorer Marie Pesch received her fourth personal foul four minutes into the second half, and sat out more than a full quarter of playing time. Lanham said the girls ran their offense well, especially in the latter stages of the game, and used the clock to their advantage.

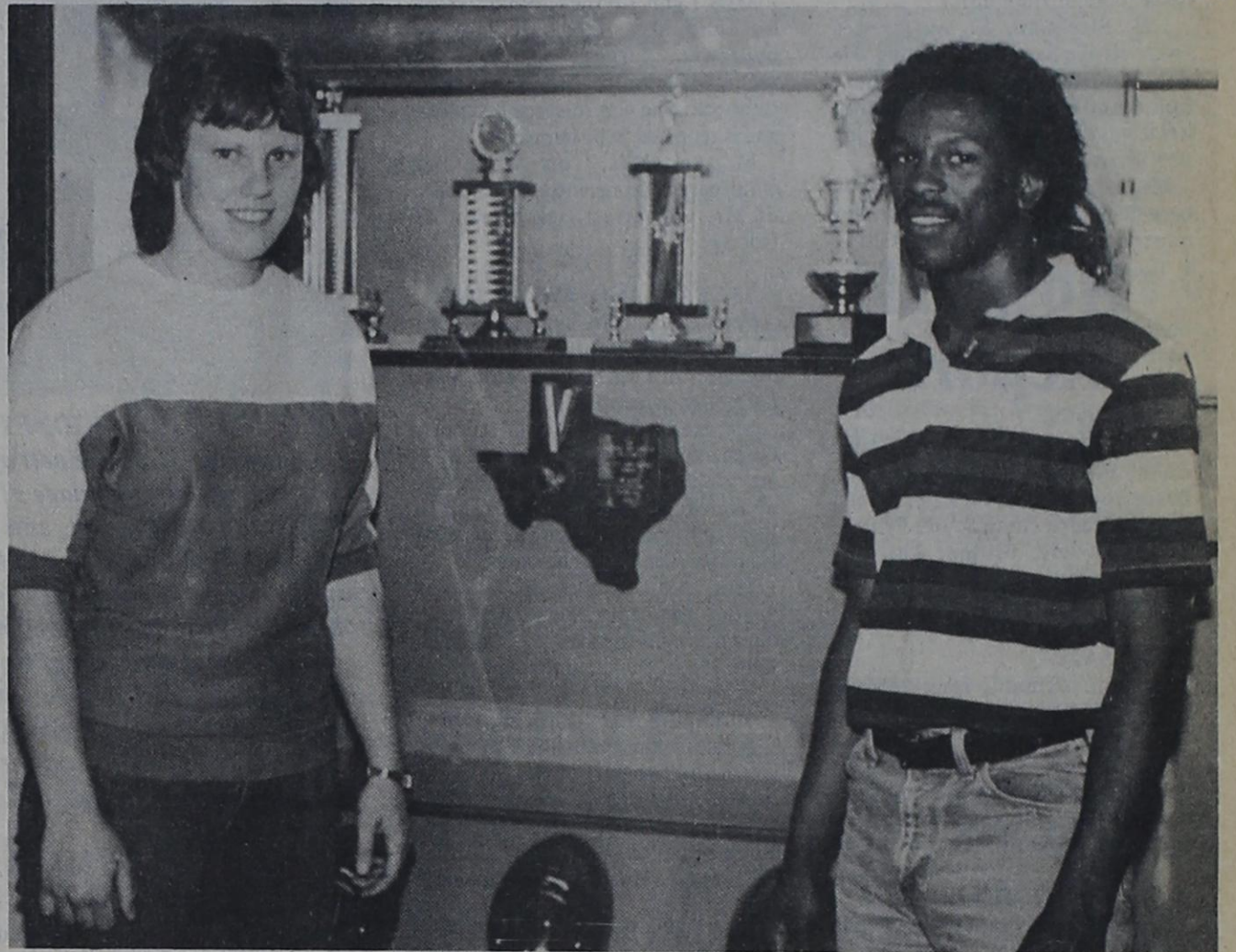
The Farwell game was also crucial for the Mustangs. By winning, the team clinched a tie for first place even though they still had to play Olton on Friday.

"But if we hadn't won, we didn't

even have a cinch on second place. Three teams would have been dead even. The boys decided at halftime they wanted to be district champs again, and came out and won it," Lanham said.

With the Steers keying on Richard Shepherd, the Mustangs decided to work on getting freshman Michael Shepherd open under the basket. The strategy worked perfectly, and Michael came up with 12 third-quarter points and 20 for the game. Bovina outscored Farwell, 38-23 in the second half.

"I am real proud of all the players on both teams. They worked hard, and did what it took to win. We will try to 'get after' whoever we get to in the playoffs," concluded the second-year Bovina coach.

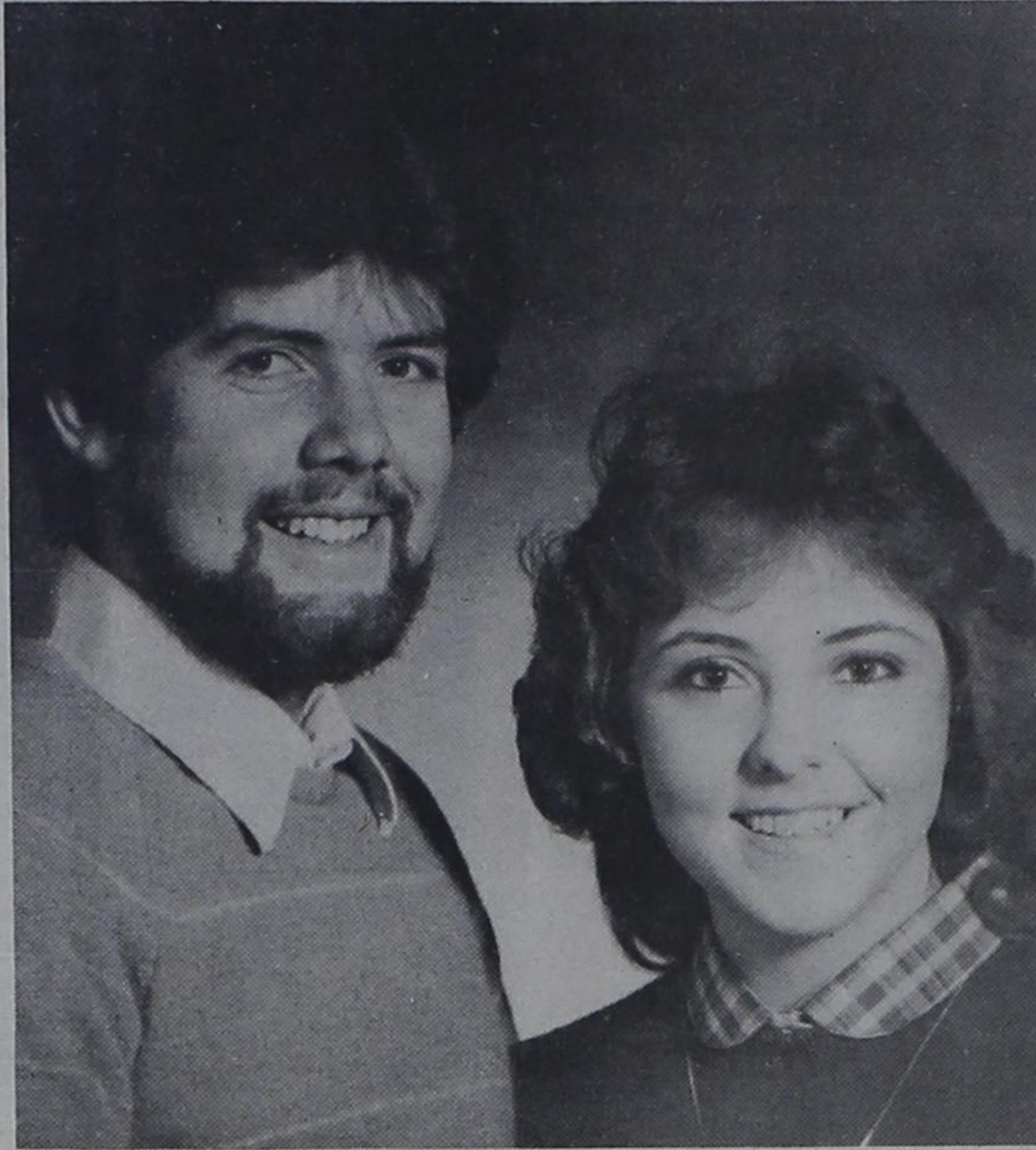

Fillies Clinch Playoff Spot

Bovina's Fillies held on for a big win at Farwell last Tuesday, 37-31.

Although the team lost to district champion Olton on Friday, 45-35, the Fillies gain the playoffs as runnerup participant.

The team's battle with Farwell went down to the wire, before the Fillies prevailed.

Marie Pesch scored six first-quarter points, as the team's slugged out during the first quarter. Castleberry countered with seven points, and the score was tied, 12-all at the end of the first period.

It was the same story in the second quarter, as the lead swapped back and forth. Bovina held a two-point lead at the half, 20-18.

Defense was the name of the game in the second half. Miss Pesch scored a pair of baskets and two free throws as Bovina outscored the Steerettes, 9-5 in the third quarter, and took a six-point lead, 29-23.

Marie Pesch received her fourth foul with four minutes left in the third quarter, and was pulled out until just over two minutes remained.

But the Fillies were playing ball control, and held on for the four point win, 37-33.

Miss Pesch scored 16 points to lead the scoring.

Hosting Olton on Friday, the Fillies gave the district champs a good workout. Miss Pesch's nine first-quarter points paced Bovina to an 11-8 quarterly lead. Olton came back to take a 19-16 lead at the intermission.

The two teams swapped points almost evenly in the third quarter, with Olton holding a 32-27 lead at the buzzer.

Failure to convert on free throws cost the Fillies the win, as they missed four chances in the fourth quarter alone, and made nine of 16 for the game, or 56 per cent.

Miss Pesch again scored 16 points to pace Bovina's point-making.

The win left the Fillies 7-3 and in second place in district. The team has a fine 21-7 season record.

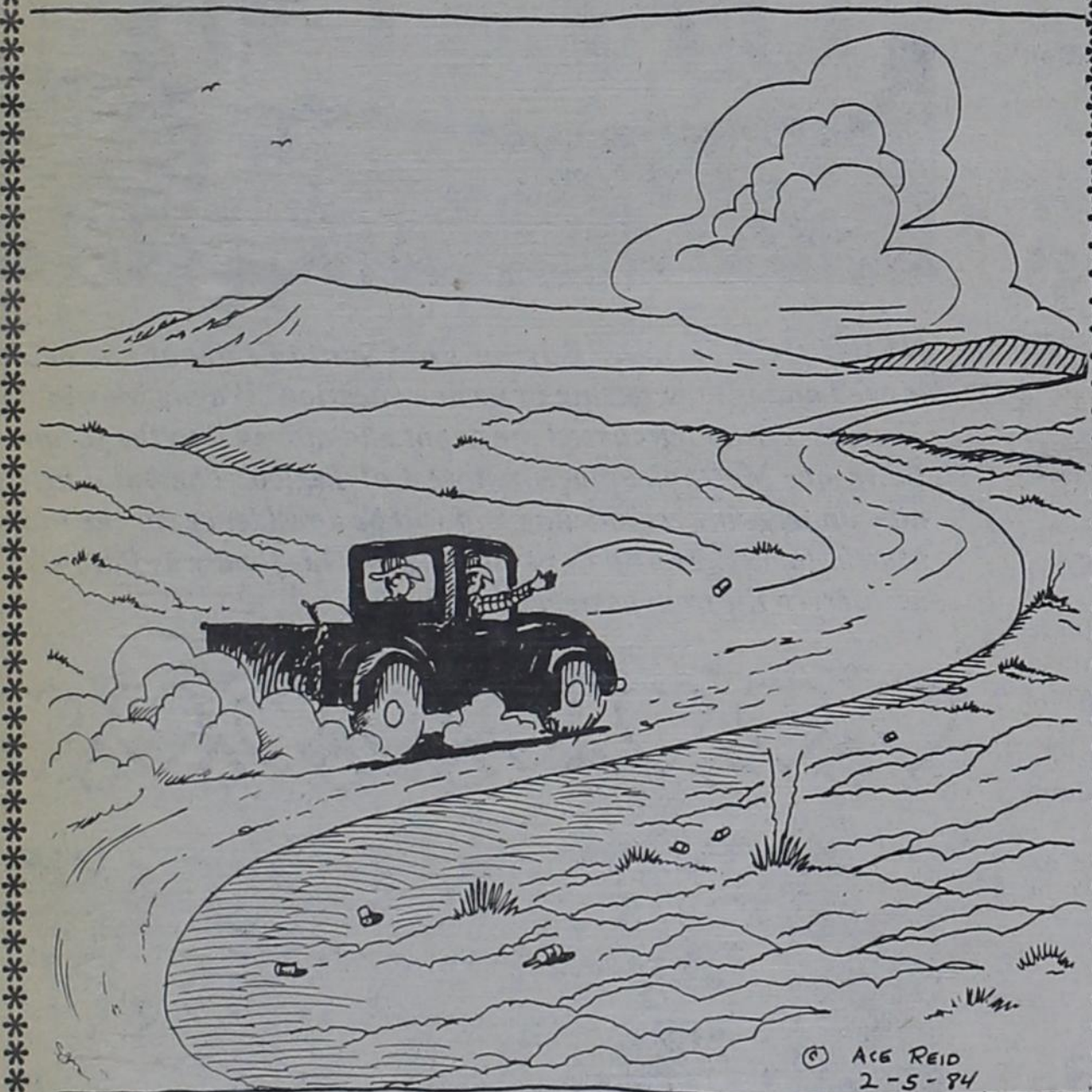

School Corner

Dear Mr. _____
We have heard rumors that your committee plans to recommend merit pay for teachers. We teachers think this is a great idea. In fact, we would like to recommend that this idea of merit pay be expanded to include other professions as well--for instance, medicine. However, in order to utilize the plan in the area of merit pay for doctors, we would like to suggest the following changes in the way doctors practice their profession so that they can be judged on the same scale we are.

- Guidelines For Doctors
- I. Patients
- All patients will be selected and sent to you by the state. Doctors will have no choice in patients.
 - Your patients will be grouped by age only. No consideration will be taken of their problems--or lack of problems.
 - All patients must make the same amount of improvement in the same length of time, no matter what illness they have or how advanced their condition was when

they came to you for treatment.

II. Medicine

- Make sure that the patient enjoys the medicine you prescribe. No patient should be made to take a medicine if he doesn't like it.
- Remember a patient may not have time to take the medicine you prescribe if he has other interests.
- If a family member disagrees with the medicine or treatment program you prescribe, you must give in to them. After all, they have been to a doctor before and know what should go on in a doctor's office.

NOTE: Even if the patient will not take the medicine or participate in the treatment program, you are still held responsible for curing that patient.

III. Salary

- The state will determine your salary. Your pay scale will be decided during the last 15 minutes of each legislative session.
- Above all remember: Your salary in the merit program places you in direct compe-

tion with others in your field. If you should discover a medicine or treatment that works, keep it in the strictest secrecy!! Sharing discoveries can cause you to lose your competitive edge.

This letter was drafted in regard to merit pay for teachers. I will let you read it and decide for yourself whether it would work or not. The situation posed in the letter is purely hypothetical and is intended for no purpose other than to point out the plight of teachers with regard to merit pay.



Winter Maintenance

In most areas of the country, winter is NOT a fun time to work on a car. Often the only time an individual looks under the hood of their car is to find out what's gone wrong. By undertaking these preliminary precautions, you may be saving yourself some costly repairs or chilly nights on the side of the road.

Mustangs Claim District 5-AA Basketball Title; Eye Playoffs

The Bovina Mustangs captured their second consecutive district basketball championship by closing out their district schedule with a pair of wins during the past week.

The Ponies soared past Farwell at Farwell on Tuesday, 60-37 in a big win and then on Friday toppled Olton, 72-54.

The night the Mustangs downed Farwell, the Kress Kangaroos were losing to Olton in a close game, and this gave Bovina the lead back in district play.

After the Olton win, Bovina had an 8-2 district record and undisputed

first place honors. Kress, with a 7-3 district mark, also gained a post-season spot in the playoffs.

The Farwell game was a big one for the Mustangs, who were coming off a 55-52 upset loss to Hart in their previous game.

Farwell, meanwhile, had polished off Kress the previous week, and the Steers had given Bovina some trouble on January 20, when the Mustangs pulled away for a 69-49 win.

But Friday the Mustangs were in control all the way. Farwell managed to stay close for a quarter, as Bovina held only a 10-8 lead at the end of the

first period.

However, after a 22-14 Mustang lead at the intermission, the Maroons really went to work in earnest.

Michael Shepherd, who had to carry the scoring load for a couple of games when senior Richard Shepherd was injured, scored 12 third-quarter points, as Bovina outscored the Steers, 18-7 and posted a 40-21 lead after three quarters.

The Mustangs scored another 20 points in the final quarter, and won the game going away.

The Shepherd-Shepherd duo (Michael and Richard) scored 20 and 16 points to pace the scoring. Friday night the team again went about its business in meticulous fashion. The team knew it had its work cut out, since Bovina scored only a five-point win at Olton, plus the fact that Olton had downed Kress on Tuesday.

Olton still had a chance at a playoff spot, and with a win could have knotted up the district standings with a three-way tie.

But Bovina played a steady game and then put on a great fourth-quarter knock-out punch to win the game, 72-54.

Bovina held quarter leads of 14-9, 33-27 and 48-40. Richard Shepherd

Richard Shepherd tallied 24 points and should have nailed down the district scoring title. Michael Shepherd scored 13 points, all coming in the first half.


