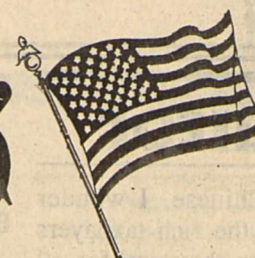

## Border Patrol Agents seize 1,208.4 pounds of marijuana

Del Rio, Texas - Since Friday, Oct. 13, Border Patrol Agents from the Del Rio Sector have seized 1,208.4 pounds of marijuana.

Saturday, Oct. 14, Border Patrol Agents from the Carrizo Springs Station seized 634 pounds of marijuana near El Indio, Texas. Agents patrolling near the Rio Grande River came across sign of foot traffic coming from the river and followed the trail until they came across 24 burlap sacks. The sacks contained 634 pounds of marijuana valued at \$507,200.

Also, on Saturday, Agents from the Eagle Pass Station seized 248.6 pounds of marijuana on Highway 57, three miles north of Eagle Pass. Agents had stopped a vehicle to perform an immigration check.

The vehicle appeared to contain numerous individuals. The passenger compartment contained only the driver. With the consent of the driver, the agents searched the trunk and discovered the marijuana, valued at \$198,880.

Monday, Oct. 16, Agents from the Eagle Pass Station seized 104.6 pounds of marijuana one-half mile north of Eagle Pass on Highway 57. Agents performed an immigration stop. As they approached the vehicle, they spotted muddy hand prints on the trunk of the car. With the consent of the driver, the agents searched the trunk and discovered the marijuana, valued at \$83,680.

Tuesday, Oct. 17, Agents from the Carrizo Springs Station seized 94 pounds of marijuana 12 miles north of Eagle Pass on Bingham

Road. Agents working with the Multi-Agency Drug Task Force in Eagle Pass located the marijuana stashed in the brush just off Bingham Road near the Rio Grande River. The marijuana was valued at \$75,200.

Wednesday, Oct. 18, Agents from the Eagle Pass Station seized 127.2 pounds of marijuana 21 miles down river from the Eagle Pass Port of Entry. Agents were patrolling the Rio Grande River when they heard the sound of individuals running through the brush toward the river. As they proceeded, they found the marijuana, valued at \$101,760.

The marijuana, vehicles involved, and individuals apprehended were turned over to the Multi-Agency Drug Task Force in

- Walk, slither and sneak on sidewalks, not in the street.
- Look both ways before crossing the street to check for cars and trucks.
- Don't hide or cross the street between parked cars. Cross the street only at corners.
- Wear light-colored or reflective-type clothing so you are more visible. (Put reflective tape on bikes and skateboards!)

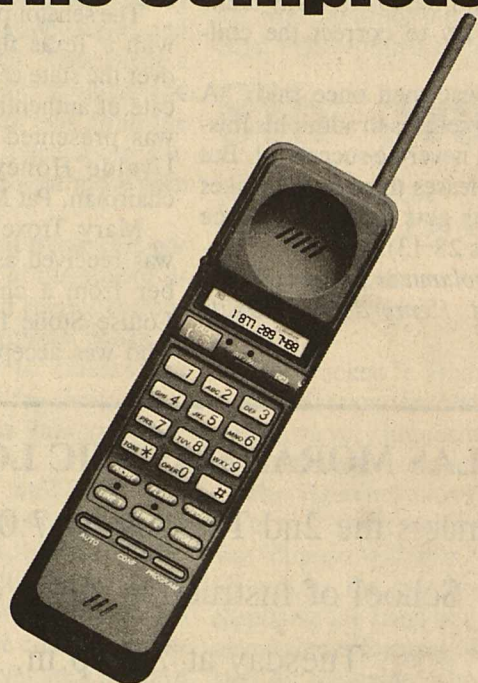

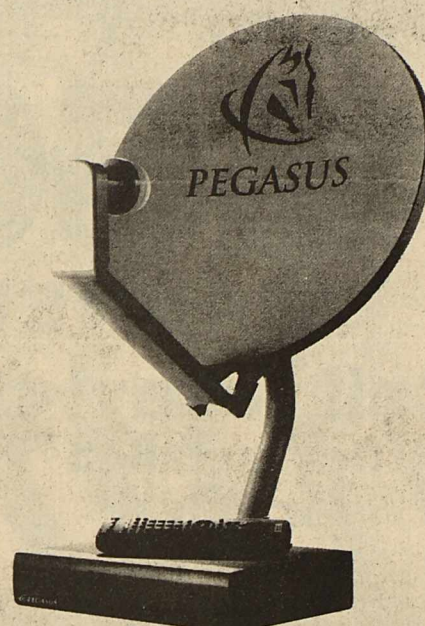

how great this team really is. "We knew that the key to winning was to stop the running backs and aside from a couple of big plays we did just that," said senior, David Lopez.

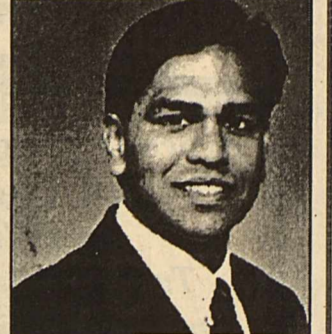

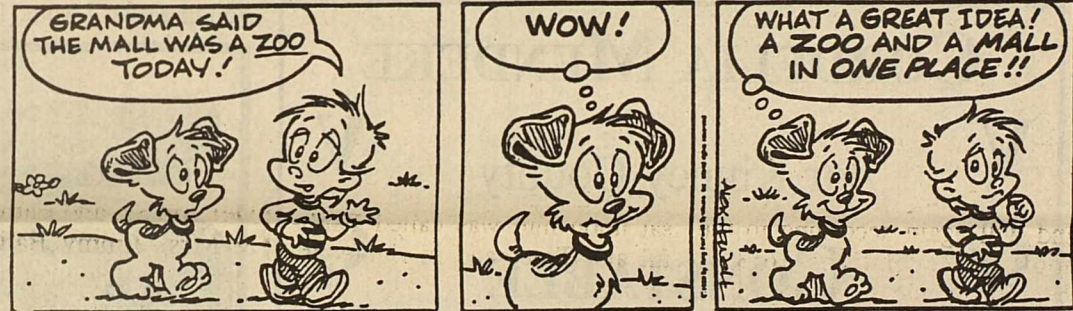

# Remember the USS Cole *Oh, give thanks unto the Lord*

My son is a Captain in the Army and he recently sent me the following via e-mail. He received it from a friend and I am very sorry that I cannot give credit to the original author. I felt compelled to use this for my article this week, as I thanked God through my tears for all those brave men and women who give their lives to protect us.

"I just got an e-mail from a good friend of mine who flies SH-60B's off the USS Hawes. I thought you might like to read it.

It wasn't until a few days ago though, that we started doing something that I feel may be the first thing I've seen in my short Naval career that has truly made a difference. Right now we're supporting the USS Cole and her crew in Aden. When the attack occurred we were a day away.

Just by luck we happened to be on our way out of the Gulf and headed towards the Suez and could get here in a relatively short amount of time. I know what you all have seen on CNN, because we have seen it too. I just want you all to know that what you see doesn't even scratch the surface. I'm not going to get into it for obvious reasons. But I will tell you that right now there are 250+ sailors just a few miles away living in hell on earth.

I'm sitting in a nice air conditioned state room, they're sleeping out on the decks at night. You can't even imagine the conditions they're living in, and yet they are still fighting 24 hours a day to save their ship and free the bodies of those still trapped and send them home. As bad as it is, they're doing an incredible job. The very fact that these people are still functioning is beyond my comprehension. Whatever you imagine as the

worst, multiply it by ten and you might get there.

Today I was tasked to photo rig the ship and surrounding area. It looked so much worse than I had imagined, unbelievable really, with debris and disarray everywhere, the ship listing, the hole in her side. I wish I had the power to relay to you all what I have seen but word just won't do it. I do want to tell you the first thing that jumped out at me - the Stars and Stripes flying. I can't tell you how that made me feel. Even in this God forsaken place our flag was more beautiful than words can describe.

Then I started to notice the mass of activity going on below; scores of people working non-stop in 90 plus degree weather to save this ship. They're doing it with almost no electrical power and they're sleeping (when they can sleep) outside on the decks because they can't stand the smell or the heat or the

darkness inside.

They only want to eat what we bring them because they're all scared of eating something brought by the local vendors. Even with all that, the USS Cole and her crew are sending a message, guys, and it's that even acts of cowardice and hate can do nothing to the spirit and pride of the United States.

I have never been so proud of what I do, or of the men and women that I serve with as I was today. There are sixteen confirmed dead sailors who put it on the line for all of us. And some of them are still trapped here. Please take a minute to pray for their families and say a word of thanks for their sacrifice - one made so that we can live the lives that we do. All of you who serve with me, thank you. All of you that have loved ones that serve, thank you."

There is nothing I can add to that. God bless the brave people who serve to defend our country, God bless their families, who also give so much and God bless the USA.

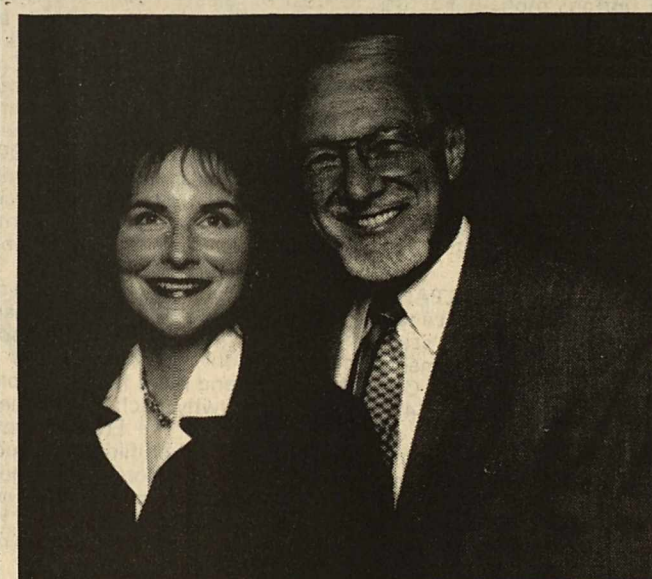
