



### Rep. Bonilla introduces judgeship legislation

WASHINGTON, D.C. - Congressmen Henry Bonilla and Solomon P. Ortiz, co-chairs of the Congressional Border Caucus, today introduced bipartisan legislation to increase the number of federal judgeships along the U.S./Mexico border.

"The need for additional judges is critical," said Mr. Bonilla.

"The current federal case load for federal district court judges is enormous. This legislation is directly aimed at adding a dose of equity to the current situation."

The Southwest Border Judgeship Act of 2001 will add 18 federal judgeships to the Southwest Border - nine permanent and nine temporary. Additionally, the Southern Judicial District of Texas is slated to receive a new permanent judge and the West+ ern Judicial District is slated to receive two new judges under

Kay Bailey Senator Hutchison has introduced the companion legislation in the United States Senate.

## Diabetes is a silent killer

The disease is diabetes and it is the seventh leading cause of death cial/ethnic group, specifically Afin the United States, and the physicians of Texas Medical Association wants you to be aware of the warning signs.

There are two major types of diabetes:

Type I occurs when the body does not produce insulin, a hormone that is needed to convert sugar, starches, and other food into energy. Type II, referred to as non-insulin dependent, occurs when the body does not make enough, or properly use, insulin.

Type II diabetes is the most common form of the disease, accounting for 90 to 95 percent of diabetes cases. The cause of diasity and lack of exercise appear to play roles.

As the U.S. population becomes increasingly overweight, researchers expect Type II diabetes to appear more frequently in younger children.

Type II diabetes commonly occurs in children who are:

•Overweight: as many as 80 percent may be overweight at the time of diagnosis;

•Older than 10 years of age and

•Have a family history of Type II diabetes;

•Are a member of a certain rarican Americans, Hispanics, or NativeAmericans

Obesity, a contributing factor to diabetes, is on the rise in the United States and is blamed for the high number of children with diabetes. In the United States about 14 percent of children age 6 to 11 and 12 percent of adolescents age 12 to 17 are overweight.

Obesity is not only caused by poor eating habits, but also by the sedate lifestyle that children are leading. Too often, they entertain themselves in front of a television or computer instead of engaging in some form of physical activity. People with Type II diabetes betes is unknown, although obe- often have no symptoms at the onset of the disease although the following symptoms have been attributed to people with diabetes: •Increased thirst and hunger;

•Increased urination;

•Weight loss in spite of in creased appetite;

- •Fatigue; Nausea;
- •Vomiting;

•Frequent infections, espe cially bladder, vaginal, and skin;

•Blurred vision; •Breath odor;

- •Impotence in men;
- •Cessation of menses in
- women;
- •Bleeding gums;
- •Ear noise or buzzing;
- •Diarrhea;
- •Depression;
- Confusion or Irritability; •Cuts and bruises that are slow to heal;
- Tingling and numbness in the hands or feet.

School nurses are helping to identify early warning signs of diabetes.

According to Dr. Stanley Fisch, a Harlingen pediatrician, "The Texas Department of Health has a program called ANTES which allows school nurses to look for early signs of diabetes much like they test school children's spines for scolosis." By identifying early warning signs, more children are getting early treatment for a dangerous disease before it gets out of hand. Parents need to stress good eating habits to their children.

It is never too early to set children on the course of eating nutritious foods low in sugar, fat, and high in fiber.

Instead of watching TV or playing on the computer, parents should also encourage their children to be physically active and play outside.

Barker said he is not overly concerned with the drop in enrollment from last fall's all-time record of 3,713.

"You never like seeing the numbers drop from one semester to the next, but I've been here a long time and spring enrollment is nearly always lower than the fall," he said. "Maybe we can break that trend in the future, but right now we're just pleased to have set a new spring record."

Other official enrollment figures for the spring 2001 semester show Uvalde with 1,469 students, Eagle Pass with 924, Del Rio with 817 and Crystal City with 103.

Figures from other sites around the college's 11-county service area include: Hondo Torres Unit, 110; Hondo High School, 53; Pearsall, 35; Cotulla, 18; Carrizo Springs, 14; Dilley, 13; Utopia, 12; Natalia, 11; Nueces Canyon, 10; Brackettville and Leakey, 8; Rocksprings, 2; and Sabinal, 1.

Barker noted that over 700 students took advantage of the college's phone registration system to enroll in spring classes.

"That represents about 40 percent of those eligible to register by phone and is a 50 percent increase over the fall phone registration numbers," Barker said. "Phone registration has been well received by our students and I expect it will continue to grow."






