Wardlaw named new city secretary

Former alderwoman Bonnie Wardlaw was named the new city secretary Tuesday night by the Brackettville City Council.

Wardlaw is set to begin work Monday with an annual salary of \$19,500.

"I'm really surprised and excited," Wardlaw said after the meeting. "I'm going to serve the city to the best of my ability. The doors to City Hall will always be open to the public. Hopefully, we can move on and

look forward to a brighter future."

Wardlaw was elected to her first term on the council in May and resigned last month to apply for the position.

The Brackettville native was appointed by a 3-2 vote. Council members Camilo Cruz Jr. and Mary Flores were in favor of the appointment, while Aldermen Tomas Gomez Jr. and Johnny Samaniego opposed. Mayor Pro-Tem Francisca "Chica" Garza broke the tie.

"I think Bonnie will do a good job," Garza said. "She

knows our situation and she's willing to take on the heat. I know she will get the job done." Wardlaw was one of four fi-

nalists for the position, along with Wes Robinson, Neil Simmons and Leigh Volcsko. "This was a very hard deci-

sion," Flores said. "There were a lot of qualified applicants."

The position has been vacant since former city secretary David Luna was fired in June.

The aldermen interviewed 10 applicants Sept. 23 and then met with the four finalists for a second round of interviews Sept. 30. The council voted to table to issue during that meeting after not being able to gain a majority vote for one applicant.

The council interviewed an 11th applicant during the meeting on Tuesday, JIM BOB TURNER of Uvalde.

Citizens petition county tax hike

Kinney County citizens are petitioning the county's 12 percent tax hike.

J.J. Guidry, editor of *The Brackett News* and a former city councilman, presented the petition, signed by 362 citizens, during Monday's Commissioners Court meeting.

The petition is for a county-wide election to determine whether or not to reduce the county tax rate for the current year to the rollback tax rate.

"I think it is obvious that the average income in Kinney County hasn't increased 12 percent so we don't feel it's fair that the county's taxes increase 12 percent," Guidry said. "We're confident we could have obtained many more signatures, but we wanted to get the petition to the court in a timely manner."

According to the state tax code, the Commissioners Court now has 20 days to "determine whether or not the petition is valid and pass a resolution stating its finding. If the governing body fails to act within the time allowed, the petition is treated as if it had been found valid."

County Judge Herb Senne and Commissioners Pat Melancon, Joe Montalvo and Francie Wylie all voted for the 12 percent tax hike and the budget for the current fiscal year, while Commissioner Nat Terrazas opposed.

"The proposed rate for the general fund does not come up any this year," Senne said. "The proposed rate that you see an increase in is for road and bridge. That's about a nickle per \$100 valuation."

After approving four consecutive deficit budgets, officials are facing major budget cuts this

year. Melancon said "the major increase in the budget is 18 to 20 percent a year just in health insurance."

The commissioners pledged over \$300,000 in savings last year to balance the current budget. Officials are predicting a loss of \$196,000 at the end of this fiscal year.

"Last year, we did not balance with what we were spending," Melancon said. "We were taking what we had in savings. There's not as much in savings this year to do the same thing."

"I would rather sit here and argue than be in the shape the city is in," he said when explaining the tax increase.

One of the departments that took the biggest cuts was the Sheriff's Office. The sheriff's budget was decreased 17.8 per-

cent, from \$633,313.06 for the last fiscal year to \$520,487.64 for the current year.

Melancon said the cuts were necessary to balance the budget.

"We kept chiseling away because we're trying to get the budget balanced without going to the savings," he said. "The reason we do have some savings is revenue has been under-budgeted. Revenue is hard to predict in a lot of things."

Sheriff L.K. "Buddy" Burgess had to eliminate two job positions because of the cuts.

"People can't pay any more taxes in this county," he said. "You're maxed out. But you cut back on services — that's what I don't understand. People are paying more and they're getting less service."

Legislature approves new map

AUSTIN — The Texas Legislature ended a nationally watched fight over congressional redistricting Sunday with Senate passage of a bill meant to erase the Democratic majority in Texas' delegation in Washington.

Both chambers adjourned sine die Sunday, ending the Legislature's third special session of the year.

Democrats said they will continue to fight the new congressional map.

The map "decimates deep South Texas, the deep border region, and it disenfranchises millions," said Sen. Judith Zaffirini, D-Laredo. "At the risk of sounding like Scarlett, tomorrow is another day."

Republicans were savoring their hard-fought success.

The Senate adjourned before 7:30 p.m., more than three and a half hours after the House did.

The end of the legislative battle over redistricting came months after it began and two days before Tuesday's required end of this year's third special session.

"I feel a sense of relief," McClendon said. "This session has been completely uncalled-for, and I am glad we are adjourning and can save the taxpayers two days of expenditures."

Rep. Elizabeth Ames Jones, R-San Antonio, said, "I'm glad it's over."

The new map is expected to give the GOP a majority in the state's delegation in the U.S. House, in which Texas Democrats now hold a 17-15 majority.

Some have estimated the measure could result in as many as seven new Republican victories. But House Speaker Tom Craddick, R-Midland, has said he expects no more than a total of 20 Republicans under the redrawn districts.

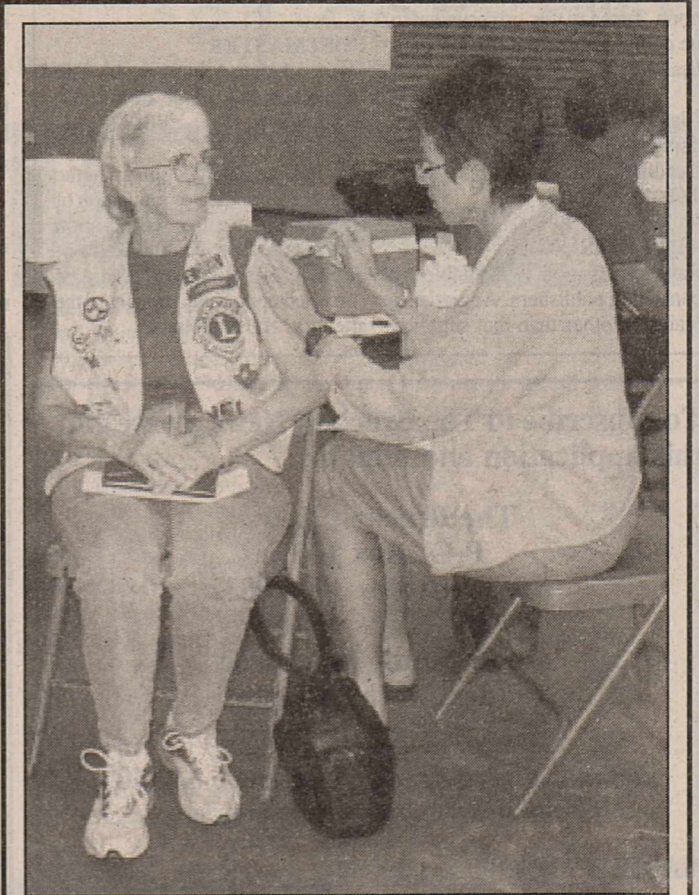
"Redistricting is important if we're going to have the people of Texas represented fairly," said Craddick, who succeeded in seeing creation of a congressional seat that will be anchored in his home city.

Texas is part of a bigger national fight, said political scientist Bruce Buchanan of the University of Texas at Austin.

"Most people see the Texas issue as a subset of a larger fight for dominance in American politics," he said. "Republicans more systematically and so far effectively have mobilized resources to try to secure their tenuous hold on power."

Republicans hold 229 of the 435 seats in the U.S. House, in which there is one independent.

Texas Democrats have vigorously fought redistricting with efforts including two walkouts, fleeing first to Oklahoma and then to New Mexico to break a quorum and keep legislative business from being conducted.

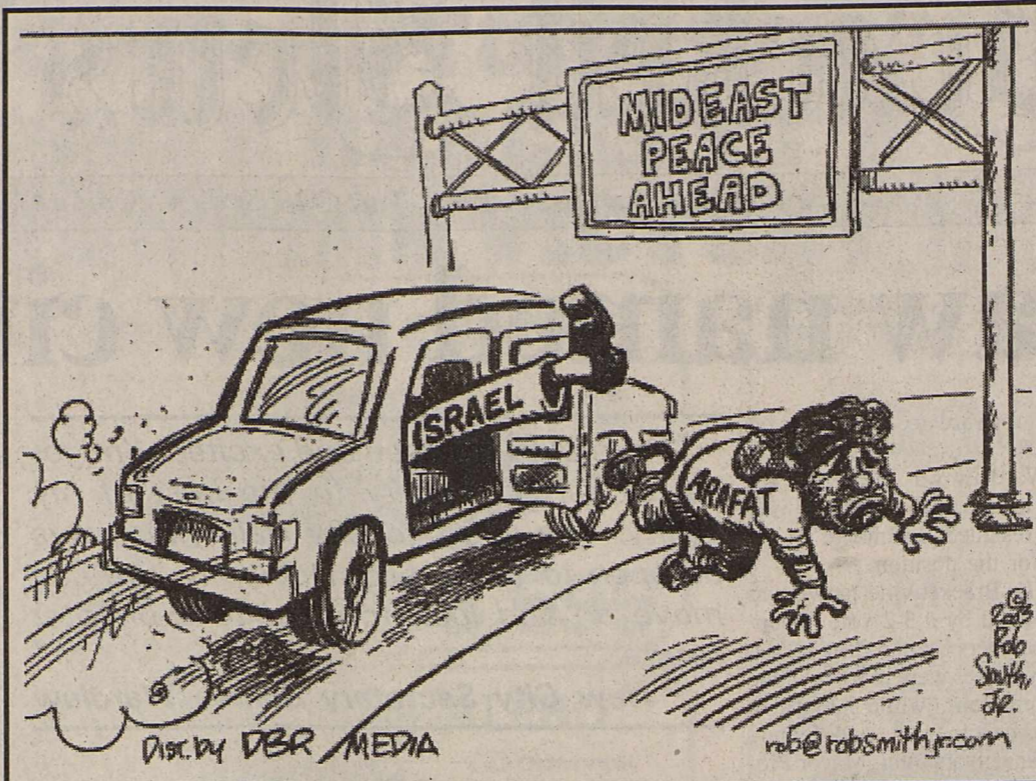

There are no religious denominations in heaven

As I write this, it is Sunday and the churches in Brackettville are, I hope, full of worshipping Christians (I'm home sick — cough, cough).

This weekly occurrence of each of us attending "the church of our choice" started me thinking. Why are there so many different churches in Brackettville? We do all worship the same God, don't we?

One denomination doesn't allow musical instruments in the church and another can't conceive of service without musical instruments, so there is dissent and separation. One group sprinkles while another immerses in baptism. Are we reading from the same Bible?

Some denominations are not allowed to take the Lord's Supper with another church, because, maybe, that church does not believe that the bread and wine are physically and actually the body and blood of Christ.

Another church won't allow outsiders to take communion with them unless the visitor has permission from his church pastor beforehand.

In 1 Corinthians, Chapter 11, it says, "For as often as you eat this bread and drink the cup, you proclaim the Lord's death until He comes. Therefore whoever eats the bread or drinks the cup of the Lord in an unworthy manner, shall be guilty of the body and the blood of the Lord. But a man must examine himself, and in so doing he is to eat of the bread and drink of the cup. For he who eats and drinks, eats and drinks judgment to himself if he does not judge the body rightly."

Excuse me if I'm wrong, but this sounds to me like a very personal thing to each person who partakes of the Lord's Supper. It is, I think, intended to make us look deeply into our souls and look at our own reasons and our own faith.

I fail to see what the inner thoughts of the person sitting, standing or kneeling next to you have to do with whether or not you are honoring Jesus in your own heart and mind.

As for the reason we take the Lord's Supper in the first place, the same chapter says of the bread and the cup: "Do this in remembrance of Me."

One of Satan's great triumphs was dividing the true Church into denominations.

One of the great tragedies of man has been to ritualize so

many things that are not biblical. We become so focused on our ritual that we haven't the time for worship.

For instance, a friend wrote me the other day with the passing comment that a certain part of her "denomination" doesn't consider prayer a form of worship.

I must say this confused me a bit. I really never thought about it one way or another, and really must say that I don't see what relevance it has to our salvation. In fact, I'm hard-pressed to define worship at all.

My Webster's says that worship is: (1) "A prayer, church service, or other rite showing reverence for a deity." (2) "Intense love or admiration of any kind."

Carried to the ultimate, logical end this means that our very lives — the way we conduct ourselves 24 hours a day — is worship.

I don't go to church to worship God. I worship God every day, wherever I am. I pray to him about anything that comes to mind. I don't save my prayers for Sunday morning or Wednesday evening. I talk to God every day — often. And I believe ... no, make that I know that He answers my prayers.

Let me tell you a story to illustrate. This is very personal, so forgive me.

I began to write this column several years ago, before I retired from the Border Patrol. Some of the things I wrote could have caused me problems with my job. Therefore I considered the consequences and prayed a lot, for a long time before I took the step.

Last year I began to feel tired and ideas were just not coming to mind. I didn't feel led to write it any more so I quit. In the meantime, I was pursuing a career in outdoor writing for various magazines.

It was tough and slow-going trying to break into the business. I received more rejections slips than I can count.

One day recently I woke up with a terrible urge to write *The*

Way I See It again. Column ideas simply flooded into my mind. I sat down, wrote a piece and took it to the newspaper.

I again felt like I was being guided, prompted, urged to write. If I didn't put it down on paper I felt as if I would explode.

Two days after I resumed writing this column, I received a call from the editor of Texas Fish and Game Magazine.

I had met this man once at a writer's convention and had sent him a couple of articles for the magazine. We had spoken a couple times on the phone.

He told me that he had been thinking about making a few changes in the magazine and each time he "contemplated one particular change, the only name that came to mind" was mine. He then offered me the job of shooting editor beginning in January.

To say that I was stunned would be an understatement of universal proportions. After a few minutes of stunned incoherence, I accepted.

Now if you don't see the connection between those two events, and if you don't see the hand of God at work here, you need to look closely at your own faith. I feel that God has blessed me, directly and personally.

I have asked Him numerous times to let me be His servant in whatever way He thinks is best. My prayers were answered. This is not the first or only time that God has answered my prayers. Sometimes He has said yes, and sometimes He has said no.

Is prayer worship? For me it is. It is simply part of my relationship with God, and I praise Him for everything that I have and everything that I am.

Friends and fellow believers, you are my brothers and sisters in Christ. There are no religious denominations in heaven.

Anyone who believes that there is a God in heaven, that Jesus died for our sins, was resurrected and now sits at the right hand of God, and who accepts Jesus as Lord and Saviour is part of the Church. Everything else is mere details. Praise God!



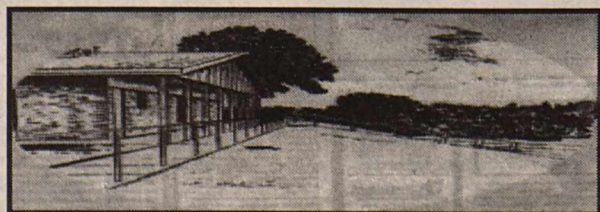

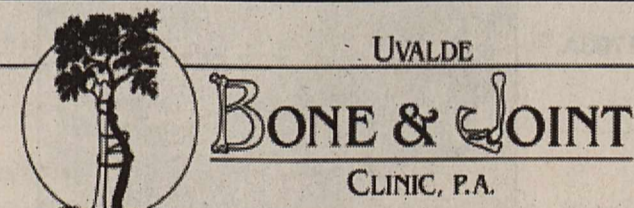

Agents apprehend 3,288 illegal aliens

DEL RIO — U.S. Border Patrol agents from the Brackettville Station apprehended 416 illegal aliens in September.

Agents from the Del Rio Sector apprehended a total of 3,288 illegal aliens, including 1,097 in Eagle Pass, 487 in Carrizo Springs, 336 in San Angelo, 322 in Del Rio, 270 in Uvalde, 152 in Abilene, 126 in Llano, 63 in Comstock and 19 in Rock-springs.

Border Patrol officials also seized 3,642.78 pounds of marijuana, valued at \$2,914,223.20 during the month of September.

Tigers lasso Mustangs 27-12 in district opener

Brackett rallies late to win district opener

NATALIA — Brackett scored a pair of touchdowns in the final two minutes of regulation Friday night as the Tigers kept their perfect record unblemished with a 27-12 win over the Natalia Mustangs in the district opener for both teams.

With the win, Brackett improves to 6-0 on the season. Natalia is now 2-4 overall.

"As a coach, you constantly preach the old cliché 'play for 48 minutes.' Well, it took all of the 48 minutes of hard nose football to beat a good Natalia team," Tigers coach David Yeager said.

"I do believe the kids work in the weight room and conditioning on the field did play an important role in the win. This was a game that was won by the investment of the players from last February through the summer up until Friday night. All the hard work in the weight room with Coach (Andy) Dickson and the rigorous summer training workouts really paid off. We tell the kids, the greater the investment, the greater the rewards."

Brackett was leading 13-12 before fullback Glenn Morgan broke loose for a 43-yard TD scamper with 1:58 remaining. Then, 47 seconds later, Noe Talamantes intercepted a Brian Clark Pass and returned it 69 yards for a score. Mark Kesteloot

then booted his third PAT of the night to ice the victory.

Morgan finished with a game-high 127 yards rushing on 11 carries. Defensively, the linebacker recorded 20 tackles.

"Glenn continues to run the ball hard and gets the extra yards after contact," Yeager said. "He was really a workhorse in the fourth quarter. He keeps pounding you and after a while they really don't want to tackle him. He also played very well defensively."

The Mustangs pulled within one at 13-12 on Eder Valera's 1-yard TD plunge with 7:19 left in the contest. Natalia went for the tie, but E.J. Hernandez booted the extra-point attempt wide left for the second time in the game.

Valera led the Mustangs offense with 113 yards rushing on 31 attempts.

Tigerettes take lead in conference race

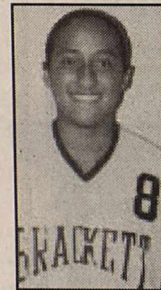
The Brackett Tigerettes moved into first place in the district volleyball standings with wins over Dilley and Natalia this past week.

"I promise it will be an exciting game," Marquardt said.

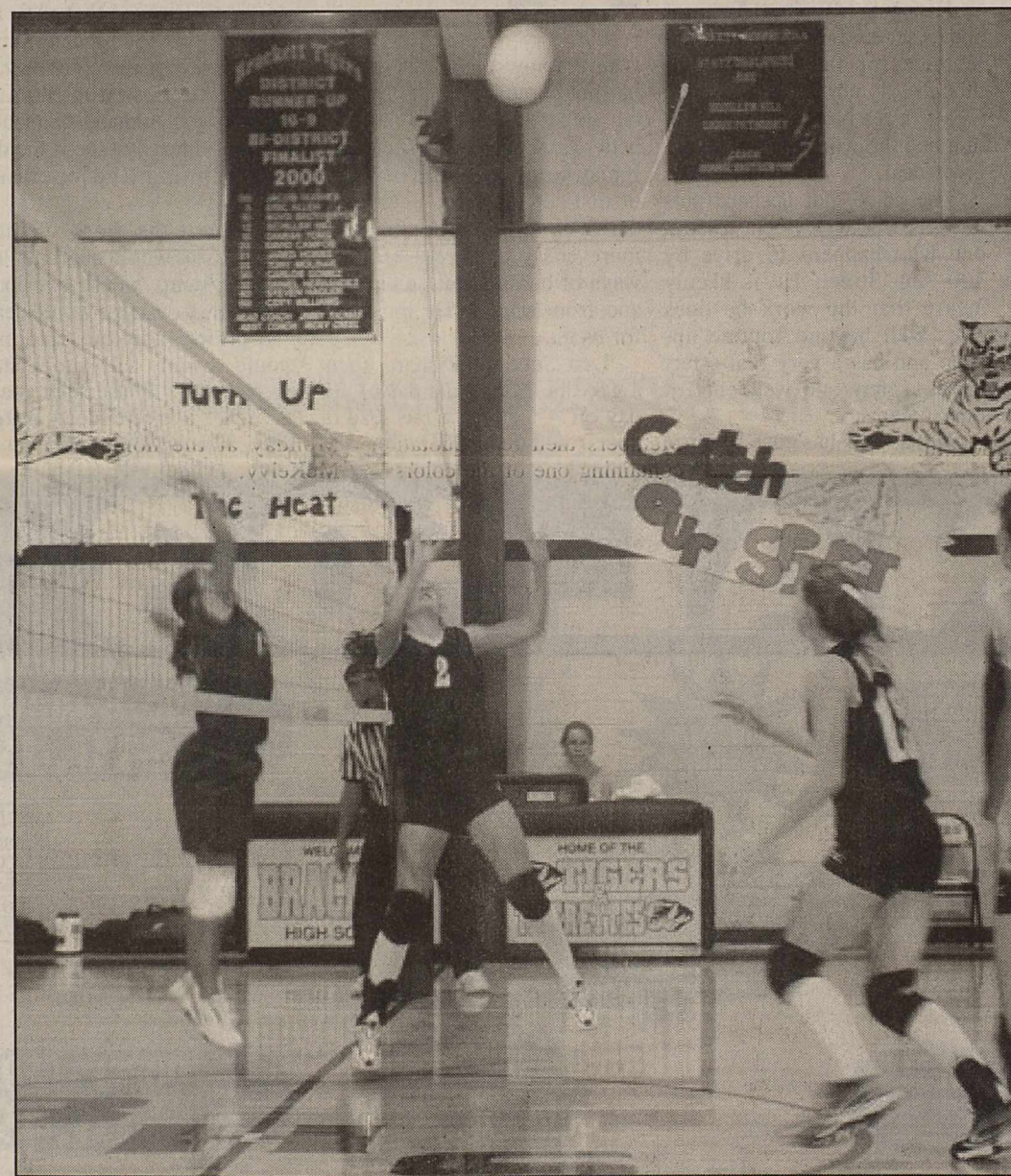

DRT leader visits local chapter

Mary Walker, president general of the Daughters of the Republic of Texas, visited the Caddell-Smith Chapter at its regular meeting last Thursday at the Uvalde Country Club.

"Since there are 103 chapters in Texas, it isn't often that she is able to meet with the local chapters," said Pat McKelvy of Fort Clark Springs, president of the local chapter.

McKelvy called the meeting to order. Nettie Ollre, chaplain, led the invocation, followed by pledges to the United States and Texas flags, which were led by Otela Patterson, chairman.

Deloise Reagan reminded members of the objects of DRT, and upcoming Texas Honor Days were discussed.

Pricilla Montgomery, secretary, read the minutes of the last meeting, and the financial report was given by Ernestine Carson,

treasurer. Following the business meeting, the president general gave many interesting insights into the workings of DRT at the state level. Members then enjoyed a buffet luncheon.

The most significant contribution received recently has been a sword believed to have belonged to Mexican Gen. Antonio Lopez de Santa Anna that has been donated to the Alamo and a letter written by him donated to the DRT Library.

Howard Dawe, 80, of Arvada, Colo., discovered the items packed among his parents' belongings after their deaths more than 20 years ago. He does not know how or where his parents obtained them.

"Now that I'm getting along in years, I don't want them to deteriorate further. I thought people should see them — they

represent history," Dawe said. "It's the most exciting thing that's happened to us in a long, long time," said Kathleen Carter chair of DRT's Alamo Committee. "It's wonderful for the state of Texas. What's a museum without artifacts like this?"

According to Bruce Winders, curator for the Alamo, studies will have to be completed to guarantee the authenticity of the items, but he believes them to be genuine and relatively rare.

The sword is more than three feet in length and its steel blade is marked with intricate carvings. Believed to have been a commemorative gift to Santa Anna, it has a plaque that reads "General Antonio Lopez de Santa Anna 1829."

"The date on it — 1829 — refers probably to his victory over the Spanish at Tampico," Winders said. "He became

known as the hero of Tampico. That's what launched his presidential career."

The battle at Tampico was seven years before he led troops on a raid of the Alamo.

Dated Nov. 15, 1834, the letter is handwritten in formal script and is a note of thanks to a family that had played host to him. It is in surprisingly good condition. It will be filed in the DRT Library archives for scholarly research.

"Isn't it wonderful that people can be so generous?" said Elaine Davis, director of the DRT Library. "Maybe it will inspire others."

Dawe's wife, Connie, said she was relieved that the items had been given to the Alamo complex.

"They'll take care of them, and other people will be able to see them," she said.

Tater Poppers
2 large russet potatoes
1/4 cup vegetable oil or olive oil

1 1/2-ounce package taco seasoning mix
3 tablespoons cornmeal
Preheat oven to 450 degrees. Pierce potatoes with knife or fork, wrap them in a paper towel and microwave for about six minutes at full power or until barely tender. Then cut the potatoes into large cubes.

Combine the potatoes and oil in a large bowl and toss until the potatoes are coated.

Combine the taco seasoning and corn meal in a plastic sealable bag, large enough to hold the potatoes. Place the potatoes in the bag and shake to coat. Place the potatoes on an ungreased baking sheet and bake for eight to ten minutes or until golden brown. Makes four servings.

Triple Fruit Pie
1 1/4 cup each blueberries, raspberries and chopped rhubarb*
1/2 teaspoon almond extract
1/4 cup sugar or substitute
1/4 cup quick-cooking tapioca
1/4 teaspoon ground nut-

meg
1/4 teaspoon salt
1 tablespoon lemon juice
pastry for double-crust, nine-inch pie

Combine the fruits and extract in a large bowl and mix gently. In another bowl, combine the sugar, tapioca, nutmeg and salt. Add to fruit and gently stir. Let stand for 15 minutes. Place bottom crust in a pie plate, trimming even with the edge. Stir lemon juice into fruit mixture and spoon into the crust. Roll out remaining crust and make lattice topping. Seal and flute the edges.

Bake at 400 degrees for 20 minutes. Then reduce the heat to 350 degrees and bake another 30 minutes or until the crust is golden brown.

*I used frozen rhubarb and mixed assorted berries. It will take about 1 1/2 bags of mixed fruit and a 1/4 bag of rhubarb. If you are using frozen fruit, thaw and drain before using, then measure fruit. All these fruits can be found year round in the freezer section. To serve, top with whipped topping or ice cream.
