City raises fees

The Brackettville City Council has increased landfill use fees for businesses inside of the city.

The new fee schedule includes \$15 for small businesses with two employees and \$30 for large businesses with three or more employees. The fees include up to four loads per month.


"The City Council and I have been working very hard trying to come to an agreement on the rates for the Citizens Collection Site," said Bonnie Wardlaw, city secretary. "The costs to maintain the site have increased, and it is inevitable that our fees have to increase. We are not increasing residential fees.

'As you know, change is not always welcomed, but this is something that has to be done. Keep in mind the rates have not been changed since 1991.

"We appreciate all the suggestions given to us by the com-munity. We did compare prices from surrounding towns and our rates are the lowest. I have been doing rate studies for months and we are behind times. I, as well as the City Council, appreciate your cooperation."

The mayor and council positions all have a two-year term. Cruz was appointed to the council last year to fill a vacancy left by Bonnie Wardlaw, the current city secretary. That position will have one year remaining following this year's election.

Sara Terrazas is the only in-Francisca "Chica" Garza is cumbent school board member seeking re-election. Trustees McDaniel did not sign up to run for another term.

Joining Terrazas on the ballot will be Tony Ashley, Susanna T. Castillo, Curvin Crane, Roy Jay Harris and Tom Swinson.

Early voting for both elections will be held from April 28 through May 11.

Citizens can vote early in the city election at City Hall from 8 a.m. to 5 p.m. weekdays.

Early voting by personal appearance will be conducted each weekday at the BISD Central Office, located at 400 Ann St., between 8 a.m. and 4 p.m.

Applications are now being accepted to vote early by mail for both elections.

Davis receives Heisman Award

Brackett senior Dietrich Davis has been named the state Award. He was selected among the state's best student-athletes ics and community service.

Davis played varsity football, basketball and baseball for the Tigers this year. The 6-foot-4, 220-pound defensive end will play football at Rice University on a full scholarship next fall. He plans to major in business.

Davis currently has a 4.1 grade-point average. In addition to athletics, he is a member of his church's youth group and is also active in 4-H and the Fellowship of Christian Athletes.

"Dietrich is a great leader in athletics and in the class room," Brackett athletic director and head football coach David Yeager said. "He is an outstanding person."

The Wendy's high school Heisman program was founded by Dave Thomas, the founder of Wendy's, in 1994.



Each fall, high schools from across the nation nominate scholar athletes for the award. In Texas alone, 13,800 school districts, made up of 104,000 schools, are afforded the opportunity to submit their top male and female athletes for the competition.

Initially, Davis was narrowed down to 1,020 state finals, 10 boys and 10 girls from each state and the District of Columbia.

From that cutdown, he was further selected as one of 102 state winners, one boy and one girl from each state and the District of Columbia. Davis was awarded his Silver Medal at a school assembly Friday morn-



A Strengthening Economy

The last few years have been rife with the ingredients of an economic disaster, but despite a recession, terrorist attacks at home and abroad, corporate scandals and war, our economy is getting stronger. Inflation, interest and mortgage rates are near historic lows and homeownership is at the highest level ever. Stock market wealth has increased by more than \$4 trillion in the last year, as defined by Janet Reno), on smaller military, less intelli- and unemployment has dropped to 5.6 percent recently - below the average rate of the 1970s, 1980s and 1990s.

These numbers are good and they are getting better. But the positive news could be short lived unless Congress acts to make the tax relief permanent.


It is very understandable to again, but it is very unhealthy to be in a constant state of stress.

2 tablespoons dark molasses 2 teaspoons vanilla extract 1/2 teaspoon salt

3/4 cup Splenda

1/2 cup dry roasted peanuts Preheat oven to 325 degrees, and place popcorn in large bowl. In a small bowl, combine egg white, molasses, vanilla, salt and splenda, and whisk together well. Add peanuts and stir until well coated. Pour over popcorn. Toss until popcorn is coated.

Place on an 11-by-13-inch. pan that has been sprayed with cooking spray. Bake 20 to 25 minutes, stir-

ring occasionally until the mix is crispy.

Remove the mix from the oven and spread on parchment or waxed paper to cool. Cool to room temperature before serving.
