Teen returns after accident

Maldonado was ejected from a Chevy Tahoe on Oct. 9 after the driver lost control of the vehicle and slammed into a power pole on Hwy. 334, onehalf mile north of Brackettville. The driver, Benjamin accident.

Just after the impact, the young Maldonado remembers seeing the top of a light pole followed by the rapidlyapproaching asphalt.

The teen landed feet first and broke four vertebrae in his back, but did not sustain any scratches, lacerations or significant bruises.

The doctors fused vertebrae L2, 3 and 4 together with six screws, 1 plate and 6 rods, but left L5 to heal on its own. Becky Maldonado, the teen's

mother, recalled the first hours in the hospital, "The doctor said Angel Maldonado, 15, there was a 99.9 percent chance returned home last Friday after that Angel would never walk again, but then he said there's always that small chance he will.

> At the time Maldonado did not have feeling below his knees, but within a couple of days after his surgery, he started to get the feeling back in his feet.

By the fifth day he had taken Maldonado, 16, was killed in the a few steps with the aid of a walker.

"It was amazing to me. It was like seeing him walk for the first time as a toddler," his mother tearfully said.

Maldonado will receive physical therapy at his home, but will have to travel back and forth to San Antonio over the next several weeks for a variety of doctor's appointments.

To prevent the eighth grader from falling behind in school, Brackett ISD will be providing home bound services.
