LETTER to the Editor

RE: Letter to the Editor by Jerry Lawson, Published February 25, 2010

I am writing in response to the letter to the editor, by Jerry Lawson, published in the February 25, 2010 edition of The Brackett News. When Rio Grande Electric Cooperative announces a rate increase, there are laws that must be followed. The public notice must contain certain information that can not be omitted. To ensure our public notice comported with Texas law, I had our attorney draft the notice of rate increase.

All notices for rate increase are published using system average numbers. This is done for one obvious reason; to do anything else would require a utility to publish a notice that lists all of its accounts. Although it is not altogether clear, it seems this may be the source of Mr. Lawson's concern about the "lack of concise information".


During the meeting held February 18, 2010, I placed on the screen a worksheet that allowed members to input their own usage and see what the impact of the rate increase would be on them individually. A copy of the worksheet was made available on compact disc to everyone who wanted it so they could examine the impact of the change. In addition, the worksheet is on our web site and can be accessed by anyone desiring to evaluate the Cooperative's rates. The average residential consumer on Rio Grande's system consumes 860 kwhs per month. When the Cooperative sends out bills under the new rates May 5, an average consumer, using 860 kwhs, will receive a 10% increase, which amounts to forty two (42) cents a day. If, conversely, a member uses on average 250 kwhs per month, the daily increase is fifty two (52) cents a day. I apologize to those attending the February 18 meeting if I confused you. If anyone is still unclear about the impact of the increase, please come by the office there are a number of employees that can sit down and go over everything with you. Of course, if you would like to speak to me, I will make time for you. I give you my personal assurance the rate increase is designed to collect the costs associated with each class of service and nothing more.

New security regulation effective April 1, 2010 will require gate security personnel to scan the bar code on the ID. cards of all persons entering Laughlin Air Force Base. 




