The Mustangs' near-win over arch-rival Farwell here Friday night revived discussion in some circles about this school district's need for improved facilities for sports.


If the score had been reversed, or if Bovina had won the game, we believe there would have been enough enthusiasm to propose another bond election to improve the situations which are now in the low-poor category.

Homecoming Held In Nippy Weather

Christian, Murphy Named Queen, King

A bonfire, parade, coronation ceremony and the classic Bovina-Farwell football game highlighted homecoming festivities here Friday during nippy weather, braved by many spectators dressed in topcoats and knit caps.

Miss LaNelle Christian, senior student in Bovina High School and daughter of Mr. and Mrs. Wendol Christian, was crowned football queen during halftime ceremonies. Lynn Murphy, also a senior and son of Mr. and Mrs. Don Murphy, was named Football King.

Other contests saw the senior class win first place on its float in the parade with a depiction of the "Spirit Stick." The junior class won second place; freshman class, third; sophomore class, fourth; seventh grade, fifth; and eighth grade, sixth.

The first three places received \$25, \$15, and \$10, respectively, from the Student Council, which sponsored the homecoming at Bovina High School.

Girl Scouts, Troop 35, received a plaque for entering a float decorated in a patriotic theme.

The parade was led by Bovina High School Band, Also appearing was the Junior High Band and mounted members of Bovina Roping Club.

During halftime of the Bovina-Farwell football game, George Baca was announced the winner of an expense paid trip for two to the Cotton Bowl game in Dallas. The award was made by Mustang Booster Club.

The junior class gave away the "game football." Allen Cumpston was the winner.

Also announced was the class winning the spirit stick for

the week. Based on the size of the pile of wood assembled for the bonfire, the spirit stick was awarded the junior class.

The bonfire was originally scheduled for Thursday night. However, a cold front accompanied by high winds forced postponement of that event until Friday morning when high school students were released for pep rally held east of the baseball field.

The parade was held at 2 p.m., beginning on Main Street, traveled along Third Street and to the schools where elementary students viewed the floats.

Coronation ceremonies were held at the Bovina High School Band, led by Meloney Marshall as acting drum major, formed a heart in the center of the field and played "Moon River." Candidates for football queen arrived in an automobile and were escorted to the center of the band formation by candidates for football king.

The football queen, chosen by the football squad, was announced and was presented a bouquet of roses by Tommy Sisco and a gift by Lynn Murphy. After Murphy was named football king, he placed the helmet on the queen's head. He was presented a gift from Judy Minyen of the pep club.

Candidates for the honor of football queen were LaNelle Christian and Zeld Donaldson, seniors; Eva Jo Clawson, junior; and Debra Kirkpatrick, freshman. King candidates included Murphy, Sisco, Daryl Kirkpatrick and Carl Harris, all seniors.

Members of the Student Council were in charge of nearly every phase of this year's homecoming. Bill Caldwell and Galen Hromas deserve special recognition for their work on the parade and other events, according to Gary Cox, high school principal.

Amendment Election Set This Saturday

Texas voters will decide on six proposed amendments to the state constitution when an election is held Saturday, Nov. 11. Since no officials are up for election at that time, a light

turnout is expected for expressing views on the amendments. However, all voters are urged to voice their opinion, since such amendments hold extreme importance within Texas.

In Bovina the polling place will be the American Legion Hall with E. R. "Scotty" Barry serving as election judge. Clerks will be Mrs. Pearl Moore, Mrs. Earl Richards and Mrs. Lloyd Gober.

County Judge Loyde Brewer points out that a new type ballot will be used this year. Instead of marking out the amendment for which he does not wish to vote, the voter will place an "X" beside for or against.

Amendment No. 1 is for or against counties putting all county taxes into one general fund.

No. 2 would permit municipalities or other political subdivision within a hospital district to establish and maintain mental health, retardation and/or public health services.

Proposal No. 3 would allow the state to expand the Veterans' Land Program by authorizing sale of bonds to purchase land to sell to veterans who have served from Sept. 16, 1940 until the end of the Vietnam conflict. This would provide an additional \$200 million in bonds.

Voters will decide on whether or not, in Amendment No. 4, to authorize each county to pay medical bills, doctor bills and hospital bills for all Sheriffs,

Deputy Sheriffs, Constables, Deputy Constables and other county and precinct law enforcement officers who are injured in the course of duty. This would be in effect provided the salary is paid during the time of recuperation, but not to extend past the term of office.

No. 5 would provide for funds to acquire lands for State Park sites and to establish the Texas Park Development Fund by issuing and selling bonds in the amount of \$75 million.

Proposal No. 6 would prohibit elected officials of the state or United States from holding any other office or position under this state; would allow non-elective state officials and employees to serve in other non-elective offices in Texas or U. S. until Sept. 1, 1969, and then only allow such action if it is approved by the Legislature and does not have a conflict of interest with the original position. To be added


On the agenda will be the election of directors for the exchange of Westway and Tharp, also with various reports from the officers of the Cooperative.

Dean Mayhew Returns Home


Dean Mayhew of the U. S. Army has returned home after spending about 10 months in Vietnam, according to his aunt, Mrs. Grady Hall.



Know The Truth

The eighth chapter of Acts furnishes the example of a religious, but lost, man becoming a Christian. Here is a man riding along in a chariot and reading the Old Testament book of Isaiah. Isaiah was a Gospel prophet; he wrote a great deal about Christ, and the coming Gospel age. The passage the Ethiopian Eunuch was reading spoke of Christ. He did not understand what he was reading, and so upon making contact with Philip, the preacher, he asked what the passage meant. When he asked for help in understanding the text, Philip opened his mouth and "preached unto him Jesus." As they went on their way, they came to a certain water, and the man said to the preacher, "See, here is water; what doth hinder me to be baptized?" Why ask such a question? Do you suppose Philip had said something about baptism as he preached Christ? Well, all the Bible says about what he preached was that he preached "Jesus." Could one preach "Jesus" or "Christ" and not tell what Christ said about our needing to believe and be baptized to be saved, Mark 16:16? Friends, are we ever wrong when we follow, to the last detail, the Bible examples? This man went on his way rejoicing -- after he was baptized. He had been born again, born of water and the Spirit, John 3:5; he had washed away his sins, Acts 22:16. Because he had done what he was told to do to be saved, he was added to the church, Acts 2:47. Now, don't ask what church he was added to -- there was only one at that time. In fact, the Bible showed the Lord intended there to be only one church, Ephesians 4:4, "one body" and this one body is the church, Ephesians 1:22-23; therefore only one church in God's plan of redemption. In the New Testament, there is no example of a man being saved and then "joining" the church of his choice. You cannot go wrong if you follow the example of this man in Acts eight.

Bookmobile Certificates Given Here






Jesus moved men to seek the truth about life and he admonishes us to do the same. Let us seek to better understand his way for our lives in church this Sunday.







Mills Explains Dollar-A-Bale

The ASCS Office has nothing to do with administering the dollar-a-bale check-off for cotton, but the office has had a number of questions concerning it asked. Some of the questions and answers are as follows:

Q. Who will collect the dollar per bale? A. Payment will be made by the cotton farmer to the collecting handler.

Q. Who is a collecting handler? A. The "collecting handler" is any person, firm or association who buys a bale from the producer or who accepts a bale under an oral or written contract or agreement for marketing of the cotton. This applies regardless of whether the cotton is marketed or whether it is put in the loan program. The collecting handler also includes the county Agricultural Stabilization and Conservation Service office or any person who advances the loan value of the cotton to the producer on a Form A loan.

Q. When is collection made? A. When the collecting handler makes the first payment to the producer - by check, credit to the grower's account, or transfer of any kind.

Q. What about a bale owned by more than one producer? A. If more than one producer shares in the proceeds received from a bale, each is obligated to pay that portion of the dollar equivalent to his proportionate share of the proceeds.

Q. How about cotton bought in the field? A. Any person who buys seed cotton or unbaled lint from the producer shall be the collecting handler and collect when the cotton is ginned. He's required to give the producer a receipt. When a bale is ginned that contains cotton bought from more than one producer, the handler collects each producer's proportionate share of the assessment and gives each producer a receipt so indicating.

Q. What if a collecting handler fails to collect on a bale?

A. Failure of the handler to collect doesn't relieve him of his obligation to remit the assessment to the Cotton Board.

Q. How about procedures for reporting and forwarding collections? A. Each calendar month is a reporting period. Payment and collecting handler reports shall be mailed to the Cotton Board within 10 days after the reporting period. The remittance shall be by check, draft or money order payable to the Cotton Board. A separate report is required on each gin from which cotton is handled and will be submitted in duplicate.

Q. What information is provided in the collecting handler's report. A. It lists producers from whom the handler was required to collect the dollar per bale, their addresses and total number of bales from each grower.

Q. What kind of receipt does the producer get? A. Receipt

for payment of the assessment may be a part of the invoice or settlement sheet the collecting handler gives the producer or it may be made on a separate form.

Q. In the event a producer doesn't want to participate, how does he go about getting a refund? A. He must apply directly to the Cotton Board for a refund application, which must be filed within 90 days after the date of his assessment. The receipt given him by the handler, or a copy or other evidence of payment, must accompany the refund application.

Q. How does the warehouse receipt figure into the record keeping? A. Each gin is assigned a code number. The warehouse first receiving the bale for storage after ginning enters the gin code number on the warehouse receipt.

Q. What records are required of the ginner? A. During ac-

Final District Game --

Ponies Come Close; Steers Escape, 7-6

If close counted in football like it does in horseshoes, the Bovina Mustangs would have picked up a win over Farwell here Friday night. The outcome gave Farwell a shaky, one-point margin, 7-6, but the Mustangs won almost everything but the score.

This was the closest the Mustangs had come to downing their Parmer County rival since they last won in '54.

The win for the Steers left them undefeated in District 3-A competition. Their record is now 3-0. They meet the Sudan Hornets Friday night in Farwell in the game that will decide the district championship.

Friday night's tilt was played in shivering temperatures and saw the heavily-favored Steers jump off to a 7-0 first quarter lead.

The Mustangs got on the scoreboard less than two minutes deep in the second period

and got their six-pointer on a two-yard plunge by Halfback Stuart McMeans. The TD was set up on a Farwell fumble and a Bovina recovery at the Farwell 36 yard line. It took the Ponies 11 plays to get the score. Halfback Lynn Murphy had the longest gainer during the drive, a 14-yard run from the 29 to the 15.

The Mustangs went for two on the extra points attempt and McMeans, operating from the quarterback position, was tackled short of the goal line to leave the score 7-6.

The Steers got their only TD the second time they had possession of the pigskin. Flashy Quarterback Lewey Bradshaw circled his own left end for a 65-yard dash to pay dirt. Al Phillips booted the extra point, which was, as it turned out, the margin of victory for the Steers.

Bovina missed a golden scoring opportunity midway through the second period as they got possession on the Farwell four yard line after a blocked punt attempt by Phillips from the Farwell 26. The Ponies failed to gain in three downs and then a bad snap from center foiled an attempted field goal to give the ball back to the Steers at their 30.

Except for the first quarter break-away run by Bradshaw, the stubborn Mustang defense held the Steers in check throughout the tilt.

Just before the end of the first half, the Steers reached the Bovina 27 yard line, facing a fourth down situation. Phillips missed a field goal from there.

A Mustang threat was halted by the Steer defense at the Farwell 28 yard line with 4:28 remaining in the game. The Mus-

tangs put a Phillips punt in play on their own 46 and covered the 32 yards to the 28 in six plays with Fullback Carl Harris picking up most of the distance with hard, determined running.

A penalty set the Bovina club back to the 41 before the drive got underway. Halfback Tommy Sisco made four to the 45 and from there Harris toted five consecutive times, making gains of two, six, 10, three and six yards. On third and one from the 28, Sisco was stopped for no gain. Harris was then stopped by Phillips on the fourth down carry and the Steers took over on their own 30.

The Farwell pass defense was especially rough on the Mustang offense as the Steers intercepted three Bovina aeri-als. On the other side of the ledger, however, the Mustangs blocked two of six Farwell punts.

Harris paced the Mustang ballcarriers with 101 net yards in 23 attempts. Murphy carried 14 times for 36 yards. Sisco had a total of 14 in eight tries.

The Bovina team completed two passes, both to McMeans, with Murphy throwing one and Quarterback Daryl Kirkpatrick the other.

The game completed the Mustangs district play for the '67 season. Their district mark is 0-4 and they stand 2-7 for the season.
