





Kinney County:

The City of Brackettville, Fort Clark Springs and Rural Kinney County have received notice from the Insurance Service Office that the Community Public Protection Classification for calculating insurance premiums has improved. Recent evaluations of our water system and Fire Department have resulted in the improved ratings. The new rates will go into effect May 11, 2011.

The following classifications have been recommended:

1. The City of Brackettville and Fort Clark Springs - Class 5/9 Properties within 1,000 feet of a fire hydrant and within 5 miles of a fire station will use Class 5.

2. Those outlying areas of Rural Kinney County, further than 5 miles from a fire station, will use a Class 9.
