### EDITORS ASSAULTED F. D. WOODRUFF AND W. J. SHEL.

DON, PUBLISHERS OF ELEC-TRA NEWS, ATTACKED.

### WERE HIT WITH STONES

### Both Knocked Down on the Street. Friend Reaches Scene and Puts Assailants to Flight.

From Thursday's Daily.

That a newspaper man's life is full of care and trouble was fully realized last night by W. J. Sheldon and F. D. Woodruff, owners and editors of the Electra News, a paper which took a decided stand against the saloons in the recent local option election at that place, when they were assaulted keeper, and his brother, Ed. Moody.

It is said that the Moody brothers, citizen of this little city. had made open statements to the effect that they intended to run Sheldon and Woodruff out of town for the part they had taken in the local option fight. Last night the two Moodys met the editors on the street and called them to one side, where they suddenly attacked them with rock. Both editors were knocked down and probably would have been badly beaten, but for the opportune interference of one of their friends who ran up and engaged their two assailants so strenuously that they were both glad to get out of reach without being killed.

At first it was thought that Sheldon had been seriously injured from the blow of a 5-pound rock upon his head. where a bad scalp wound was inflicted, but this morning he was able to be at his office. Woodruff, was less seriously injured than Sheldon and he too was able to be at his work this morning.

The two Moodys were arrested by WILL REQUIRE AN Constable Yeary and last night went before the justice of the peace at Electra and plead guilty and paid fines for a plain assault to forestall a more serious charge.

The assault is denounced by many good citizens of Electra as a cowardly attack and there is much feeling against the two assailants.

Just to keep the record straight, isn't there a law against corporations contributing to campaign funds, or does this law apply only to bad corporations ?- Fort Worth Telegram.

With each contribution raised and forwarded to the treasurer of the campaign fund is sent a list of those contributing and instead of giving credit to the paper which might or might not be controlled by a corporation, the secretary of the campaign committee writes out a receipt and forwards the same by mail to each and every contributor. In this way, it appears, conbeen declined.



YOUNG MATRON COLLAPSES IN TELLING WHY HUSBAND SHOT ANOTHER MAN.

Suddenly at Beaumont While Testifying in Cantrell Case.

Beaumont, Tex., Sept. 1.--Mrs. John Reinhardt, aged 23 years, died suddenly in the witness chair in the Fiftyeighth district court room at 3 o'clock this afternoon from heart failure, while testifying in behalf of her husband, John Reinhardt, who was having a habeas curpus hearing on a charge of having killed Ed Cantrell at Saratoga, Hardin county, Aug. 4, because the latter was alleged to have offended and insulted Mrs. Reinhardt.

The wife of the defendant was on the stand and had testified as to Car- ware cross-examination by Attorney Tom she was quickly picked up and carried

Bail Quickly Fixed.

The defendant had taken the stand, following his wife's removal from the court room, and supposing she had merely fainted from the strain, it was the intention to proceed with the trial. which was then nearly ended. When the news of Mrs. Reinhardt's death was brought in, Judge Pope stopped the proceedings and ordered that the deendant's ball be fixed at \$500. The bond was quickly made and defendant was released a few moments after his wife's body was removed to an undertaking establishment. The physician said the cause of death was organic heart failure, superinduced by the excitement and heay strain. It was developed also that she had been subject to attacks of heart trouble and fre quently fainted when suddenly fright ened or under great excitement.


