THE TOBACCO TRUST

GOVERNMENT COMMENCES ACTION AGAINST IT.

UNLAWFUL AGREEMENT

Restraint of Trade are Charged by Government and the Dissolution of Monopoly Sought.

New York, July 10.—The government filed today in the United States circuit court in this city a petition against the American Tobacco Company, the Imperial Tobacco Company, the British-American Tobacco Company, American Snuff Company, American Cigar Company, United Cigarettes Company, American Cigarette Company, Mac Andrews & Forbes Company, Corley-Foll Company and other corporations and twenty individuals connected with the named companies. These corporations and individuals constitute what is generally known as the "Tobacco Trust" and the petition directs the government to dissolve this trust by breaking up the agreements which the consolidated concerns making. In showing the growth of the trust since its origination in 1890, the conclusion was reached that nearly day, that unless prevented, it would completely monopolize the tobacco industry. That all the defendants engaged in interstate and foreign trade and commerce in tobacco products manufactured there, as alleged by the petition. It is stated that the act of July 2, 1890, "to protect trade and commerce" and subsequent acts have been violated by the government therefore seeks the dissolution of the defendants in restraint of trade and restraint from engaging in the interstate and foreign trade or commerce and that a receiver be appointed to take charge of their affairs and administer them so as to bring about a liquidation in harmony with the laws. The petition shows that the total assets of the tobacco trust now exceed \$100,000,000 and the allegation is made that the members of the combination divided up the tobacco business of the world, assigning some special territory to each for un molested enjoyment and restraint the unlawful agreements, combinations, trusts, and attempts to break up the monopoly. The government asks that the existing combinations, trusts and monopolies be enjoined, and each of the defendant companies be restrained from holding controlling stock in any other. It is further that the Imperial Tobacco Company be enjoined from doing business within the jurisdiction of the United States until it has ceased to violate the terms of its agreement with the American companies; that the annual production of domestic tobacco is estimated at 800,000,000 pounds of domestic tobacco, of which the total product in the United States, manufacture, sell and distribute more than 28,000,000 pounds of tobacco; 10 per cent of the smoking and chewing tobacco; 95 per cent of the snuff; 75 per cent of the cigarettes; 75 per cent of the small cigars; 95 per cent of the loose products; 80 per cent of the pipe products and 10 to 15 per cent of the cigars and stogies of the United States. The annual production of domestic tobacco is estimated at 800,

000,000 pounds, 75 per cent of which is purchased by the American Tobacco Company and its associates and allies at prices which the government alleges to be unlawfully influenced by the combination. It is said that this is in defiance of the laws of trade, where open competition controls the prices.

Oklahoma Constitutional Convention Reconvened at Guthrie Today.

Guthrie, Okla., July 10.—The convention that early this year drafted a constitution for the proposed new State of Oklahoma, reconvened here today, after a two months recess. The present work of the convention will be to set a new election date and to finish up a good deal of minor work and to adjourn sine die. The final adjournment is expected within ten days. After the convention is adjourned, the Republican state committee will issue a call for a state convention to name a full set of officers. The Republican convention had been called to meet at Tulsa July 12, but it was later determined to cancel this date and wait until this constitutional convention finishes its work before meeting. The Democrats have already named their ticket.

SCHMITZ'S SUCCESSOR.

Planned to Leave Selection of Delegates From Labor Councils and Commercial Organizations.

These are to select a mayor to fill out the unexpired portion of Schmitz's term. If this plan is accepted the convention will be held within two weeks. Chas. T. Boxton was sworn in as temporary mayor last night.

EXHAUSTIVE REPORT

ON JAPANESE TROUBLE IS FORWARDED TO WASHINGTON.

NO DISCRIMINATION MADE

Police Commissioners Contend That Issuance of License is Within Their Discretion.

San Francisco, Cal., July 10.—An exhaustive report of all the facts connected with the recent refusal of the police commissioners to grant employment office licenses to the Japanese was mailed to Attorney General Bonaparte by United States District Attorney Devlinay. There is every indication that the Japanese will appeal to the courts to have it determined whether the treaty rights have been infringed upon by the action of the police commissioners in denying them intelligence office licenses. There is no ordinance on the books prohibiting the issuance of employment office licenses to aliens, but the police commission contends that such a business comes within the police permits and their action does not discriminate against the Japanese nor infringe their treaty rights, they being treated the same as other aliens.

Cruise Was Planned Long Ago.

Paris, France, July 10.—Another statement from an "authorized source" issued this morning contains the information that the decision of the United States to despatch a battleship fleet to the Pacific was reached long ago and was only deferred in order not to embarrass the negotiations between the Japanese and the United States.

The statement continues: "We may therefore be permitted to expect a record which will relieve the cruise of

the fleet from the slightest unfriendliness towards Japan."

Passing Storm Will Disappear.

New York, July 10.—"I think the friendly relations long standing between the United States and Japan will be preserved and the passing storm will disappear in the waters of the Pacific ocean. I firmly believe that this one incident cannot be thrown in the way of the present relations between the two countries, which began at the time of my birth." Thus spoke Admiral Yamamoto, the Japanese Minister of Marine, during the Japanese-Russian war as a greeting to the American people today on his arrival with his suite on the Carmania. Admiral Yamamoto has been inspecting the gun shops and shipyards of Europe and while here visited our navy yards and ship building plants. He was met at quarantine by Lieutenant Henderson, representing Rear Admiral Goodrich, commander at the New York navy yard.

Insulting Interview Denied.

Simultaneously with the denial of this interview, the Hochi will publish an anonymous interview with a Japanese naval expert, highly eulogistic of the efficiency of the present American navy and the high standard of its gunners.

Japan Has Made No Demands.

C., July 10.—From the State Department and from the Japanese embassy here came swift and conclusive denial today of the accuracy of the statement cabled from the Hague to the London Daily Telegraph and reprinted in this country to the effect that Japan had made categorical demands on the United States government for satisfaction in connection with the treatment of the Japanese in San Francisco and that Japan had served notice here of her intent to deal with the Californians herself if the national government fails to do so. At the State Department it was said that the American public was fully aware of the nature of all the exchanges that had taken place on this subject; that there had been no correspondence of recent date and there were no negotiations in progress between the two governments. This statement was fully confirmed at the Japanese embassy.

DECLARED HE NEVER HAD ANY HOSTILITY FOR STEUNENBERG.

THE POLITICAL SITUATION

Defense Attempted to Get Colorado Politics Before the Jury, But the Court Sustained the State's Objection.

Boise, Idaho, July 10.—When the Haywood trial opened up this morning, Senator Borah read the cross-examination in the deposition of W. A. Abernathy, contractor and former miner in the Couer d'Alenes, who declared that he heard Harry Orchard say he would "get" Governor Steunenberg some time. This was the last of the depositions, which have occupied the court since Monday.

The defense attempted to open up the political situation in Colorado in 1904 and 1905, by John L. Tierney, a newspaper correspondent. The State objected and the jury was dismissed pending the argument.

The court sustained the State's objection as to the introduction of evidence affecting the political situation in Colorado in the Haywood trial. The attorneys left the stand and the jury was recalled at 12:25 p. m. Charles H. Moyer, president of the Western Federation of Miners, was called for the defense.

Moyer Was Nervous.

Moyer displayed some nervousness as the examination began, but within a few minutes was going very steadily in the recital of his connection with the Western Federation of Miners. During the review of the Couer d'Alenes strike in 1899, the witness said he was in sympathy with the strikers in the struggle, but never had any personal hostility for Frank Steunenberg. Shortly before noon the witness was started upon a long examination as to the Cripple Creek strike of 1903-04.

OFF ON GLIDDEN TOUR.

Fully Covering the Duties and Responsibilities of the Contractor is a Necessity.

"A house that presents the appearance of having cost \$10,000 cannot be built for \$5,000 or \$6,000, with honest workmanship and first class materials, although it is possible to make a pretty good showing to this effect by cheapening the construction and spending the money thus secured in furnishing those details that appeal to the eye and make a house 'look stylish,'" said a well known contractor yesterday, who has had years of experience in house building.

"The average man is not a judge of the value of a building," continued the contractor, "unless he has followed its construction by close observation from the beginning of the excavation until the completion of the interior and exterior.

Limit Always Fixed By the Home Builder.

"When a homeseeker desires to build he usually places a limit on the amount he desires to put in the construction of the house, and there is the same variety in economy in building as in other affairs of life. In order to have more stone in the front of the house, carved panels or other details intended for show, it may be necessary to reduce the size of the house. On the other hand, the size in the reduction of the house may

be a real saving dependent upon the tastes of the family who are to occupy it. When the dimensions of the house are decided upon and the amount of money set aside that the owner feels willing to invest in building, an architect should be consulted and after the plans are accepted, intrusted with the making of the contract with the builder. This contract should, by all means, be in writing and cover fully the responsibilities and duties of the contractor in the transaction.

No Extra Work Clause a Safety.

"In the written contract it should be stipulated, that no payments shall be made for extra work done by the contractor unless authorized in writing by the owner, or by the architect. Then if the contractor does any extra work for which he has no written order he does it at his own risk. For instance: The contractor thinks that a little extra work upon the veranda or perhaps in the completion of a stairway would be an improvement. He goes ahead without the knowledge of the owner. Later the owner discovers the extra work of an objectionable nature, for which he refuses to pay. In case the clause referred to above is incorporated in the contract or agreement, the contract has no remedy at law, but if it is not so stated the owner is liable for any such extra work, if it is done with his knowledge.

Architect as Aid in Selecting Material.

"Another way in which an architect is of estimable value to the owner is in the acceptance or rejection of materials used in the construction of the house. If the contractor is allowed to use inferior material which is not detected by the owner until the completion of the building, and he then wishes to have that material

replaced, he is apt to meet with long and wearisome litigation.

"It is wise to have it stated in the agreement that no change shall be made in the specifications without the order of the architect, as he is naturally supposed not only to be competent to judge in the matter of materials and workmanship, but also as to the desirability of changes as the building progresses. Thus the owner will not be single handed in his judgment, so to speak.

"While it is true that an implied contract is not always binding, there are many cases where it is as good as a written one. Hence the owner shall be careful as to any understanding between himself and the contractor."

County Judge Yeager, ex-officio county superintendent of schools, has been notified by the State Superintendent of Public Instruction that no county examinations of applicants for teachers' licenses will be held during the month of August. The next examination will, therefore, be held in this county on the first Friday and Saturday in September.

THE NEW LIQUOR LAW.

Retail Liquor License Raised on All Classes of Intoxicants.

The Baskin-McGregor saloon regulation law goes into effect on July 11, and the Times presents herewith some of the most salient points in the new law for the information of its readers and the public generally. Following are some of the main points in the law:

Retail liquor license raised from \$600 to \$750; beer license raised to \$125.

License forfeited for selling to minors and allowing them to enter saloons.

License forfeited for permitting any games to be played on retailers' premises, including cards, dice, dominoes, billiards, pool, etc.

License forfeited for selling to lewd women or allowing them to enter a saloon, with other penalties.

License forfeited in case of transferring same.

Any person desiring liquor or malt license shall first make application, under oath, to the controller of the state. Then he shall file a petition with the county judge, setting forth that he has been a resident in such county for two years and has complied with preliminary statutes of this law, and if the place of business he wishes to locate in be in any block or square where there are more bona fide residences than business houses, or in any block where there is a church or school, then said petition shall be accompanied by the written consent of a majority of such property owners.

The saloons shall close at 12 o'clock at night and remain closed until 5 o'clock in the morning during week days, and from 12 o'clock Saturday night till 5 o'clock Monday morning. The penalty for violating this clause is not less than \$25 or more than \$300 fine or imprisonment in the county jail for not more than three months, or by both such fine and imprisonment, and, in addition, upon a complaint of county attorney, the license of said dealer, may be forfeited.

A bond of \$5,000 shall be given for liquor license, said bondsmen to be held responsible for the good conduct of the proprietor.

No screens or devices allowed to obstruct the view of the inside of the saloon from the outside.

No music, loud or boisterous talking, yelling or indecent language, or any other noise calculated to disturb or annoy any person in the neighborhood of said saloon shall be permitted.

No obscene pictures.

No license shall be issued to any person to do business as a retailer in any house or building used for the purpose of prostitution, or a house of assignation, or a gambling house, and any retailer selling to such house shall forfeit his license.

Imprisonment in the county jail for not more than twelve months, or a fine not exceeding \$500, or both imprisonment and fine, for employing any female as servant, bartender or waitress other than a member of the family of the saloon keeper.

It shall be unlawful for any person to sell intoxicating drinks at any place where people have assembled for worship, or for educational purposes, or at any election precinct on election day; penalty not less than \$50, nor more than \$200 fine, or six months in county jail, or both.

Looking for Stockdale.

Sheriff Davis and Marshal Gwinn left for Eschit yesterday afternoon in search of Stockdale, the escaped prisoner who got away from his captors at Burkburnett Sunday night. Stockdale is known to have crossed the Red River and is believed to be in hiding near Eschit, or Kell.

The Denver's Big Earnings.

In answer to the complaint of the railroads in Texas that the railroad commission is about to confiscate their property by reason of the enforcement of the reduced rates made by the commission, Hon. O. B. Colquitt recently addressed a letter to friends giving a synopsis of the data concerning several railroads operating in the State.

The following concerning the Fort Worth and Denver City railroad will be of interest to our readers:

"The Fort Worth and Denver City Railway company's earnings, after paying cost of operation, capitalized at 4 per cent, was equal to that rate of interest on \$82,124 per mile. Its stocks and bonds combined outstanding amount to \$38,646 per mile, and its average earnings for the last eight years is equal to 4 per cent on \$28,720 per mile, 5 per cent on \$30,796 per mile, or 8 per cent on \$25,813 per mile. The commission's estimate of the cost of reproducing this property new is \$12,708; and I dare to express the opinion that the road could be constructed at this time in as good condition as it exists today at the estimated cost made by the commission. The earnings of this road for the fiscal year ending June 30, 1906, were more than 25 per cent on the money that it would now take to build the road."

Rain Prevents Game.

The second game of the series between Wichita and Stamford at the latter place had to be called off yesterday afternoon on account of rain. The rains have been general in the section about Stamford and there is some doubt as to whether the rain will not prevent the game this afternoon also.

AUTOS MUST REGISTER.

Bill Which Goes Into Effect on July 12
Requires all Automobiles to Regis-
ter in County Where Owned.

Owners of automobiles must regis-
ter with the county clerk after July
12, as, on that date, House bill No.
93, introduced by Mr. Ridgway and
passed by the last Legislature, be-
comes effective.

Sec. 1 of said bill provides that "all
owners of automobiles or motor ve-
hicles shall, before using such ve-
hicles or machines on the public roads,
streets or driveways, register with the
county clerk of the county in which
he resides. As owner, each name
shall be registered by the county clerk
in consecutive order in a book to be
kept for that purpose, and shall be
numbered in the order of their reg-
istration. Each owner or owners to display in a
conspicuous place on said machine the
number so registered, which numbers
shall be in figures not less than six
inches in height. The county clerk
shall be paid by such owner or owners
a fee of 50c for each machine regis-
tered."

The penalty for failure to register
with the county clerk is fixed at not
less than \$5 nor more than \$100.
