Proceedings Begun Against Men Who Looted Pennsylvania Treasury. By Associated Press.

Harrisburg, Pa., Jan. 27.-Proceed ings were begun today against the men charged with a conspiracy to loot the State treasury in connection with the construction and furnishing of the big State captol building. The defendants in the first five cases are Chief Contractor John H. Sanderson and Architect Joseph M. Huston of Philadelphia, former Auditor General William P. Snyder of Spring City, former State Treasurer William L. Matthews of Media and James M. Shumaker of Johns town, former superintendent of grounds and buildings. Sanderson supplied most of the furnishings for the capitol. His contract amounted to \$5,487, 899, and his profits in some instances are alleged to have been as much as 4,000 per cent. Huston designed the plans for the buildings and furnishings, his commissions amounting to \$415,631.

THE POLL TAX LAW

Two-Thirds of the Receipts Go to the to General Revenue.

The constitution and laws of this State make every male person between the ages of 21 and 60 years, within the State on the first day of January in any year subject to the payment of a poll tax for said year. The total amount of this poll tax is \$1.50, of which \$1 goes to the State school fund, and 50 cents to a State voting or was used as a basis for a system of registration of voters. Every person subject to such tax is liable for the payment of t whether or not he makes the payment in time to qualify himself as a voter. If he owes property taxes he cannot pay the same without also paying his poll tax. It is a lien upon his property and can be enforced the same as any other tax. to discharge the obligation.

The collectors fees are fully explained in section 144 of the election

The collector of taxes shall be, paid 15 cents for each poll tax receipt issued by him, to be paid prorata by the State and county in proportion to the amount of pool tax received by each and this shall include his compensation for administering oath, furnishcertified certified lists of qualified voters in election precincts for usce in general elections and primary conventions, when desired, and for all duties required of him under this act; provided that collectors whose sauaries are fixed by what is known as the fee bill shall recive 10 cents for each poli tax receipt and certificate of exemption issued by him, and such fees shall be exofficio and not accountable under said fee bill.

The collector is required to furnish copies of all receipts for each voting precinct, and in addition an alphabetically arranged list of all persons paying poll taxes in each of such pre-

He is required to issu certificates of exemption to all persons not subject to a poll tax who resides in cities of 10,000 or more inhabitants, and to furnish copies and lists of same.

To the future historian the report of the Forest Service in the lumber cut of the United States for 1906 will be a document of melancholy interest. It will be like a contemporary description of the slaughter of the last great herd of buffalo in 1875. In 1906 we slashed from our disappearing forests about forty billion feet of lumber, worth seven hundred million dolfars. it was more than we had ever cut be fore. It seemed as if we could not bear the sight of a standing tree, and had been setzed with a frenzied eagerness to turn the last remnants of our woodlands into barren wastes of stumps in the shortest possible time.

In some kinds of lumber the hand of destruction is already stayed by the lack of anything more to destroy. In the seven years between 1899 and 1906 the cut of white pine has been reduced over 40 per cent, and oak by nearly as much. The average value of lumber of all kinds has increased in the same period by 49 per cent, an eloquent commentary on the probress of exhaustion. The stumpage values of the principal varieties of trees have doubted and tripled in seven years. Yellow pine has increased from \$1.12 to \$3.16 per thousand feet, oak from \$3.18 to \$6.52, ash from \$3.03 to \$7.58, and white pine from \$3.66 to \$8.09. The line of devastation has swept across the continent, until now the older lumber producing regions are eclipsed. Washington has now become the first State in the volume of its cut and Louisiana second. Wisconsin has gone down from first place in 1905 to third in 1906 and is still declining. The rapid exhaustion of the finer woods is bringing poorer varieties to the front, but it is only a matter of a few years before a tree of any kind will command the respect due to rarity.


