Under the new voter registration regulations, citizens have until today (Wednesday) or possibly tomorrow, we aren't sure which, to register to vote in the May 6 primary elections ----if they haven't already done S0.

The new rules say you have to register 30 days ahead of an election in order to be eligible to vote. What we're not sure about is how the 30 days are counted.

Anyway, today isn't too late to register for the May primaries and no time is too late to register for other forthcoming elections.

We don't know if this new rule is a good one or not. Probably is. At any rate, it is a rule and we'll be playing by it, like it or not. * * * * * *

A new business in Bovina is scheduled to open its doors the early part of May.




The business will be located on Third Street, next door to Fantasy Beauty Salon.
