The fewer the native seed planted, the better the chance will be for a cotton crop in Nacogdoches county next year.

We are expecting some big developments in the Nacogdoches oil field pretty soon. It isn't altogether newspaper talk.

We have been expecting a visit from the editor of the Alkali Eye, but its all off now. We never expect to see him in Nacogdoches now.

The Tyler Courier wants another attorney general like Hogg or Culbertson and says Jno. M. Duncan would fill the bill exactly. Deed he would.

It is estimated that the boll weevil has cost Texas fifteen million dollars this year. What would it cost the boll weevil if Texas quit raising cotton?

Two painters working on the new market house in Houston fell from a scaffold to the ground, a distance of seventy feet, Monday, and were killed instantly.

There are already more candidates on the "anxious seat" for attorney general than one can shake a stick at. Wonder what is making that office so desirable? Texas has quit making governors of attorney generals.

It is announced that Senator Platt, who is seventy years old, is to be married. At the same time it is stated that he is confronted with a breach of promise suit from a young lady whose affections he has tampered with for passtime.

SAM DIXON, who is gathering up exhibits in Texas for the World Fair at St. Louis, says he has never seen finer apples than he has found in some parts of the State. In the northern part of East Texas apples grow especially fine.

The town of Paterson, New Jersey, has been damaged \$2,000,000 by floods the past week, and thousands of men, women and children are without employment and in need of relief. The manufactory suffered the greatest damage.

The Howard Hotel, the leading hotel in the city, was burned at Lake Charles, La., Tuesday night. The loss is forty thousand dollars, fifteen thousand insurance. One man had his leg broken during the fire by falling off the roof of an adjacent building.

If the farms of the county will stand by the Fruit and Truck Grower's association, work together, and diversify intelligently, the dire predictions as to what the boll weevils are going to do to the next years crop will have no terrors for them. They will no more need of cotton than a cat has for climbing-irons.

The feudists are still fighting and killing each other in Kentucky. An old feud between the Partins and Sowers culminated a day or two ago in the killing of one of the Sower boys at Middleboro. Feeling is bitter between the families and other fatalities are expected.

The Northern paper mills are seeking locations in the South where raw material is cheaper and more plentiful. Houston is in a fair way to get a rich plum of this kind. With proper inducements Nacogdoches might catch one. There could be no more favorable location than this.

BOOKER WASHINGTON has returned from a visit to Europe. He has been studying the negro problem while on his trip, and says the opportunities for education and labor in this country for the negro are much better than the poorer classes get on the other side of the mighty deep.

We don't think so very much of Ex-Gov. Hoggs proposition for the farmers to "organize for political purposes," but we have great confidence in the foresight of the big ex-governor, and feel assured that in the end he will prove right. The farmers ought to organize for their own betterment, whether it be for business, social or political purposes.

HARVEY WATTERSON, son of the Hon. Henri, of "Star-eyed Goddess" fame, has entered politics in New York as a candidate for the legislature of that state. The young man is 24 years of age, is a graduate from the Columbia Law school and has a law office in Wall street. His father will go to New York and stump the district for the boy.

THE SENTINEL did not help elect prohibition in Nacogdoches county, but it was carried by nearly three to one without our help and now we are willing to help enforce it to the fullest letter of the law. We are in favor of enforcing all laws as long as they are in the statutes. If they are not good let them be repealed, but enforce them as long as they are laws.

CHARLES BEELER, of San Antonio has recently been released from the penitentiary, having served a term for robbing the Wells Fargo Express company of \$52,000. \$2000 of the money was recovered, but the remaining fifty thousand was hid by Beeler somewhere and he refused to tell where it is. He is constantly shadowed by detectives, and though he is worth fifty thousand he cannot enjoy his stolen riches.

A HOUSTON tax payer refused to tell his age to the tax collector and the collector refuses to issue him a poll tax receipt and now the point is raised as to whether a man must tell his exact age or swear that he is over twenty-one to be entitled to vote under the new election law. The question in this instance has been referred to the attorney general, both the tax payer and collector being stubborn, and each refusing to yield.

SPEAKING with reference to an article in a recent issue of The Sentinel under the caption of "Not all a Swindle," The Jacksonville Fruit and Truck Journal says: "The Sentinel is correct in her views on this subject. This has been an off season all around; too much rain, too much experience among newer associations, too many poor tomatoes packed and not enough of organization. All this will be righted in time. There is yet some money to be made out of tomatoes."

It is time right now for farmers to take up the matter of planting foreign cotton seed next year. It must be done if there is any cotton raised here. The boll weevil bores into the native seed, eats up the kernel and beds up for the winter. This is the reason many farmers got a poor stand this year. We must import seed from as far North as possible, get the very earliest varieties, plant early and push for all there is in it, or the boll weevil will get the entire crop of Nacogdoches county next year.

When you come in all puffed up with imaginary indignation and half tanked up with booze, and nip your little quarter or four-bit piece down and order the Sentinel stopped, you only make an ass of yourself and a laughing stock for thoughtful people. THE man that plants Kings Improved cotton seed next year, is the man who is going to make cotton, and he is the only man who will make any next year. The seed will be high, as it is shipped from the furthest north point in North Carolina that cotton can be raised, and is shipped in sealed sacks, but it is the only chance for cotton next year, and an acre planted with Kings' Improved seed, will be better than twenty planted with the weevil infested and later producing seed. This is no advertisement, we are neither handling it, nor do we expect to, it is just the straight fact, given to the cotton growers of the county.

PROF. ORR has placed the Summer Hill Select School at Omen once more on its feet and the school opened last week with 175 pupils. It was a sad day for the school when he left it two years ago, and when he was prevailed on to take charge of it again, it had run down to almost nothing. Prof. Orr is well and widely known as one of the leading educators of the State.

GEN. WEBB FLANNAGAN is indignant over the treatment of negroes in Rusk county and proposes to unfold a tale of woe to the state and federal authorities. He says that negroes have been beaten to death and a number driven from the country. He states that heavy leather straps padded with nails were used on two negroes, one of whom died and the other is not expected to live. The matter is to be laid before the Governor. The general didn't mention the fact that three white men were fired upon from ambush by a negro and that one of them was killed and another dangerously wounded one night last week.

A COTTON raiser near Dallas has a cotton field from which he will gather a bale an acre. The seed came from Georgia, and his crop has not been molested by insects. Another farmer near Terrell reports that he gathered twenty-five bushels of boll weevils from two acres of cotton. Both these men live in the same section of the State and while two isolated cases cannot prove any proposition, it does look as though the imported seed had a little to do with the difference in the size of the crop. It is certain that in this county next year, the man who plants the earlier maturing imported seed is about the only one who stands any show for a crop, and he will have to get a good early start and then hustle, at that.

EXPERIMENTS have proved that "King's Earliest" is the cotton most adapted to the boll-weevil infested sections. Entomologist Hunter, head of the boll weevil experimental work in this state, reports that successful experiments have been made at the various stations with a variety of cotton known as King. This variety of cotton bears heavily, produces a high grade and is not bothered much by the weevil. Farmers are much encouraged over this declaration and result, and it is believed a large acreage of this King variety will be planted in South Texas the coming season. A local merchant has ordered two carloads of seed of this variety for the farmers for next season. The farmers of Nacogdoches county should get together at once, estimate the quantity of seed wanted and get in their order without delay. It will not be an easy matter to secure seed of this variety if an order is not sent in early.

Under the new election law the election fixers will find their work next year somewhat complicated. — Tyler Courier.

So will the voter and most everybody else that has anything to do with election tickets.

SENATOR PLATT whose wedding to Mrs. Janeway has recently been announced to take place in the near future, has been sued, for breach of promise by Miss Mae Wood, a clerk in the postoffice department at Washington. The young lady "may" marry him probably Wood, but Jane has the way.

CLARIDGE, editor of the I. & G. N. Magazine and also of the Stock Farmer, published at San Antonio, has looked into the workings of the Fruit Growers' Union, and has come to the conclusion that the best thing for the fruit and truck growers of Texas to do is to get into the organization. — Jacksonville Banner.

With the first frost the boll weevil will bore a hole in a cotton seed, eat up the kernel and then coil himself up for a winter's nap, ready to spring forth in time to gorge him self on the next cotton crop. — Austin Statesman.

Every home grown cotton seed should be ground up at the oil mill, (we do not believe the weevil will survive that treatment) and clean pure seed planted. The man who plants boll weevils will raise boll weevils.

GROVER CLEVELAND was given a great ovation at St. Louis a few nights ago when he spoke before the Commercial Club of that city. His theme was "America Good Citizenship," and as a solution and a remedy for corrupt politics he said, "Give to our people something that will concentrate their common affection and solicitous care, and let that be to their country's good. Give them a purpose that stimulates to unite in friendly endeavors and let that purpose be demonstrated of efficiency and beneficence of our popular rule."

A LETTER from Mr. John T. Patrick, of the Seaboard Air Line Railway, Pinebluff, N. C., brings the information that that gentleman contemplates a visit to Texas, during which he will visit Nacogdoches. Mr. Patrick is the industrial agent of the railroad with which he is connected and is a regular Sam Dixon as a hustler, and promoter of agricultural development. This gentlemen says Texas seems to him from a distance to be the greatest State in the Union, and asks for some information regarding East Texas and Nacogdoches county, which at present is attracting more attention than any other section. On behalf of the people at large we extend Mr. Patrick a special and cordial invitation to pay us a visit. We can show him better than we can tell him. THE Rockefeller are becoming almost as dominant in railroad systems as they are in oil.

THE Odd Fellows of Houston have secured a lot upon which they will build a three story hall.

WITHIN the past three years the Southern Pacific and Union Pacific Railway lines have spent \$86,603,938 in improvements.

THE Salvation of the Texas cotton grower lies in early planting of quick maturing cotton, seed to be obtained as far North as possible.

WE are not advertising "King's Earliest," but that is the seed to plant in Nacogdoches county next year. We are convinced of that fact.

THE Sentinel office now manufactures its own electricity, having put in a dynamo yesterday. It can now handle "shocking" occurrences, and expects to electrify its readers quite often.

THE public free schools of Nacogdoches Independent district opened yesterday with almost a full attendance. The Nacogdoches schools are moving off more satisfactory to all concerned this year than ever before for many years past.

SENATOR PLATT and Mrs. Janeway were married and Miss Mae Wood can only be solaced for her lacerated affections by damages. As the Senator is over seventy it is probable that money will heal her wounded heart however.

IF one does not think Nacogdoches is constantly widening and expanding, all he has to do is to take a little trip out in some direction where he has not been for a year or two. New residences are being built in every direction and splendid little farms are being opened and improved for miles out where until a recent date stood a vast forest. The "poor" piny woods land south of town is now producing fine crops of corn, cotton, fruit and vegetables.

BOLL WEEVIL PROBLEM.

The farmers of Smith county have set an example which, in our opinion ought to be followed by the farmers of Nacogdoches county. A meeting was held in Tyler, at which several hundred attended, representing every community in the county. A committee previously appointed by the Commercial Club of Tyler submitted the following report, which was adopted:

"After a thorough study and investigation of this question we believe it is the most serious problem that ever confronted the people of this country. At every place we went could be seen evidences of the destruction which these pests have wrought, business is paralyzed and many people are in actual want for the necessities of life.

"To fully realize the gravity of the situation one must go as we have gone and see the destruction wrought by these rapacious insects. We feel that our command of language is inadequate to picture and describe this awful situation by reason of which the loss for this year is estimated by the president of the Cotton Growers' Association at \$60,000,000. Therefore, from our personal observations and investigations and from information gathered from those who have studied this question, made practical experiments, and obtained good results there from your committee would make the following recommendations and suggestions to the farmers of Smith and adjoining counties:

"1. The cutting and burning of all stalks, both cotton and corn, sorghum stubble, grass, stumps, dead trees and trash, in all of which the weevil hibernates.

"2. Deep plowing of the land as early as possible, as a great many of the weevils will be destroyed in this way.

"3. Procuring the earliest varieties of cotton seed from as far north as possible for planting purposes.

"4. Wide rows and plenty of distance for the plant, which will give the sun better access to the stalk and especially to the squares which may fall off, drying and parching them up, so that very few, if any, of the weevil eggs deposited therein will hatch out. Check-

ing the rows would, in our opinion, be the best method by which this could be accomplished. Where the cotton is not checked, running the rows east and west would, we think, materially help in this respect.

"5. A reduction of the acreage in cotton to facilitate rapid cultivation, and the use of fertilizers upon thin soil, to give the plant an early start.

"6. Early planting and as rapid cultivation as possible until the cotton is fully matured.

"These methods have been successful when adopted and practiced by individuals, and we feel assured that much greater benefits and more satisfactory results will be secured if taken up and followed out by an entire community or county.

"As an illustration of the advantages to be derived from the planting of early varieties of cotton seed from a more northern latitude, we were told in Taylor of two men who had large farms near that place, that ordered "King's Early" cotton seed from North Carolina and planted them in the same field, beside land planted with native seed. A few days before we were there a man blindfolded pulled up 10 stalks of each variety, and they counted the bolls on each. The native cotton average 11 bolls to the stalk and the "King's Early" average 54 bolls to the stalk, both kinds having been planted at the same time, received the same cultivation and were planted on the same quality of soil.

"Upon the other hand, every field we saw, we believe without a single exception, that was planted late and with the ordinary native seed, was absolutely and entirely destroyed by the weevil.

"In conclusion it is our opinion that those who intend to follow the old plan for raising cotton had just as well abandon now all hope of receiving any reward for their labor; but adopting these suggestions, and others that experience may develop, the damage may be hedged against and reduced until a remedy of extermination can be found."

It is essential to the health of the tree that dead limbs should be kept cut out, that they should be cut off close to the body of the tree, and that whatever time this or any other pruning is done, the cut surfaces should always be well painted. The paint serves both as a protection against weathering, and as a preventative against the attack of fungi.—Jacksonville Fruit and Truck Journal.

THE resignation of Hon. Tom Ball as Congressman of 8th Texas district is in the hands of the governor and will take effect Nov. 16th next. The governor has issued his proclamation ordering an election on Nov. 17th to elect his successor.

As an outcome of the recent meeting of rice growers, Houston is to have a bonded rice warehouse. A rice kitchen is also to be established at the St Louis World's Fair.

KINGS IS BEST.

Mr. R. T. Fain, who lives near North church has been planting King's Earliest cotton seed for the past two or three years, and says that he is convinced from experience that this is the most profitable variety that can be grown in this climate. He recommends buying new seed every year and not saving the seed from cotton grown here. Get the seed as far North as possible, plant early and cultivate as rapidly as possible. The weevil gets into this cotton the same as any other, but it matures earlier and makes a crop before the weevil becomes so destructive. It is the top crop, or the last of the crop that matures that the weevil damages most, and the earlier the crop is matured the more it is immune from the ravages of the pest.

It is whispered that the prohibition sentiment is going to have a great deal to do with who gets elected to county offices next year. We do not like this spirit. A man ought to be accorded the right to think and vote as he pleases upon this question, and if he is a good man and well qualified, his attitude in the prohibition election ought to cut no figure in his chances of election to office. Fitness and qualification for the office sought ought to be the main consideration, and whether they be antis or pros, we ought to elect the best men.

By the decision of the Canadian Boundary commission, Uncle Sam gains a right good slice of territory hitherto claimed by Great Britain, including the town of Kluckwan. There are many Canadians on the territory awarded to the United States and they will have to move or submit to American arrangements. The decision shuts off all practical routes to the Alaska gold fields except through American territory.

FORMER Gov. Taylor, of Tennessee, thinks Roosevelt the easiest man to beat the Republicans can put out for president. He has traveled through the North and East and has heard leading republicans speak their sentiments. Gov. Taylor is a republican himself and says he is for a man whom neither faction of the party has any particular grievance, and such a man's name is not Roosevelt.

THE Procella and Spanish Bluff roads, running out south of town have been thickly settled for miles out. There are no prettier places to be seen around Nacogdoches than those of A. Chesnutt, Jim McKnight, Jeff O'dell, W M Cox, Bob Weaver and others still farther out on the Procella road, and Martin Davis, Marion Hall, Beason's farm, Lindsey & Harris' lake and other settlements extending several miles out on the Spanish Bluff road. George Muckleroy has just bought a forty acre tract opposite the Lindsey & Harris lake where he will build a nice residence and open up a splendid little farm. There are no big bodies of piny woods land or any other kind of land in the woods near town now, and what there is left is going skyward in prices. There is very little land left within three miles of Nacogdoches that can now be had for less than twenty to twenty-five dollars an acre.

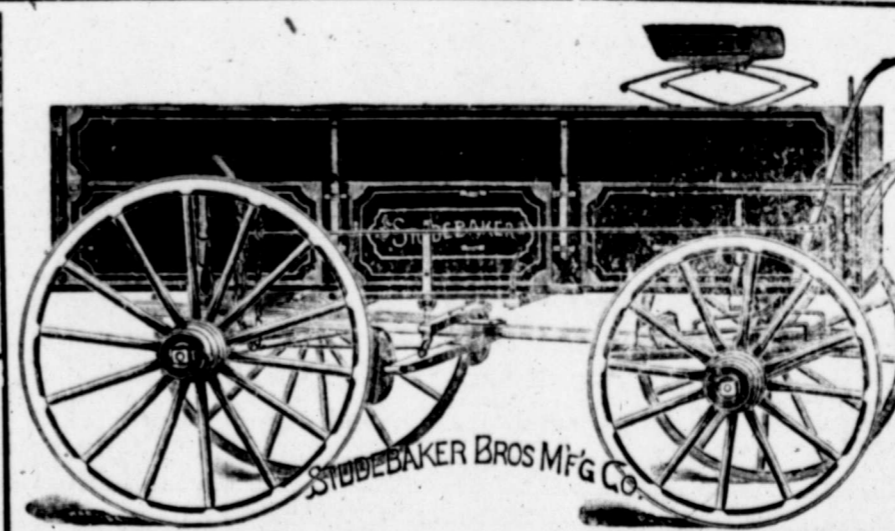

ELECTION PRECINCT NO. ONE.
Beginning at a point where the Nacogdoches and Henderson road crosses Main street in the town of Nacogdoches. Thence north with said public road about 6 1/2 miles to the south boundary line of B. R. Scoggin's homestead tract to a community road. Thence east with said community road to the upper Nacogdoches and Logansport road. Thence northeast with said Nacogdoches and Upper Logansport road to the south boundary line of J. M. Smelley's homestead tract. Thence east with said line to the northeast corner of said Smelley homestead. Thence east to Lanana creek. Thence south with Lanana creek to where J. W. Petty's south boundary line crosses said creek. Thence east with said Petty's south boundary line until it strikes Jim Greer's west boundary line. Thence east to Holloway Lilly's north boundary line. Thence with said Lilly's line to the Appleby and Sterne public road. Thence east on said line between Bennett Blake and D. L. Campbell to the Carriso creek. Thence down said Carriso creek to the Nacogdoches and Melrose lower road. Thence west with said Nacogdoches and Melrose lower road to the place of beginning, and shall be known as Nacogdoches East Box No. One.

ELECTION PRECINCT NO. TWO.
Beginning at the southwest corner of Precinct No. 1. Thence eastward with the Nacogdoches and Melrose lower road to the Carriso creek. Thence down said Carriso creek to the Angelina river. Thence up said Angelina river to the mouth of the Loco creek. Thence up said Loco creek to the Nacogdoches and Spanish Bluff road. Thence eastwardly with said Nacogdoches and Spanish Bluff road to the Moral creek. Thence up said Moral creek to the Old San Antonio road. Thence eastward with said San Antonio road to the place of beginning. Said precinct shall be known as Nacogdoches South Box No. 2.

ELECTION PRECINCT NO. FOUR.
Beginning in the Old San Antonio road, where it crosses the Moral creek. Thence westward with said road to the Loco creek. Thence southward with said Loco creek to the Spanish Bluff road. Thence eastward with the said Spanish Bluff road to the Moral creek. Thence up said Moral creek to the place of beginning, and shall be known as Alazan Voting Box No. 4.

ELECTION PRECINCT NO. FIVE.
Beginning at the northeast corner of Justice Precinct No. 1. Thence south to the Carriso creek. Thence down said Carriso creek to the northeast corner of Voting Precinct No. 1. Thence west with the north boundary line of said voting Precinct No. 1 to the Nacogdoches and Henderson road. Thence northward up said road to the north boundary line of Justice Precinct No. 1. Thence east with the north boundary line of said Justice Precinct No. 1 to the place of beginning, and shall be known as Appleby Voting Precinct No. 5.

ELECTION PRECINCT NO. SIX.
Beginning where the Nacogdoches and Melrose upper road crosses the Carriso creek. Thence up said creek to where it heads, between Will Shepherd's and Will Watkins'. Beginning where the old Brileytown road crosses Martin creek. Thence up Martin creek to the southwest corner of the Flores. Thence east on the Flores line to the Attoyac river. Thence up said Attoyac river to the mouth of the Naconiche creek. Thence up said Naconiche creek to Miller's mill. Thence west with the old line to the Brileytown and Melrose road. Thence with said Brileytown and Melrose road to the place of beginning, and shall be known as Martinsville Voting Precinct No. 7.

ELECTION PRECINCT NO. EIGHT.
Beginning where the Nacogdoches and Melrose upper road crosses the Carriso creek. Thence down said Carriso creek to the Angelina river. Thence down said Angelina river to the mouth of Laback creek. Thence up said Laback creek to its head. Thence with the old line to the south line of the Flores grant. Thence west with said line to the southwest corner of said Flores grant. Thence down Martin creek to its mouth. Thence west on a straight line to the place of beginning, and shall be known as Melrose Voting Precinct No. 8.

ELECTION PRECINCT NO. NINE.
Beginning at the northwest corner of the Baker survey. Thence with the north boundary line to the northeast corner of said Baker survey. Thence east to the Attoyac river. Thence up said Attoyac river to the Flores line. Thence west on said Flores line to the old line of Black Jack beat. Thence down said line to the place of beginning, and shall be known as Attoyac Voting Precinct No. 9.

ELECTION PRECINCT NO. TEN.
Beginning at Charley Baker's northwest corner. Thence with the old line to the head of the Laback creek. Thence eastwardly to the head of Lagrury creek. Thence down said Lagrury creek to the Attoyac river. Thence up said Attoyac river to the Attoyac voting precinct. Thence with the south line of said Attoyac voting precinct to the place of beginning, and shall be known as Chireno Voting Precinct No. 10.

ELECTION PRECINCT NO. ELEVEN.
Beginning at the head of the Laback creek. Thence down said Laback

creek to the Angelina river. Thence down said Angelina river to its junction with the Attoyac river. Thence up said Attoyac river to the mouth of the Lagrury creek. Thence up said Lagrury creek to its head. Thence westwardly to the head of Laback creek, the place of beginning, and shall be known as Etoile Voting Precinct No. 11.

ELECTION PRECINCT NO. TWELVE.
Beginning at Rock Ford, where the Nacogdoches and Looneyville road crosses the Loco creek. Thence west to where the old Nacogdoches and Hatchett's ferry road crosses the Douglas and Linn Flat road. Thence west to where the division land line between J. M. Cartright and J. W. Blackburn crosses the Douglas and Henderson road. Thence west to what is known as Red Hill on the Douglas and Hatchett's ferry road. Thence west to the residence of George S. Whitaker. Thence west to Clear Lake on the Angelina river. Thence south with the Douglas and Henderson road to the place of beginning, and shall be known as Gilbert Voting Precinct No. 14.

ELECTION PRECINCT NO. FIFTEEN.
Beginning at the residence of M. J. Cook. Thence north with the division line between Looneyville and Linn Flat Justice Precincts to the Rusk county line. Thence west with said Rusk county line to the Angelina river. Thence down said Angelina river to the mouth of Beech creek. Thence up said Beech creek to J. L. McCollum's residence. Thence north with the Douglas and Henderson road to the residence of Seeb Cook. Thence east with the Looneyville and Linn Flat road to the place of beginning, and shall be known as Indian Creek Voting Precinct No. 15.

ELECTION PRECINCT NO. SIXTEEN.

Editor Sentinel:
Please allow me space for an important article in your paper. The question is, will cotton fall by next fall. Money men are now counting the dollars which they expect to realize from next year's cotton crop. It's an old saying, "there's many a slip between the cup and the lip," and the price of cotton next year, while very uncertain, will depend in a large measure upon the amount planted in the spring. A heavy acreage will certainly throw the price and in order to keep good prices now is the time for farmers to act. Not many farmers ever made a fortune raising cotton and buying corn, when it can be done. Wheat and oats should be sown this fall and plenty of the best land selected for the next years corn and potatoes and ribbon cane. There is hardly a man in this section but what has some good cane land on his survey. The remainder to be planted in cotton and Irish potatoes, raise your meat on your pastures and corn. Live at home and let the Northern States and Kansas go to the culchur for what you care. If this is done when 1904-5 cotton acreage is announced there will not be such a striking similarity, between the price of cotton and an elevator boy on the top floor.
