An old corn grower says that when a crop of 60 bush els to the acre is secured the corn costs 13 cents a bushe to produce, for 50 bushels it is 15 cents, for 40 bushels 18 cents, for 35 bushels 22 cts. and for 30 bushels 30 cents.
