
'At the recent session of the State Farmers' Uunion the committee on peanut industry made the following report, which is worthy the consideration of every Nacogdoches county farmer:

We, your committee on peanut industry, find that Terrell, Texas, has secured a manufacturing establishment which has handled 1500 bushels per day for three years, eight months to the year, and will increase their capacity when the crop will justify, and they are not to work less than fifty hands at any time. And we find that the Spanish variety is the best peanut for oil and feed, and they stand the dry? weather better than any kind, and they will yield from 60 to 100 bushels per acre. They bring on the open market 75 cents per bushel, and they will grow on nearly any kind of land; but the sandy land is the best adapted to them. We find






