## MRS. RUNYAN DEAD.

Funeral Was Conducted at Timpson This Morning.

Mrs. T. E. Runyan died this afternoon at 12:45 o'clock at the home of her parents, Rev. and Mrs. John N. Wilson, after suffering about three months. Her home was in Fort Worth, at which place she was first attacked by the malady that was the cause of her death. As soon as she was in a condition to travel her mother brought her here, where she could have constant care and nursing, and good medical attention.

Last Tuesday morning an operation was performed by local physicians, assisted by the former family physician, Dr. Nelson, of Nacogdoches. But little hope was held out for her ultimate recovery when the operation was performed, though that was the only possible chance to preserve her life. — Timpson Times.

Mrs. Runyan was reared in Nacogdoches county, and she has hosts of friends who will regret to learn of her death. The funeral was conducted from the home of her parents in Timpson at 9 o'clock this morning. The Sentinel joins their many friends in extending sympathy to the bereaved family.

WHAT has become of the Texas Five Million club? Has it been side-tracked for politics.

WHILE the diversification spirit is enthusing the farmers of Nacogdoches county, they should not lose sight of the Spanish peanut.

THOSE fire hydrants just installed in the business portion of the city no doubt do not meet the approval of the fire bug, but they certainly look good to the property owners.

THE final estimate of the Indian cotton crop places it at 8,000,000 bales, against 4,900,000 last year. Still the price is three and a half cents below fifteen cents.

ACCORDING to a recent press bulletin issued by the United States bureau of forestry, places the total lumber cut in the United States for 1906 at 37,550,636,000 board feet, the greatest cut in the history of the country.

IF Nacogdoches must wait for a new railroad till that proposed Rusk steel plant can manufacture the steel rails with which to lay the track, we fear the Nacogdoches Southeastern, the T. & N. O. and the Rabbit will be our only dependence for a long time to come.

THE Sentinel has been placed under renewed obligation to Congressman Cooper for having placed the esteemed Congressional Record on our exchange list. Now if the Colonel will only secure an appropriation for that postoffice building we will forget his failure to send us our quota of garden seeds.

WHAT does this mean? The Timpson Times says: "Contractors on the Santa Fe extension from Center to Zuber received a telegram from headquarters Tuesday suspending all work. Letter of explanation will follow." Can it be that the Santa Fe people have again decided to change the route of the extension?

A RECENT news item in the Houston Post says that "Henry Swigart of Tallmadge, Ohio, pursued by three armed deputy sheriffs, was attacked by a jersey cow and pinned fast to a stanchion until the officers came up and seized him." A single one armed Texas ranger can seize half a dozen Swigarts, and without the aid of even a jersey calf.

THE Houston Post makes much boast because a mercantile firm of that city has received an order from the Indian agricultural department for four tons of Spanish peanuts to be shipped to Bombay. That is an item worthy of boast, but we look for the Post to announce when the shipment is made that the nuts were produced in Heavenly Houston.

## A FAIR PROPOSITION.

During the recent meeting of the State Democratic Executive committee at Fort Worth, Committeeman J. M. Edwards of Smith county offered a resolution providing for the selection of the four delegates at large to the National Democratic convention at Denver by direct vote of the Democrats of Texas at a State primary election. The resolution was voted down, however, a majority of the committee contending that under the election law the State Committee has no authority to order such election. Section 139 provides for the selection of delegates to the county and State conventions on each presidential year, but the law makes no specific provision for the selection of delegates to the national convention. In refusing to submit this question of selecting the delegates-at-large to a vote of the Democrats of the State, it is the opinion of The Sentinel that the committee made a grievous mistake. This view is shared by the esteemed Austin Statesman, one of the State's most ardent and outspoken supporters of Senator Bailey, as the following will show. The Statesman says: "It is the unanimous and enthusiastic opinion of The Statesman that those friends of Senator Bailey who voted against the resolution offered by Committeeman Edwards to submit the matter of selecting the delegates from the state-at-large to the national democratic convention to be held in July made a great mistake. To begin with the law should so provide an elective primary for that purpose, and in the absence of a provision in the law the committee should make the necessary provision for such election. Our firm belief is that it is best to have such an election. In fact we should like very much to get the matter reconsidered. Let the democratic people of Texas rule. We hereby petition Chairman Carden to reconvene the committee to reconsider and submit the selection of such delegates to a democratic primary election to be held throughout the state. It is right and we can lick 'em too easy to talk about. As a matter of right there is nothing wrong in those who oppose Senator Bailey making the fight to keep him off that delegation, and it is equally right that those who want him to go should make a fight to get him on the delegation. We are for a primary election."

THE court of criminal appeals has decided that the law placing a \$2,000 tax on dealers in "Ino," "Uno," "Frosty," etc., is unconstitutional. This law was passed in the last session of the legislature and was brought into court as a test case. This case was exparte Woods from Orange. The court holds the law unconstitutional on account of the legislature levying an occupation tax of two thousand dollars on the sale of non-intoxicating liquors in local option territory and because the provision authorizes druggists to sell liquor without paying a tax.

## TRIBUTE TO THE DEAD.

The following from an exchange is applicable to some folks not a thousand miles from Nacogdoches:

"Dead men are only fit to inhabit cemeteries. If they are decently dead, dead all over, we tenderly lay them away in the sleep of the tomb; but if they are dead to all the enterprises out of the narrow plans of their own interests and yet persist in walking around, moving their dry bones, calloused hearts and consciences where real business is wont to throb and pulse with vigor, they are only like the drone bees, in the way until they are stung to death and dragged outside the hive of legitimate industry. Twenty real live men are worth more to the public generally than a round-full thousand of useless material that lies around like rubbish in a rising stream that is aching and forming to turn mills and factories. Yes, live men bless, and dead men curse a man."

THERE is talk of Monty J. Moore of Cameron entering the race for attorney general. This is the same Monty who entered the gubernatorial race two years ago, and after a casual glance over the field, decided it best to go way back and sit down.—Grand Saline Sun.

And the last heard of Monty he was still sitting.

LAST spring a Fannin county man planted an acre of beets to feed his cow, and after he had fed her on them for five months and sold six tons, he built a barn to house the rest for winter use. That's no fairy tale, as will be attested by one of the county's best citizens.—Bonham News.

Never mind the proof, no one has disputed your statement; though that is a pretty good beet story.

THE announcement of Col. Dick Wynne for attorney general came as a thunder clap in a clear sky in the political camp, and puts the contest in a complicated attitude. With two candidates opposing Attorney General Davidson, the situation ought to look good to the present incumbent, but the presumption is that Senator Looney will withdraw. In commenting on Colonel Wynne's announcement, the Tyler Courier and Times says: "Col. Wynne started out in life with a wife and a yoke of oxen. He plowed in new ground with the oxen as his motive power, while his wife did the cooking and house work. After years of hardships Col. Wynne entered the practice of law. All of this occurred in Rusk county, about 35 miles from Tyler, in old East Texas, and the county in which Col. Wynne lived for 25 years when he moved to Fort Worth, where he has practiced law for nearly 30 years. He is a straight ticket voting democrat, and there never was a day nor an hour that Dick Wynne was not on the side of, and a defender of, the rights of the common people. Davidson's bosses had just as well start at once getting themselves together for they are facing trouble. Their man is out-classed from any and every standpoint."

## UNEMPLOYED AGENTS.

Provision Made for Securing Homes for Immigrants.

The following circular, which is being sent out by the Department of Commerce and Labor at Washington, has been handed The Sentinel by Capt. Jno. S. Dougherty with request to publish. Any one desiring any of the blanks mentioned in the circular can secure them by applying to Mr. Dougherty:


Sir: Through the courtesy of the Bureau of Statistics of the Department of Agriculture, the Division of Information of the Bureau of Immigration and Naturalization of the Department of Commerce and Labor directs your attention to section 40 of the act of Congress "to regulate the immigration of aliens into the United States," approved February 20, 1907, reading in part as follows:

"Sec. 40. Authority is hereby given the Commissioner-General of Immigration to establish, under the direction and control of the Secretary of Commerce and Labor, a division of information in the Bureau of Immigration and naturalization; and the Secretary of Commerce and Labor shall provide such clerical assistance as may be necessary. It shall be the duty of said division to promote a beneficial distribution of aliens admitted into the United States among the several states and territories desiring immigration. Correspondence shall be had with the proper officials of the states and territories, and said division shall gather from all available sources useful information regarding the resources, products, and physical characteristics of each state and territory, and shall publish such information in different languages and distribute the publications among all admitted aliens who may ask for such information at the immigrant stations of the United States and to such other persons as may desire the same."

In order to carry out the object of the act above quoted the Division of Information is seeking to get into direct communication with all of the farmers in the United States who may wish to employ farm labor or domestics, or who have lands for sale or rent, with a view to learning from them what their needs are and the details of the same. We are addressing you because it is believed that you will be glad to render assistance along these lines.

For the purpose of securing detailed and accurate information certain blanks are used which will be gladly sent to those who may be interested. For your information there is attached a copy of the "Farm Laborers" blank together with Form E, and if you need help of that description, the division will be glad to have you fill it out and return it. Other blanks of special interest to farmers are those relating the demand and opportunities for "Domestics" and "Settlers," the latter being used by those having

lands for sale or for rent. Should you desire either of those blanks the Division of Information will forward copies on request.

The Division will be pleased to have you aid it by letting the farmers of your township know of its existence, its object, what information it wishes to secure, and inviting them to write to it of their needs. Should you be willing to aid the Division a supply of the different blanks will be sent to you for distribution among those who may have use for the same. It would also aid the Division if you would from time to time forward lists of those in your township who may desire help of any kind.

It frequently occurs that desirable persons who are seeking work have not sufficient funds to pay their fare to any distant point, and should you or your acquaintances fill out blanks, the question in regard to the willingness to advance transportation expenses, in case of necessity, should be answered.

In dealing with the alien we must include the unemployed citizen as well; for in the over-populated districts many who have become citizens are as ignorant of the opportunities for bettering their conditions elsewhere as are the newly admitted aliens.

The Division would thank you to give the subject-matter of this letter the widest publicity possible in your township, and would appreciate your cooperation with it in its work to the fullest extent possible along the lines above indicated.

Any response you may make to this communication may be inclosed in the franked envelop addressed to the Bureau of Statistics of the Department of Agriculture, and it will be duly transmitted to the Division of Information of the Department of Commerce and Labor.

Texas and Tobacco.  
Current Issue.

And here is some more work for the experts, State and Federal, in tobacco growing. If the people of this country must have cigarettes—and it seems they must in spite of

the reformers—what's the use of sending \$400,000 to Turkey annually for cigarette tobacco? From Trebizond in Asia Minor Consul M. J. Jewett writes in Consular and Trade Reports:

"Tobacco for cigarettes is the most important product of Trebizond Province of Asia Minor. The tobacco growing regions embrace Barra, Samsoun, Platena, and Trebizond. Last year 9063 tons of cigarette tobacco was exported from Samsoun, of which 609 tons went direct to the United States. The annual product of the whole province is about 17,000 tons. The value of the declared exports of cigarette tobacco to the United States for the whole province during the year ended June 30, 1907, was \$400,629. The crop for this year, in spite of the damage done by insects, promises to be large and of good quality. In the Trebizond and Platena districts a cutworm did some damage in the early part of the season, but the crop is estimated at 80 or 40 per cent. more than last year. As practically nothing was done to destroy the cutworm, it is feared that next year they may be much more abundant and cause serious damage. In the Barra region the locusts did considerable damage and the crop is reported as considerably below the average."

Evidently the quality of tobacco most suitable for this purpose is not produced in this country—at least not enough to supply the demand—otherwise such large importations would not be made; but can it be successfully produced here? That is the question of interest to Virginia, Kentucky, the Carolina's, Tennessee—and Texas. For Texas is doing something worth while in that line now.

This is a matter wholly within the jurisdiction of those who have practical or technical knowledge of climatic conditions and soil qualities, and there is probably something in it well worth looking after.

If Nacogdoches can knock out Trebizond, then the Current Issue is for Nacogdoches every time.

Truck Farming Increasing. The trucking industry in the vicinity of Nacogdoches is on the increase, and the prospects are there will be a larger acreage than usual planted to truck. Mr. J. H. Thomas writes the Kansas City Packer that he will have 3,000 bushels of potatoes for shipment, besides 20 acres in cabbage and a quantity of beets, radishes, lettuce, etc.

If one shipper will have that much produce for shipment, it is safe to say the acreage will be more than double that mentioned by Mr. Thomas. Any one having produce to dispose of would do well to see Mr. Thomas.

## Farmers Meeting Saturday.

Mr. C. P. Franklin, special agent of the United States agricultural department, in charge of the demonstration work in Nacogdoches county, was in the city Saturday completing arrangements for the big farmers meeting to be held here next Saturday.

Mr. Franklin says that in addition to Mr. Procter, the state agent, Mr. G. W. Orms, district agent, and perhaps others, will be here and address the farmers.

An effort is being made to secure Hon. R. T. Milner, the state commissioner of agriculture, for this meeting, and if he can come he will also deliver an address. The prospects now indicate that the meeting will be largely attended, and it will result in much benefit to the farmers.

## Death of W. J. Bruton.

The many friends of W. J. Bruton were pained to learn of his death which sad event occurred at his home in Fort Worth, at 8:30 a. m., the 3th inst. At the time of his death, Mr. Bruton lacked but four days being seventy years of age.

The immediate cause of his death was, bronchial asthma, which resulted from a severe cold contracted about a week before his death. Funeral services were conducted from his residence that evening at 3 o'clock, after which interment took place in Oakwood cemetery.

Deceased had been in rather feeble health for several months, having received an apoplectic stroke last September, from which he never fully recovered. Enterprise, where he continued to live until 1899, at which time he moved to Nacogdoches and engaged in the hotel business. Here his wife's health failing, he returned to Mt. Enterprise; served for a time as postmaster; subsequently he served a term as justice of the peace, during which time he engaged in the grocery business, and continued his business until last November when on account of his health he disposed of his business and went to Fort Worth to be with his son, O. F. Bruton.

He was married to Miss Bettie Jackson of Bloomington, Ill., and is survived by Mrs. Bruton, four sons and two daughters, as follows: C. G. Bruton of Nacogdoches; D. C. Bruton of Mt. Enterprise; O. F. Bruton of Fort Worth; S. L. Bruton of U. S. N.; Mrs. J. R. Westfall of Mt. Enterprise; and Mrs. J. N. Russell of Henderson.

After becoming a citizen of Mt. Enterprise, the progressive spirit and sterling character of deceased stamped him as one eminently worthy of esteem and confidence which he enjoyed to a degree rarely attained. A man superlatively sensitive to his duty; he always did and worked for the right as he saw it, without any thought of sinister consequences. As a neighbor he had no superior; his heart and hand was ever ready to comfort the distressed and aid the unfortunate. ## SENSATION IN SHORT TRIAL.

Witnesses Testify Defendant Ordered Garrett to Shoot.

Houston Chronicle.

Tyler, Tex., Feb. 19.—The most sensational part of the Short murder trial was perhaps reached yesterday afternoon and this morning when King Jetton, a young man 19 years old, was placed on the stand. The state, on direct examination, developed facts connecting Short with the conspiracy to kill Dr. Paul. He said he heard a conversation Short had over the telephone, presumably to his home, giving instructions to the negro, Dick Garrett, to allow no one to arrest him, and to kill anyone trying it. On the cross examination, Attorney John put the witness to a most rigid test, only to be told the same story from beginning to end.

Following the witness came the father of young Jetton, who corroborated his testimony. The state next endeavored to introduce a copy of the bill of indictment, the

witness, with finger pointed at him, putting volley after volley of questions, waiting only for brief answer. So far the state's witnesses have stood the rigid cross examination without a falter. Interest is growing in the case, it being absolutely impossible to seat the spectators, and the rule of allowing no one to stand is being enforced by the court.

Judge Short seems to be standing up under the trial well. Often during the examinations he is in consultation with his attorneys, and from the drift of the questions it can be seen that his dictations are being followed in some instances.

The work today has progressed well, considering the time consumed by attorneys with objections, something like six witnesses having been examined. In all probability the state will finish its case not later than Friday morning, but the defense, with its more than 150 witnesses, will require several days.

## INTERESTING EVIDENCE.

City Marshal Hunter Testifies in the Short Trial.

Tyler, Texas, Feb. 24.—

The court held a night session Saturday night, and after examining a number of witnesses F. E. Hunter, city marshal of Center, was placed on the stand at 10 o'clock. His testimony was that the sheriff had called to him to stop the negro, Dick Garrett, which he did; that while holding the negro he searched for a pistol but failed to find that the negro had one; that he had the negro under control when Sheriff Booth came up and struck the negro over the head with a 2x4 scantling three and a half feet long, and he, for that reason, turned the negro loose; that the sheriff did not state whether he wanted to whip or arrest the negro, and that he did not propose to hold the negro to be beaten up; that he then went before the clerk of the city court, swore out a complaint against the negro, got a warrant and went to the law office of Judge Short and arrested the negro and took a bond for his appearance before the city court, which he approved. This bond was made two or three hours before the negro killed Dr. Paul at Judge Short's home. It will be remembered that Witness W. F. Parker for the defense testified that he was a deputy sheriff and had been for twenty-five years, and was at Judge Short's office when the negro was arrested. He then left the office and met Sheriff Booth and told him in the presence of Dr. Paul that the negro had made a good bond and had been sent back to work. The sheriff then remarked that he would not recognize the bond; that he wanted the negro and was going to get him.

## Hunting His Sister.

The governor yesterday received a letter from B. F. Lee, of 313 North Locust street, Hagerston, Washington county, Maryland, in which the writer makes inquiries concerning his sister, who he says was a Mrs. Abshear, the wife of a traveling salesman, named Alfred Abshear. The writer says he has a reason to believe that she is probably living in Texas, and that she lived in Waco in 1894, and before that time she and her husband lived at Fort Worth. He has written to the authorities at both of these places and he says he has been unable to obtain any information which would throw any light on her whereabouts.

THERE will be a meeting of Democrats from all over the state at Fort Worth next Saturday, February 29, at 10 a. m., to devise ways for getting an expression on state prohibition in the Democratic primary this year. A special rate of one and a third fare for the round trip has been secured from the railroads. All Democrats favoring the submission of the prohibition question to the vote of the people are requested to attend the meeting.

## A HIGHER CALLING.

In commenting on the peculiar fitness and adaptability of newspaper men for filling the position of legislator, the Madam Editor of the Timpson Times says:

"Apart from the consideration that the editor of the Times has so offered himself the Madam believes that there are no more capable, honest and deserving men in the state than its 'country' editors, and that if the politicians were raked out and replaced by such men, the people would have less room for complaint. Editors live closer to the people than politicians, and their highest ambition is not to feather their own nests."

No one can consistently dispute the Madam's contention, but when a newspaper man condescends to run for the legislature he then becomes a politician. There is no higher calling open to man than the newspaper business, and when an editor offers his services in the halls of the legislature he makes a sacrifice for which he receives poor compensation and little credit.

 East Texas is waking up, under the impulse of diversification, to a proper conception of its needs for better and more transportation outlets to the markets of the country. Cabbage and onions and potatoes and strawberries and peaches decay in truck patches and orchard, unless given quick movement to the markets of the canning plant.—Fort Worth Star.

East Texas is indeed waking up. With Beaumont as the center there is here being developed a fine farming region as there is in the state. Western Louisiana, too, has caught the step and the plow is being pushed through the piney woods region as never before, and the broad expanse that is drained by the Neches and the Sabine rivers is taking on new life.

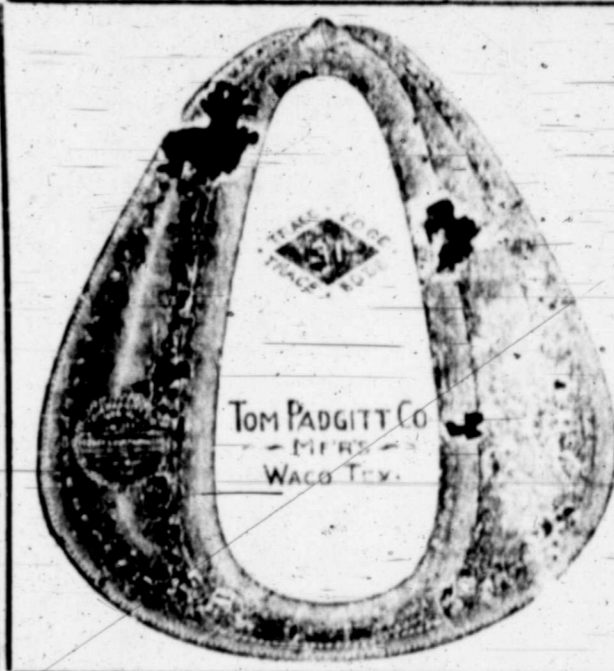
